



All structural steel shall be AASHTO M 270 Grade 36 unless otherwise noted. No field welding is permitted except as specified in the contract documents. Reinforcement bars designated (E) shall be epoxy coated.

Prior to pouring the new concrete deck section, all heavy or loose rust, loose mill scale, and other loose or potentially detrimental foreign material shall be removed from the surfaces in contact with concrete. Tightly adhered paint may remain unless otherwise noted. Removal shall be accomplished by methods that will not damage the steel and the cost will be included in the pay item covering removal of the existing concrete.

Plan dimensions and details relative to existing plans are subject to nominal construction variations. The Contractor shall field verify existing dimensions and details affecting new construction and make necessary approved adjustments prior to construction or ordering of materials. Such variations shall not be cause for additional compensation for a change in scope of the work, however, the Contractor will be paid for the quantity actually furnished at the unit price bid

Existing reinforcement bars extending into the removal area shall be cleaned, straightened and incorporated into the new construction. Any reinforcement bars that are damaged during concrete removal shall be replaced with an approved bar splicer or anchorage system. Cost included with Concrete Removal.

Existing structural steel shall only be cleaned and painted as required by the Special Provision "Cleaning and Pointing Adjacent Areas of Existing Steel Structures".

Joint openings shall be adjusted according to Article 520.04 of the Std. Specs. when the deck is poured at an ambient temperature other than 50°F.

All new Structural Steel and bearing assemblies shall be hot-dip galvanized. See Special Provision for "Hot Dip Galvanizing for Structural Steel".





TYPICAL BRIDGE SECTION - EXISTING




TYPICAL BRIDGE SECTION - PROPOSED


TYPICAL BRIDGE SECTION EXISTING

Drilled and set anchor bolts shall be installed according to Article 521.06 of the Standard Specifications. Side retainers and $^{\prime}_4$ in. stainless steel plates required for the bearing assembly shall be included in the cost of Elastomeric Bearing Assembly, Type I.

The minimum jack capacity required is 15 Tons.

Existing diaphragm removal and reinstallation
may be required to facilitate drilling holes, cost to be
included with "Jack and Remove Existing Bearings".



Side retainers and 'a in. stainless steel plates required for the bearing assembly shall be included in the cost of Elastomeric Bearing Assembly, Type I.

The minimum jack capacity required is 15 Tons.







PLAN-TOP & BOTTOM PLATE









Notes:

The strip seal shall be made continuous and shall have a minimum thickness of $\frac{1}{4}$ ". The configuration of the strip seal shall match the configuration of the locking edge rails. Open or "webbed" strip seal gland configurations are not permitted. The gland shall be sized for a maximum rated movement of 4 inches.

The locking edge rails depicted are configured for typical applications and are conceptual only. The actual configuration of the locking edge rails and matching strip seal may vary from manufacturer to manufacturer provided they fit the application and meet the minimum anchorage shown. Flanged edge rails, however, will not be allowed.


The manufacturer's recommended installation methods shall be followed.

All steel components shall be galvanized after fabrication according to Article 520.03 of the Standard Specifications.

The Maximum space between locking edge rail segments shall be $\frac{3}{16}$ " and sealed with a suitable sealant; however, any rail joint within 10' measured perpendicular to the face of the curb or parapet shall be welded as shown in the locking edge rail splice detail.

Cost of parapet sliding plates, embedded plates, and anchorage studs included with Preformed Joint Strip Seal.

34" F-shape barrier shown, 42" F-shape similar as noted. The concrete opening below the strip seal will vary based on the locking edge rail chosen by the Contractor. Deck and parapet lengths shown elsewhere in the plans are dimensioned to the concrete opening, not the joint opening, and are based on the rolled locking edge rail. If the Contractor elects to use a different locking edge rail, dimensional adjustments may be required. Such adjustments shall be at no additional cost to the State.



 $\frac{3}{8}$ " ϕ threaded rods in $\frac{7}{16}$ " ϕ holes at ± 4 '-0" cts. for holding the proper joint opening based on the temperature during the deck pour. Place to miss studs. All rods shall be burned, or sawed off flush with the plates after concrete is set.

SECTION A-A * Granular or solid flux filled headed studs conforming to Article 1006.32 of the Std. Specs., automatically end welded.



SHOWING ROLLED RAIL JOINT








