## **FENCE REMOVAL AND REINSTALLATION**

**Description.** This work shall consist of the satisfactory removal and reinstallation of portions of existing fence and its appurtenances at locations shown in the plans or as directed by the Engineer. This work shall be completed according to the applicable portions of Section 201, Section 664, and Section 665 of the Standards Specifications and as noted herein.

Posts shall be set vertical and true in alignment and post spacing shall match existing fence spacing as closely as possible.

Fence shall be removed at the location(s) identified in the plans, in order to allow access for the TREE REMOVAL behind the fence. Once the appropriate trees have been removed, the fence will be reinstalled at the same location.

Prior to beginning work, the Contractor shall report any existing fence damage to the Engineer. Any fence, posts, railing, etc. damaged during removal, storage, or reinstallation shall be repaired or replaced by the Contractor as directed by the Engineer. No additional compensation will be provided for repair or replacement of fence damaged during removal, storage, or reinstallation.

**Method of Measurement.** This work will be measured in place in units of feet, along the base of the existing fence to be removed.

**Basis of Payment.** This work will be paid for at the contract unit price per foot for FENCE REMOVAL AND REINSTALLATION.
