The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAP Route 17 (US 52/IL 64), Project F-0017 (121), Section (1, 2)RS & (3-1)RS-1, Carroll County, Contract #64560, and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF PROJECT

U 52/IL 64 from East of Savanna to East of Mt. Carroll.

DESCRIPTION OF PROJECT

This project consists of rubblizing mainline and N IL 78, 7¼" structural overlay, adding stabilized shoulders, removing and replacing S IL 78, adding turn lanes, replacing or lining culverts, storm sewer placement, and realignment of Quarry Road.
