Our office has reviewed your application received March 1, 2023, concerning the proposed projects to replace span bridges with culverts. This project is authorized to impact ~0.02 acres of streambed and bank at both locations. Location A (41.9087, -89.6293) will replace bridge with a 10'x 96' culvert and rip-rap emplacement over an unnamed tributary to Jordan Creek located in Section 7, Township 22 North, Range 8 East in Ogle County Illinois. Location B (41.8989, -89.6679) will replace bridge with a 10'x 72' culvert and rip-rap emplacement over Jordan Creek located in Section 14, Township 22 North, Range 7 East, Whiteside County, Illinois.

Your project is authorized under Nationwide Permit No. 14 – Linear Transportation Projects, provided you meet the permit conditions for the nationwide permits, which are included in the Fact Sheets. The Corps has also made a determination of no effect on federally threatened and endangered species or critical habitat. The Illinois Environmental Protection Agency (IEPA) has also issued Section 401 Water Quality Certification with conditions for this nationwide permit. Please note these additional conditions included in the Fact Sheet. The decision regarding this action is based on information found in the administrative record, which documents the District's decision-making process, the basis for the decision, and the final decision.

This verification is valid until March 14, 2026, unless the nationwide permit is modified, reissued, or revoked. It is your responsibility to remain informed of changes to the nationwide permit program. We will issue a public notice announcing any changes if and when they occur. Furthermore, if you commence or are under contract to commence this activity before the date the nationwide permit is modified or revoked, you will have twelve months from that date to complete your activity under the present terms and conditions of this nationwide permit. If the project plans change, you should contact our office for another determination.

This authorization does not eliminate the requirement that you must still acquire other applicable Federal, state, and local permits. If you have not already coordinated your project with the Illinois Department of Natural Resources – Offices of Water Resources, please contact them at 217/782-3863 to determine if a floodplain development permit is required for your project.
