THE CONTRACTOR IS ADVISED THAT THERE MAYBE PRESENCE OF DEPARTMENT-OWNED UNDERGROUND ELECTRICAL CABLE WITHIN THE LIMITS OF THE PROPOSED IMPROVEMENT. THE CONTRACTOR SHALL REQUEST THE ILLINOIS DEPARTMENT OF TRANSPORTATION IN OTTAWA (815-434-8417) TO LOCATE THE UNDERGROUND FACILITIES, PROVIDING A MINIMUM OF 72 HOURS NOTICE. THE DEPARTMENT IS NOT A MEMBER OF THE JOINT UTILITY LOCATING INFORMATION FOR EXCAVATORS (JULIE) SYSTEM

ALL DAMAGE TO DEPARTMENT OWNED UNDERGROUND FACILITIES, CAUSED BY THE CONTRACTOR SHALL BE REPAIRED TO THE SATISFACTION OF THE DEPARTMENT AT THE CONTRACTOR'S EXPENSE, THIS SHALL INCLUDE ALL TEMPORARY REPAIRS REQUIRED TO KEEP THE FACILITY OPERATIONAL WHILE MATERIAL IS BEING OBTAINED TO MAKE PERMANENT REPAIRS, SPLICING OF ELECTRIC CABLE SHALL NOT BE ALLOWED. ELECTRIC CABLE SHALL BE REPLACED FROM POLE TO POLE OR CONTROLLER.

THE CONTRACTOR IS REMINDED TO CAREFULLY EXAMINE THIS CONTRACT FOR NEW OR CHANGED CONDTIONS FROM ANY PRVIOUS VERSION HE MAY HAVE EXAMINED.

THE REMOVAL OF DAMAGED GUARDRAIL AND DAMAGED POSTS SHALL NOT BE PAID FOR SEPARATELY BUT SHALL BE CONSIDERED INCLUDED IN THE COST OF THE VARIOUS REPLACEMENT PAY ITEMS.

THE TRAFFIC CONTROL REQUIRED FOR THE REPAIRS OR INSTALLATION OF GUARDRAIL OR FENCE SHALL BE CONSIDERED INCIDENTAL TO THE VARIOUS PAY ITEMS OF WORK, AND SHALL BE IN ACCORDANCE WITH THE TRAFFIC CONTROL STANDARDS INCLUDED HEREIN.

ALL HARDWARE (NUTS, BOLTS, WASHERS, STAPLES, WIRES, TIES, ETC.) REQUIRED FOR THE REPAIRS TO OR INSTALLATION OF GUARDRAIL AND FENCE SHALL BE CONSIDERED INCIDENTAL TO THE VARIOUS PAY ITEMS OF WORK IN THIS CONTRACT.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR PROTECTING UTILITY PROPERTY FROM CONSTRUCTION OPERATIONS AS OUTLINED IN ARTICLE 107.31 OF THE STANDARD SPECIFICATIONS. THE J.U.L.I.E. NUMBER IS 1-800-892-0123. A MINIMUM OF 48 HOURS ADVANCE NOTICE IS REQUIRED.
