Failure to comply with this special provision may result in the withholding of payments to the contractor, and/or cancellation, termination, or suspension of the contract in whole or part.

This Special Provision must be included in each subcontract agreement.

Compliance with this Special Provision shall be included in the cost of the contract and no additional compensation will be allowed for any costs incurred.

PEAK HOUR RESTRICTIONS

The Contractor shall have all lanes open to traffic during peak hours in northbound lanes and southbound lanes along IL 255 as shown in the plans. The Contractor shall not be permitted to conduct any type of operation that would impede the flow of traffic during peak hours. The Contractor shall be permitted to work on the weekends while adhering to the peak hour restrictions, except the Contractor is prohibited from working on those holiday weekends specified in Article 107.09.

Peak hours are defined as:

See PEAK HOUR RESTRICTIONS chart in the plans.

In addition to the restrictions noted above, no lane closures will be allowed on Fridays between 12:00 p.m. and 12:00 a.m. midnight.

Should the Contractor fail to have all lanes open to traffic during the defined peak hours, the Contractor shall be liable and shall pay to the Department \$5000, not as a penalty but as liquidated damages, for every 15-minute interval or portion thereof that the flow of traffic is impeded by the Contractor's operations. The Department will deduct these liquidated damages from any monies due or to become due to the Contractor from the Department.
