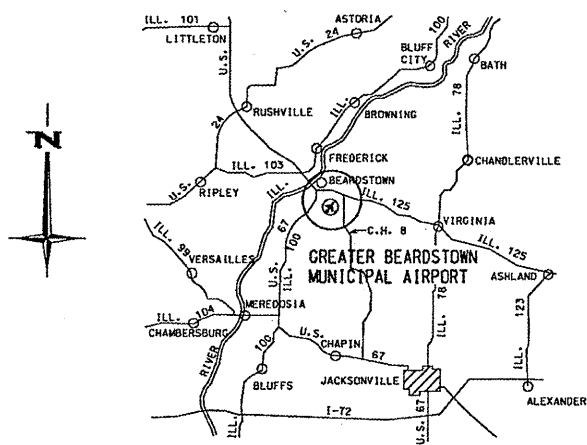

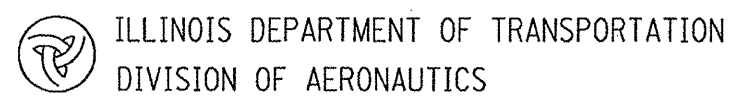
VICINITY MAP

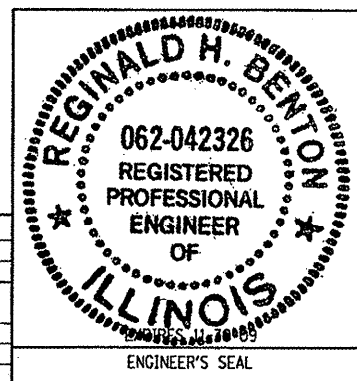
