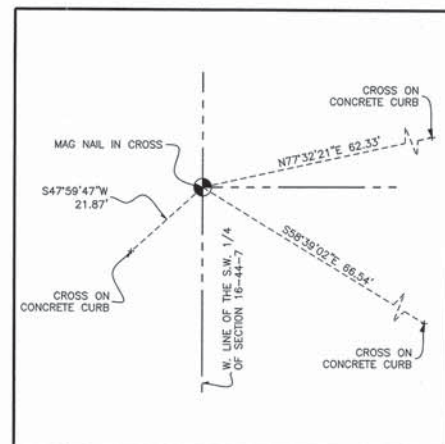
SOUTH QUARTER CORNER OF SECTION 15-44-7

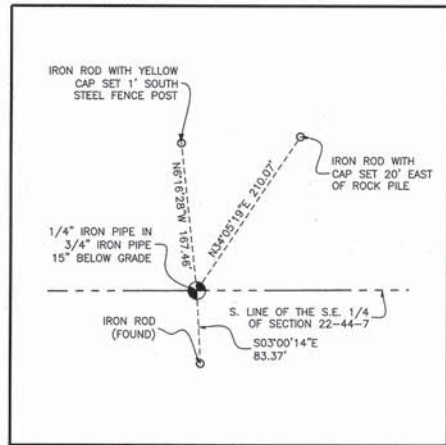
SOUTHWEST CORNER OF SECTION 15-44-7

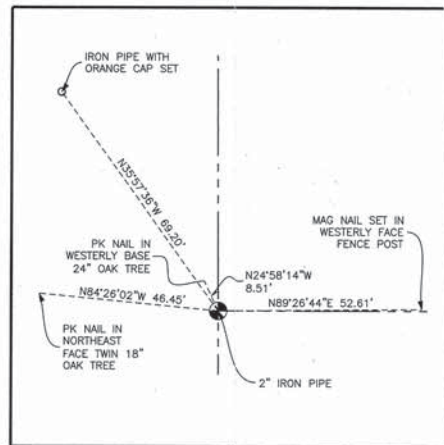
WEST QUARTER CORNER OF SECTION 15-44-7

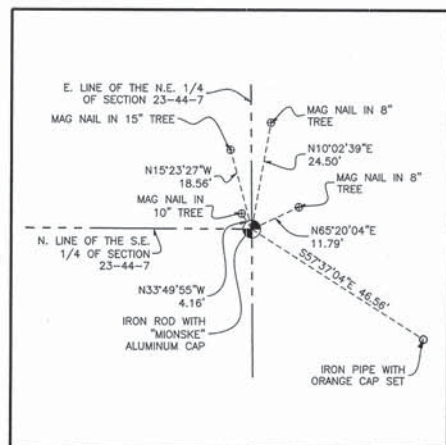
WEST QUARTER CORNER OF SECTION 16-44-7

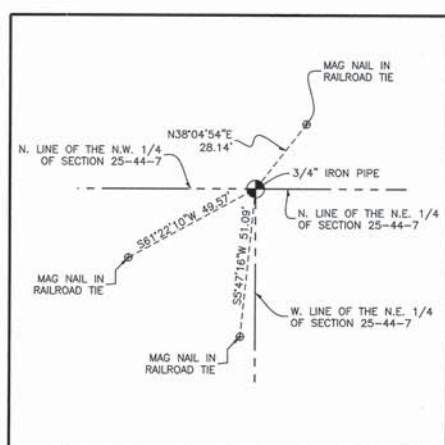
