The Contractor shall submit to the Engineer sufficient information for each piece of equipment and its attachments to enable the Engineer to determine the proper equipment category. If a rate is not established in the Blue Book for a particular piece of equipment, the Engineer will establish a rate for that piece of equipment that is consistent with its cost and use in the industry.

b. Rented Equipment. Whenever it is necessary for the Contractor to rent equipment to perform extra work, the rental and transportation costs of the equipment plus five percent for overhead will be paid. In no case shall the rental rates exceed those of established distributors or equipment rental agencies.

All prices shall be agreed to in writing before the equipment is used."

## COMMITMENTS

As part of a commitment, at the start of construction, the Contractor will be responsible to first remove and cleanup the debris for the small apartment building located on the northwest side of the Parkview Motel property within five (5) working days.

Temporary fencing is to be placed around the limits of the temporary easement (where there are 4 to 5 parking spaces) at the start of the small apartment building removal, mentioned above, and shall be removed directly after removal and cleanup of debris within the required five (5) working days.
