CORRECTIONS:

Article 8.8 Monthly Preventive Maintenance Program

Chart item 8.10.17 Correct to June 2016 Only
Chart item 8.10.19 Eliminated

Article 9.10.11 Wireless Communications

Delete in paragraph 1: “maintain fifteen (17)” and Replace with: “maintain seventeen (17)”
Delete in paragraph 3: “twenty five (35)” and Replace with: “thirty five (35)”

Article 9.10.13 Electrical Maintenance Contract Issue Trak System (EMCIT)

Delete “paragraph 3 under Start-Up EMCIT Requirements” and Replace with:

“The Contractor shall pay through routine maintenance the monthly service cost for a productivity license, based on total number of (100) named users for Cloud based issue tracking, work flow and process management applications, e-mail processing and notifications, IssueTrak Mobile, auto assignments, escalation rules, process manager, knowledge base, dashboard, report writer, scheduled reports, Cloud Active Directory module, Cloud Asset Management module, 4 days of onsite training by Professional Services of the maintainer/developer, and the “unlimited maintenance plus” designated product, which includes all software upgrades, major releases and unlimited technical support and many other core features.”

ADD TO SECTION 1

Addition to Article 7.5.8 Yearly Control Cabinet Full Inspection

Use Log L-3 and/or all entry fields in the Excel Spreadsheet.

Addition to Article 8.10.16 Asset Inventory

The Contractor shall update an Engineer supplied Asset Inventory by Location to an Excel Spreadsheet and submit in the Routine Maintenance November submittal (due by December 7, 2016). The Contractor shall keep current the Asset Inventory monthly during this Contract, update each time there is a change in equipment (recorded on a Disposition Log and Transaction Summary), and submit in the Routine Maintenance submittal.

Add Article 9.10.15 Fiber Cable Management System

The 3-GIS cable management system is used to document and manage horizontal and backbone cables, hardware, assets, pathways, locations, contacts, and detail equipment connections, test results, attaches drawings, photos and documents, creates a contact directory, and cable label. The Contractor shall provide labor for data entry and red-lining of plans into the fiber optic cable management system. The Contractor shall provide personnel to be trained to modify electronic record drawings, as specified in the respective Articles herein, for the fiber cable management system, 3-GIS.

Addition to Article 10.26 Convert Existing Electric Utility Service to Metered Service

The meter enclosure shall be located on the load side of the existing service disconnect unless otherwise directed by the Engineer. Existing service cable from the service disconnect may be re-used to connect to the meter enclosure however new same size service cable shall be extend the service from the meter housing to existing battery back-up system or directly to the traffic signal cabinet as directed by the Engineer. Underground or exposed service cable shall be installed in rigid steel conduit.

ADD TO SECTION 2

RML1 ROUTINE MAINTENANCE LOCATION

Description

This pay item provides a monthly payment for additional locations maintained that exceed the fixed monthly routine maintenance payment for locations maintained of 4750.

Method of Measurement

The Contractor shall provide the Engineer monthly, an Excel spreadsheet listing of additional maintained locations that exceed 4750. Review Article 5.0 Monthly Routine Maintenance and Additional Non-Routine Payment.

Basis of Payment

The work shall be paid at the Contract unit price, each, for ROUTINE MAINTENANCE LOCATION maintained during the past month that exceed 4750, which shall be payment in full for completing the work as described herein.
