LOCATION OF PROJECT

This project is located along IL 58 (Golf Road) and begins just east of I-294 (Tri-State Tollway) and proceeds approximately 16,074 feet (3.04 miles) in an easternly direction to Lincoln Street and along Elk Blvd and begins just east of US 12/45 (Lee St/Mannheim Rd) and proceeds approximately 550 ft in an easternly direction to US 12 (Rand Rd) and along Central Rd and begins just west of Lotus Ln and proceeds approximately 250 feet (0.05 miles) in an easternly direction in the City of Des Plaines and the Villages of Morton Grove and Niles in Cook County.

• All excavation planned at the northwest quadrant, northeast quadrant, and southwest quadrant at the intersection of Golf Road (IL 58) and Michael Manor. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of Golf Road (IL 58) and Washington Road, Niles, Cook County

- All excavation planned at the southeast quadrant at the intersection of Golf Road (IL 58) and Washington Road. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(5). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.
- All excavation planned at the northwest quadrant, northeast quadrant, and southeast quadrant at the intersection of Golf Road (IL 58) and Washington Road. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1).
 Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of Golf Road (IL 58) and Julie Drive, Niles, Cook County

 All excavation planned at the northeast quadrant at the intersection of Golf Road (IL 58) and Julie Drive. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of Golf Road (IL 58) and Shermer Road, Niles, Cook County

 All excavation planned at the northwest quadrant, northeast quadrant, southwest quadrant, and southeast quadrant at the intersection of Golf Road (IL 58) and Shermer Road. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of Golf Road (IL 58) and Parkview Road, Niles, Cook County

 All excavation planned at the northwest quadrant at the intersection of Golf Road (IL 58) and Parkview Road. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Central Road Drainage Improvements, w/o Lotus Lane to e/o Lotus Lane, Niles, Cook County

 All excavation planned for installation of reinforced concrete pipe drainage improvements on Central Road from w/o Lotus Lane to e/o Lotus Lane. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Work Zones
