9. THE STATIONING IN THE PLANS IS PROVIDED AS A POINT OF REFERENCE AND FOR DISTANCE PURPOSES ONLY. THIS IS NOT THE ACTUAL STATIONING FOR THE ROADWAY.

At Location No. 3, the limits of the existing centerline and no passing zone pavement markings shall be documented prior to applying the proposed A-1 surface treatment. Upon completion of the application of the surface treatment, the roadway surface shall be swept and freed of all loose aggregate to allow the placement of paint pavement marking between the documented limits. The 4" paint pavement marking lines and all labor and materials required to complete this work shall be included in the costs of the A-1 surface treatment pay items.
