Justification for use of project Labor Agreement on Contract 70943 McLean County:

The use of a project Labor Agreement on this project is consistent with all State and Local statutory regulatory requirements.

**Project Description:** This project is for a standard overlay, paved shoulders, and culvert repair on Illinois 9 from Illinois 122 to Walton Drive in Bloomington in McLean County. Other improvements associated with the project include milling, pavement patching, milled rumbles strips, ditch grading, signal modernization, pavement marking, and raised reflective pavement markers.
