 - Plantings
- Maintenance
 - Trees, Shrubs, Perennials, Vines and Seeding establishment


- Access Control Plans Included with Suggested Access and **Anticipated Closures**

 - Access from Exit Ramps








• I-90/94 Maintenance Access Points





Access from City Streets













 Access from Frontage Roads/Ramps/City Streets through Existing Gates

DISADVANTAGED BUSINESS ENTERPRISE (DBE) PARTICIPATION

The contract does not contain DBE contractor provisions.

- The Contractor's Bidder Utilization Form BC-1256 should be submitted with the bid and include minority and female employee utilization in all job categories in the workforce to be allocated to the contract.
- All Contract Compliance documents will be required to be uploaded to the IDOT SharePoint site.
- Payroll reports and certifications will be required weekly.
- All payrolls should be appropriately numbered with the final payroll labeled "Final".
- The Workforce Analysis Form SBE-956 should be uploaded monthly.
- All submittals must have IDOT's contract number on them.
- The prime contractor is responsible for the submittal of payrolls by subcontractors.
- The contractor is advised that the rates of pay posted in the wage decision of the contract will be strictly enforced.
- Minority utilization in each trade is 19.6% and female utilization in each trade is 6.9%. Please be mindful to be inclusive of the different minority groups that are available to work, building a diverse workforce through the community.
- A Contractor's weather-protected bulletin board is to be located at the jobsite in a prominent and accessible place where the workers can easily see it.
