#### SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted April 1, 2016, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAI Route 39 and FAS Route 253 (I-39/US 51 and IL 251), Project STP-9SVU(809), Section D4 Bridge Painting 2022, Woodford and Marshall Counties, Contract No. 68G57 and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

### **LOCATION OF PROJECT**

This project is located at various structures in Marshall and Woodford Counties in District Four as follows:

# **DESCRIPTION OF PROJECT**

This work shall consist of cleaning and painting of eight (8) structures. Abrasive blast cleaning per SSPC-SP10 shall be used for all locations. All eight (8) structures shall use Paint System 1-OZ/E/U, and related collateral work to complete the project.

#### DATE OF COMPLETION

The Contractor shall schedule his operations to complete all work and open all the roadway to traffic on or before **November 25**, **2022**. Location Nos. 3, 4, 5, and 6 need to be completed prior to **July 29**, **2022**. The Contractor shall note that this completion date is based on an expedited work schedule.
