

GENERAL NOTES

1. ALL CONSTRUCTION SHALL BE DONE IN ACCORDANCE WITH THE FOLLOWING ILLINOIS STANDARD SPECIFICATIONS: THE "STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION" ADOPTED JANUARY 1, 2007; THE LATEST EDITION OF THE "MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES FOR STREETS AND HIGHWAYS"; THE "MANUAL OF TEST PROCEDURES FOR MATERIALS"; THE LATEST EDITION OF THE "SUPPLEMENTAL SPECIFICATIONS AND RECURRING SPECIAL PROVISIONS", AND THE DETAILS AND SPECIAL PROVISIONS INCLUDED IN THE CONTRACT DOCUMENTS.
2. THE CONTRACTOR SHALL CALL J.U.L.I.E. (1-800--892-0123) 72 HOURS BEFORE EXCAVATION. FOR UNDERGROUND UTILITY LOCATIONS, UTILITY LOCATIONS SHOWN ON PLANS ARE APPROXIMATE.
3. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE PROTECTION OF ALL ABOVE AND BELOW GROUND UTILITIES, EVEN THOUGH THEY MAY APPEAR ON THE PLANS, AND ANY DAMAGE DONE TO EXISTING UTILITIES BY THE CONTRACTOR SHALL BE REPAIRED IMMEDIATELY AT THE CONTRACTOR'S EXPENSE.
4. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND EXISTING CONDITIONS IN THE FIELD PRIOR TO BIDDING OF THE PROJECT.
5. THE CONTRACTOR SHALL PROTECT AND CAREFULLY PRESERVE ALL PROPERTY MARKS AND MONUMENTS UNTIL THE OWNER, AND AUTHORIZED SURVEYOR OR AGENT HAS WITNESSED OR OTHERWISE REFERENCED THEIR LOCATION.
6. THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES, THE WILL COUNTY DEPARTMENT OF HIGHWAYS, LOCAL AGENCIES, AND THE ILLINOIS DEPARTMENT OF TRANSPORTATION.
7. WHEN ARTIFICIAL LIGHTING IS UTILIZED IN NIGHT OPERATIONS THE CONTRACTOR SHALL EXERCISE THE UTMOST PRECAUTIONS IN PREVENTING ADVERSE VISIBILITY TO THE MOTORING PUBLIC AND ADJOINING RESIDENTIAL AREAS.
8. THE CONTRACTOR SHALL MAINTAIN THE SURFACE DRAINAGE OF THE ROAD DURING CONSTRUCTION OF THIS PROJECT. WHEN EXISTING DRAINAGE FACILITIES ARE DISTURBED, THE CONTRACTOR SHALL PROVIDE AND MAINTAIN TEMPORARY OUTLETS AND CONNECTIONS FOR ALL PRIVATE OR PUBLIC DRAINS, SEWER INLETS, OR CATCH BASINS. THE CONTRACTOR SHALL PROVIDE FACILITIES TO TAKE IN ALL STORM WATER WHICH WILL BE RECEIVED BY THESE AND SEWER DISCHARGE THE SAME. THE CONTRACTOR SHALL PROVIDE AND MAINTAIN A TEMPORARY OUTLET AND BE PREPARED AT ALL TIMES TO DISPOSE OF THE WATER RECEIVED FROM THESE TEMPORARY CONNECTIONS UNTIL SUCH TIME AS THE PERMANENT CONNECTIONS ARE IN SERVICE. THIS WORK SHALL NOT BE PAID FOR DIRECTLY, BUT WILL BE CONSIDERED INCIDENTAL TO THE CONTRACT UNLESS OTHERWISE NOTED ON PLANS.
9. THE CONTRACTOR IS TO MAINTAIN ACCESS TO ABUTTING PROPERTY OWNERS AT ALL TIMES, EXCEPT FOR SHORT PERIODS OF TIME, WHEN ACCESS IS GOING TO BE INTERRUPTED, THE CONTRACTOR SHALL NOTIFY THE PROPERTY OWNER NO LESS THAN 24 HOURS IN ADVANCE OF THE INTERRUPTION AND SHALL NOTIFY THE OWNER OF THE TIME AND DURATION OF THE INTERRUPTION.
10. BARRICADES: THE CONTRACTOR SHALL PROVIDE AND INSTALL TWO WEIGHTED SAND BAGS ON EACH TYPE I OR II BARRICADE USED - ONE (1) WEIGHTED SANDBAG ACROSS EACH BOTTOM RAIL.
11. EXISTING CONDITIONS WERE TAKEN FROM THE BEST AVAILABLE INFORMATION. INFORMATION SHOWN CONCERNING FEATURES AND UTILITIES IS NOT GUARANTEED ALL INCLUSIVE OR CORRECT. THE CONTRACTOR SHALL VERIFY THE FEATURES PRIOR TO CONSTRUCTION. EXISTING UTILITIES SHALL BE MAINTAINED IN SERVICE AT ALL TIMES, UNLESS OTHERWISE NOTED ON THE PLANS. THE LOCATION, MATERIAL, AND DIMENSIONS OF EXISTING FACILITIES AND OBSTRUCTIONS ARE BASED UPON AVAILABLE RECORDS AND ARE SHOWN ON THE PLANS STRICTLY AS AN AID TO THE CONTRACTOR, BUT MUST NOT BE CONSTRUED AS BEING ACCURATE, COMPLETE, OR CORRECT.
12. IN ACCORDANCE WITH ARTICLE 107.25 OF THE STANDARD SPECIFICATIONS, THE CONTRACTOR SHALL BE REQUIRED TO MAINTAIN, STOCK, RE-ERECT TEMPORARILY AND/OR REPLACE AT PERMANENT LOCATIONS ALL EXISTING SIGNING AS NOTED THEREIN AS DIRECTED BY THE ENGINEER.
13. CITY OF NAPERVILLE DPU-E REQUIRES THE CONTRACTOR TO CONTACT J.U.L.I.E. TO LOCATE ALL UTILITIES. CONTRACTOR SHALL PROTECT ALL UTILITIES. IT IS NOT ANTICIPATED THAT UTILITIES SHALL HAVE TO BE RELOCATED.
