TEMPORARY FENCE

Effective: July 1, 1994

Revised: October 23, 2024

The Contractor shall perform this work according to Section 201 of the Standard Specifications. The type of temporary fence shall consist of the orange snow fence unless another type is approved by the Engineer. The fence will be place in the grass area next to daycare which is in the southwest quadrant of the West Access Road and Barge Terminal Road intersection. The temporary fence shall be erected in such a manner to help prevent the kids from entering the construction zone and to permit the Contractor to proceed with his operations.

This work shall be paid for at the contract unit price per Foot for TEMPORARY FENCE.
