

THE CONTRACTOR SHALL PROTECT AND CAREFULLY PRESERVE ALL PROPERTY MARKERS AND MONUMENTS UNTIL THE OWNER, AN AUTHORIZED SURVEYOR OR AGENT HAS WITNESSED OR OTHERWISE REFERENCED THE LOCATION.
- 2. ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE TO BE GIVEN TO UTILITIES BEFORE DIGGING. FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING J.U.L.I.E. (1-800-892-0123 OR 811) OR FOR NON-MEMBERS THE UTILITY COMPANY DIRECTLY.
- 3. ALL WELLS REQUIRE SEALING OF MISCELLANEOUS OPENINGS IN THE WELL HEAD TO PREVENT LEAKAGE DURING TREATMENT OPERATIONS. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT WILL BE INCLUDED IN COST OF THE SPECIFIED TREATMENT METHODS.
- 4. THE DEPARTMENT RESERVES THE RIGHT TO NOTIFY THE CONTRACTOR TO CHANGE THE SEQUENCE OF WELL CLEANING IF NEEDED TO ENSURE PROPER DEWATERING NEEDS FOR THE DEPARTMENT. THE CONTRACTOR SHALL ALLOW 24 HOURS BETWEEN WELL TREATMENTS. THE CONTRACTOR SHALL INSTALL THE TEMPORARY DISCHARGE PIPES BACK INTO THE WELL DISCHARGE PIPES. ALL DISCHARGE WATER SHALL BE DISCHARGED INTO THE WELL FORCE MAINS.
