### **LOCATION OF PROJECT**

This project is located in several locations throughout District One including: FAI Route 80 between east of Ridge Road and Briggs Street, Illinois Route 83 from Illinois Route 120 to Illinois Route 137, 183rd Street at Central Avenue, Interstate 55 over Sawmill Creek, Illinois Route 58 at Poplar Creek Tributary, Illinois Route 19 at Wise Road, US Route 20 at Gary Avenue, Lake Cook Road at Wallingford Lane, Illinois Route 7 from south of 135th Street to 131st Street, Illinois Route 31 over ditch, US Route 14 at ditch south of state line, 123rd Street over Mill Creek, Illinois Route 120 at O'Plaine Road, Illinois Route 53 over Great Western Trail, US Route 20 at Illinois Route 31, US Route 30 at Illinois Route 50, Illinois Route 394 at Burville Road, Illinois Route 53 at Joann Lane, Illinois Route 22 west of Illinois Route 83 and various other locations. The work involves various areas of tree removal within the above locations.

## **DESCRIPTION OF PROJECT**

The project consists of removing trees, as well as all incidental and collateral work necessary to complete the project as shown on the plans and as described herein.

These will not be paid as separate items, but the costs shall be considered as included in the contract prices for tree removal items. No additional compensation will be allowed.
