

GENERAL NOTES:

1. UTILITY INTERFERENCE IS NOT ANTICIPATED ON THIS CONTRACT. SHOULD THIS PROVE OTHERWISE DURING THE IMPLEMENTATION OF THE CONTRACT, NO ADDITIONAL COMPENSATION SHALL BE DUE THE CONTRACTOR AS A RESULT. THE CONTRACTOR IS REMINDED THAT JULIE MUST BE CONTACTED TO LOCATE ANY AND ALL UTILITIES WITHIN THE PROJECT LIMITS. THE JOINT UTILITY LOCATING INFORMATION FOR EXCAVATORS (JULIE) SYSTEM PHONE NUMBER IS (800) 892-0123.
2. THE CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND CONDITIONS IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING MATERIALS.
3. PROPER ADHESIVE (P-50) SHALL BE APPLIED TO THE GROOVED SURFACE PRIOR TO THE INSTALLATION OF THE PAVEMENT MARKING TAPE.
4. ADDITIONAL PAVEMENT MARKING REMOVAL REQUIRED ADJACENT TO THE PROPOSED GROOVING AS REQUIRED BY THE RESIDENT ENGINEER SHALL NOT BE PAID FOR SEPARATELY BUT SHALL BE INCLUDED IN THE COST OF THE GROOVING FOR RECESSED PAVEMENT MARKING PAY ITEMS.
5. PROPOSED PAVEMENT MARKINGS SHALL BE PLACED AT THE CURRENT LOCATIONS OF THE EXISTING PAVEMENT MARKINGS THROUGHOUT THE PROJECT LIMITS EXCEPT WHERE EXISTING MARKINGS FALL ON A JOINT OR SHOULDER. IN THIS CASE, EXISTING MARKINGS SHALL REMAIN IN PLACE AND NEW MARKINGS SHALL BE PLACED IN PROPER LOCATION. IN NO CASE SHALL NEW MARKING BE PLACED WITHIN 2 INCHES OF AN EXISTING JOINT.
