## EXCAVATING AND GRADING EXISTING SHOULDER

**Description.** This work shall be performed, measured and paid in accordance with Article 202 of the Standard Specifications except as modified herein:

**202.07 Method of Measurement.** Revise the 7<sup>th</sup> paragraph in (b) to read:  
Earthwork required for the construction of HMA, Concrete and Aggregate shoulders will be measured for payment in units of 100 ft (30 m) along each edge of pavement.
