A. THE FOLLOWING IS A DESCRIPTION OF THE PROJECT LOCATION:

THE PROJECT CONSISTS OF STRUCTURE REPLACEMENT OF THE STRUCTURE CARRYING IL ROUTE 158 OVER IL ROUTE 3. SOUTH OF COLUMBIA.

B. THE FOLLOWING IS A DESCRIPTION OF THE CONSTRUCTION ACTIVITY WHICH IS THE SUBJECT OF THIS PLAN:
