Addendum #1

SPECIAL PROVISIONS

1. Add the following to “**PLATED WOOD TRUSS SPECIFICATION**” on page 111 of the Special Provisions:

Note # 6. The truss fabricator’s structural engineer shall design the trusses for the ceiling dead loads, which shall include all mechanical equipment, and a concentrated live load of 300 lb placed anywhere above the ceiling. The truss fabricator’s structural engineer shall submit sealed calculations for the dead load and live load, which shall include both the magnitude and the distribution of loads to the trusses.

2. **Omit SECTION 03300 of the Special Provisions.**
3. **Omit Note #6 in Section 06101 of the Special Provisions.**
4. **Add the following Note to Section 06101 of the Special Provisions:**

Note #10. Refer to Structural Wood Specifications and Wood Deck Specifications on page 111 of the Special Provisions, and to structural plan sheets S2 through S9 for additional information. Information on the Structural Specifications and Plans shall take precedence over Architectural Specification Section 06101.

5. **Add the following Note to Section 06192 of the Special Provisions:**

Note #14. Refer to Plated Wood Truss Specification on page 111 of the Special Provisions and to Structural Plan sheets S3 through S6 for additional information.
