




### REMOVE AND REPLACE BITUMINOUS PAVEMENT NOTES

THE AREA(S) DESIGNATED AS WILL HAVE THE EXISTING BITUMINOUS PAVEMENT AND BASE COURSE REMOVED (FULL DEPTH) AND REPLACED WITH AGGREGATE BASE COURSE, BITUMINOUS BASE COURSE AND BITUMINOUS SURFACE COURSE, ALL REMOVED MATERIAL WILL BE LAWFULLY DISPOSED OF BY THE CONTRACTOR OFF THE AIRPORT SITE.

WHERE THE PROPOSED REMOVAL AND REPLACEMENT AREA ABUTS THE EXISTING PAVEMENT, THE PAVEMENT WILL BE SAWED PRIOR TO REMOVAL. THE SAWING WILL BE CONSIDERED AS AN INCIDENTAL ITEM TO THE PROPOSED PAVEMENT REMOVAL AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.

PRIOR TO PLACEMENT OF THE PROPOSED BITUMINOUS BASE COURSE, THE CRUSHED AGGREGATE SHALL BE SPRAYED WITH AN APPLICATION OF BITUMINOUS PRIME COAT AT A RATE OF 0.35 GALLONS PER SQUARE YARD. THE VERTICAL SIDES OF THE EXISTING BITUMINOUS PAVEMENT SHALL BE SPRAYED WITH AN APPLICATION OF BITUMINOUS TACK COAT. AN APPLICATION RATE OF 0.20 GALLONS PER SQUARE YARD WAS USED FOR CALCULATING THE QUANTITY OF TACK COAT FOR THIS APPLICATION. THE EXACT AMOUNT OF BITUMINOUS TACK COAT TO BE USED SHALL BE DETERMINED BY THE RESIDENT ENGINEER AT THE TIME OF CONSTRUCTION.

PRIOR TO PLACEMENT OF THE PROPOSED BITUMINOUS SURFACE COURSE. THE BITUMINOUS BASE COURSE AND THE VERTICAL SIDES OF THE EXISTING BITUMINOUS PAVEMENT SHALL BE SPRAYED WITH AN APPLICATION OF BITUMINOUS TACK COAT. AN APPLICATION RATE OF 0.20 GALLONS PER SQUARE YARD WAS USED FOR CALCULATING THE QUANTITY OF TACK COAT FOR THIS APPLICATION. THE EXACT AMOUNT OF BITUMINOUS TACK COAT TO BE USED SHALL BE DETERMINED BY THE RESIDENT ENGINEER AT THE TIME OF CONSTRUCTION.

ALL WORK RELATED TO THE BITUMINOUS JOINT SEALING WILL BE CONSIDERED AS AN INCIDENTAL ITEM TO THE PROPOSED PAVEMENT REPLACEMENT AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.

ANY ADJACENT PAVEMENT DAMAGED BY THE PAVEMENT REMOVAL OR REPLACEMENT OPERATIONS WILL BE REPAIRED AT THE CONTRACTOR'S OWN EXPENSE.
