The material of the end sections used must match the material of the pipe culvert it will be connected to.

CONCRETE COLLARS

Existing field tiles shall be located and connected with new storm sewers and concrete collars. The concrete collars are to be considered included in the cost of drainage structures and storm sewers and no additional compensation will be allowed.

VERTICAL ADJUSTMENT OF TRAFFIC BARRIER TERMINAL

The existing traffic barrier terminal type 1 special tangents that were installed in 2019 will be vertically adjusted after the shoulder paving on the project. This work will be in accordance with the District 5 Special Provision for Vertical Adjusted Guardrail except the method of measurement and basis of payment will be as follows.

Method of Measurement: The vertical adjustment of traffic barrier terminals will be measured for payment per EACH upon completion.

Basis of Payment: The work to vertical adjust traffic barrier terminals will be paid for at the contract unit price per EACH for VERTICAL ADJUSTMENT OF TRAFFIC BARRIER TERMINAL, which price shall include all labor, materials, tools, equipment and parts necessary for the work.
