REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES (PROJECT SPECIFIC)

Description. This work shall consist of the removal and disposal of regulated substances according to Section 669 of the Standard Specifications as revised below.

Contract Specific Sites. The excavated soil and groundwater within the areas listed below shall be managed as either “uncontaminated soil”, hazardous waste, special waste or non-special waste. For stationing, the lateral distance is measured from centerline and the farthest distance is the offset distance or construction limit, whichever is less.

Intersection of IL Route 47 and Walker Drive, Elburn, Kane County

- All excavation planned at the northeast quadrant at the intersection of IL Route 47 and Walker Drive. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and Ream Drive, Elburn, Kane County

- All excavation planned at the northeast quadrant, and southeast quadrant at the intersection of IL Route 47 and Ream Drive. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and IL Route 38 (Lincoln Highway), Elburn, Kane County

- All excavation planned at the southeast quadrant at the intersection of IL Route 47 and IL Route 38 (Lincoln Highway). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and Valley Drive, Elburn, Kane County

- All excavation planned at the northeast quadrant, and southeast quadrant at the intersection of IL Route 47 and Valley Drive. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and Elburn Community Center Entrance Drive, Elburn, Kane County

- All excavation planned at the northeast quadrant, and southeast quadrant at the intersection of IL Route 47 and Elburn Community Center Entrance Drive. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and Reader Street, Elburn, Kane County

- All excavation planned at the northwest quadrant, and southwest quadrant at the intersection of IL Route 47 and Reader Street. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of IL Route 47 and Railroad Street, Elburn, Kane County

- All excavation planned at the northwest quadrant, and southwest quadrant at the intersection of IL Route 47 and Railroad Street. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(5). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Work Zones

Three distinct OSHA HAZWOPER work zones (exclusion, decontamination, and support) shall apply to projects adjacent to or within sites with documented leaking underground storage tank (LUST) incidents, or sites under management in accordance with the requirements of the Site Remediation Program (SRP), Resource Conservation and Recovery Act (RCRA), or Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), or as deemed necessary. For this project, the work zones apply for the following ISGS PESA Sites:
None
