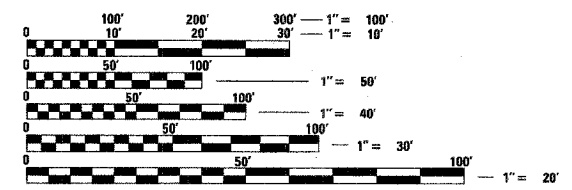
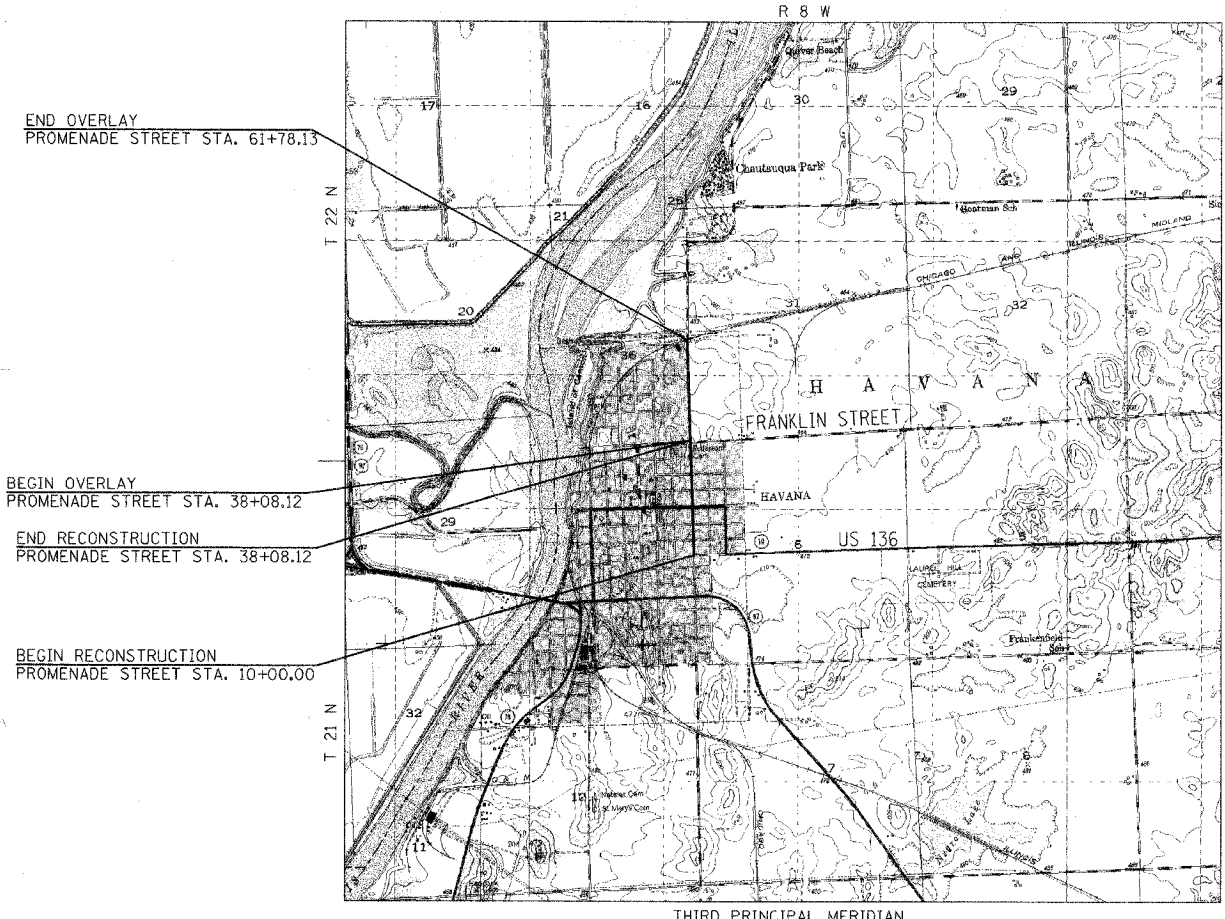
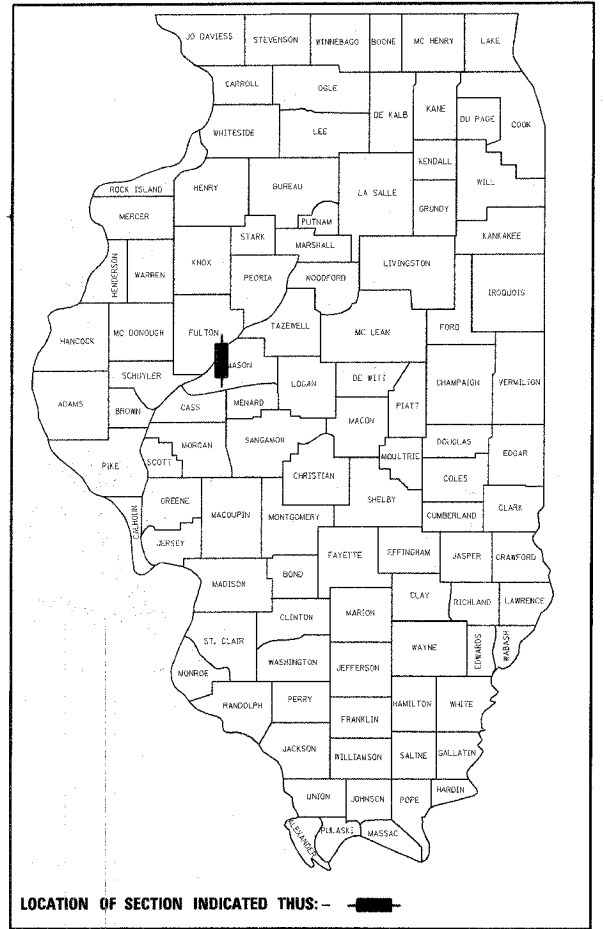

13. COSTS ASSOCIATED WITH EARTH EXCAVATION FOR THE WORK PERFORMED IN THIS CONTRACT SHALL BE INCLUDED IN THE COST OF THE WORK BEING PERFORMED. IT IS ESTIMATED THE TOTAL VOLUME OF EARTH EXCAVATION TO LESS THAN 100 CUBIC YARDS.
14. THE POSSIBILITY EXISTS THERE MAY BE ARCHAEOLOGICAL ARTIFACTS WITHIN THE PROJECT LIMITS. THE CONTRACTOR SHALL CONTACT DAVID J. 2. THE CONTRACTOR SHALL FIELD VERIFY THE EXACT LENGTH AND QUANTITY REQUIRED FOR STORM SEWERS, CATCH BASINS, PIPE CULVERTS, AND MANHOLES.
3. THE COST OF CONNECTING EXISTING STORM SEWER TO NEW DRAINAGE STRUCTURES SHALL BE INCLUDED IN THE COST OF THE NEW DRAINAGE STRUCTURE.

1. THE WATER MAIN WITH APPURTENANCES SHALL BE FURNISHED AND INSTALLED IN ACCORDANCE WITH DIVISION IV THE "STANDARD SPECIFICATIONS FOR WATER AND SEWER MAIN CONSTRUCTION IN ILLINOIS, FIFTH EDITION" DATED MAY 1996; HOWEVER IDOT PAY ITEMS HAVE BEEN USED TO DESCRIBE THE WORK.
2. THE CITY OF HAVANA SHALL PROVIDE FIRE HYDRANTS AND METER BOXES TO BE USED ON THIS PROJECT. THE CONTRACTOR SHALL CONTACT DON HENDERSON @ 309-548-1108 TO ARRANGE FOR DELIVERY.
3. WATER MAINS SHALL BE AMERICAN WATER WORKS ASSOCIATION (AWWA) C900 PVC PRESSURE CLASS 100 OR AWWA C905 PVC PRESSURE CLASS 160 WITH PUSH-ON OR RESTRAINED JOINTS. WATER SERVICE LINES SHALL BE AWWA C901 POLYETHYLENE PRESSURE PIPE OR TUBING, PRESSURE CLASS 200.
4. MINIMUM COVER OVER WATER MAINS SHALL BE 48".
5. HYDROSTATIC TESTING SHALL BE PERFORMED ACCORDING TO SECTION 7 OF AWWA C605 BASED ON A WORKING PRESSURE OF 62 PSI.
6. THE CONTRACTOR SHALL CONTACT AMEREN CIPS 10 WORKING DAYS PRIOR TO PERFORMING ANY EXCAVATION WORK FOR WATER LINE CONSTRUCTION FOR THE PURPOSE OF DETERMINING ANY POLE STABILIZATION REQUIREMENTS. THE CONTACT PERSON IS GARRY JOHNSON, P.E. AND CAN BE CONTACTED AT 217-414-7882.
7. BEDDING, HAUNCHING, AND INITIAL BACKFILL SHALL BE CA-11, CA-13, CA-16, FA-5, FA-6, OR FA-10. INITIAL BEDDING, HAUNCHING AND INITIAL BACKFILL SHALL BE INCLUDE IN THE COST OF WATER LINE OR WATER SERVICE LINE.

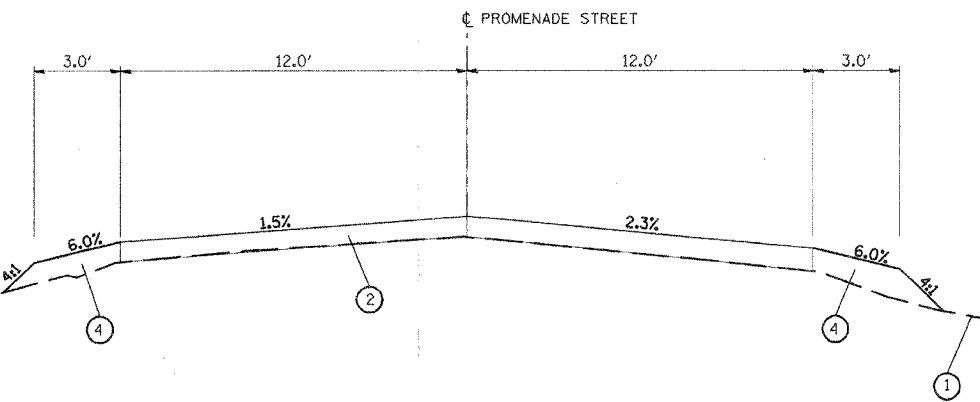

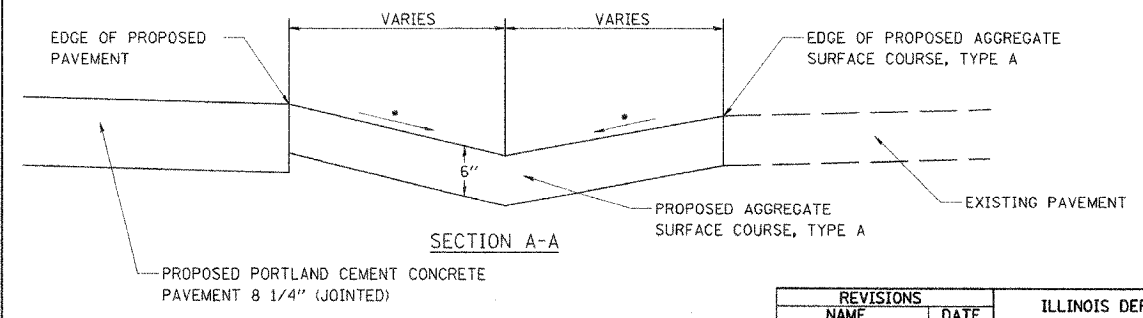
