SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction, Adopted January 1, 2012 (Revised January 1, 2014)", the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the "Supplemental Specifications and Recurring Special Provisions" indicated on the Check Sheet included herein, which apply to and govern the construction of Various Routes, Section D4 OVD SIN STR REP: 14-47 in Peoria, Tazewell and Knox Counties, **Contract No. 46314**, and in case of conflict with any part, or parts, of said Specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF PROJECT

This project is located on various routes in Peoria, Tazewell and Knox Counties throughout Region Three/District Four.

DESCRIPTION OF PROJECT

This project consists of Overhead Sign Structure Replacement 2014-14 for Contract 46314 in District Four.

The work shall consist of removing and replacing damaged or deteriorated overhead sign structure components at the locations described in the schedule of locations. Additional items of work not covered by the standard pay items shall be authorized by the Engineer as extra work as provided for by Article 104.02 of the Standard Specifications for Road and Bridge Construction. Extra work shall be paid for in accordance with Article 109.04 of the Standard Specifications for Road and Bridge Construction.

This work shall include all labor, material, and equipment necessary for proper execution and completion of the work as shown on the plans as herein specified. It shall include all work not specifically included in the contract documents which is reasonably and properly inferable and necessary for proper completion of the improvement. Work to be completed under this contract is located in Peoria, Tazewell and Knox Counties.

The Contractor shall notify the Resident Engineer at least 10 working days before beginning any work in the field and shall obtain permission to begin such work.

COMPLETION DATE

All work on this contract shall be completed on or before **October 31, 2015**. Should the Contractor fail to complete all work by **October 31, 2015**, the Contractor shall be liable in accordance with Article 108.09 of the Standard Specifications.
