

GENERAL NOTES

THIS DT SAFETY SIGNAGE PROJECT IS LOCATED THROUGHOUT THE ENTIRE DISTRICT 7, REGION 4. THE WORK INCLUDED IN THIS SECTION CONSISTS OF INSTALLING SIGNING ENHANCEMENTS AT VARIOUS STATE AND COUNTY LOCATIONS AND ALL OTHER WORK NECESSARY TO COMPLETE THIS SECTION.

ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE TO BE GIVEN TO UTILITIES BEFORE DIGGING. FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING J.U.L.I.E. (PH. 800-892-0123) OR FOR A NON-MEMBER, THE UTILITY COMPANY DIRECTLY. ILLINOIS DEPARTMENT OF TRANSPORTATION IS NOT A MEMBER OF THE JOINT UTILITY LOCATING INFORMATION FOR EXCAVATORS (J.U.L.I.E.) SYSTEM AND MUST BE CONTACTED DIRECTLY.

ALL PROPOSED SIGNS MUST BE FIELD VERIFIED AND ADJUSTED AS NEEDED BY THE ENGINEER TO PROVIDE CLEAR VISIBILITY OF THE SIGN AS WELL AS ADEQUATE SIGHT DISTANCE FOR VEHICLES.

THE QUANTITY OF TELESCOPING STEEL SIGN SUPPORT SHOWN FOR EACH LOCATION IS AN ESTIMATE OF THE QUANTITY NEEDED. ACTUAL POST LENGTHS WILL NEED TO BE DETERMINED IN THE FIELD BASED ON THE FINAL LOCATION OF EACH SIGN, AS DETERMINED BY THE ENGINEER.

EXISTING SIGN PANELS ENCOUNTERED THAT ARE NOT SHOWN IN THE PLANS SHALL BE RELOCATED TO THE PROPOSED SIGN SUPPORT AND MOUNTED IN A SIMILAR ORIENTATION AS DETERMINED BY THE ENGINEER.

IN NO CASE SHALL THE TIME BETWEEN THE REMOVAL OF AN EXISTING SIGN PANEL AND THE PLACEMENT OF THE NEW SIGN PANEL BE IN EXCESS OF FOUR HOURS, UNLESS AUTHORIZED IN WRITING BY THE ENGINEER.

ALL EXISTING SIGN PANELS THAT ARE REMOVED AND ARE NOT TO BE RELOCATED SHALL BECOME THE PROPERTY OF THE CONTRACTOR.
