IDOT PROJECT LABOR AGREEMENT DETERMINATION

{Letting: June 14, 2024 Completion Date: October 31, 2026 plus 5 working days}

In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

- 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).
- 2) The Project is being constructed using state or local funds only (i.e., no federal funds).
- 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances. See attachment A below.
- 4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.
- 5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption.
- 6) The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project.
- 7) In the absence of a PLA, there is an increased likelihood of jurisdictional disputes among unions or of conflict between unionized and non-unionized workers on the Project that could have a potentially material adverse effect on the time, cost, or quality of work performed on the Project.

Upon your approval, the Department shall undertake to negotiate in good faith a PLA with the relevant labor organization(s) and shall include in all necessary bid specifications and other documents information regarding the actual or form of PLA that is to binding upon all contractors and their employees.

The use of Project Labor Agreement (PLA) for Contract 62N32 is consistent with all State and Local statutory and regulatory requirements.

Item 3: This project includes both State and Federal funding and the programmed cost for this project is estimated at \$8,103,000. The scope of work consists of implementation of several ITS elements to improve local and regional mobility by addressing arterial congestion and improving transit mode share along IL 56/Butterfield Road /22nd Street from IL to York Rd. The ITS elements include traffic signal modernization, signal timing/progress, changeable message signs, signing (new), traffic surveillance, ADA, and bus pad improvements.

The project is located in the City of Wheaton, City of Warrenville, Village of Downers Grove, Village of Oak Brook, Village of Lombard, and Village of Oakbrook Terrace, in DuPage County, Illinois.
