



MARKING NOTES

ALL TAXIWAY MARKINGS SHALL BE SOLID AND YELLOW IN COLOR. ALL RUNWAY MARKINGS SHALL BE SOLID AND WHITE IN COLOR.

ALL TAXIWAY CENTERLINE MARKINGS SHALL BE 6" IN WIDTH. ALL RUNWAY CENTERLINE MARKINGS SHALL BE 32" IN WIDTH. ALL MARKINGS SHALL BE AS DETAILED.

ALL MARKINGS SHALL CONSIST OF TWO APPLICATIONS OF WATERBORNE PAINT AND ONE APPLICATION OF TYPE B GLASS BEADS (REFLECTIVE MEDIA). THE REFLECTIVE MEDIA WILL BE APPLIED IN THE SECOND APPLICATION OF PAINT. PAINT SHALL BE APPLIED AT THE RATE OF 115 SQ. FT./GAL. MAXIMUM PER APPLICATION. GLASS BEADS SHALL BE APPLIED AT THE RATE OF 7 LBS./GAL. OF PAINT MINIMUM.

"CUT-OFF" SHEETS SHALL BE USED TO INSURE STRAIGHT EDGES.
