4.	NO SUBCONTRACTORS MAY BE UTILIZED WITHOUT APPROVAL FROM THE DEPARTMENT.
5.	WHEN THE DEPARTMENT AUTHORIZES THE USE OF A SUBCONTRACTOR IN THE EXECUTION OF A WORK ORDER, THE DEPARTMENT WILL PAY THE CONTRACTOR THE ACTUAL AMOUNT OF THE SUBCONTRACTOR INVOICE PLUS A FIVE PERCENT MAXIMUM MARK UP FOR PROCESSING.
6.	THE CONTRACTOR SHALL RECEIVE THE ACTUAL COST FOR PARTS AND MATERIALS SUPPLIED (INCLUDING TRANSPORTATION CHARGES PAID BY THE CONTRACTOR) TO WHICH COST A MAXIMUM OF 15 PERCENT WILL BE ADDED.
7.	ALL OTHER INCIDENTAL EQUIPMENT AND TOOLS SHALL BE PROVIDED BY CONTRACTOR AT PRICES ESTABLISHED IN THE EQUIPMENT WATCH RENTAL RATE BLUE BOOK WHICH CAN BE OBTAINED AT HTTP://WWW.EQUIPMENTWATCH.COM.
