SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAU Route 1320 (IL 58); Section 581 EXT-BR; Cook County; Contract 60B82, and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF IMPROVEMENT

The improvement begins on a point on the centerline of IL 58 (Golf Road), approximately 480 feet east of IL 59 (Sutton Road) and extends westerly a distance of 1,031 feet, including the structure over Poplar Creek. The improvement also includes resurfacing of 946 feet of IL 59 (Sutton Road) within unincorporated Hanover Township in Cook County.

DESCRIPTION OF IMPROVEMENT

This is a bridge beam replacement, deck replacement and intersection resurfacing improvement and the work to be performed under this contract consists of bridge beam removal and replacement, bridge deck replacement, bridge approach pavement replacement, hot mix asphalt surface removal, combination concrete curb and gutter removal and replacement, pavement patching, detector loop replacement, hot mix asphalt leveling binder and surface course resurfacing, placement of thermoplastic pavement markings and all other incidental and collateral work necessary to complete the improvement as shown on the plans and as described herein.
