The roof hatch is existing in the North tower. Only that work marked "NIC" is not included. All other work is required.

The foundation for the walkway slab is shown as being required for Section 06-00026-01-MS (Welcome Center).

The walkway leading to the towers is included in Section 03-00026-00-PK (Restrooms).

According to Section 01501, Part A, paragraph 1.3, sub-paragraph B of the Special Provisions, temporary electricity is the responsibility of the contractor.

Earth Excavation is specific for each phase of work and presumes that Section 03-00026-00-PK is performed prior to Section 06-00026-01-MS. Any other sequence will cause a revision of the plans and quantities for both sections.
