TWO WEEK NOTIFICATION PRIOR TO STARING WORK

Revise the first sentence of Article 107.09 Public Convenience and Safety to the following "The Contractor shall notify the Engineer at least 14 days in advance of starting any construction work."

This additional notification is required so that the public can be notified of the pending construction.

KEEPING ROADS OPEN TO TRAFFIC

It is the intention of the Department to limit the amount of time that lane closures are in place. Therefore, FAP Rte. 132 (IL 34/145) shall be kept open to two lanes of traffic prior to the Contractor receiving all materials needed to perform all staged work..

The closure of Willow Grove Road shall be limited to a maximum of 4 weeks during stage 1 construction of S.N. 083-0019.

While performing construction operations, the Contractor shall work only on one side of the pavement at a time and shall keep all equipment, materials, and vehicles off the pavement and shoulder on the side of the pavement that is open to traffic.
