EARTH EXCAVATION

This item shall consist of furnishing and undertaking **Earth Excavation** as shown on the plans, according to Section 201 of the "Standard Specifications for Road and Bridge Construction", except as modified herein:

In the process of Earth Excavation and activities including removal of organic material, all materials may remain on site, consistent with permission of the adjacent property as indicated on plans. Additionally, haul may be deposited, with the direction of the property owner, on the property adjacent to the right-of-way west of the Terminal Railroad property and east of the levee.

Grading is to include removal of topsoil to adjacent stockpiles, for re-use upon final grading and establishment turf from seed, fertilizer, and mulch. Cross sections have been surveyed to top of grade and shrinkage factor is to account for loses of topsoil during EARTH EXCAVATION.

This work will be paid for at the contract unit price per CUBIC YARD for EARTH EXCAVATION, and shall include other items of work included under the general heading of Earthwork for which no payment item is included in the contract.

GRANULAR EMBANKMENT SPECIAL

This item shall consist of furnishing, transporting and placing a course of **GRANULAR EMBANKMENT SPECIAL** as shown on the plans, according to Section 206 of the "Standard Specifications for Road and Bridge Construction", except as modified herein: as shown on the plans.

The material is to conform to a CA2 GRADATION per section 1004.01 of the "Standard Specifications for Road and Bridge Construction".

This work will be paid for at the contract unit price per TON for **GRANULAR EMBANKMENT SPECIAL**.

SUBBASE GRANULAR MATERIAL (SPECIAL)

This item shall consist of furnishing, transporting and placing a course of **SUBBASE GRANULAR MATERIAL (SPECIAL)** shown on the plans, according to Section 311 of the "Standard Specifications for Road and Bridge Construction", except as modified herein:

The material is to conform to a CA6 GRADATION per section 1004.01 of the "Standard Specifications for Road and Bridge Construction".

This work will be paid for at the contract unit price per CU YD for **SUBBASE GRANULAR MATERIAL (SPECIAL)**
