THE CONTRACTOR IS REMINDED THAT JULIE MLGT BE CONTACTED TO LOCATE ANY AND ALL UTILITIES WITHIN THE PROJECT LIMITS. - 2. THE CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND CONDITIONS IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING MATERIALS.
- 3. PROPER ADHESIVE (P-50) SHALL BE APPLIED TO THE GROOVED SURFACE PRIOR TO THE INSTALLATION OF THE PAVEMENT MARKING TAPE.

IN THIS CASE, EXISTING MARKINGS SHALL REMAIN IN PLACE AND NEW MARKINGS SHALL BE PLACED IN PROPER LOCATION. IN NO CASE SHALL NEW MARKING BE PLACED WITHIN 2 INCHES OF AN EXISTING JOINT.
