2. The contractor shall furnish the posts and erect the signs at the location directed by the engineer. All signs shall be post mounted.
3. The noted work, including signs, posts, hardware, and labor shall be included in the contract unit price, each, for Traffic Control and Protection, Std. 701321, no other compensation will be allowed.
4. The width shown on the W12-1103 sign shall be 18" less than what is shown in the staged lane widths or as directed by the Engineer.
5. The "X" MILES AHEAD will be determined by the engineer.

 Rail splice inserts may be built out of 2 - 3/8" bent plates in lieu of the 4 plate rail splice inserts shown, provided the outside dimensions are matched.
 All round head bolts shall be ASTM A449.
 The centerline of rail splices shall be placed between 1'-8" to 2'-6" from the centerline of the posts.
 The free end of the splice tube shall be oriented away from the closest post.

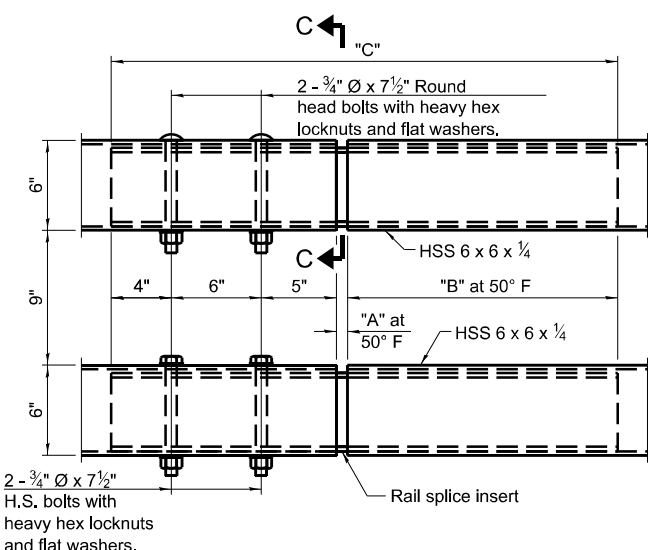


ROUND HEAD BOLT DETAIL

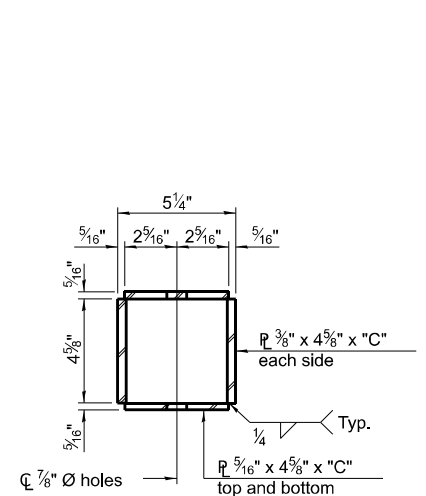

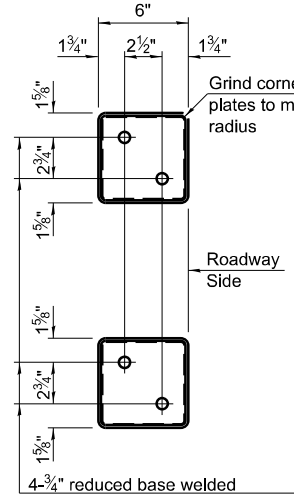

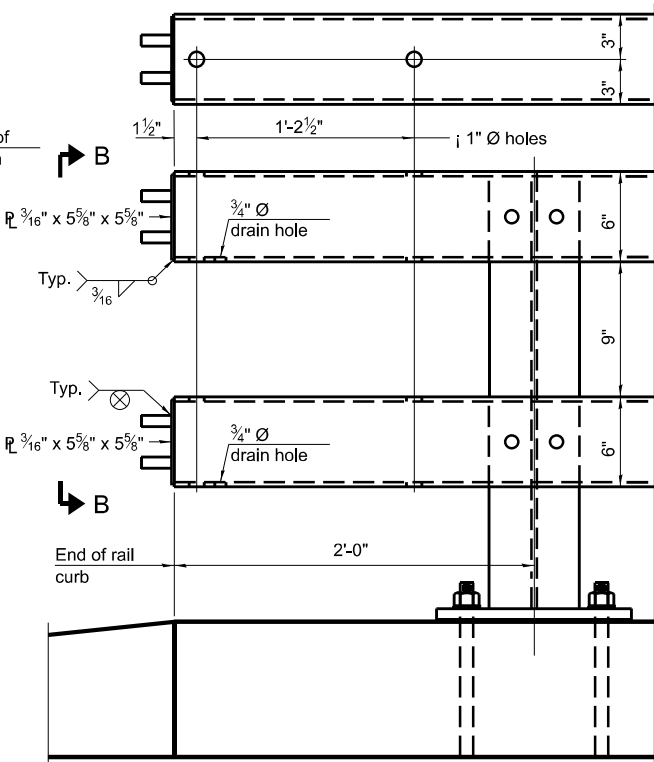
TOP AND BOTTOM RAIL SPLICE ELEVATION



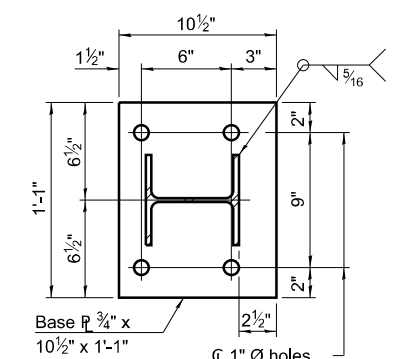

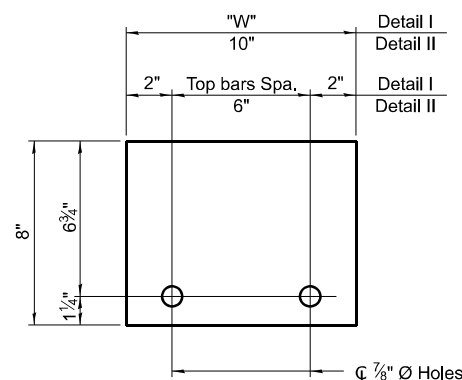
Detail III - Installation for a new deck beam with no initial wearing surface or with an initial hot-mix asphalt (HMA) wearing surface present. The deck beam directly beneath the temporary concrete barrier shall be fabricated with bar splicer inserts in the side of the beam, as detailed, to accommodate the installation of the retainer assemblies. A pair of bar splicers, 6" apart, shall be placed at 6'-0" centers along the length of the beam. The cost of the bar splicers is included with the deck beam.

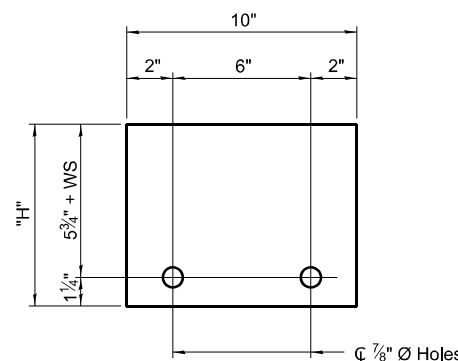

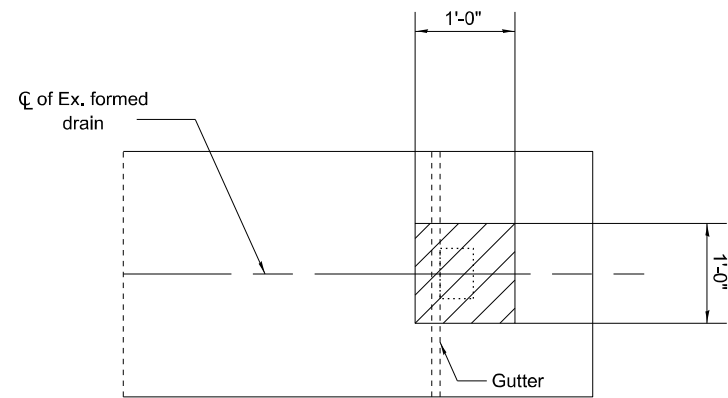

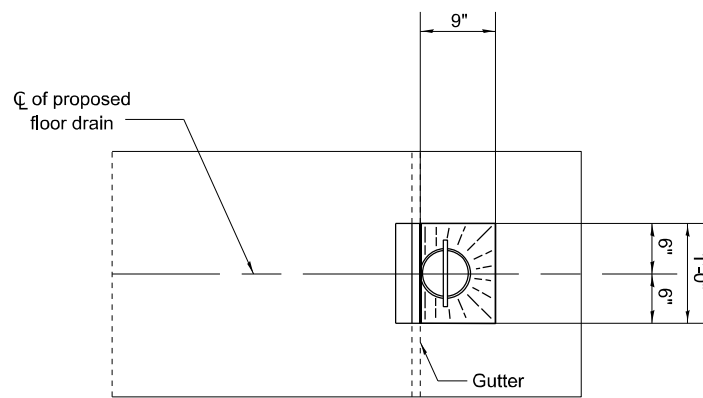

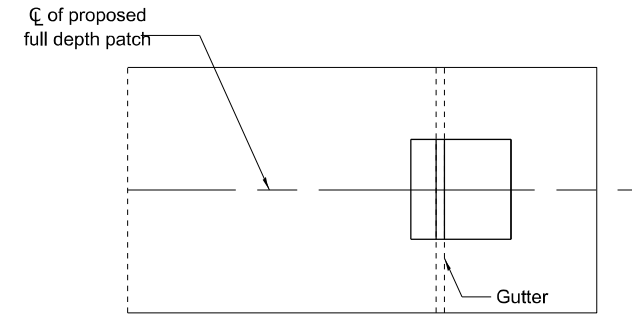


PLAN-REMOVAL OF EXISTING FORMED OPENING AND ADJACENT CONCRETE

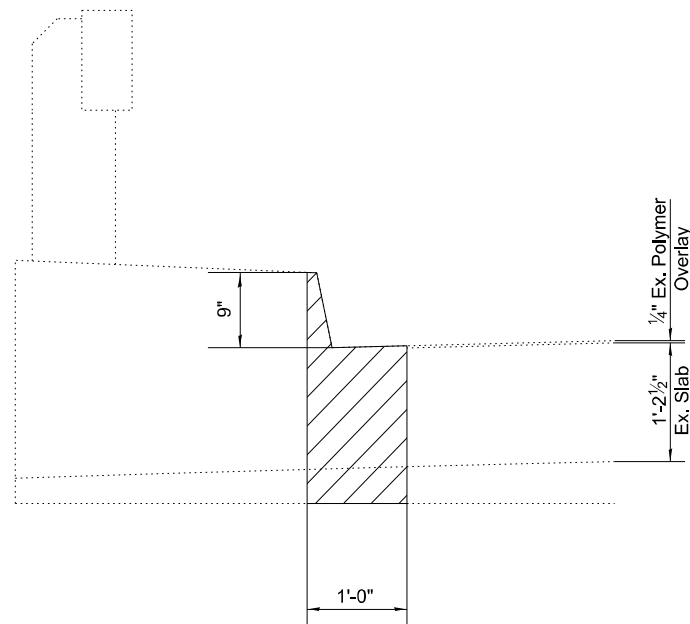


PLAN-PROPOSED FLOOR DRAIN & FULL DEPTH PATCH

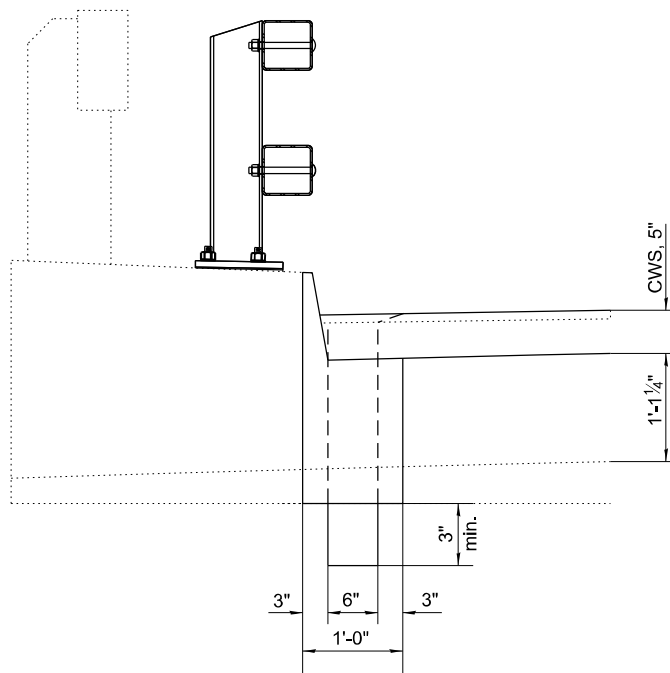

PLAN-PROPOSED FULL DEPTH PATCH @ ELIMINATED FLOOR DRAINS

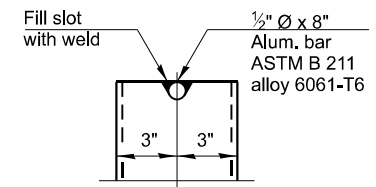


SECTION-REMOVAL OF EXISTING FORMED OPENING AND ADJACENT CONCRETE

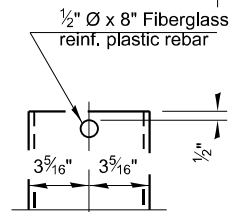


SECTION-PROPOSED FLOOR DRAIN & FULL DEPTH PATCH

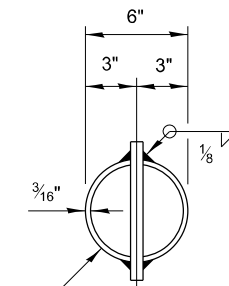
