





THE COLOR OF THE FINAL FINISH COAT FOR ALL INTERIOR STEEL SURFACES SHALL BE GRAY, MUNSELL NO 5B 7/1. THE COLOR OF THE FINAL FINISH COAT FOR EXTERIOR AND BOTTOM FLANGE OF THE FASCIA BEAMS SHALL BE REDDISH BROWN, MUNSELL NO 2.5YR 3/4,

FASCIA BEAM PAINTING DETAIL **FIGURE 1** 




#### GENERAL NOTES Class X concrete shall be used throughout Coorse aggregate to be used in parapet handrails and end posts must be free of chert flint limonite, lignite and soft sandslone. The concrete floor slob shall be finished in accordance with Article 51.19 of the Standard Specifications. Slope wall shall be reinf: reed with welded wire fabric G'x G' mesh #4 wires, weighing 58 # per 100 sg ff All rainforcement bars shall be lapped 20 diameters unless other was shewn. Rivets 7.4, Open holes 1516.4, unless noted All balaters, rackers, bearing plates, lead plates, pintes and anchar balts shall be fabricated and set in accordance with Article 5/15 of the Standard Specifications and are included in quantity of Structural Steel. Anchor bolts shall be set before riveting diaphragms over supports. Ril Structural Steel shall conform to the RSTU Designation A-36. Except as otherwise provided, all structural steel shall receive one shop coat of red lead paint and two field coats of aluminum paint. See Articles 56.1 to 56.5 Inclusive of the Standard Specifications. The Contractor shall drive one concrete test pile in a permanent location at the South Abutm , as directed by the Engineer, before ordering remainder of piles. Holes shall be precored for piles under South and North Abutments. See Articles 629(c) of the Standard Specifications. Expansion guarois are included in quantity of Structural Stee/. The exposed surfaces of the expansion guard shall be given two shop coats of rzd lead paint, the contact surfaces shall be given one coat of red lead paint. Inchor studs shall not be painted. Excavation for portions of structures in the embankment shall not be classified. Permanent forms will not be permitted in forming the concrete floor.




