


General Notes:

These Special Conditions supplement the plans and specifications. Where they are in conflict with the plans and specifications they shall govern.

1. REFERENCED SPECIFICATIONS

THE FOLLOWING SPECIFICATIONS ARE INCLUDED BY REFERENCE. ALL CONSTRUCTION SHALL BE IN ACCORDANCE WITH THE APPLICABLE SECTIONS EXCEPT AS MODIFIED HEREIN OR ON THE PLANS OR IN THE SPECIFICATIONS BOUND SEPARATELY:

- ILLINOIS DEPARTMENT OF TRANSPORTATION STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, LATEST EDITION.
- CITY OF GENOA MUNICIPAL CODE.
- ILLINOIS DEPARTMENT OF TRANSPORTATION MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES.
- ILLINOIS URBAN MANUAL STANDARDS FOR URBAN SOIL EROSION AND SEDIMENTATION CONTROL.

2. NOTIFICATION

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO NOTIFY THE FOLLOWING:

- IDOT DISTRICT 3, 48 HOURS PRIOR TO COMMENCEMENT OF CONSTRUCTION.

- THE CITY OF GENOA 48 HOURS PRIOR TO COMMENCEMENT OF CONSTRUCTION.
 THE ELECTRIC, TELEPHONE AND GAS UTILITIES PRIOR TO COMMENCEMENT, OF CONSTRUCTION.

3. PERMITS

- NO CITY OF SENOA PERMITS ARE REQUIRED.

4. QUANTITIES
THE CONTRACTOR IS RESPONSIBLE FOR VERIFYING ALL QUANTITIES AS INDICATED
ON THE PLANS. THE QUANTITIES WHICH ARE INDICATED ARE FOR RIDDING
PURPOSES ONLY AND MUST BE VERIFIED. ANY DISCREPANCIES ARE TO BE
REPORTED TO THE FINGINEER.

5. EXAMINATION OF THE SITE
THE CONTRACTOR IS RESPONSIBLE FOR EXAMINING ALL SITE CONDITIONS PRIOR
TO COMMENCEMENT OF CONSTRUCTION AND IS TO COMPARE THE SITE
CONDITIONS AS INDICATED ON THE ENGINEERING PLANS.

THE PROPOSED IMPROVEMENTS MUST BE CONSTRUCTED IN ACCORDANCE WITH THE ENGINEERING PLANS. THE CONSTRUCTION DETAILS, AS PRESENTED ON THE PLANS, MUST BE FOLLOWED BY THE CONTRACTOR. PROPER CONSTRUCTION TECHNIQUES MUST BE FOLLOWED ON THOSE IMPROVEMENTS INDICATED ON THE ENGINEERING PLANS.

7. LOCATION OF EXISTING UNDERGROUND UTILITIES

THE LOCATION OF VARIOUS EXISTING UNDERGROUND LITILITIES WHICH ARE SHOWN ON THE PLANS ARE FOR INFORMATION ONLY AND REPRESENT THE BEST KNOWLEGGE OF THE ENGINEER. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY THEIR LOCATIONS AND ELEVATIONS PRIOR TO THE CONSTRUCTION OPERATIONS.

8. DAMAGE TO PROPERTY

ANY EXISTING PAVEMENT, SIDEWALK, DRIVEWAYS, ETC. DAMAGED BY THE CONTRACTOR'S OPERATIONS AND NOT CALLED FOR IN THE CONTRACT TO BE REMOVED SHALL BE REPLACED AT THE EXPENSE OF THE CONTRACTOR.

9. CONTRACTOR TO VERIFY ELEVATIONS

THE CONTRACTOR SHALL VERIFY ALL ELEVATIONS PRIOR TO THE START OF WORK AND, IF THERE ARE ANY DISCREPANCIES, IS TO NOTIFY THE ENGINEER AT ONCE. NO WORK SHALL BE DONE UNTIL THE DISCREPANCY IS RESOLVED.
