- WHEREVER IN THE PLANS AND SPECIFICATIONS THE TERM "STANDARD SPECIFICATION" IS USED IT SHALL BE UNDERSTOOD BY THE CONTRACTOR TO MEAN THE "STANDARD SPECIFICATION FOR ROAD AND BRIDGE CONSTRUCTION" AS PREPARED BY THE DEPARTMENT OF TRANSPORTATION OF THE STATE OF ILLINOIS AND ADOPTED ON JANUARY 1, 2012.
- 2. ANY REFERENCE TO STANDARDS THROUGHOUT THE PLANS SHALL BE INTERPRETED TO BE THE LATEST STANDARDS OF THE DEPARTMENT OF TRANSPORTATION WITH THE REVISION NUMBER AS SHOWN ON SHEET NO. 3 OF THE PLANS.
- 3. IT IS THE CONTRACTOR'S RESPONSIBILITY TO ASCERTAIN EXISTING FIELD CONDITIONS BEFORE BIDDING ON THE PROJECT.
- 4. THE CONTRACTOR WILL BE REQUIRED TO COMPLY WITH STATE AND LOCAL REGULATIONS REGARDING AIR, WATER AND NOISE POLLUTION.
- 5. THE CONTRACTOR SHALL TAKE CARE NOT TO STORE OR DISPOSE OF DEBRIS AND UNSUITABLE MATERIALS WITHIN LIMITS OF THE IMPROVEMENT AND TAKE CARE TO LIMIT CONSTRUCTION TO WITHIN THE RIGHT-OF-WAY AND EASEMENT AREAS. UNNECESSARY ENCROACHMENTS INTO PRIVATE OR PUBLIC AREAS WILL NOT BE ALLOWED.
- 6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR CLEANUP OF THE SITE PRIOR TO FINAL ACCEPTANCE IN ACCORDANCE WITH ARTICLE 104.06 OF THE STANDARD SPECIFICATIONS.
- 7. THE CONTRACTOR SHALL BE RESPONSIBLE FOR PROTECTING UTILITY PROPERTY FROM CONSTRUCTION OPERATIONS AS OUTLINED IN ARTICLE 107.31 OF THE STANDARD SPECIFICATIONS. THE J.U.L.LE NUMBER IS 800-892-0123. A MINIMUM OF 48 HOURS ADVANCE NOTICE IS REQUIRED.
- 8. THE CITY OF URBANA SHALL BE RESPONSIBLE FOR NOTIFYING THE PUBLIC, THE UNITED STATES POSTAL SERVICE, AND THE EMERGENCY SERVICE AGENCIES OF ALL ROAD CLOSURES AND CHANGES IN THE TRAFFIC MAINTENANCE PLANS. THE CONTRACTOR SHALL NOTIFY THE CITY OF URBANA OF ALL ROAD CLOSURES AND CHANGES IN THE TRAFFIC MAINTENANCE PLANS A MINIMUM OF 48 HOURS IN ADVANCE.
- 9. PROPOSED BICYCLE ROUTE AND LANE SIGNAGE MAY BE SHOWN ON VARIOUS PLAN SHEETS. THE SIGNAGE IS SHOWN FOR INFORMATION ONLY AND FURNISHING AND ERECTING PROPOSED SIGNAGE IS NOT PART OF THE SCOPE OF WORK FOR THIS PROJECT.
- 10. THE EXISTING PAVEMENT MARKINGS FOR CROSS WALKS AND STOP BARS SHALL REMAIN IN PLACE.
