TRAFFIC BARRIER TERMINAL, TYPE 6 (SPECIAL)

This work shall be done in accordance with Section 631 of the Standard Specifications except for the following. The terminal shall be provided with a 17' radius and the posts along the approach slab shall be 9' long. The Contractor shall field check the radius prior to ordering materials.

Basis of Payment: This work will be paid for at the contract unit price per each for TRAFFIC BARRIER TERMINAL, TYPE 6 (SPECIAL).

TRAFFIC CONTROL PLAN

Traffic control shall be in accordance with the applicable sections of the "Standard Specifications for Road and Bridge Construction", the applicable guidelines contained in the "National Manual on Uniform Traffic Control Devices for Streets and Highways", Illinois Supplement to the National Manual of Uniform Traffic Control Devices, these Special Provisions, and any special details and Highway Standards contained herein and in the plans.

Special attention is called to Articles 107.09 and 107.14 of the "Standard Specifications for Road and Bridge Construction" and the following Highway Standards relating to traffic control:

TRAFFIC CONTROL AND PROTECTION, STANDARD 701321 (SPECIAL)

This work shall be done in accordance with the applicable portions of Section 700 of the Standard Specifications and Highway Standard 701321. Standard 701321 shall be modified to fit the existing site conditions as shown on the plans. Additional signals to maintain access to entrances shall be required as well as additional signs. The Engineer shall determine the exact layout required for the stage construction. Additional barricades, temporary concrete barrier, portable traffic signals, and signs may be required in addition to those shown in the plans. Temporary rumble strips shall not be used due to the residential area.
