## **CONSTRUCTION LAYOUT**

**General:** The Village shall furnish or shall employ a Professional Land Surveyor to furnish and place construction layout stakes for this project providing adequate reference points to construct the work as shown in the Plans. The Village shall maintain all layout data and field notes. Stakes for line and grade will be set at sufficient station intervals to assure substantial conformance to plan line and grade.

The Village shall provide field forces, equipment, and material to set additional stakes for this project, which are needed to establish offset stakes, reference points, and any other horizontal or vertical controls, including supplementary bench marks, necessary to secure a correct layout of the work.

The Contractor shall be responsible for having the finished work conform to the lines, grades, elevations, and dimensions called for in the Plans. Inspection or checking of the layout shall be performed by the Contractor to secure the proper dimensions, grades and elevations of the work. The Contractor shall exercise care in the preservation of stakes and benchmarks. Contractor is responsible for re-staking due to damaged or lost stakes. No additional compensation will be provided for re-staking or for staking beyond that provided by the Village.

**Basis of Payment:** This work will be considered incidental to the contract and no compensation will be allowed.
