



THIS PROJECT IS LOCATED ON VARIOUS ROUTES IN FAYETTE, EFFINGHAM, JASPER, CRAWFORD, CLAY, RICHLAND, LAWRENCE, WAYNE, EDWARDS AND WABASH COUNTIES, ALL LOCATED WITHIN REGION 4-DISTRICT 7. THE WORK INCLUDED IN THIS SECTION CONSISTS OF MAINTAINING AND REPAIRING THE ELECTRICAL HIGHWAY LIGHTING, ELECTRICAL HIGHWAY WARNING SYSTEMS, INTELLIGENT TRANSPORTATION SYSTEM DEVICES, FIBER OPTIC CABLE, AND ALL OTHER WORK NECESSARY TO COMPLETE THIS SECTION.

ALL WORK IS TO BE REPLACED IN KIND OR, AS INDICATED ON THE CONTRACT PLANS OR PROVISIONS.




- 1. SYSTEM CONSISTS OF TWO W6 X 15 I-BEAM SIGNPOSTS WITH CONCRETE FOUNDATION AND A FLANGE WITH BREAKAWAY BOLTS
- 2. THE I-BEAMS ARE 12' LONG AND DRILLED AS PER THE I-BEAM DETAIL TO ACCOMODATE A PIPE TO ALLOW THE MOUNTING OF THE SOLAR
- 3. THE WEB OF THE I-BEAM IS TO BE PLACED PARALLEL TO THE LANES.
- 4. THE TWO POSTS MUST BE PLACED DIRECTLY ACROSS FROM EACH OTHER AND PERPENDICULAR TO THE LANES.
- 5. TWO POSTS ARE REQUIRED LOCATED AS PER THE ENGINEER AND DRAWING.
- 6. THE CABINETS ARE ATTACHED TO THE I-BEAM USING 8" GALVANIZED J-BOLTS.
- 7. THE BOTTOM OF THE CABINET HEIGHT MUST BE NO LOWER THAN 4' ABOVE THE GROUND AND BE ABLE TO VIEW ACROSS ALL LANES AT THE CROWN OF THE PAVEMENT.
- 8. THE IDOT OFFICE OF PLANNING AND PROGRAMMING DATA MANAGEMENT LAB RICH MARX (217-782-2065) MUST BE CONTACTED TWO WEEKS PRIOR TO ANY WORK BEING DONE TO ENSURE PROPER POST PLACEMENT.



SHIM DETAIL Furnish two 0.01" thick and two 0.03" thick stainless steel or brass (ASTM B36) shims per post.




Posts shall be plumbed by using shims with post-to-stub post connection bolts snug tight only. Final tightening of all High Strength Bolts shall be in accordance with Article 727.05 and threads at the junction of the bolt and nut shall be burred or center punched to prevent the nut from loosening.


LOADING: 80 m.p.h. wind with 30% gust factor, normal to sign. DESIGN STRESSES:

Structural steel - 20,000 p.s.i. Reinforcing steel - 20,000 p.s.i. Concrete - 1,400 p.s.i. Footing soil pressure - 2,000 p.s.f.

After fabrication, the post and upper 6", min. of the stub post shall be hot-dip galvanized in accordance with AASHTO Mill. All bolts, nuts and washers shall be hot-dip galvanized in accordance with AASHTO M232.




