- 2. ALL TRAFFIC SIGNAL HEADS SHALL BE 12", UNLESS OTHERWISE NOTED.
- ALL CONDUIT IN TRENCH SHALL BE P.V.C. ALL CONDUIT PUSHED MAY BE GALVANIZED STEEL OR SCHEDULE BO P.V.C. CONDUIT ATTACHED TO STRUCTURES SHALL BE GALVANIZED STEEL.
- 4. A 1/4" DIAMETER CONTINUOUS NYLON ROPE SHALL BE FURNISHED AND LEFT IN PLACE IN ALL CONDUITS BETWEEN HANDHOLES AND FOUNDATIONS OR CONTROLLER AS INCIDENTAL TO THE RESPECTIVE CONDUIT PAY ITEM.

 $V_2 \times 1V_4$ (13 x 31) stainless steel bolt with split lock washer and nylon insert lockout welded to frame and to cover (typical). Anti-corrosion compound shall be applied to each assembly.
