GENERAL NOTES

REINFORCEMENT BARS DESIGNATED (E) SHALL BE EPOXY COATED.

REINFORCEMENT BARS SHALL CONFORM TO THE REQUIREMENTS OF AASHTO A 706 GRADE 60 (IL MODIFIED).

HATCHED AREAS INDICATED LIMITS OF HANDRAIL REMOVAL. THE EXISTING HANDRAIL SHALL BE CUT SHORT OF THE NEW CONCRETE BY 1" TO ALLOW FOR PLACEMENT OF FORMS.

BARS DESIGNATED d*(E) SHALL BE DRILLED AND GROUTED INTO THE EXISTING CONCRETE PARAPET. EPOXY GROUTING SHALL BE DONE IN ACCORDANCE WITH ARTICLE 584 OF THE STANDARD SPECIFICATIONS. THE COST OF THE EPOXY GROUTING AND DRILLING SHALL BE INCLUDED IN THE COST OF REINFORCEMENT BARS, EPOXY COATED.

PLAN DEMENSIONS AND DETAILS RELATIVE TO THE EXISTING STRUCTURE HAVE BEEN TAKEN FROM EXISTING PLANS AND ARE SUBJECT TO NOMINAL CONSTRUCTION VARIATIONS. IT SHAL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY SUCH DEMENSIONS AND DETAILS IN THE FIELD AND MAKE NECESSARY APPROVED ADJUSTMENTS PRIOR TO CONSTRUCTION OR ORDERING OF MATERIALS. SUCH VARIATIONS SHALL NOT BE CAUSE FOR ADDITIONAL COMPENSATION FOR A CHANGE IN THE SCOPE OF WORK. HOWEVER, THE CONTRACTOR WILL BE PAID FOR THE QUANTITY ACTUALLY FURNISHED AT THE UNIT PRICE FOR THE WORK.
