This work will be paid for at the contract unit price bid per SQ YD for **HMA SURFACE REMOVAL - BUTT JOINT** and no additional compensation will be allowed for the above requirements.

REMOVAL AND DISPOSAL OF ORGANIC WASTE

Cleared trees and shrubs shall be disposed of in accordance with Article 202.03. Open burning (burning on the ground) within CONWR must meet all requirements of the **National Wildfire Coordinating Group (NWCG) Standards for Prescribed Fire Planning and Implementation, PMS 484.** Open burning or disposal offsite shall be in accordance with the Standard Specifications.

The contractor may also burn onsite within CONWR using an Air Curtain Destructor. The Air Curtain Destructor shall be a self-contained unit and must be approved by the Engineer. If this method of burning is used the requirements of PMS 484 will be waived. Ash from the Destructor Unit may be disposed of on site, the location and placement must be approved by the Engineer prior to disposal.

Organic Waste originating within CONWR may be chipped or shredded and distributed in wooded areas adjacent to the trail with approval of the Engineer. The depth of distributed chipped or shredded material shall not exceed 6". Chipped or shredded material shall be well ground with a maximum particle size of 2"x1"x1/2".

SIGN PANEL TYPE 1 – (SPECIAL)

SIGN PANEL TYPE 1 - (SPECIAL) Description: This special provision covers work related to the fabrication and installation of sign panels onto posts adjacent to the trail and roadways at the locations listed in the SIGNAGE SCHEDULE.

Materials: Materials shall be according to the requirements in article 720 for SIGN PANELS AND APPURTENANCES and the details shown in the plans.

Sign panel "A" shall include a multicolored graphic consisting of the following colors and similar to the one included below. A final multicolored graphic will be provided by Williamson County after the contract is awarded.

Final design of all sign panels shall be approved by the engineer.

PUBLIC ACCESS TO CONWR DURING THE 2024 ECLIPSE

The Crab Orchard National Wildlife Refuge (CONWR) will host a special event for the public to view the April 8, 2024 eclipse. Public access to the viewing area will be via Chamnesstown Road (approximately Station 99+50). Chamnesstown Road and the adjacent parking area must be free of all equipment and materials from 6:00am to 8:00pm on April 8, 2024. Chamnesstown Road and the trail crossing must be in good condition with at minimum an aggregate surface and easily traversable by a passenger car. The public accessing the viewing area will have the right of way when crossing the proposed trail.

WASTING OF EXCESS EXCAVATION WITHIN CONWR

Excess excavation within (CONWR) must be wasted within the refuge boundary at locations approved by Engineer. Two locations have been approved for placement of excess excavation. These locations are:

- 0.5 miles south of the IL 148/Old 13 intersection. This is a gated storage area adjacent to IL 148 with an aggregate entrance on the east side of IL 148. At this location excess excavation may be placed in stockpiles. This area may also be used as a staging area for equipment.
- West of the proposed trail between stations 183+00 to 195+00. At this location excess material shall be placed in lifts generally matching the contour of the existing ground. Material shall be placed so that no ponding of water is created and the existing drainage patterns are unchanged. The material shall be spread to a uniform surface without deep ruts. Only natural soil may be placed at this location, rock, broken concrete, stumps or other debris may not be placed at this location. This location shall be seeded with temporary erosion control seeding as directed by the Engineer.
