EARTH EXCAVATION

Description. Existing pipe culverts and other unclassified materials such as rubble, tree limbs, rubbish, stones, etc. shall be removed at the locations shown on the plans or as designated by the Engineer. The material removed as required in this special provision shall be disposed of outside the limits of the right of way in accordance with Article 202.03 of the Standard Specifications and as directed by the Engineer.

Basis of Payment. This work will not be paid for separately, but shall be considered as included in the unit price per cubic yard for EARTH EXCAVATION, and no additional compensation will be allowed.

STONE RIPRAP, CLASS A4

Description. This work shall be completed in accordance with Section 281 of the Standard Specifications. The following provisions shall apply.

Basis of Payment. This work will be paid for at the contract unit price per ton for STONE RIPRAP, CLASS A4. The contract unit price shall include all materials, equipment and labor necessary to complete the work. Excavation and bedding stone required for installation shall not be measured for payment but shall be included in the cost for STONE RIPRAP, CLASS A4.
