- b) All Bid Proposals shall be in accordance with IDOT Letting requirements

Contract Requirements

- a) Letting Date: Friday, July 31, 2020, See IDOT Notice of Letting
- b) The contract time to complete this project will be 50 calendar days from the date of Notice to Proceed as issued by the Owner. Notice to proceed is expected in spring of 2021.
- c) Failure to complete the work within the contract time will result in liquidated damages to the Owner per IDOT Special Provision Section 80-08. This is different than the liquidated damages listed in the plan set.

- a) This project includes the rehabilitation of the Terminal ramp including, slab replacement, spall repair, and joint cleaning and re-sealing.
- b) Spall repair will use full quantity and will not increase.
- c) Existing Joint width.

→ Security/Safety and Phasing

- a) This project is located inside the Air Operation Area (AOA) and will fall under the Airport's security requirements. Security training will be required.
- b) Site access for the project will be from the existing airfield gate next to the Terminal and Corporate Hangar.
 - The gate shall remain locked with a lock or guarded by a security guard at all times.
 - Gate access cards will be provided by airport and should be given to essential personnel only. All access cards will be returned at end of project.
- c) Safety and Phasing Plans
 - Phase 1
 - Phase 1A night work (9:00 PM to 6:00 AM)
 - Phase 2
- d) Provide 72 hour notice before closure
- e) Two closures for each phase is acceptable
- f) Construction Safety & Phasing (CSPP)




