STATE REQUIRED ETHICAL STANDARDS GOVERNING CONTRACT PROCUREMENT: ASSURANCES, CERTIFICATIONS AND DISCLOSURES

I. GENERAL

A. Article 50 of the Illinois Procurement Code establishes the duty of all State chief procurement officers, State purchasing officers, and their designees to maximize the value of the expenditure of public moneys in procuring goods, services, and contracts for the State of Illinois and to act in a manner that maintains the integrity and public trust of State government. In discharging this duty, they are charged by law to use all available information, reasonable efforts, and reasonable actions to protect, safeguard, and maintain the procurement process of the State of Illinois.

B. In order to comply with the provisions of Article 50 and to carry out the duty established therein, all bidders are to adhere to ethical standards established for the procurement process, and to make such assurances, disclosures and certifications required by law. By execution of the Proposal Signature Sheet, the bidder indicates that each of the mandated assurances has been read and understood, that each certification is made and understood, and that each disclosure requirement has been understood and completed.

C. In addition to all other remedies provided by law, failure to comply with any assurance, failure to make any disclosure or the making of a false certification shall be grounds for termination of the contract and the suspension or debarment of the bidder.

II. ASSURANCES

A. The assurances hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. The Department may terminate the contract if it is later determined that the bidder rendered a false or erroneous assurance, and the surety providing the performance bond shall be responsible for the completion of the contract.

B. Felons

1. The Illinois Procurement Code provides:

Section 50-10. Felons. Unless otherwise provided, no person or business convicted of a felony shall do business with the State of Illinois or any state agency from the date of conviction until 5 years after the date of completion of the sentence for that felony, unless no person held responsible by a prosecutorial office for the facts upon which the conviction was based continues to have any involvement with the business.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-10.

C. Conflicts of Interest

1. The Illinois Procurement Code provides in pertinent part:

Section 50-13. Conflicts of Interest.

(a) Prohibition. It is unlawful for any person holding an elective office in this State, holding a seat in the General Assembly, or appointed to or employed in any of the offices or agencies of state government and who receives compensation for such employment in excess of 60% of the salary of the Governor of the State of Illinois, or who is an officer or employee of the Capital Development Board or the Illinois Toll Highway Authority, or who is the spouse or minor child of any such person to have or acquire any contract, or any direct pecuniary interest in any contract therein, whether for stationery, printing, paper, or any services, materials, or supplies, that will be wholly or partially satisfied by the payment of funds appropriated by the General Assembly of the State of Illinois or in any contract of the Capital Development Board or the Illinois Toll Highway authority.

(b) Interests. It is unlawful for any firm, partnership, association or corporation, in which any person listed in subsection (a) is entitled to receive (i) more than 7 1/2% of the total distributable income or (ii) an amount in excess of the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.

(c) Combined interests. It is unlawful for any firm, partnership, association, or corporation, in which any person listed in subsection (a) together with his or her spouse or minor children is entitled to receive (i) more than 15%, in the aggregate, of the total distributable income or (ii) an amount in excess of 2 times the salary of the Governor, to have or acquire any such contract or direct pecuniary interest therein.

(d) Securities. Nothing in this Section invalidates the provisions of any bond or other security previously offered or to be offered for sale or sold by or for the State of Illinois.

(e) Prior interests. This Section does not affect the validity of any contract made between the State and an officer or employee of the State or member of the General Assembly, his or her spouse, minor child or any combination of those persons if that contract was in existence before his or her election or employment as an officer, member, or employee. The contract is voidable, however, if it cannot be completed within 365 days after the officer, member, or employee takes office or is employed.

The current salary of the Governor is \$171,000.00. Sixty percent of the salary is \$102,600.00.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-13, or that an effective exemption has been issued by the Board of Ethics to any individual subject to the Section 50-13 prohibitions pursuant to the provisions of Section 50-20 of the Code and Executive Order Number 3 (1998). Information concerning the exemption process is available from the Department upon request.

D. Negotiations

1. The Illinois Procurement Code provides in pertinent part:

Section 50-15. Negotiations.

(a) It is unlawful for any person employed in or on a continual contractual relationship with any of the offices or agencies of State government to participate in contract negotiations on behalf of that office or agency with any firm, partnership, association, or corporation with whom that person has a contract for future employment or is negotiating concerning possible future employment.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-15, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

E. Inducements

1. The Illinois Procurement Code provides:

Section 50-25. Inducement. Any person who offers or pays any money or other valuable thing to any person to induce him or her not to bid for a State contract or as recompense for not having bid on a State contract is guilty of a Class 4 felony. Any person who accepts any money or other valuable thing for not bidding for a State contract or who withholds a bid in consideration of the promise for the payment of money or other valuable thing is guilty of a Class 4 felony.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-25, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

F. Revolving Door Prohibition

1. The Illinois Procurement Code provides:

Section 50-30. Revolving door prohibition. Chief procurement officers, associate procurement officers, State purchasing officers, their designees whose principal duties are directly related to State procurement, and executive officers confirmed by the Senate are expressly prohibited for a period of 2 years after terminating an affected position from engaging in any procurement activity relating to the State agency most recently employing them in an affected position for a period of at least 6 months. The prohibition includes, but is not limited to: lobbying the procurement process; specifying; bidding; proposing bid, proposal, or contract documents; on their own behalf or on behalf of any firm, partnership, association, or corporation. This Section applies only to persons who terminate an affected position on or after January 15, 1999.

2. The bidder assures the Department that the award and execution of the contract would not cause a violation of Section 50-30, and that the bidder has no knowledge of any facts relevant to the kinds of acts prohibited therein.

G. Reporting Anticompetitive Practices

1. The Illinois Procurement Code provides:

Section 50-40. Reporting anticompetitive practices. When, for any reason, any vendor, bidder, contractor, chief procurement officer, State purchasing officer, designee, elected official, or State employee suspects collusion or other anticompetitive practice among any bidders, offerors, contractors, proposers, or employees of the State, a notice of the relevant facts shall be transmitted to the Attorney General and the chief procurement officer.

2. The bidder assures the Department that it has not failed to report any relevant facts concerning the practices addressed in Section 50-40 which may involve the contract for which the bid is submitted.

H. Confidentiality

1. The Illinois Procurement Code provides:

Section 50-45. Confidentiality. Any chief procurement officer, State purchasing officer, designee, or executive officer who willfully uses or allows the use of specifications, competitive bid documents, proprietary competitive information, proposals, contracts, or selection information to compromise the fairness or integrity of the procurement, bidding, or contract process shall be subject to immediate dismissal, regardless of the Personnel code, any contract, or any collective bargaining agreement, and may in addition be subject to criminal prosecution.

2. The bidder assures the Department that it has no knowledge of any fact relevant to the practices addressed in Section 50-45 which may involve the contract for which the bid is submitted.

I. Insider Information

1. The Illinois Procurement Act provides:

Section 50-50. Insider information. It is unlawful for any current or former elected or appointed State official or State employee to knowingly use confidential information available only by virtue of that office or employment for actual or anticipated gain for themselves or another person.

2. The bidder assures the Department that it has no knowledge of any facts relevant to the practices addressed in Section 50-50 which may involve the contract for which the bid is submitted.

III. CERTIFICATIONS

A. The certifications hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. The Department may terminate the contract if it is later determined that the bidder rendered a false or erroneous certification, and the surety providing the performance bond shall be responsible for completion of the contract.

B. Bribery

1. The Illinois Procurement Code provides:

Section 50-5. Bribery.

(a) Prohibition. No person or business shall be awarded a contract or subcontract under this Code who:

(1) has been convicted under the laws of Illinois or any other state of bribery or attempting to bribe an officer or employee of the State of Illinois or any other state in that officer's or employee's official capacity; or

(2) has made an admission of guilt of that conduct that is a matter of record but has not been prosecuted for that conduct.

(b) Businesses. No business shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of the business if the employee or agent is no longer employed by the business and:

(1) the business has been finally adjudicated not guilty; or

(2) the business demonstrates to the governmental entity with which it seeks to contract, and that entity finds that the commission of the offense was not authorized, requested, commanded, or performed by a director, officer, or high managerial agent on behalf of the business as provided in paragraph (2) of subsection (a) of Section 5-4 of the Criminal Code of 1961.

(c) Conduct on behalf of business. For purposes of this Section, when an official, agent, or employee of a business committed the bribery or attempted bribery on behalf of the business and in accordance with the direction or authorization of a responsible official of the business, the business shall be chargeable with the conduct.

(d) Certification. Every bid submitted to and contract executed by the State shall contain a certification by the contractor that the contractor is not barred from being awarded a contract or subcontract under this Section. A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

2. The bidder certifies that it is not barred from being awarded a contract under Section 50.5.

C. Educational Loan

1. Section 3 of the Educational Loan Default Act provides:

§ 3. No State agency shall contract with an individual for goods or services if that individual is in default, as defined in Section 2 of this Act, on an educational loan. Any contract used by any State agency shall include a statement certifying that the individual is not in default on an educational loan as provided in this Section.

2. The bidder, if an individual as opposed to a corporation, partnership or other form of business organization, certifies that the bidder is not in default on an educational loan as provided in Section 3 of the Act.

D. Bid-Rigging/Bid Rotating

1. Section 33E-11 of the Criminal Code of 1961 provides:

§ 33E-11. (a) Every bid submitted to and public contract executed pursuant to such bid by the State or a unit of local government shall contain a certification by the prime contractor that the prime contractor is not barred from contracting with any unit of State or local government as a result of a violation of either Section 33E-3 or 33E-4 of this Article. The State and units of local government shall provide the appropriate forms for such certification.

(b) A contractor who makes a false statement, material to the certification, commits a Class 3 felony.

A violation of Section 33E-3 would be represented by a conviction of the crime of bid-rigging which, in addition to Class 3 felony sentencing, provides that any person convicted of this offense or any similar offense of any state or the United States which contains the same elements as this offense shall be barred for 5 years from the date of conviction from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of State or local government as a result of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation and: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract and that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent in behalf of the corporation.

A violation of Section 33E-4 would be represented by a conviction of the crime of bid-rotating which, in addition to Class 2 felony sentencing, provides that any person convicted of this offense or any similar offense of any state or the United States which contains the same elements as this offense shall be permanently barred from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of State or local government. No corporation shall be barred from contracting with any unit of a conviction under this Section of any employee or agent of such corporation if the employee so convicted is no longer employed by the corporation and: (1) it has been finally adjudicated not guilty or (2) if it demonstrates to the governmental entity with which it seeks to contract and that entity finds that the commission of the offense was neither authorized, requested, commanded, nor performed by a director, officer or a high managerial agent in behalf of the corporation.

2. The bidder certifies that it is not barred from contracting with the Department by reason of a violation of either Section 33E-3 or Section 33E-4.

E. International Anti-Boycott

1. Section 5 of the International Anti-Boycott Certification Act provides:

§ 5. State contracts. Every contract entered into by the State of Illinois for the manufacture, furnishing, or purchasing of supplies, material, or equipment or for the furnishing of work, labor, or services, in an amount exceeding the threshold for small purchases according to the purchasing laws of this State or \$10,000.00, whichever is less, shall contain certification, as a material condition of the contract, by which the contractor agrees that neither the contractor nor any substantially-owned affiliated company is participating or shall participate in an international boycott in violation of the provisions of the U.S. Export Administration Act of 1979 or the regulations of the U.S. Department of Commerce promulgated under that Act.

2. The bidder makes the certification set forth in Section 5 of the Act.

F. Drug Free Workplace

1. The Illinois "Drug Free Workplace Act" applies to this contract and it is necessary to comply with the provisions of the "Act" if the contractor is a corporation, partnership, or other entity (including a sole proprietorship) which has 25 or more employees.

2. The bidder certifies that if awarded a contract in excess of \$5,000 it will provide a drug free workplace by:

(a) Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance, including cannabis, is prohibited in the contractor's workplace; specifying the actions that will be taken against employees for violations of such prohibition; and notifying the employee that, as a condition of employment on such contract, the employee shall abide by the terms of the statement, and notify the employer of any criminal drug statute conviction for a violation occurring in the workplace no later than five (5) days after such conviction.

(b) Establishing a drug free awareness program to inform employees about the dangers of drug abuse in the workplace; the contractor's policy of maintaining a drug free workplace; any available drug counseling, rehabilitation, and employee assistance programs; and the penalties that may be imposed upon employees for drug violations.

(c) Providing a copy of the statement required by subparagraph (1) to each employee engaged in the performance of the contract and to post the statement in a prominent place in the workplace.

(d) Notifying the Department within ten (10) days after receiving notice from an employee or otherwise receiving actual notice of the conviction of an employee for a violation of any criminal drug statute occurring in the workplace.

(e) Imposing or requiring, within 30 days after receiving notice from an employee of a conviction or actual notice of such a conviction, an appropriate personnel action, up to and including termination, or the satisfactory participation in a drug abuse assistance or rehabilitation program approved by a federal, state or local health, law enforcement or other appropriate agency.

(f) Assisting employees in selecting a course of action in the event drug counseling, treatment, and rehabilitation is required and indicating that a trained referral team is in place.

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of the actions and efforts stated in this certification.

G. Debt Delinquency

1. The Illinois Procurement Code provides:

Section 50-11 and 50-12. Debt Delinquency.

The contractor or bidder certifies that it, or any affiliate, is not barred from being awarded a contract under 30 ILCS 500. Section 50-11 prohibits a person from entering into a contract with a State agency if it knows or should know that it, or any affiliate, is delinquent in the payment of any debt to the State as defined by the Debt Collection Board. Section 50-12 prohibits a person from entering into a contract with a State agency if it, or any affiliate, has failed to collect and remit Illinois Use Tax on all sales of tangible personal property into the State of Illinois in accordance with the provisions of the Illinois Use Tax Act. The contractor further acknowledges that the contracting State agency may declare the contract void if this certification is false or if the contractor, or any affiliate, is determined to be delinquent in the payment of any debt to the State during the term of the contract.

H. Sarbanes-Oxley Act of 2002

1. The Illinois Procurement Code, Section 50-60(c), provides:

The contractor certifies in accordance with 30 ILCS 500/50-10.5 that no officer, director, partner or other managerial agent of the contracting business has been convicted of a felony under the Sarbanes-Oxley Act of 2002 or a Class 3 or Class 2 felony under the Illinois Securities Law of 1953 for a period of five years prior to the date of the bid or contract. The contractor acknowledges that the contracting agency shall declare the contract void if this certification is false.

I. Addenda

The contractor or bidder certifies that all relevant addenda have been incorporated in to this contract. Failure to do so may cause the bid to be declared unacceptable.

J. Section 42 of the Environmental Protection Act

The contractor certifies in accordance with 30 ILCS 500/50-12 that the bidder or contractor is not barred from being awarded a contract under this Section which prohibits the bidding on or entering into contracts with the State of Illinois or a State agency by a person or business found by a court or the Pollution Control Board to have committed a willful or knowing violation of Section 42 of the Environmental Protection Act for a period of five years from the date of the order. The contractor acknowledges that the contracting agency may declare the contract void if this certification is false.

K. Apprenticeship and Training Certification (Does not apply to federal aid projects)

In accordance with the provisions of Section 30-22 (6) of the Illinois Procurement Code, the bidder certifies that it is a participant, either as an individual or as part of a group program, in the approved apprenticeship and training programs applicable to each type of work or craft that the bidder will perform with its own forces. The bidder further certifies for work that will be performed by subcontract that each of its subcontractors submitted for approval either (a) is, at the time of such bid, participating in an approved, applicable apprenticeship and training program; or (b) will, prior to commencement of performance of work pursuant to this contract, begin participation in an approved apprenticeship and training program applicable to the work of the subcontract. The Department, at any time before or after award, may require the production of a copy of each applicable Certificate of Registration issued by the United States Department of Labor evidencing such participation by the contractor and any or all of its subcontractors. Applicable apprenticeship and training programs are those that have been approved and registered with the United States Department of Labor. The bidder shall list in the space below, the official name of the program sponsor holding the Certificate of Registration for all of the types of work or crafts in which the bidder is a participant and that will be performed with the bidder's forces. Types of work or craft work that will be subcontracted shall be included and listed as subcontract work. The list shall also indicate any type of work or craft job category that does not have an applicable apprenticeship or training program. The bidder is responsible for making a complete report and shall make certain that each type of work or craft job category that will be utilized on the project as reported on the Construction Employee Workforce Projection (Form BC-1256) and returned with the bid is accounted for and listed.

NA - FEDERAL

The requirements of this certification and disclosure are a material part of the contract, and the contractor shall require this certification provision to be included in all approved subcontracts. In order to fulfill this requirement, it shall not be necessary that an applicable program sponsor be currently taking or that it will take applications for apprenticeship, training or employment during the performance of the work of this contract.

L. Executive Order Number 1 (2007) Regarding Lobbying on Government Procurements

The bidder hereby warrants and certifies that they have complied and will comply with the requirements set forth in this Order. The requirements of this warrant and certification are a material part of the contract, and the contractor shall require this warrant and certification provision to be included in all approved subcontracts.

M. Disclosure of Business Operations in Iran

Public Act 95-0616 provides that each bid, offer, or proposal submitted for a State contract shall include a disclosure of whether or not the Company acting as the bidder, offer or, or proposing entity, or any of its corporate parents or subsidiaries, within the 24 months before submission of the bid, offer, or proposal had business operations that involved contracts with or provision of supplies or services to the Government of Iran, companies in which the Government of Iran has any direct or indirect equity share, consortiums or projects commissioned by the Government of Iran, or companies involved in consortiums or projects commissioned by the Government of Iran and either of the following conditions apply:

- (1) More than 10% of the Company's revenues produced in or assets located in Iran involve oil-related activities or mineral-extraction activities; less than 75% of the Company's revenues produced in or assets located in Iran involve contracts with or provision of oil-related or mineral-extraction products or services to the Government of Iran or a project or consortium created exclusively by that government; and the Company has failed to take substantial action.
- (2) The Company has, on or after August 5, 1996, made an investment of \$20 million or more, or any combination of investments of at least \$10 million each that in the aggregate equals or exceeds \$20 million in any 12-month period, which directly or significantly contributes to the enhancement of Iran's ability to develop petroleum resources of Iran.

The terms "Business operations", "Company", "Mineral-extraction activities", "Oil-related activities", "Petroleum resources", and "Substantial action" are all defined in the Act.

Failure to make the disclosure required by the Act shall cause the bid, offer or proposal to be considered not responsive. The disclosure will be considered when evaluating the bid, offer, or proposal or awarding the contract. The name of each Company disclosed as doing business or having done business in Iran will be provided to the State Comptroller.

IV. DISCLOSURES

A. The disclosures hereinafter made by the bidder are each a material representation of fact upon which reliance is placed should the Department enter into the contract with the bidder. The Department may terminate the contract if it is later determined that the bidder rendered a false or erroneous disclosure, and the surety providing the performance bond shall be responsible for completion of the contract.

B. Financial Interests and Conflicts of Interest

1. Section 50-35 of the Illinois Procurement Code provides that all bids of more than \$10,000 shall be accompanied by disclosure of the financial interests of the bidder. This disclosed information for the successful bidder, will be maintained as public information subject to release by request pursuant to the Freedom of Information Act.

The financial interests to be disclosed shall include ownership or distributive income share that is in excess of 5%, or an amount greater than 60% of the annual salary of the Governor, of the bidding entity or its parent entity, whichever is less, unless the contractor or bidder is a publicly traded entity subject to Federal 10K reporting, in which case it may submit its 10K disclosure in place of the prescribed disclosure. If a bidder is a privately held entity that is exempt from Federal 10K reporting, but has more than 400 shareholders, it may submit the information that Federal 10K companies are required to report, and list the names of any person or entity holding any ownership share that is in excess of 5%. The disclosure shall include the names, addresses, and dollar or proportionate share of ownership of each person making the disclosure, their instrument of ownership or beneficial relationship, and notice of any potential conflict of interest resulting from the current ownership or beneficial interest of each person making the disclosure having any of the relationships identified in Section 50-35 and on the disclosure form.

In addition, all disclosures shall indicate any other current or pending contracts, proposals, leases, or other ongoing procurement relationships the bidding entity has with any other unit of state government and shall clearly identify the unit and the contract, proposal, lease, or other relationship.

2. <u>Disclosure Forms</u>. Disclosure Form A is attached for use concerning the individuals meeting the above ownership or distributive share requirements. Subject individuals should be covered each by one form. In addition, a second form (Disclosure Form B) provides for the disclosure of current or pending procurement relationships with other (non-IDOT) state agencies. **The forms must be included with each bid or incorporated by reference.**

SPECIAL PROVISIONS FOR CITY OF NORTH CHICAGO MARTIN LUTHER KING JR. DRIVE RECONSTRUCTION

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," the "Manual of Test Procedures for Materials", and the "Standard Specification for Water & Sewer Main Construction in Illinois" (latest edition) in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of Martin Luther King Jr. Drive; Section: 03-00159-00 PV; Project: M-8003(342); City of North Chicago; and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF PROJECT

The work on Martin Luther King Jr. Drive begins just east of Green Bay Road (Illinois Route 131) and extends easterly for a distance of 5,900 feet to Sheridan Road (Illinois Route 137).

DESCRIPTION OF IMPROVEMENT

The work included in this Contract shall consist of furnishing all the materials, labor, equipment and incidentals required for drainage structures; storm sewers; sanitary sewers; water main; pavement removal, hot-mix surface removal; curb and gutter; driveway removal and replacement; hot-mix asphalt pavement; hot-mix asphalt resurfacing; adjustment of drainage structures; lighting; traffic signals; restoration and all other incidental work-necessary-to-complete this improvement according the Plans, Standard Specifications and Special Provisions.

COMPLETION DATE PLUS WORKING DAYS

Effective: September 30, 1985 Revised: January 1, 2007

Revise Article 108.05 (b) of the Standard Specifications as follows:

"When a completion date plus working days is specified, the Contractor shall complete all contract items and safely open all roadways to traffic by 11:59 PM on, September 30, 2010 except as specified herein.

S.P.1

The Contractor will be allowed to complete all clean-up work and punch list items within <u>10</u> working days after the completion date for opening the roadway to traffic. Under extenuating-circumstances the Engineer may direct that certain items of work, not affecting the safe opening of the roadway to traffic, may be completed within the working days allowed for clean up work and punch list items. Temporary lane closures for this work may be allowed at the discretion of the Engineer.

Article 108.09 or the Special Provision for "Failure to Complete the Work on Time", if included in this contract, shall apply to both the completion date and the number of working days.

MAINTENANCE OF ROADWAYS

Effective: September 30, 1985

Revised: November 1, 1996

Beginning on the date that work begins on this project, the Contractor shall assume responsibility for normal maintenance of all existing roadways within the limits of the improvement. This normal maintenance shall include all repair work deemed necessary by the Engineer, but shall not include snow removal operations. Traffic control and protection for maintenance of roadways will be provided by the Contractor as required by the Engineer.

If items of work have not been provided in the contract, or otherwise specified for payment, such items, including the accompanying traffic control and protection required by the Engineer, will be paid for in accordance with Article 109.04 of the Standard Specifications.

FINE AGGREGATE FOR HOT-MIX ASPHALT (HMA) (DISTRICT ONE)

Effective: May 1, 2007

Revise Article 1003.03 (c) to read:

"Gradation. The fine aggregate gradation for all HMA shall be FA1, FA 2, FA 20, or FA 21. When Reclaimed Asphalt Pavement (RAP) is incorporated in the HMA design, the use of FA 21 Gradation will not be permitted.

RECLAIMED ASPHALT PAVEMENT (RAP) (DISTRICT ONE)

Effective: January 1, 2007 Revised: January 24, 2008April 1, 2007

In Article 1030.02(g), delete the last sentence of the first paragraph in (Note 2).

Revise Section 1031 of the Standard Specifications to read:

"SECTION 1031. RECLAIMED ASPHALT PAVEMENT

1031.01 Description. Reclaimed asphalt pavement (RAP) is reclaimed asphalt pavement resulting from cold milling or crushing of an existing dense graded hot-mix asphalt (HMA) pavement. The Contractor shall supply written documentation that the RAP originated from routes or airfields under federal, state, or local agency jurisdiction.

1031.02 Stockpiles. The Contractor shall construct individual, sealed RAP stockpiles meeting one of the following definitions. No additional RAP shall be added to the pile after the pile has been sealed. Stockpiles shall be sufficiently separated to prevent intermingling at the base. Stockpiles shall be identified by signs indicating the type as listed below (i.e. "Homogeneous Surface").

Prior to milling, the Contractor shall request the District to provide verification of the quality of the RAP to clarify appropriate stockpile.

- (a) Homogeneous. Homogeneous RAP stockpiles shall consist of RAP from Class I, Superpave (High ESAL), HMA (High ESAL), or equivalent mixtures and represent:
 1) the same aggregate quality, but shall be at least C quality; 2) the same type of crushed aggregate (either crushed natural aggregate, ACBF slag, or steel slag); 3) similar gradation; and 4) similar asphalt binder content. If approved by the Engineer, combined single pass surface/binder millings may be considered "homogenous" with a quality rating dictated by the lowest coarse aggregate quality present in the mixture.
- (b) Conglomerate 5/8. Conglomerate 5/8 RAP stockpiles shall consist of RAP from Class I, Superpave (High ESAL), HMA (High ESAL), or equivalent mixtures. The coarse aggregate in this RAP shall be crushed aggregate and may represent more than one aggregate type and/or quality but shall be at least C quality. This RAP may have an inconsistent gradation and/or asphalt binder content prior to processing. All conglomerate 5/8 RAP shall be processed prior to testing by crushing to where all RAP shall pass the 5/8 in. (16 mm) or smaller screen. Conglomerate 5/8 RAP stockpiles shall not contain steel slag or other expansive material as determined by the Department.
- (c) Conglomerate 3/8. Conglomerate 3/8 RAP stockpiles shall consist of RAP from Class I, Superpave (High ESAL), HMA (High ESAL), or equivalent mixtures. The coarse aggregate in this RAP shall be crushed aggregate and may represent more than one aggregate type and/or quality but shall be at least B quality. This RAP may have an inconsistent gradation and/or asphalt binder content prior to processing. All conglomerate 3/8 RAP shall be processed prior to testing by crushing to where all RAP shall pass the 3/8 in. (9.5 mm) or smaller screen. Conglomerate 3/8 RAP stockpiles shall not contain steel slag or other expansive material as determined by the Department.
- (d) Conglomerate "D" Quality (DQ). Conglomerate DQ RAP stockpiles shall consist of RAP from Class I, Superpave (High or Low ESAL), HMA (High or Low ESAL), or equivalent mixtures. The coarse aggregate in this RAP may be crushed or round but shall be at least D quality. This RAP may have an inconsistent gradation and/or asphalt binder content. Conglomerate DQ RAP stockpiles shall not contain steel slag or other expansive material as determined by the Department.

(e) Non-Quality. RAP stockpiles that do not meet the requirements of the stockpile - categories listed above shall be classified as "Non-Quality".

RAP containing contaminants, such as earth, brick, sand, concrete, sheet asphalt, bituminous surface treatment (i.e. chip seal), pavement fabric, joint sealants, etc., will be unacceptable unless the contaminants are removed to the satisfaction of the Engineer. Sheet asphalt shall be stockpiled separately.

1031.03 Testing. When used in HMA, the RAP shall be sampled and tested either during or after stockpiling.

For testing during stockpiling, washed extraction samples shall be run at the minimum frequency of one sample per 500 tons (450 metric tons) for the first 2000 tons (1800 metric tons) and one sample per 2000 tons (1800 metric tons) thereafter. A minimum of five tests shall be required for stockpiles less than 4000 tons (3600 metric tons).

For testing after stockpiling, the Contractor shall submit a plan for approval to the District proposing a satisfactory method of sampling and testing the RAP pile either in-situ or by restockpiling. The sampling plan shall meet the minimum frequency required above and detail the procedure used to obtain representative samples throughout the pile for testing.

Before extraction, each field sample shall be split to obtain two samples of test sample size. One of the two test samples from the final split shall be labeled and stored for Department use. The Contractor shall extract the other test sample according to Department procedure. The Engineer reserves the right to test any sample (split or Department-taken) to verify Contractor test results.

- (a) Testing Conglomerate 3/8. In addition to the requirements above, conglomerate 3/8 RAP shall be tested for maximum theoretical specific gravity (G_{mm}) at a frequency of one sample per 500 tons (450 metric tons) for the first 2000 tons (1800 metric tons) and one sample per 2000 tons (1800 metric tons) thereafter. A minimum of five tests shall be required for stockpiles less than 4000 tons (3600 metric tons).
- (b) Evaluation of Test Results. All of the extraction results shall be compiled and averaged for asphalt binder content and gradation and, when applicable G_{mm}. Individual extraction test results, when compared to the averages, will be accepted if within the tolerances listed below.

If more than 20 percent of the individual sieves are out of the gradation tolerances, or if more than 20 percent of the asphalt binder content test results fall outside the appropriate tolerances, the RAP shall not be used in HMA unless the RAP representing the failing tests is removed from the stockpile. All test data and acceptance ranges shall be sent to the District for evaluation.

With the approval of the Engineer, the ignition oven may be substituted for extractions according to the Illinois Test Procedure, "Calibration of the Ignition Oven for the Purpose of Characterizing Reclaimed Asphalt Pavement (RAP)".

- (a) RAP from Class I, Superpave (High ESAL), or HMA (High ESAL) surface mixtures are designated as containing Class B quality coarse aggregate.
- (b) RAP from Superpave (Low ESAL)/HMA (Low ESAL) IL-19.0L binder and IL-9.5L surface mixtures are designated as Class D quality coarse aggregate.
- (c) RAP from Class I, Superpave (High ESAL), or HMA (High ESAL) binder mixtures, bituminous base course mixtures, and bituminous base course widening mixtures are designated as containing Class C quality coarse aggregate.

(d) RAP from bituminous stabilized subbase and BAM shoulders are designated as containing Class D quality coarse aggregate.

1031.05 Use of RAP in HMA. The use of RAP in HMA shall be as follows.

- (a) Coarse Aggregate Size. The coarse aggregate in all RAP shall be equal to or less than the nominal maximum size requirement for the HMA mixture to be produced.
- (b) Steel Slag Stockpiles. RAP stockpiles containing steel slag or other expansive material, as determined by the Department, shall be homogeneous and will be approved for use in HMA (High ESAL and Low ESAL) surface mixtures only.
- (c) Use in HMA Surface Mixtures (High and Low ESAL). RAP stockpiles for use in HMA surface mixtures (High and Low ESAL) shall be either homogeneous or conglomerate 3/8, in which the coarse aggregate is Class B quality or better.
- (d) Use in HMA Binder Mixtures (High and Low ESAL), HMA Base Course, and HMA Base Course Widening. RAP stockpiles for use in HMA binder mixtures (High and Low ESAL), HMA base course, and HMA base course widening shall be homogeneous, conglomerate 5/8, or conglomerate 3/8, in which the coarse aggregate is Class C quality or better.
- (e) Use in Shoulders and Subbase. RAP stockpiles for use in HMA shoulders and stabilized subbase (HMA) shall be homogeneous, conglomerate 5/8, conglomerate 3/8, or conglomerate DQ.
- (f) The use of RAP shall be a contractor's option when constructing HMA in all contracts. When the contractor chooses the RAP option, the percentage of RAP shall not exceed the amounts indicated in the table for a given N Design.

1031.06 HMA Mix Designs. At the Contractor's option, HMA mixtures may be constructed utilizing RAP material meeting the above detailed requirements.

RAP designs shall be submitted for volumetric verification. If additional RAP stockpiles are tested and found that no more than 20 percent of the results, as defined under "Testing" herein, are outside of the control tolerances set for the original RAP stockpile and HMA mix design, and meets all of the requirements herein, the additional RAP stockpiles may be used in the original mix design at the percent previously verified.

1031.07 HMA Production. The coarse aggregate in all RAP used shall be equal to or less than the nominal maximum size requirement for the HMA mixture being produced.

To remove or reduce agglomerated material, a scalping screen, crushing unit, or comparable sizing device approved by the Engineer shall be used in the RAP feed system to remove or reduce oversized material. If material passing the sizing device adversely affects the mix production or quality of the mix, the sizing device shall be set at a size specified by the Engineer.

If the RAP control tolerances or QC/QA test results require corrective action, the Contractor shall cease production of the mixture containing RAP and either switch to the virgin aggregate design or submit a new RAP design. When producing mixtures containing conglomerate 3/8 RAP, a positive dust control system shall be utilized.

HMA plants utilizing RAP shall be capable of automatically recording and printing the following information.

(a) Dryer Drum Plants.

S.P. 8

- (1) Date, month, year, and time to the nearest minute for each print.
- (2) HMA mix number assigned by the Department.
- (3) Accumulated weight of dry aggregate (combined or individual) in tons (metric tons) to the nearest 0.1 ton (0.1 metric ton).
- (4) Accumulated dry weight of RAP in tons (metric tons) to the nearest 0.1 ton (0.1 metric ton).
- (5) Accumulated mineral filler in revolutions, tons (metric tons), etc. to the nearest 0.1 unit.
- (6) Accumulated asphalt binder in gallons (liters), tons (metric tons), etc. to the nearest 0.1 unit.
- (7) Residual asphalt binder in the RAP material as a percent of the total mix to the nearest 0.1 percent.
- (8) Aggregate and RAP moisture compensators in percent as set on the control panel. (Required when accumulated or individual aggregate and RAP are printed in wet condition.)

(b) Batch Plants.

- (1) Date, month, year, and time to the nearest minute for each print.
- (2) HMA mix number assigned by the Department.
- (3) Individual virgin aggregate hot bin batch weights to the nearest pound (kilogram).
- (4) Mineral filler weight to the nearest pound (kilogram).
- (5) RAP weight to the nearest pound (kilogram).
- (6) Virgin asphalt binder weight to the nearest pound (kilogram).
- (7) Residual asphalt binder in the RAP material as a percent of the total mix to the nearest 0.1 percent.

The printouts shall be maintained in a file at the plant for a minimum of one year or as directed by the Engineer and shall be made available upon request. The printing system will be inspected by the Engineer prior to production and verified at the beginning of each construction season thereafter.

1031.08 RAP in Aggregate Surface Course and Aggregate Shoulders. The use of RAP in aggregate surface course and aggregate shoulders shall be as follows.

- (a) Stockpiles and Testing. RAP stockpiles may be any of those listed in Article 1031.02, except "Other". The testing requirements of Article 1031.03 shall not apply.
- (b) Gradation. One hundred percent of the RAP material shall pass the 1 1/2 in. (37.5 mm) sieve. The RAP material shall be reasonably well graded from coarse to fine. RAP material that is gap-graded or single sized will not be accepted."

HOT MIX ASPHALT - DENSITY TESTING OF LONGITUDINAL JOINTS (D-1)

Effective: January 1, 2007 Revised: February 26, 2008

<u>Description</u>: This work shall consist of testing the density of longitudinal joints as part of the quality control / quality assurance (QC/QA) of hot-mix asphalt (HMA). This work shall be according to Section 1030 of the Standard Specifications except as follows.

Definitions:

Density Test Location: The station location used for density testing.

Density Test Site: Individual test site where a single density value is determined.

Density Reading: A single, one minute nuclear density reading.

Density Value: The density determined at a given density test site from the average of two "density readings".

Quality Control / Quality Assurance (QC/QA)

1030.05(d) (3) add the following paragraphs:

Longitudinal joint density testing shall be performed at each random "density test location". Longitudinal joint testing shall be located at a distance equal to the lift

thickness, or a minimum of two inches, from each pavement edge. For Example, on a four inch HMA lift the near edge of the nuclear gauge or core barrel shall be within four inches from the edge of pavement. The remaining 3 density test sites shall be equally spaced between the two edge readings. Documentation shall indicate whether the joint was confined or unconfined.

The joint density value shall be determined using either a correlated nuclear gauge or cores. When using a correlated nuclear gauge, two "density readings" shall be taken at the given density test site. The gauge shall be rotated 180 degrees between "density readings". If the two "density readings" are not within 1.5 lb/cu ft (23 kg/cu m) then one additional "density reading" shall be taken. Additional "density readings" taken at a given site shall not be allowed to replace the original "density readings" unless an error has occurred (i.e. the nuclear gauge was sitting on debris).

EPOXY COATING ON REINFORCEMENT (DISTRICT ONE)

Effective: January 1, 2007

2/

For work outside the limits of bridge approach pavement, all references in the Highway Standards and Standard Specifications for reinforcement, dowel bars, tie bars and chair supports for pavement, shoulders, curb, gutter, combination curb and gutter and median shall be epoxy coated, unless noted on the plan.

TEMPERATURE CONTROL FOR CONCRETE PLACEMENT (DISTRICT ONE) Effective: May 1, 2007

Delete the second and third sentences of the second paragraph of Article 1020.14(a) of the Standard Specifications.

REMOVAL AND DISPOSAL OF UNSUITABLE MATERIAL

This work shall consist of removing and disposing of unsuitable materials, of varying depths from the proposed subgrade, at the locations specified on the Plans and where directed by the Engineer, in accordance with the applicable portions of Section 202 of the Standard Specifications and as directed by the Engineer

This work shall be paid for at the contract unit price per cubic yard for REMOVAL AND DISPOSAL OF UNSUITABLE MATERIAL, which price shall include all labor, material and equipment necessary to remove and dispose of the unsuitable material as specified herein.

POROUS GRANULAR EMBANKMENT, SUBGRADE

Effective: September 30, 1985 Revised: January 1, 2007

This work consists of furnishing, placing, and compacting porous granular material to the lines and grades shown on the plans or as directed by the Engineer in accordance with applicable portions of Section 207. The material shall be used as a bridging layer over soft, pumpy, loose soil and for placing under water and shall conform with Article 1004.04 except the gradation shall be as follows:

The porous granular material shall be placed in one lift when the total thickness to be placed is 2 feet (600 mm) or less or as directed by the Engineer. Each lift of the porous granular material shall be rolled with a vibratory roller meeting the requirements of Article 1101.01(g) to obtain the desired keying or interlock and compaction. The Engineer shall verify that adequate keying has been obtained.

A 3 inch (75 mm) nominal thickness top lift of capping aggregate having a gradation of CA 6 will be required when Aggregate Subgrade is not specified in the contract and Porous Granular Embankment, Subgrade will be used under the pavement and shoulders. Capping aggregate will not be required when embankment meeting the requirements of Section 207 or granular subbase is placed on top of the porous granular material.

Construction equipment not necessary for the completion of the replacement material will not be allowed on the undercut areas until completion of the recommended thickness of the porous granular embankment subgrade.

Full depth subgrade undercut should occur at limits determined by the Engineer. A transition slope to the full depth of undercut shall be made outside of the undercut limits at a taper of 1 foot (300 mm) longitudinal per 1 inch (25 mm) depth below the proposed subgrade or bottom of the proposed aggregate subgrade when included in the contract.

<u>Method of Measurement</u>. This work will be measured for payment in accordance with Article 207.04. When specified on the contract, the theoretical elevation of the bottom of the aggregate subgrade shall be used to determine the upper limit of Porous Granular Embankment, Subgrade. The volume will be computed by the method of average end areas.

<u>Basis of Payment</u>. This work shall be paid for at the contract unit price per cubic yard (cubic meter) for POROUS GRANULAR EMBANKMENT, SUBGRADE which price shall include the capping aggregate, when required.

The Porous Granular Embankment, Subgrade shall be used as field conditions warrant at the time of construction. No adjustment in unit price will be allowed for an increase or decrease in quantities from the estimated quantities shown on the plans.

AGGREGATE SUBGRADE, 12" (300 mm)

Effective: May 1, 1990 Revised: January 1, 2007

This work shall be done in accordance with the applicable portions of Section 207. The material shall conform to Article 1004.04 except as follows:

1. Crushed Stone, Crushed Blast Furnace Slag, and Crushed Concrete will be permitted. Steel slag and other expansive materials as determined through testing by the Department will not be permitted.

**The Bituminous material shall be separated and mechanically blended with the crushed concrete so that the bituminous material does not exceed 40% of the final products. The top size of the bituminous material in the final product shall be less than 4 inches (100 mm) and shall not contain more than 10.0% steel slag RAP or any material that is considered expansive by the Department.

The Aggregate subgrade shall be placed in two lifts consisting of a 9 inch (225 mm) and variable nominal thickness lower lift and a 3 inch (75 mm) nominal thickness top lift of capping aggregate having a gradation of CA 6. The CA 6 may be blended as follows. The bituminous materials shall be separated and mechanically blended with interlocking feeders with crushed concrete or natural aggregate, in a manner that the bituminous material does not exceed 40% of the final product. This process shall be approved by the engineer prior to start of production. The top side of the bituminous material in the final products shall be less than 1 1/2 inches (37.5 mm) and shall not contain any material considered expansive by the department. Reclaimed Asphalt Pavement (RAP) (having a maximum of 10% steel slag RAP) meeting the requirements of Article 1004.07 and having 100% passing the 3 inch (75 mm) sieve and well graded down through fines may also be used as capping aggregate. IDOT testing of the RAP material will be used in determining the percent of steel slag or Expansive Material. When the contract specifies that an aggregate subbase is to be placed on the Aggregate Subgrade, the 3 inches (75 mm) of capping aggregate will be eliminated. A vibratory roller meeting the requirements of Article 1101.01(g) shall be used to roll each lift of material to obtain the desired keying or interlock and necessary compaction. The Engineer will verify that adequate keying has been obtained.

When a recommended remedial treatment for unstable subgrades is included in the contract, the lower lift of Aggregate Subgrade may be placed simultaneously with the material for Porous Granular Embankment, Subgrade when the total thickness to be placed is 2 feet (600 mm) or less.

Method of Measurement.

Contract Quantities. Contract quantities shall be in accordance with Article 202.07.

Measured Quantities. Aggregate subgrade will be measured in place and the area computed in square yards (square meters).

<u>Basis of Payment.</u> This work will be paid for at the contract unit price per square yard (square meter) for AGGREGATE SUBGRADE, 12" (AGGREGATE SUBGRADE, 300 mm).

PORTLAND CEMENT CONCRETE DRIVEWAY PAVEMENT

This item shall consist of the construction of driveway pavements as per detail and at locations shown on the Plans or as directed by the Engineer.

The driveway shall be constructed on compacted SUB-BASE GRANULAR MATERIAL, TYPE B, 4" on a dry natural or compacted subgrade. Driveways shall have a minimum thickness of 6 inches.

Formwork for PCC Driveway Pavement shall be a minimum of 2x6. <u>No 2x4 forms will be</u> allowed during construction.

The driveway pavements at EMCO Chemical Distributors, Inc. (EMCO) shall be composed of high-early strength Portland cement concrete to expedite the construction of the driveway pavement and the driveway pavement shall be constructed one at a time to maintain access into EMCO. No extra payment will be allowed for the use of high-early strength concrete at this location.

This work will be paid for at the contract unit price per square yard for PORTLAND CEMENT CONCRETE DRIVEWAY PAVEMENT, of the thickness specified, which shall include payment for the aggregate base and all work specified herein.

PAVEMENT REMOVAL

Work under this item shall be performed in accordance with Section 440 of the Standard Specifications except as herein modified.

<u>Description</u>: This work shall consist of removing all existing concrete and/or hot-mix asphalt pavement, as specified on the plans and as directed by the Engineer, from the top of the existing pavement section to the top of existing subgrade elevation. This work shall include the removal and disposal of granular base and sub-base courses, stabilization stone, earth, slag of all types and abandoned structures to the top of existing subgrade elevation.

<u>General Requirements:</u> The pavement section shall be sawcut full depth prior to beginning removal. All sawcutting required in the satisfactory removal of the pavement section will be considered incidental to the removal and no additional costs shall be paid.

The pavement requiring breaking by machine shall be removed in such a manner as not to disturb underlying utility structures. It shall be the Contractor's responsibility to protect all existing utilities.

All existing pavement section shall be disposed of beyond the limits of the project, as specified in Article-202.03-of the Standard Specifications. Stockpiling of the pavement section shall not be allowed.

After excavating to the required subgrade level, the Engineer shall inspect the subgrade. Prior to placing any pavement section material, the excavation level or subgrade level shall be compacted and, where possible, proof-rolled with a 25-ton heavy pneumatic tire-roller by making at least 4 passes. The compacting and proof-rolling will detect soft or unstable pockets of material which shall be removed and replaced as herein specified. The compacting and proof-rolling shall be incidental to the work and no additional compensation will be paid. The subgrade shall be compacted to 95% of maximum density as determined by AASHTO T-99.

If the existing subgrade soil is not suitable for providing an IBR soil support value of 2, the Contractor shall excavate and replace unsuitable soil with POROUS GRANULAR EMBANKMENT, SUBGRADE over GEOTECHNICAL FABRIC FOR GROUND STABILIZATION.

Pavement Removal shall also include, were encountered, blocking of all abandoned sewers and duct lines.

No burning or use of explosives will be allowed.

<u>Method of Measurement</u>: PAVEMENT REMOVAL as shown on the plans and as directed by the Engineer will be measured in place and the area computed in square yards. This shall include removal of all types of material between the top of existing pavement and the top of existing subgrade elevation.

<u>Basis of Payment:</u> This work will be paid for at the contract unit price per square yard for PAVEMENT REMOVAL as measured in place. The contract unit price shall include all costs of removal down to the top of existing subgrade elevation for breaking, removing and disposing of existing concrete pavement, pavement with concrete base and asphalt, stone, stabilization stone, earth, slag of all types, street car track including rails, ties and/or ballast, abandoned structures, rebar, and mesh down to the top of existing subgrade elevation. In addition, the unit price shall include full depth sawcut, compacting and proof rolling the subgrade. Rock excavation will not be included but shall be paid for separately.

DRIVEWAY PAVEMENT REMOVAL

Work under this item will be performed in accordance with Section 440 of the Standard Specifications and the Standard Construction Details, except as herein modified.

<u>Description</u>: This work consists of the removal and disposal of existing concrete, hot-mix asphalt, stone or dirt driveway and/or alley and pavements or combination of pavements to the proposed elevations and dimensions as indicated on the plans or directed by the Engineer. Any additional excavation required to install the proposed P.C.C. DRIVEWAY PAVEMENT, 6" or P.C.C. DRIVEWAY PAVEMENT, 8" at the proposed elevations and Standard Detail Cross Sections will be considered incidental to this item. The proposed driveway and alley pavement will not be considered part of this item.

<u>General Requirements</u>: The Contractor must sawcut full depth a perpendicular clean joint between that portion of the driveway or alley to be removed and that portion of the driveway or alley which is to remain in place. The cost of this work will be incidental to the contract unit price of this item. If the Contractor removes or damages the existing driveway or alley pavement outside of the limits designated by the Engineer for removal or replacement, he will be required to repair that portion at his own expense to the satisfaction of the Engineer.

<u>Method of Measurement</u>: Driveway and alley pavement will be measured in place in square yards. The dimensions used will be the greater of the existing driveway or the proposed driveway up to plan dimensions; however, areas of overlap with other removal items will not be measured for payment twice.

<u>Basis of Payment:</u> This work will be paid for at the contract unit price per square yard for DRIVEWAY PAVEMENT REMOVAL, which price includes, removal and disposal of the existing driveway or alley material from existing elevation to proposed sub-base elevation and to the Standard Section Dimensions. Also, included in this item is full depth sawcutting.

TRAFFIC CONTROL PLAN

Effective: September 30, 1985 Revised: January 1, 2007

Traffic Control shall be in accordance with the applicable sections of the Standard Specifications, the Supplemental Specifications, the "Illinois Manual on Uniform Traffic Control Devices for Streets and Highway", any special details and Highway Standards contained in the plans, the Traffic Specifications and the Special Provisions contained herein.

Special attention is called to Articles 107.09 and the following Highway Standards, Details, Quality Standard for Work Zone Traffic Control Devices, Recurring Special Provisions and Special Provisions contained herein, relating to traffic control.

The Contractor shall contact the Engineer at least 72 hours in advance of beginning work.

SPECIAL PROVISIONS: Traffic Control and Protection, (Special) Maintenance of Roadways Traffic Control and Protection for Temporary Detour

TRAFFIC CONTROL AND PROTECTION FOR TEMPORARY DETOUR

Effective: September 1, 1995 Revised: January 1, 1997

When traffic is to be directed over a detour route, the Contractor shall furnish, erect, maintain and remove all applicable traffic control devices along the detour route.

Furnishing, erecting, maintaining and removing traffic control devices along detour routes, in accordance with the details shown in the plans, will be paid for at the contract unit price each for TRAFFIC CONTROL AND PROTECTION FOR TEMPORARY DETOUR.

TRAFFIC CONTROL AND PROTECTION, (SPECIAL)

The Contractor shall be responsible for all signing, traffic control, and protection of this project in accordance with applicable parts of Section 700 of the Standard Specifications and the latest edition of the State of Illinois Manual on Uniform Traffic Control Devices. Streets under construction may be closed to through traffic during construction with the consent of the Engineer. The Contractor shall follow the Highway Standards provided in the plans and complete the work as directed by the Engineer.

This item of work shall include furnishing, installing, maintaining, replacing, relocating and removing all traffic control devices used for the purpose of regulating, warning or directing traffic during the construction or maintenance of this improvement.

Traffic Control and Protection, (Special) shall be provided as called for in the Plans, these Special Provisions, applicable Highway Standards, applicable sections of the Standard Specifications, or as directed by the Engineer.

The governing factor in the execution and staging of work for this project is to provide the motoring public with the safest possible travel conditions along the roadway through the construction zone.

The Contractor shall arrange his operations to keep delays or the closing of any lane of the roadway to a minimum.

All traffic control devices used on this project shall conform to the Plans, Special Provisions, Traffic Control Standards, Traffic Specifications and the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways. No modification of these requirements will be allowed without prior approval of the Engineer.

Traffic control devices include signs and their supports, signals, pavement markings, barricades with sand bags, barrels, channeling devices, warning lights, arrow boards, flaggers, or any other device used for the purpose of regulating, warning or guiding traffic through the construction zone.

The initial erection of a traffic control installation shall not include devices that are bent, scratched, faded, worn, dirty or otherwise present a shabby appearance. The Contractor is required to conduct routine inspections of the work site at a frequency that will allow for the prompt replacement of any traffic control device that has become displaced, worn or damaged to the extent that it no longer conforms to the shape, dimensions, color and operational requirements of the MUTCD, and the Traffic Control Standards or will no longer present a neat appearance to motorists. A sufficient quantity of replacement devices, based on vulnerability to damage, shall be readily available to meet this requirement.

The Contractor shall be responsible for the proper location, installation and arrangement of all traffic control devices. Special attention shall be given to advance warning signs during construction operations in order to keep lane assignment consistent with barricade placement at all times. The Contractor shall immediately remove, cover or turn from the view of the motorists all traffic control devices which are inconsistent with lane assignment patterns and conflicting conditions during the transition from one construction stage to another. When the Contractor elects to cover conflicting or inappropriate signing, the materials used shall totally block out reflectivity for the sign and shall cover the entire sign. The Engineer shall approve the method used for covering the signing.

The Contractor shall coordinate all traffic control work on this project with adjoining or overlapping projects. When directed by the Engineer, the Contractor shall remove all traffic control devices that were furnished, installed and maintained by him/her under this Contract, and such devices shall remain the property of the Contractor. All traffic control devices shall remain in place until authorization for relocation or removal is received from the Engineer.

The Contractor shall ensure that all traffic control devices installed by him/her are operational, functional and effective 24 hours a day, including Sundays and holidays.

The Contractor shall stage construction activities or construct temporary entrances so that access is

never eliminated. The Contractor shall complete any and all coordination necessary to maintain traffic in a manner that will not hinder the delivery of mail by the U. S. Postal Service within the work zone. The cost of any necessary provisions shall be incidental to this Special Provision.

Where access is specified across the work zone, temporary aggregate ramps must be provided and maintained until pavement is once again restored. The ramps may need to be cut out and put back at various stages of excavation and as road building progresses. TEMPORARY ACCESS (PRIVATE ENTRANCE), TEMPORARY ACCESS (COMMERCIAL ENTRANCE) and TEMPORARY ACCESS (ROAD) shall be paid for separately as AGGREGATE SURFACE COURSE, TYPE B as specified herein.

This item includes all signs, signals, electric arrow boards, reflectorized paint lines and markings, traffic cones, barricades, warning lights, drums, flagmen, and other traffic control devices required for the type of operation being performed. The Contractor shall at all times conduct the work in such a manner as to ensure the least obstruction to vehicular and pedestrian traffic. The convenience and safety of the general public and of residents along the site shall be provided for in an adequate and satisfactory manner.

All of the contractor's workers must wear reflective vests at all times during work operations.

The Contractor shall distribute by hand a typed notice to residences that have driveways or accessways that will be closed or half closed due to curb, sidewalk, or driveway apron work. The City will furnish the notice. The notice must be delivered at 48 hours before removal work begins. The contractor costs due to hand distribution of the notice furnished by the City shall be included in the cost of traffic control for this contract.

The contractor shall obtain, erect, maintain and remove all signs, markings, barricades, electric light arrow boards, flagmen and other traffic control devices as may be necessary for the purpose of regulating, warning or guiding traffic and or pedestrians. Placement and maintenance of all traffic control devices shall be as directed by the Engineer, and in accordance with the plans, attached standards, applicable parts of Article 107.14 of Standard Specifications and the Manual on Uniform Traffic Control Devices for Streets and Highways.

The Contractor shall clean the pavement of all dust, dirt and debris at the end of each day's operation and as required at other times. Nails should never be allowed lying on the pavement.

The Contractor shall replace any traffic control device, which has become ineffective due to damage or defacement. All traffic control devices shall be kept clean and neat in appearance. Barricades placed in excavated areas shall have leg extensions to maintain proper barricade height above the traveled way.

All barricades or signs shall be equipped with highly reflectorized covering and flashing amber warning lights. Construction signs necessary only during working hours shall be removed or covered-during non-working hours.

Barricades used for channelization or delineation and warning signs, shall be sequentially placed in the direction of the traffic flow and removed in reverse order. Lane closure signs and flagmen signs shall be erected prior to barricades and/or cones, and shall remain erected until such time as all traffic control devices have been removed from the pavement.

The Contractor shall also provide a list of three persons who can be contacted on a 24-hour basis to handle barricading, or other problems relating to the construction activity. These emergency response persons shall be capable of responding within 1 hour after notification by the City. If there has been no response within 1 hour after notification, the City will respond at a cost of \$40 per hour (1 man plus truck) with a minimum charge of two hours plus materials. This charge will be deducted from payments to the contractor.

Failure to comply with directions from the Engineer for correction of or changes to traffic control devices will result in a charge of \$500.00 per day.

The work zone and all effort included in the management of traffic will be paid for at the contract unit price lump sum for TRAFFIC CONTROL AND PROTECTION, (SPECIAL). The price shall include all labor, materials and equipment necessary to provide, erect and maintain all traffic control and protection as specified herein or as directed by the Engineer. No additional compensation shall be made.

TEMPORARY INFORMATION SIGNING

Effective: November 13, 1996 Revised: January 2, 2007

Description.

This work shall consist of furnishing, installing, maintaining, relocating for various states of construction and eventually removing temporary informational signs. Included in this item may be ground mount signs, skid mount signs, truss mount signs, bridge mount signs, and overlay sign panels which cover portions of existing signs.

Materials.

Materials shall be according to the following Articles of Section 1000 - Materials:

- Note 1. The Contractor may use 5/8 inch (16 mm) instead of 3/4 inch (19 mm) thick plywood.
- Note 2. Type A sheeting can be used on the plywood base.
- Note 3. All sign faces shall be Type A except all orange signs shall meet the requirements of Article 1106.01.
- Note 4. The overlay panels shall be 0.08 inch (2 mm) thick.

GENERAL CONSTRUCTION REQUIRMENTS

Installation.

The sign sizes and legend sizes shall be verified by the Contractor prior to fabrication.

Signs which are placed along the roadway and/or within the construction zone shall be installed according to the requirements of Article 701.14 and Article 720.04. The signs shall be 7 ft (2.1 m) above the near edge of the pavement and shall be a minimum of 2 ft (600 mm) beyond the edge of the paved shoulder. A minimum of two (2) posts shall be used.

The attachment of temporary signs to existing sign structures or sign panels shall be approved by the Engineer. Any damage to the existing signs due to the Contractor's operations shall be repaired or signs replaced, as determined by the Engineer, at the Contractor's expense.

Signs which are placed on overhead bridge structures shall be fastened to the handrail with stainless steel bands. These signs shall rest on the concrete parapet where possible. The Contractor shall furnish mounting details for approval by the Engineer.

Method Of Measurement.

This work shall be measured for payment in square feet (square meters) edge to edge (horizontally and vertically).

All hardware, posts or skids, supports, bases for ground mounted signs, connections, which are required for mounting these signs will be included as part of this pay item.

Basis Of Payment.

This work shall be paid for at the contract unit price per square foot (square meter) for

TEMPORARY INFORMATION SIGNING.

AGGREGATE SURFACE COURSE, TYPE B

The Contractor shall construct and maintain aggregate surface course for temporary access to private entrances, commercial entrances and roads according to Article 402.07 and as directed by the Engineer.

The aggregate surface course shall be constructed to the dimensions and grades specified below, except as modified by the plans or as directed by the Engineer.

- (a) Entrance. The minimum width shall be 3.6 m (12 ft.). The minimum compacted thickness shall be 150 mm (6 in.). The maximum grade shall be eight percent, except as required to match the existing grade.
- (b) Commercial Entrance. The minimum width shall be 7.2 m (24 ft.). The minimum compacted thickness shall be 230 mm (6 in.). The maximum grade shall be six percent, except as required to match the existing grade.
- (c) Road/Staging Area. The minimum width shall be 7.2 m (24 ft.). The minimum compacted thickness shall be 230 mm (6 in.). The grade and elevation shall be the same as the removed pavement, except as required to meet the grade of any new pavement constructed.

Aggregate surface course shall be used to construct a staging area along the loading docks at EMCO Chemical Distributors, Inc. for trucks waiting to enter the loading docks.

Maintaining the temporary access shall include relocating and/or regrading the aggregate surface coarse for any operation that may disturb or remove the temporary access. The same type and gradation of material used to construct the temporary access shall be used to maintain it.

When use of the temporary access is discontinued, the aggregate shall be removed and Utilized in the permanent construction or disposed of according to Article 202.03.

Aggregate surface course for temporary access will be measured for payment as ton based on computer generated truck weight tickets from an approved scale for every private entrance, commercial-entrance or road-constructed for the purpose of temporary access. If a residential drive or commercial entrance is to be constructed under multiple stages, the aggregate needed to construct the subsequent stages will not be measured for payment but shall be considered incidental to the initial temporary access provided.

Aggregate surface course for temporary access will be paid for at the contract unit price per ton for AGGREGATE SURFACE COURSE, TYPE B.

Partial Payment of the each amount bid for temporary access, of the types specified, will be paid according to the following schedule:

a) Upon construction of the temporary access, sixty percent of the contract unit price per each, of the type constructed, will be paid.

Subject to the approval of the Engineer for the adequate maintenance and removal of the temporary access, the remaining forty percent of the pay item will be paid upon the permanent removal of the temporary access.

STORM SEWERS, RUBBER GASKET

This work consists of constructing storm sewers of the required inside diameter with the necessary fittings crossing water main, at the locations shown on the plans, meeting the material and installation requirements in Section 41 of the latest edition of the "Standard Specifications for Water and Sewer Main Construction in Illinois", and the applicable portions of Section 550 of the Standard Specifications.

Rubber gasket joints shall meet the standard specifications of ASTM Designation C 443. The joints shall be approved by the Illinois Environmental Protection Agency for storm sewer lines crossing above water main.

Basis of Payment: This work will be paid for in accordance with Article 550.09 of the Standard Specifications at the contract unit price per foot for STORM SEWERS, RUBBER GASKET of the class, type, and diameter specified.

CONCRETE RETAINING WALL REMOVAL

This work shall consist of the removal and disposal of existing concrete retaining walls at

locations as shown on the plans or directed by the Engineer. The concrete retaining walls shall be removed and disposed of as specified in the applicable portions of Section 501 of the Standard Specifications.

This work shall be paid for at the contract unit price per foot for CONCRETE RETAINING WALL REMOVAL measured as removed, which price shall include all equipment and labor necessary to complete this work as specified.

HANDRAIL REMOVAL

This work shall consist of the removal and disposal of existing pipe handrails at locations shown on the plans or directed by the Engineer.

This work shall be paid for at the contract unit price per foot for HANDRAIL REMOVAL measured as removed, which price shall include all equipment and labor necessary to complete this work as specified.

FIRE HYDRANTS TO BE REMOVED

This work shall consist of the removal of the existing fire hydrants at the locations shown on the Plans, in accordance with this Special Provision and as directed by the Engineer.

The work shall consist of shutting off the fire hydrant service valve, removing the fire hydrant assembly, capping the water service line, and removing the valve box over the service valve. Any excavation required to remove the hydrant and valve box, shall be considered incidental to the pay item. Any excavated material shall be properly disposed of at a suitable offsite location. The hole formed by the removal shall be backfilled with granular backfill (incidental to the pay item). The Contractor shall coordinate with the City for the shutdown of all fire hydrants so that the Fire Department is accurately aware of which fire hydrants are operable.

The removed hydrants shall be returned by the Contractor to the City's storage yard.

This work shall not be performed until the new work has been accepted by the City in order to provide uninterrupted service to the affected property owners.

This work shall be paid for at the contract unit price per each for FIRE HYDRANTS TO BE REMOVED, which price shall include all labor, material and equipment necessary to complete the work as described above.

<u>MANHOLES, SANITARY</u> <u>MANHOLES, SANITARY WITH OUTSIDE DROP CONNECTION</u>

This work shall be done in accordance with Section 32 of the Water and Sewer Main Specifications and the detail shown on the Plans.

The pay item shall include furnishing and installing Type 1 frames and self sealing closed lid, chimney seal (external or internal) and flexible boot for inlet and outlet pipes.

All manholes shall be inspected and leakage tested in accordance with ASTM C1244-93 or C969-94. This work shall be included in the price of the manhole.

Measurement. The manholes shall be measured per each regardless of depth. Outside drop connections shall not be measured separately but shall be included in the price of the manhole.

Payment. MANHOLES, SANITARY and MANHOLES, SANITARY WITH OUTSIDE DROP CONNECTION shall be paid for at the contract unit price per each of the diameter specified, and with the type of frame and grate or frame and lid specified, and include all labor, equipment and materials to perform the work as described above.

VALVE VAULTS, 5'-DIAMETER

This work shall consist of constructing valve vaults with castings at the location of new valves installed on this project, in accordance with the details on the Plans and the applicable portions of Section 33 of the Water and Sewer Main Specifications. Valve vaults shall be precast reinforced concrete with precast reinforced concrete bottoms. Unless otherwise shown, the pipe openings in the barrel section shall be located so that the water main will pass through the center of the vault structure. Concentric cone sections shall be provided at all vaults, unless the depth of cover over the main is such that a short barrel section and flat top (with offset opening) are required to allow the frame and lid to meet finish grade.

The valve vaults shall have gray cast iron steps conforming to ASTM A-48, integrally cast into sidewalls. Barrel and cone sections shall be set so as to provide a vertical alignment of all steps. Concrete adjusting rings up to a maximum total adjustment of eight inches may be used to bring the rim of the casting to final grade. The vault shall be provided with a Type 1 frame with a self sealing closed lid. The closed lid shall be marked with the word "<u>WATER</u>".

All barrel and cone sections shall be fully bedded in a rubber gasket joint. Inside and outside the vault, joints between sections shall be filled with mortar and given a brushed finish.

This work will be paid for at the contract unit price per each for VALVE VAULTS, 5' DIAMETER which price shall include all materials, labor and equipment necessary to excavate for and construct the complete vault structure, including frame and lid, and backfill, except in areas where trench backfill is required.

VALVE BOXES 6"

This work shall consist of furnishing and installing valve boxes at the locations shown on the Plans and where directed by the Engineer.

Valve boxes shall be Mueller cast iron valve boxes No. 664-S with rubber stabilizer or an Engineer approved equal. The lids shall be embossed with "WATER".

The item shall be paid for at the contract unit price per each for VALVE BOXES, of the size specified.

VALVE VAULTS TO BE REMOVED

At locations specified on the plans or at locations specified by the Engineer, this work shall consist of all labor, equipment, and material necessary to remove valve values in accordance with all applicable portions of Section 602 of the Standard Specifications and the detail shown on the plans. Frames and lids shall be salvaged and delivered to the City's storage yard at no additional compensation.

This work shall be paid for at the contract unit price each for VALVE VAULTS TO BE REMOVED.

WATER VALVE AND BOX TO BE REMOVED

At locations specified on the plans or at locations specified by the Engineer, this work shall consist of all labor, equipment, and material necessary to remove and dispose of existing valves and boxes in accordance with all applicable portions of Section 602 of the Standard Specifications.

Cut existing water main at least two feet away from existing valves and plug pipe in accordance with the water main details.

This work shall be paid for at the contract unit price each for WATER VALVE AND BOX TO BE REMOVED.

WATER VALVE BOXES TO BE ABANDONED

At locations specified on the plans or at locations specified by the Engineer, this work shall consist of all labor, equipment, and material necessary to abandon water valve boxes in accordance with the details in the plans. This includes the removal of the lid and top section of the valve box, closing the water valve and backfilling all voids necessary to achieve required compaction for the roadway.

This work shall be paid for at the contract unit price for WATER VALVE BOXES TO BE ABANDONED.

REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES

This work shall be done, measured and paid for in accordance with Section 669 of the IDOT Specifications except as herein modified.

- 1. Worker Safety--Soils and groundwater within the areas of regulated substances identified on the Plans may contain concentrations of volatile organic compounds (VOCs), polychlorinated biphenyls (PCBs), semivolatile organic compounds (SVOCs) and heavy metals that require worker precautions. Contractors shall ensure that all workers be informed of this condition to comply with OSHA Right-to-Know and worker protection regulations. Contractor shall prepare and implement a Site Health and Safety Plan per Article 669.06 of the IDOT Specifications.
- •
- 2. Groundwater Management in Excavations—Groundwater removal in the areas of regulated substances shall be minimized to the extent practical. Backfill plugs shall be installed by Contractor per Article 669.09 of the IDOT Specifications to minimize the amount of groundwater management during the work. In the event groundwater is required to be removed from the trench excavation, such water shall be pumped to a temporary on-site holding tank provided by the contractor. The holding tank shall be of sufficient volume to accommodate the amount of water anticipated to be removed from the trench excavation. The holding tank shall be of sufficient volume to accommodate the amount of water anticipated to be removed from the on-site tank(s). Groundwater within the tank shall be composite sampled and analyzed for target analyte compounds at an IEPA certified laboratory. The results of analysis shall be provided to the ENGINEER within 7 days of sample collection. Based on the results of the water quality analysis, the ENGINEER will direct final disposition of

the stored groundwater. Groundwater shall be transported via bulk tanker truck to a licensed commercial or municipal wastewater treatment facility for final treatment and disposal. Contractor shall specify the treatment facility(ies), subject to Engineer approval.

- 3. Soil Management—Soil excavated from water main trenches in the areas of regulated substances may only be placed back in the trench as backfill within the boundary of the areas it was removed from when such area will be re-surfaced by Portland cement or bituminous concrete under this Contract work. Any surplus trench soils from the areas of regulated substances shall be transported to a licensed disposal facility, based on the designation of soil encountered (non-hazardous special waste [Subtitle D Landfill] or hazardous waste [Subtitle C Landfill]), subject to ENGINEER approval. All on-site and off-site soil backfill sources are subject to approval of the ENGINEER. The Contractor shall have soils designated for landfill disposal analyzed by a chemical laboratory for those parameters necessary to obtain a waste profile approval at the Subtitle C and Subtitle D landfill. This soil sample testing is designated as Soil Disposal Analysis.
- 4. IDOT Specification Article 669.09 related to waste manifest documents is amended by this Special Provisions to indicate that a City of North Chicago waste generator number will be obtained and an authorized representative of the City of North Chicago will sign manifests as generator.

This work shall be measured for payment in accordance with Section 669 of the IDOT Specifications except the quantity of Special Waste Disposal and Hazardous Waste Disposal for which payment will be made will not exceed the volume of the trench as computed by using the maximum trench width permitted by the Special Provisions and the actual depth of trench with a deduction, if any, for the volume of the pipe.

The work shall be paid for as the following contract pay items:-

GENERAL ELECTRICAL REQUIREMENTS

Effective: January 1, 2007

Add the following to Article 801 of the Standard Specifications:

"Maintenance transfer and Preconstruction Inspection:

<u>General.</u> Before performing any excavation, removal, or installation work (electrical or otherwise) at the site, the Contractor shall request a maintenance transfer and preconstruction site inspection, to be held in the presence of the Engineer and a representative of the party or parties responsible for maintenance of any lighting and/or traffic control systems which may be affected by the work. The request for the maintenance transfer and preconstruction inspection shall be made no less than seven (7) calendar days prior to the desired inspection date. The maintenance transfer and preconstruction shall:

Establish the procedures for formal transfer of maintenance responsibility required for the construction period.

Establish the approximate location and operating condition of lighting and/or traffic control systems which may be affected by the work

<u>Marking of Existing Cable Systems</u>. The party responsible for maintenance of any existing lighting and/or traffic control systems at the project site will, at the Contractor's request, mark and/or stake, once per location, all underground cable routes owned or maintained by the State. A project may involve multiple "locations" where separated electrical systems are involved (i.e. different controllers). The markings shall be taken to have a horizontal tolerance of at least 304.8 mm (one (1) foot) to either side.. The request for the cable locations and marking shall be made at the same time the request for the maintenance transfer and preconstruction inspection is made. The Contractor shall exercise extreme caution where existing buried cable runs are involved. The markings of existing systems are made strictly for assistance to the Contractor and this does not relieve the Contractor

of responsibility for the repair or replacement of any cable run damaged in the course of his work, as specified elsewhere herein. Note that the contractor shall be entitled to only one request for location marking of existing systems and that multiple requests may only be honored at the contractor's expense. No locates will be made after maintenance is transferred, unless it is at the contractor's expense.

<u>Condition of Existing Systems</u>. The Contractor shall conduct an inventory of all existing electrical system equipment within the project limits, which may be affected by the work, making note of any parts which are found broken or missing, defective or malfunctioning. Megger and load readings shall be taken for all existing circuits which will remain in place or be modified. If a circuit is to be taken out in its entirety, then readings do not have to be taken. The inventory and test data shall be reviewed with and approved by the Engineer and a record of the inventory shall be submitted to the Engineer for the record. Without such a record, all systems transferred to the Contractor for maintenance during construction shall be returned at the end of construction in complete, fully operating condition."

Revise the 6th paragraph of Article 801.05(a) of the Standard Specifications to read:

<u>"Resubmittals</u>. All submitted items reviewed and marked 'APPROVED AS NOTED', or 'DISAPPROVED' are to be resubmitted in their entirety with a disposition of previous comments to verify contract compliance at no additional cost to the state unless otherwise indicated within the submittal comments."

Revise Article 801.11(a) of the Standard Specifications to read:

"<u>Lighting Operation and Maintenance Responsibility</u>. The scope of work shall include the assumption of responsibility for the continuing operation and maintenance the of existing, proposed, temporary, sign and navigation lighting, or other lighting systems and all appurtenances affected by the work as specified elsewhere herein. Maintenance of lighting systems will be paid for separately"

Add the following to Section 801.11(a) of the Standard Specifications:

<u>"Energy and Demand Charges.</u> The payment of basic energy and demand charges by the electric utility for existing lighting which remains in service will continue as a responsibility of the Owner, unless otherwise indicated. Unless otherwise indicated or required by the Engineer duplicate lighting systems (such as temporary lighting

and proposed new lighting) shall not be operated simultaneously at the Owner's expense and lighting systems shall not be kept in operation during long daytime periods at the Owner's expense. Upon written authorization from the Engineer to place a proposed new lighting system in service, whether the system has passed final acceptance or not, (such as to allow temporary lighting to be removed), the Owner will accept responsibility for energy and demand charges for such lighting, effective the date of authorization. All other energy and demand payments to the utility shall be the responsibility of the Contractor until final acceptance."

Add the following to Section 801 of the Standard Specifications:

"Lighting Cable Identification. Each wire installed shall be identified with its complete circuit number at each termination, splice, junction box or other location where the wire is accessible."

"Lighting Cable Fuse Installation. Standard fuse holders shall be used on non-frangible (non-breakaway) light pole installations and quick-disconnect fuse holders shall be used on frangible (breakaway) light pole installations. Wires shall be carefully stripped only as far as needed for connection to the device. Over-stripping shall be avoided. An oxide inhibiting lubricant shall be applied to the wire for minimum connection resistance before the terminals are crimped-on. Crimping shall be performed in accordance with the fuse holder manufacturer's recommendations. The exposed metal connecting portion of the assembly shall be taped with two half-lapped wraps of electrical tape and then covered by the specified insulating boot. The fuse holder shall be installed such that the fuse side is connected to the pole wire (load side) and the receptacle side of the holder is connected to the line side."

Revise the 2^{nd} and 3^{rd} sentences of the second paragraph of Article 801.02 of the Standard Specifications to read:

"Unless otherwise indicated, materials and equipment shall bear the UL label, or an approved equivalent, whenever such labeling is available for the type of material or equipment being furnished."

ELECTRIC SERVICE INSTALLATION

Effective: January 1, 2007

Description. This item shall consist of all material and labor required to extend, connect or modify the electric services, as indicated or specified, which is over and above the work performed by the utility. Unless otherwise indicated, the cost for the utility work, if any, will be reimbursed to the Contractor separately under ELECTRIC UTILITY SERVICE CONNECTION. This item may apply to the work at more than one service location and each will be paid separately.

<u>Materials</u>. Materials shall be in accordance with the corresponding material Articles for the materials being used under this pay item.

CONSTRUCTION REQUIREMENTS

General. The Contractor shall ascertain the work being provided by the electric utility and shall provide all additional material and work not covered by contract pay items required to complete the electric service work in complete compliance with the requirements of the utility.

No additional compensation will be allowed for work required for the electric service, even though not explicitly shown on the Drawings or specified herein

Method Of Measurement. Electric Service Installation shall be counted, each.

Basis Of Payment. This work will be paid for at the contract unit price each for **ELECTRIC SERVICE INSTALLATION** which shall be payment in full for the work specified herein.

ELECTRIC UTILITY SERVICE CONNECTION (COMED)

Effective: January 1, 2002 Revised February 1, 2005

Description. This item shall consist of payment for work performed by ComEd in providing or modifying electric service as indicated. THIS MAY INVOLVE WORK AT MORE THAN ONE ELECTRIC SERVICE. For summary of the Electrical Service Drop Locations see the schedule contained elsewhere herein.

CONSTRUCTION REQUIREMENTS

<u>General.</u> It shall be the Contractor's responsibility to contact ComEd. The Contractor shall coordinate his work fully with the ComEd both as to the work required and the timing of the

installation. No additional compensation will be granted under this or any other item for extra work caused by failure to meet this requirement. Please contact ComEd, New Business Center Call Center, at 866 NEW ELECTRIC (1-866-639-3532) to begin the service connection process. The Call Center Representatives will create a work order for the service connection. The representative will ask the requestor for information specific to the request. The representative will assign the request based upon the location of project.

The Contractor should make particular note of the need for the earliest attention to arrangements with ComEd for service. In the event of delay by ComEd, no extension of time will be considered applicable for the delay unless the Contractor can produce written evidence of a request for electric service within 30 days of execution.

<u>Method Of Payment</u>. The Contractor will be reimbursed to the exact amount of money as billed by ComEd for its services. Work provided by the Contractor for electric service will be paid separately as described under ELECTRIC SERVICE INSTALLATION. No extra compensation shall be paid to the Contractor for any incidental materials and labor required to fulfill the requirements as shown on the plans and specified herein.

For bidding purposes, this item shall be estimated as \$3,000.

Basis Of Payment. This work will be paid for at the contract lump sum price for **ELECTRIC UTILITY SERVICE CONNECTION** which shall be reimbursement in full for electric utility service charges.

<u>Designers Note</u>: The estimate of cost of service connections for bidding purposes shall be provided by Bureau of Electrical Operations.

<u>GROUND ROD</u>

Effective: January 1, 2007

Description. This item shall consist of furnishing, installing and connecting ground rods for the grounding of service neutral conductors and for supplementing the equipment grounding system via connection at poles or other equipment throughout the system. All materials and work shall be in accordance with Article 250 of the NEC.

Materials. Materials shall be according to the following Articles of Section 1000 - Materials

CONSTRUCTION REQUIREMENTS

<u>General.</u> All connections to ground rods, structural steel or fencing shall be made with exothermic welds. Where such connections are made to insulated conductors, the connection shall be wrapped with at least 4 layers of electrical tape extended 152.4 mm (six inches) onto the conductor insulation.

Ground rods shall be driven so that the tops of the rod are 609.6 mm (24 inches) below finished grade. Where indicated, ground wells shall be included to permit access to the rod connections.

Where indicated, ground rods shall be installed through concrete foundations.

Where ground conditions, such as rock, preclude the installation of the ground rod, the ground rod may be deleted with the approval of the Engineer.

Where a ground field of "made" electrodes is provided, such as at control cabinets, the exact locations of the rods shall be documented by dimensioned drawings as part of the Record Drawings.

Ground rod connection shall be made by exothermic welds. Ground wire for connection to foundation steel or as otherwise indicated shall be stranded uncoated bare copper in accordance the applicable requirements of ASTM Designation B-3 and ASTM Designation B-8 and shall be included in this item. Unless otherwise indicated, the wire shall not be less than No. 2 AWG.

Where connections are made to epoxy coated reinforcing steel, the epoxy coating shall be sufficiently removed to facilitate the exothermic weld.

<u>Method Of Measurement.</u> Ground rods shall be counted, each. Ground wires and connection of ground rods at poles shall be included in this pay item.

Basis Of Payment. This item shall be paid at the contract unit price each for **GROUND ROD**, of the diameter and length indicated which shall be payment in full for the material and work described herein.

UNDERGROUND RACEWAYS

Effective: January 1, 2007

Revise Article 810.03 of the Standard Specifications to read:

"Installation. All underground conduit shall have a minimum depth of 30-inches (700 mm) below the finished grade."

Add the following to Article 810.03 of the Standard Specifications:

"All metal conduit installed underground shall be Rigid Steel Conduit unless otherwise indicated on the plans."

Add the following to Article 810.03 of the Standard Specifications:

"All raceways which extend outside of a structure or duct bank but are not terminated in a cabinet, junction box, pull box, handhole, post, pole, or pedestal shall extend a minimum or 300 mm (12") or the length shown on the plans beyond the structure or duct bank. The end of this extension shall be capped and sealed with a cap designed for the conduit to be capped. The ends of rigid metal conduit to be capped shall be threaded, the threads protected with full galvanizing, and capped with a threaded galvanized steel cap. The ends of rigid nonmetallic conduit and coilable nonmetallic conduit shall be capped with a rigid PVC cap of not less than 3 mm (0.125") thick. The cap shall be sealed to the conduit using a room-temperature-vulcanizing (RTV) sealant compatible with the material of both the cap and the conduit. A washer or similar metal ring shall be glued to the inside center of the cap with epoxy, and the pull cord shall be tied to this ring."

Add the following to Article 810.03(c) of the Standard Specifications:

"Coilable non-metallic conduit shall be machine straightened to remove the longitudinal curvature caused by coiling the conduit onto reels prior to installing in trench, encasing in concrete or embedding in structure. The straightening shall not deform the cross-section of the conduit such that any two measured outside diameters, each from any location and at any orientation around the longitudinal axis along the conduit differ by more than 6 mm (0.25")." The longitudinal axis of the straightened conduit shall not deviate by more than 20 mm per meter (0.25" per foot" from a straight line. The HDPE and straightening mechanism manufacturer operating temperatures shall be followed.

WIRE AND CABLE

Effective: January 1, 2007

Revise the second sentence of the first paragraph of Article 1066.02(a) to read:

"The cable shall be rated at a minimum of 90°C dry and 75°C wet and shall be suitable for installation in wet and dry locations, and shall be resistant to oils and chemicals."

Revise the second paragraph of Article 1066.02(b) to read:

"Uncoated conductors shall be according to ASTM B3, ICEA S-95-658/NEMA WC70, and UL Standard 44. Coated conductors shall be according to ASTM B 33, ASTM B 8, ICEA S-95-658/NEMA WC70 and UL Standard 44."

Revise the third paragraph of Article 1066.02(b) to read:

"All conductors shall be stranded. Stranding meeting ASTM B 8, ICEA S-95-658/NEMA WC70 and UL Standard 44. Uncoated conductors meeting ASTM B 3, ICEA S-95-658/NEMA WC70 and UL Standard 44."

Revise the first sentence of Article 1066.03(a)(1) to read:

"General. Cable insulation designated as XLP shall incorporate cross-linked polyethylene (XLP) insulation as specified and shall meet or exceed the

requirements of ICEA S-95-658, NEMA WC70, U.L. Standard 44."

Add the following to Article 1066.03(a)(1) of the Standard Specifications:

"The cable shall be rated 600 volts and shall be UL Listed Type RHH/RHW/USE."

Revise the Aerial Electric Cable Properties table of Article 1066.03(a)(3) to read:

Aerial Electric Cable Properties

Revise the first paragraph of Article 1066.03(b) to read:

"EPR Insulation. Cable insulation shall incorporate ethylene propylene rubber (EPR) as specified and the insulation shall meet or exceed the requirements of ICEA S-95-658, NEMA Standard Publication No. WC70, and U.L. Standard 44, as applicable."

Add the following to Article 1066.03(b) of the Standard Specifications:

"Cable sized No. 2 AWG and smaller shall be U.L. listed Type RHH/RHW and may be Type RHH/RHW/USE. Cable sized larger than No. 2 AWG shall be U.L. listed Type RHH/RHW/USE."

Revise Article 1066.04 to read:

"Aerial Cable Assembly. The aerial cable shall be an assembly of insulated aluminum conductors according to Section 1066.02 and 1066.03. Unless otherwise indicated, the cable assembly shall be composed of three insulated conductors and a steel reinforced bare aluminum conductor (ACSR) to be used as the ground conductor. Unless otherwise indicated, the code word designation of this cable assembly is "Palomino". The steel reinforced aluminum conductor shall conform to ASTM B-232. The cable shall be assembled according to ANSI/ICEA S-76-474."

Revise the second paragraph of Article 1066.05 to read:

"The tape shall have reinforced metallic detection capabilities consisting of a woven reinforced polyethylene tape with a metallic core or backing."

Revise Article 1066.08 to read:

"Electrical Tape. Electrical tape shall be all weather vinyl plastic tape resistant to abrasion, puncture, flame, oil, acids, alkalies, and weathering, conforming to Federal Specification MIL-I-24391, ASTM D1000 and shall be listed under UL 510 Standard. Thickness shall not be less than 0.215 mm (8.5 mils) and width shall not be less than 20 mm (3/4-inch)."

LUMINAIRE

Effective: January 1, 2007

Add the following to first paragraph of Article 1067(c) of the Standard Specifications:

"The reflector shall not be altered by paint or other opaque coatings which would cover or coat the reflecting surface. Control of the light distribution by any method other than the reflecting material and the aforementioned clear protective coating that will alter the reflective properties of the reflecting surface is unacceptable"

Add the following to Article 1067(e) of the Standard Specifications:

"The ballast shall be a High Pressure Sodium, high power factor, constant

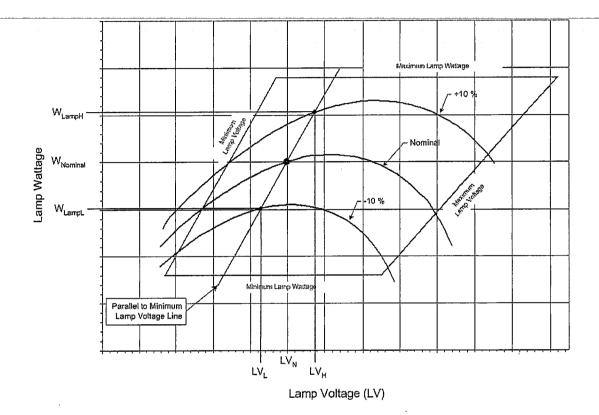
wattage auto-regulator, lead type (CWA) for operation on a nominal 240 volt system."

Revise Article 1067(e)(1) of the Standard Specifications to read:

"The high pressure sodium, auto-regulator, lead type (CWA) ballast shall be designed to ANSI Standards and shall be designed and rated for operation on a nominal 240 volt system. The ballast shall provide positive lamp ignition at the input voltage of 216 volts. It shall operate the lamp over a range of input voltages from 216 to 264 volts without damage to the ballast. It shall provide lamp operation within lamp specifications for rated lamp life at input design voltage range. Operating characteristics shall produce output regulation not exceeding the following values:

Add the following to Article 1067(f) of the Standard Specifications:

"Independent Testing. Independent testing of luminaires shall be required whenever the quantity of luminaires of a given wattage and distribution, as indicated on the plans, is 50 or more. For each luminaire type to be so tested, one luminaire plus one luminaire for each 50 luminaires shall be tested. Example: *A plan quantity of 75 luminaires would dictate that 2 to be tested; 135 luminaires would dictate that three be tested.*" If the luminaire performance table is missing from the contract documents, the luminaire(s) shall be tested and the test results shall be evaluated against the manufacturer's published data. The test luminaire(s) results shall be equal to or better than the published data. If the test results indicated performance not meeting the published data, the test luminaire will be designated as failed and corrective action as described herein shall be performed.

The Contractor shall be responsible for all costs associated with the specified testing, including but not limited to shipping, travel and lodging costs as well as the costs of the tests themselves, all as part of the bid unit price for this item. Travel, lodging and other associated costs for travel by the Engineer shall be direct-billed to or shall be pre-paid by the Contractor, requiring no direct reimbursement to the Engineer or the independent witness, as applicable"

The Contractor shall select one of the following options for the required testing with the Engineer's approval:

a. Engineer Factory Selection for Independent Lab: The Contractor may select this option if the luminaire manufacturing facility is within the state of Illinois. The Contractor shall propose an independent test laboratory for approval by the Engineer. The selected luminaires shall be marked

by the Engineer and shipped to the independent laboratory for tests.

- b. Engineer-Witness-of-Independent-Lab-Test: The Contractor-may-selectthis option if the independent testing laboratory is within the state of Illinois. The Engineer shall select, from the project luminaires at the manufacturer's facility or at the Contractor's storage facility, luminaires for testing by the independent laboratory.
- c. Independent Witness of Manufacturer Testing: The independent witness shall select from the project luminaires at the manufacturers facility or at the Contractor's storage facility, the luminaires for testing. The Contractor shall propose a qualified independent agent, familiar with the luminaire requirements and test procedures, for approval by the Engineer, to witness the required tests as performed by the luminaire manufacturer.

The independent witness shall as a minimum meet the following requirements:

- ▶ Have been involved with roadway lighting design for at least 15 years.
- ▶ Not have been the employee of a luminaire or ballast manufacturer within the last 5 years.
- Not associated in any way (plan preparation, construction or supply) with the particular project being tested.
- Be a member of IESNA in good standing.
- Provide a list of professional references.

This list is not an all inclusive list and the Engineer will make the final determination as to the acceptability of the proposed independent witness.

d. Engineer Factory Selection and Witness of Manufacturer Testing: The Contractor may select this option if the luminaire manufacturing facility is within the state of Illinois. At the Manufacturer's facility, the Engineer shall select the luminaires to be tested and shall be present during the testing process. The Contractor shall schedule travel by the Engineer to and from the Manufacturer's laboratory to witness the performance of the required tests."

Add the following to Article 1067.02(a)(1) of the Standard Specifications:

"The beam of maximum candlepower for luminaires specified or shown to have a 'medium' distribution shall be at 70 degrees from the horizontal \pm 2.5 degrees. Submittal information shall identify the angle."

Revise Article 1067.06(a)(1) of the Standard Specifications to read:

-"The-lamps-shall-be-of-the-clear-type-and-shall-have-a-color-of-1900°-to-2200°--Kelvin."

The following Traffic Signal Special Provisions supplement the above specifications, manuals, and codes. In case of conflict with any part or parts of said documents, these Special Provisions shall take precedence and shall govern.

The following terms and acronyms are used:

The Resident Engineer
The County Traffic Engineer – LCDOT

The construction, installation, modification and/or removal work shall be accomplished at the following intersection(s):

Martin Luther King Jr. Drive and Lewis Avenue Martin Luther King Jr. Drive and Commonwealth Avenue

The intent of this Special Provision is to prescribe the materials and construction methods commonly used in traffic signal installations. All material furnished shall be new. The locations and the details of all installations shall be indicated on the plans or as directed by the Engineer.

The work performed under this contract shall consist of furnishing and installing all traffic signal work as specified on the plans and as specified herein in a manner acceptable and approved by the Engineer.

MAST ARM SIGN PANELS

Add the following to Article 720.02 of the "Standard Specifications":

Signs attached to poles or posts (such as mast arm signs) shall have mounting brackets and sign channels which are equal to and completely interchangeable with those used by LCDOT. All aluminum signs shall have a white reflectorized legend and border on a green reflectorized background, type AZ sheeting. The sign face shall not have any holes. 3M Scotch Joining Systems bonding tape or an approved equal shall be used in place of screws or rivets. The Signfix Aluminum Channel Framing System is currently recommended, but other brands of mounting hardware, or bonding tape may be acceptable based upon LCDOT approval.

INSPECTION OF ELECTRICAL SYSTEMS

Add the following to Article 802.01 of the "Standard Specifications":

All cabinets, including temporary traffic signal cabinets, shall be assembled by an approved equipment supplier in District One. LCDOT reserves the right to request that any controller and cabinet be tested at a District 1 approved equipment supplier's facility prior to field installation. Such testing will be at no extra cost to the contract. All permanent or temporary "railroad

interconnected" controllers and cabinets, shall be newly constructed, built, tested and approved by the controller equipment vendor, in the vendor's District 1 approved facility, prior to field installation. The vendor shall provide the technical equipment and assistance as required by the Engineer to fully test this equipment.

DAMAGE TO TRAFFIC SIGNAL SYSTEM

Revise Article 802.02 of the "Standard Specifications" to read:

Any damaged equipment or equipment not operating properly from any cause whatsoever shall be repaired and/or replaced with new equipment provided by the Contractor at no additional cost to the Contract and/or owner of the traffic signal system, to the satisfaction of the Engineer. Final repairs or replacement of damaged equipment must meet the approval of the Engineer prior to or at the time of final inspection, otherwise the traffic signal installation will not be accepted. Cable splices outside the controller cabinet shall not be allowed.

INTERRUPTION OF COMMUNICATION

The interruption of communication with County equipment shall be kept to an absolute minimum. This includes communication such as controller telemetry, video transmission, camera control. signals, Highway Advisory Radio, wireless interconnect, telephone (POTS/ISDN/DSL), high speed Internet, or any other County communication signals. This provision applies to cable types including copper, multimode fiber optic, singlemode fiber optic, telephone cables, Internet cables, or any other cable used by the County to monitor and maintain its various signal and ITS equipment.

The contractor shall plan ahead, and shall stage his construction work accordingly, so that he can interrupt communication, and then restore communication, with as little down time as possible. For example, when a section of existing interconnect is being relocated, the new handholes and conduits should be installed prior to disconnecting the interconnect cable. The interconnect cable can then be disconnected, pulled out of the existing conduit, pulled through the new conduit, and re-connected. In addition, when an existing fiber optic cable is to be re-used, the contractor shall be prepared to immediately replace any fiber splices and/or terminations that become damaged.

Prior to disconnecting any LCDOT communication link, the contractor shall contact the Traffic Engineer for approval of his planned construction method.

RESTORATION OF WORK AREA

Add to Section 802 of the "Standard Specifications":

Restoration of the traffic signal work area shall be incidental to the related pay item such as

foundation, conduit, handhole, trench and backfill, etc. and no extra compensation shall be allowed. All roadway surfaces such as shoulders, medians, sidewalks, pavement, etc. shall be restored to match the previously existing conditions. All damage to mowed lawns shall be replaced with an approved sod, and all damage to unmowed fields shall be seeded, in accordance with Section 250 and 252 of the "Standard Specifications" respectively.

SUBMITTALS.

Revise Article 802.04 of the "Standard Specifications" to read:

The Contractor shall provide:

- a. All material approval requests shall be submitted a minimum of seven (7) days prior to the delivery of equipment to the job site, or within thirty (30) calendar days after the contract is awarded, or within fifteen (15) calendar days after the preconstruction meeting, whichever is earliest.
- b. Seven (7) copies of a letter listing the manufacturer's name and the model numbers of the proposed equipment. The Traffic Engineer will review the letter and determine whether the proposed equipment is approved for use. The copies will be stamped as "approved", "not approved", or "approved as corrected" and returned to the Contractor.
- c. Two (2) copies of material catalog cuts.
- d. Seven (7) copies of mast arm poles and assemblies drawings.
- e. The contract number or permit number, project location/limits and corresponding pay item number must be on each sheet of the letter, material catalog cuts and mast arm poles and assemblies drawings as required in items b, c and d.
- f. Exceptions, Deviations and Substitutions. In general, exceptions to and deviations from the requirements of the Contract Documents will not be allowed. It is the Contractor's responsibility to note any deviations from Contract requirements at the time of submittal and to make any requests for deviations in writing to the Engineer. In general, substitutions will not be acceptable. Requests for substitutions must demonstrate that the proposed substitution is superior to the material or equipment required by the Contract Documents. No exceptions, deviations or substitutions will be permitted without the approval of the Engineer.

MAINTENANCE AND RESPONSIBILITY.

Revise Article 802.07 of the "Standard Specifications" to read:

a) Existing traffic signal installations and/or any electrical facilities at locations included in this contract may be altered or reconstructed totally or partially as part of the work on this contract. The Contractor is hereby advised that all traffic control equipment presently installed at these locations may be the property of the State of Illinois, Department of Transportation, Division of Highways, County, Private Developer, or the Municipality in

which it is located. Once the Contractor has begun any work on any portion of the project, all traffic signals within the limits of this contract or those which have the pay item MAINTENANCE OF EXISTING TRAFFIC SIGNAL INSTALLATION, TEMPORARY TRAFFIC SIGNAL INSTALLATION, and/or MAINTENANCE OF EXISTING FLASHING BEACON INSTALLATION, shall become the full responsibility of the Contractor. The Contractor shall supply the Engineer and the County's Traffic Signal Maintenance Contractor a 24-hour emergency contact name and telephone number. The Contractor shall provide sufficient qualified personnel to respond to all notifications of malfunctions on a round-the-clock basis (24 hours a day, 7 days a week). The Contractor is required to keep a time and date log of each response, from the time of the initial report to the time of final permanent repair.

- b) When the project has a pay item for MAINTENANCE OF EXISTING TRAFFIC SIGNAL INSTALLATION, TEMPORARY TRAFFIC SIGNAL INSTALLATION, and/or MAINTENANCE OF EXISTING FLASHING BEACON INSTALLATION, the Contractor must notify the Traffic Engineer at (847) 377-7400 of their intent to begin any physical construction work on the project or any portion thereof. This notification must be a minimum of seven (7) working days prior to the start of construction to allow sufficient time for an inspection of the existing traffic signal installation(s) and the transfer of maintenance to the Contractor. If work is started prior to the inspection, maintenance of the traffic signal installation(s) will be immediately transferred to the Contractor without an inspection. The Contractor shall then become responsible for repairing or replacing all equipment that is not operating properly or is damaged at no cost to the owner of the traffic signal. Final repairs to or the replacement of damaged equipment must meet the approval of the Engineer at the time of final inspection or the traffic signal installation will not be accepted.
- c) Contracts that don't include traffic signal installations or modifications, but do include pay items for milling or pavement patching which may result in the destruction of traffic signal loops, do not require maintenance transfer. These contracts do require a notification of intent to work and an inspection. A minimum of seven (7) working days prior to the loop removal, the Contractor shall notify the Traffic Engineer at (847) 377-7400, at which time arrangements will be made to adjust the traffic controller timing to compensate for the absence of detection.
- d) The Contractor is advised that the existing and/or temporary traffic signal installation must remain in operation during all construction stages, except for the most unavoidable down time. Any plan to shutdown the traffic signal installation for a period exceeding fifteen (15) minutes must receive prior approval from the Engineer. Approval to shutdown the traffic signal installation will only be granted during the hours of 9:00 A.M. to 3:00 P.M. on weekdays. Shutdowns will not be allowed during inclement weather, weekends or holiday periods.

e) The Contractor shall be fully responsible for the safe and efficient operation of the traffic signals. Any inquiry, complaint or request by the Division, the County's Traffic Signal-Maintenance Contractor or the public, shall be investigated and repairs started within one hour. Failure to provide this service will result in liquidated damages of \$500 per day per occurrence. In addition, the Contractor shall restore service and complete permanent repairs in accordance with the following <u>Repair Timetable</u>. The Traffic Engineer reserves the right to assign any work not completed within this timeframe to the County's Traffic Signal Maintenance Contractor. All costs associated to repair this uncompleted work shall be the responsibility of the Contractor. Failure to pay these costs to the Traffic Signal Maintenance Contractor within one month after the incident will result in additional liquidated damages of \$500 per month per occurrence. Unpaid bills will be deducted from the cost of the Contract. The County's Traffic Signal Maintenance Contractor any signalizing device on the Division's highway system at any time without notification.

Unless specifically stated to the contrary, all items shall be repaired within the time frame described in the Repair Timetable. The times listed are noncumulative. Any repairs not specifically covered in the Repair Timetable, or described elsewhere, shall be completed within a time frame matching the most similar line item in the Repair Timetable.

TRAFFIC SIGNAL INSPECTION (TURN-ON). Revise Article 802.10 of the "Standard Specifications" to read:

It is LCDOT's intent to have all electric work completed and the equipment field-tested by the vendor, prior to LCDOT's "turn-on" field inspection. The Contractor must have all traffic signal work completed and the electrical service installation connected by the utility company prior to requesting an inspection and "turn-on" of the traffic signal installation. In the event the Traffic Engineer determines that the work is not complete and that the inspection will require more than two (2) hours to complete, the inspection shall be canceled and the Contractor will be required to reschedule at another date.

The Contractor may request a "turn-on" and inspection of the completed traffic signal installation at each separate location. This request must be made to the Traffic Engineer at (847) 377-7400 a minimum of seven (7) working days prior to the time of the requested inspection. LCDOT will not grant a field inspection until the Contractor provides notification that the equipment has been field tested, and the intersection is operating according to contract requirements. The LCDOT facsimile number is (847) 362-5290.

Signal indications being tested shall match the lane configurations and markings at the intersection. If any conflicting signal indications are visible to motorist or pedestrians while testing, the Contractor shall be responsible to provide police officer(s) to direct traffic. In addition, the Contractor shall provide a representative from the control equipment vendor's office to attend the traffic signal inspection for both permanent and temporary traffic signal "turn-ons".

Upon demonstration that the signals are operating properly and that all work has been completed in accordance with the contract and to the satisfaction of the Traffic Engineer, the Traffic Engineer will then allow the signals to be placed in continuous operation. The Agency that is responsible for the maintenance of each traffic signal installation will reassume the traffic signal maintenance upon successful completion of this inspection.

The Lake County Division of Transportation requires the following from the Contractor at Traffic Signal "turn-ons":

- 1. One (1) set of signal plans of record.
- 2. Notification from the Contractor and the equipment vendor that the equipment was satisfactorily field-tested.
- 3. A knowledgeable representative of the controller equipment supplier shall be present at the traffic signal "turn-on". The representative shall be knowledgeable concerning the cabinet design and the controller functions.
- 4. A copy of the approved material letter.
- 5. One (1) copy of the operation and service manuals for the signal controller and the

associated control equipment.

- 6. Five (5) copies (11" x 17") of the cabinet wiring diagrams.
- 7. Five (5) copies of the traffic signal installation cable log.

Acceptance of the traffic signal equipment by LCDOT shall be based on the inspection results at the traffic signal "turn-on". If approved, the traffic signal acceptance shall be given verbally at the "turn-on" inspection, followed by written correspondence from the Traffic Engineer. The Contractor shall be responsible for all traffic signal equipment and associated maintenance thereof until LCDOT acceptance is granted. Any "punch list" work remaining after the installation is accepted shall be completed within thirty (30) calendar days of the acceptance date. If this work is not completed within thirty days, LCDOT reserves the right to have the work completed by others at the Contractor's expense. This cost will be in addition to Liquidated Damages for Untimely Work.

The Contractor shall furnish all equipment and/or parts to keep the traffic signal installation operating.

All cost of work and materials required to comply with the above requirements shall be included in the pay item bid prices, under which the subject materials and signal equipment are paid, and no

additional compensation will be allowed. Materials and signal equipment not complying with the above requirements will be subject to removal and disposal at the Contractor's expense.

LIQUIDATED DAMAGES FOR UNTIMELY WORK

A primary concern of LCDOT is to maintain a safe and efficient roadway for the public. Therefore, the Contractor shall proceed with the traffic signal work as soon as conditions and project staging permit. If in the opinion of the Engineer construction conditions are suitable for traffic signal work, and the Contractor has not yet begun the traffic signal work, the Engineer shall notify the Contractor to proceed. The Contractor shall begin the traffic signal work within seven (7) calendar days after notification to proceed. The Contractor shall continue to prosecute the traffic signal work until completion, or until he can no longer proceed due to conditions beyond his control. The Contractor shall notify the Engineer of any conditions impeding and/or delaying his prosecution of the work. Failure by the Contractor to proceed with the traffic signal work as specified herein shall result in liquidated damages of <u>\$500.00</u> per calendar day per occurrence.

LOCATING UNDERGROUND FACILITIES.

Revise Section 803 of the "Standard Specifications" to read:

Contractor requests for equipment locates will be granted only once prior to the start of the contract. Additional requests shall be at the expense of the Contractor. The location of underground traffic facilities does not relieve the Contractor of their responsibility to repair any item(s) damaged during the construction, at his/her own expense.

Locate requests should be directed to LCDOT's Traffic Signal Maintenance Contractor or to the LCDOT Traffic Engineering Department at (847) 377-7400.

The exact location of all utilities shall be field verified by the Contractor before the installation of any components of the traffic signal system. For locations of utilities call J.U.L.I.E. at **1-800-892-0123**. For the locations of some utilities, other Agencies or Municipalities may need to be contacted.

ELECTRIC SERVICE INSTALLATION.

Revise Section 805 of the "Standard Specifications" to read:

Description. This work shall consist of all materials and labor required to install, modify, or extend the electric service installation. All installations shall meet the requirements of the details in the "District 1 Standard Traffic Signal Design Details" and applicable portions of the Specifications.

Materials.

- a. General. The completed control panel shall be constructed in accordance with UL Std. 508, Industrial Control Panel, and carry the UL label. Wire terminations shall be UL listed.
- b. Enclosures. All electrical service enclosures shall be UL 50, single door design, fabricated from Type 5052 H-32 aluminum. All seams shall be continuous welded and ground smooth, and the cabinet shall be sized to adequately house all required components with extra space for arrangement and termination of wiring. Enclosures shall meet the following additional requirements:
 - 1. Pole Mounted Cabinet. The cabinet shall be NEMA Type 4X. Stainless steel screws and clamps shall secure the cover and assure a watertight seal. The cover shall be removable by pulling the continuous stainless steel hinge pin. The cabinet shall have an oil-resistant gasket and a lock kit shall be provided with an internal O-ring in the locking mechanism assuring a watertight and

dust-tight seal. A minimum size of 14-inches high, 9-inches wide and 8inches deep is required. The cabinet shall be channel mounted to a wooden utility pole using assemblies recommended by the manufacturer.

- 2. Ground Mounted Cabinet. The cabinet shall be NEMA Type 3R with back panel. The cabinet frame and door shall be 0.125-inch thick, the top 0.250-inch thick, and the bottom 0.500-inch thick. The door and door opening shall be double flanged. The door shall be approximately 80% of the front surface, with a full-length tamperproof stainless steel .075-inch thick hinge bolted to the cabinet with stainless steel carriage bolts and nylock nuts. The locking mechanism shall be slam-latch type with a keyhole cover. A minimum size of 40-inches high, 16-inches wide, and 15-inches deep is required. The cabinet shall be mounted upon a square Type A concrete foundation as indicated on the plans. The foundation is paid for separately.
- c. Surge Protector. Overvoltage protection, with LED indicator, shall be provided for the 120-volt load circuit by the means MOV and thermal fusing technology. The response time shall be <5n seconds and operate within a range of -40C to +85C. The surge protector shall be UL 1449 Listed.
- d. Circuit Breakers. Circuit breakers shall be standard UL listed molded case, thermalmagnetic bolt-on type, with trip-free indicating handles. 120-volt circuit breakers shall have an interrupting rating of not less than 65,000 rms symmetrical amperes. Unless otherwise indicated, the main disconnect circuit breaker for the traffic signal controller shall be rated 60 amperes, 120 V and the auxiliary circuit breakers shall be rated 10 amperes, 120 V.
- e. Fuses, Fuseholders and Power Indicating Light. Fuses shall be small-dimensional cylindrical fuses of the dual element time-delay type. The fuses shall be rated for 600 V AC and shall have a UL listed interrupting rating of not less than 10,000 rms symmetrical amperes at rated voltage. The power indicating light shall be LED type with a green colored lens and shall be energized when electric utility power is present.
- f. Ground and Neutral Bus Bars. A single copper ground and neutral bus bar, mounted on the equipment panel shall be provided. Ground and neutral conductors shall be separated on the bus bar. Compression lugs, plus 2 spare lugs, shall be sized to accommodate the cables with the heads of the connector screws painted green for ground connections and white for neutral connections.

- g. Utility Services Connection. The Contractor shall notify the Utility Company marketing representative a minimum of 30 working days prior to the anticipated date of hook-up. This 30-day advance notification will begin only after the Utility-Company marketing representative has received service charge payments from the Contractor. Prior to contacting the Utility Company for service connection, the service installation controller cabinet and cable must be installed for inspection by the Utility Company.
- h. Ground Rod. Ground rods shall be copper-clad steel, a minimum of 10-feet in length, and ³/₄-inch in diameter. Ground rod resistance measurements to ground shall be 25 ohms or less. If necessary additional rods shall be installed to meet resistance requirements at no additional cost to the contract.

Installation

- a. General. The Contractor shall confirm the orientation of the traffic service installation and its door side with the Engineer, prior to installation. All conduit entrances into the service installation shall be sealed with a pliable waterproof material.
- b. Pole Mounted. Brackets designed for pole mounting shall be used. All mounting hardware shall be stainless steel. Mounting height shall be as noted on the plans or as directed by the Engineer.
- c. Ground Mounted. The service installation shall be mounted plumb and level on the foundation and fastened to the anchor bolts with hot-dipped galvanized or stainless steel nuts and washers. The space between the bottom of the enclosure and the top of the foundation shall be caulked at the base with silicone.

Basis of Payment. The service installation shall be paid for at the contract unit price each for SERVICE INSTALLATION of the type specified which shall be payment in full for furnishing and installing the service installation complete. The type A foundation which includes the ground rod shall be paid for separately. SERVICE INSTALLATION, POLE MOUNTED shall include the ³/₄-inch grounding conduit, ground rod, and pole mount assembly. Any changes by the utility companies shall be approved by the Engineer and paid for as an addition to the contract according to Article 109.05 of the "Standard Specifications".

GROUNDING OF TRAFFIC SIGNAL SYSTEMS.

Revise Section 807 of the "Standard Specifications" to read:

General. All traffic signal systems, equipment and appurtenances shall be properly grounded in

strict conformance with the NEC. See IDOT District 1 Traffic Signal detail plan sheet for additional information.

The grounding electrode system shall include a ground rod installed in <u>all</u> foundations, and the service installation. An additional ground rod will be required at locations where measured resistance to ground exceeds 25 ohms. Ground rods are included in the associated pay items and will not be paid for separately. Testing shall be according to Article 801.11.

- a) The grounded conductor (neutral conductor) shall be white color-coded. This conductor shall be bonded to the equipment-grounding conductor only at the Electric Service Installation. All power cables shall include one neutral conductor of the same size.
- b) The equipment-grounding conductor shall be green color-coded. The following is in addition to Article 801.14 of the "Standard Specifications".
 - Equipment-grounding conductors shall be XLP insulated No. 6, unless otherwise noted on the plans, and bonded to the grounded conductor (neutral conductor) only at the electric service Installation. The Earth shall not be used as the equipment-grounding conductor, and no splices shall be allowed in the cable between ground rods. The equipmentgrounding conductor is paid for separately.
 - 2) Equipment-grounding conductors shall be bonded, using a Listed grounding connector, to all traffic signal mast arm poles, traffic signal posts, pedestrian posts, pull boxes, handhole frames and covers and other metallic enclosures throughout the traffic signal wiring system, except where noted herein. A Listed electrical joint compound shall be applied to all conductors' terminations, connector threads and contact points.
 - 3) All metallic and non-metallic raceways containing traffic signal circuit runs shall have a continuous equipment-grounding conductor, with the following exceptions: Raceways containing only detector loop lead-in circuits, circuits under 50 volts and/or fiber optic cable will not be required to include an equipment-grounding conductor.
- c) The grounding electrode conductor shall be similar to the equipment-grounding conductor in color coding (green) and size. The grounding electrode conductor is used to connect the ground rod to the equipment-grounding conductor and is bonded to ground rods via exothermic welding, listed pressure connectors, listed clamps or other approved listed means.

GROUNDING EXISTING HANDHOLE FRAME AND COVER

This work shall consist of all materials and labor required to bond the equipment-grounding conductor to the existing handhole frame and handhole cover. All installations shall meet the requirements of the details in the "District One Standard Traffic Signal Design Details" and

applicable portions of the Specifications.

The equipment-grounding conductor shall be bonded to the handhole frame and to the handhole cover. Two (2) ¹/₂-inch diameter x 1 ¹/₄-inch long hex-head stainless steel bolts, spaced 1.75-inches apart center-to-center shall be fully welded to the frame and to the cover to accommodate a heavy duty Listed grounding compression terminal (Burndy type YGHA or approved equal). The grounding compression terminal shall be secured to the bolts with stainless steel split-lock washers and nylon-insert locknuts.

Welding preparation for the stainless steel bolt hex-head to the frame and to the cover shall include thoroughly cleaning the contact and weldment area of all rust, dirt and contaminates. The Contractor shall assure a solid strong weld. The welds shall be smooth and thoroughly cleaned of flux and spatter. The grounding installation shall not affect the proper seating of the cover when closed.

The grounding cable shall be paid for separately.

Basis of Payment: This work shall be paid for at the contract unit price each for GROUNDING EXISTING HANDHOLE FRAME AND COVER, which shall be payment in full for grounding one handhole complete, regardless of the type of handhole or its location.

GROUNDING CABLE.

The cable shall meet the requirements of Section 817 of the "Standard Specifications", except for the following:

Add to Article 817.02 of the "Standard Specifications":

Unless otherwise noted on the Plans, the system grounding cable shall be one conductor, #6 gauge copper, with an XLP jacket.

The traffic signal grounding conductor (system grounding cable) shall be bonded, using a Listed grounding connector (Burndy type KC/K2C, as applicable, or approved equal), to all new and existing traffic signal mast arm poles and traffic/pedestrian signal posts, including push button posts. The grounding conductor shall be bonded to all new and existing pull boxes, handhole frames and covers and other metallic enclosures throughout the traffic signal wiring system and noted herein and detailed on the plans. Bonding to existing handhole frames and covers shall be paid for separately.

Add the following to Article 817.05 of the "Standard Specifications":

Basis of Payment. Payment shall be at the Contract unit price, per foot, for ELECTRIC CABLE IN CONDUIT, GROUNDING, NO. 6, 1C, which price includes all associated labor and material including grounding clamps, splicing, exothermic welds/other Listed connectors and hardware.

CONDUIT IN GROUND.

The conduit shall meet the requirements of Section 810 of the "Standard Specifications", except for the following:

Delete Article 810.01 of the "Standard Specifications" and add the following:

Description. This item shall consist of furnishing and installing galvanized steel conduit, fittings and accessories in the ground, either pushed, trenched, plowed, or directionally bored, with fittings complete as specified herein and as shown on the Contract drawings.

Add the following to Article 810.03 of the "Standard Specifications":

Pavement, driveways, and curbs shall not be removed to install electrical conduits. All buried conduits shall be placed at a minimum depth of 30 inches, except under railroad tracks, where the minimum depth shall be five (5) feet, as measured from the final surface grade to the top of the conduit. All conduit couplings shall be threaded. Conduits terminating in junction and pull boxes shall be terminated with hubs.

When empty conduit is installed for future traffic signal interconnects(s), the Contractor shall provide a pull line within the conduit.

Revise Article 810.05 of the "Standard Specifications" to read:

Basis of Payment: This work will be paid for at the contract unit price per foot for CONDUIT IN GROUND of the type and size specified, which price shall be payment in full for furnishing and installing the conduit either pushed, trenched, plowed, or directionally bored with fittings, complete. Trenching, backfilling and area restoration are incidental to the cost of this item.

HANDHOLES.

Add the following to Section 814 of the "Standard Specifications":

All handholes shall be cast-in-place concrete, with a minimum inside dimension of 21-1/2 inches. Frames and lid openings shall match this dimension. The minimum wall thickness for heavy-duty hand holes shall be 12 inches. The handhole cover shall be labeled "Traffic Signals" with legible raised letters.

All conduits shall enter the handhole at a minimum depth of thirty (30) inches. However, the depth of conduit from detector loops located less than five (5) feet from the handhole may be less than thirty (30) inches.

All cable hooks shall be hot-dipped galvanized in accordance with AASHTO Specification M111. Hooks shall be a minimum of 3/8-inch diameter and extend into the handhole at least 6 inches. Hooks shall be placed a minimum of 12 inches below the lid, or lower if additional space is required. All cable hooks shall be secured with a retaining nut tightened against the handhole concrete.

RAILROAD INTERCONNECT CABLE.

The cable shall meet the requirements of Section 817 of the "Standard Specifications", except for the following:

Add the following to Article 817.02 of the "Standard Specifications":

The cable shall be three conductor standard #14 copper cable in a clear polyester binder, shielded with #36 AWG tinned copper braid with 85% coverage, and insulated with .016 inch polyethylene (black, blue, red). The jacket shall be black 0.045 PVC or polyethylene.

Revise Article 817.05 of the "Standard Specifications" to read:

Basis of Payment. This work shall be paid for at the contract unit price per foot for ELECTRIC CABLE IN CONDUIT, RAILROAD, NO. 14, 3C, which price shall be payment in full for furnishing, installing, and making all electrical connections in the traffic signal controller cabinet. Connections in the railroad controller cabinet shall be performed by railroad personnel.

MAINTENANCE OF EXISTING TRAFFIC SIGNAL INSTALLATION.

Revise Section 850 of the "Standard Specifications" to read:

The Contractor shall not be required to pay the energy charges for the operation of the existing traffic signal installation. Full maintenance responsibility shall start as soon as the Contractor begins any physical work on the Contract or any portion thereof.

The Contractor shall have electricians on staff with IMSA Level II certification to provide signal maintenance.

This item shall include maintenance of all traffic signal equipment at the intersection, including cameras, emergency vehicle pre-emption equipment, master controllers, telephone service installations, communication cables and conduits to adjacent intersections.

The maintenance shall be according to Article 802.07 of the "Standard Specifications", and the following contained herein.

The Contractor shall check all controllers every two (2) weeks, which will include visually inspecting all timing intervals, relays, detectors, and pre-emption equipment to ensure that they are functioning properly. This item includes, as routine maintenance, all portions of the emergency vehicle pre-emption system. The Contractor shall maintain in stock at all times a sufficient amount of materials and equipment to provide effective temporary and permanent repairs.

The Contractor shall provide immediate corrective action when any part or parts of the system fail to function properly. Two (2) far side heads facing each approach shall be considered the minimum acceptable signal operation pending permanent repairs. When repairs at a signalized intersection require that the controller be disconnected, and power is available, the Contractor shall place the traffic signal installation on flashing operation. The signals shall flash RED for all directions unless a different indication has been specified by the Engineer. The Contractor shall be required to place at least 2 STOP signs (R1-1-36) at each approach of the intersection as a temporary means of regulating traffic. At approaches where a yellow flashing indication is necessary, as directed by the Engineer, STOP signs will not be required. The Contractor shall furnish and equip all their signal maintenance vehicles with a sufficient number of STOP signs as specified herein. The Contractor shall maintain a sufficient number of spare STOP signs in stock at all times to replace those which may be damaged or stolen.

The Contractor shall provide the Engineer with a 24-hour telephone number for traffic signal maintenance. The Contractor, or his representative, shall be available on a 24-hour basis to respond to emergency calls by the Traffic Engineer or other parties.

Traffic signal equipment which is lost or not returned to the County for any reason shall be replaced with new equipment meeting the requirements of these Specifications.

The Contractor shall respond to all emergency calls from the County or others within one hour after notification and provide immediate corrective action. When equipment has been damaged or becomes faulty beyond repair, the Contractor shall replace it with new and identical equipment. The cost of furnishing and installing the replaced equipment shall be borne by the Contractor at no additional charge to the County. The Contractor may institute action to recover damages from a responsible third party. If at any time the Contractor fails to perform all work as specified herein to keep the traffic signal installation in proper operating condition or if the

Engineer cannot contact the Contractor's designated personnel, the Engineer shall have the County's Traffic Signal Maintenance Contractor perform the maintenance work required. The County's Traffic Signal Maintenance Contractor shall bill the Contractor for the total cost of the work. The Contractor shall pay this bill within thirty (30) days of the date of receipt of the invoice or the cost of such work will be deducted from the amount due the Contractor. The Contractor shall allow the County's Traffic Signal Maintenance Contractor to make reviews of the existing traffic signal installation that has been transferred to the Contractor for maintenance.

Basis of Payment. This work shall be paid for at the contract unit price each for MAINTENANCE OF EXISTING TRAFFIC SIGNAL INSTALLATION.

TRAFFIC-ACTUATED CONTROLLER.

Add the following to Section 857 of the "Standard Specifications":

The controller shall be the latest model available that is compatible with "*icons*" software (NTCIP) or "Aries" software, currently in use by LCDOT, and shall be NEMA TS2 Type 1 compatible, unless specified otherwise on the plans. Controller software compatibility requirements are based upon the controller's location in the communication system, and shall be as shown on the plans. The controller shall be equipped with an Ethernet port and a removable data key to save the controller database. Only controllers supplied by approved District 1 closed-loop equipment manufacturers will be allowed. The controller shall be the most recent model and software version supplied by the manufacturer. The traffic signal controller shall provide features to inhibit simultaneous display of circular yellow and yellow arrow indications.

INTERSECTION MONITOR MODULE

This item shall consist of furnishing and installing an Intersection Monitor (IM) Module or Intersection Monitor (IM) Data Key manufactured by the Econolite Corporation as a replacement or addition to an existing traffic signal controller. This item is necessary at isolated (non-interconnected) traffic signals in order to monitor the intersection and controller operations. The IM module is required in ASC/2 controllers and the IM Data Key is required in ASC/3 controllers.

Basis of Payment: This item will be paid for at the contract unit price each for INTERSECTION MONITOR MODULE, which price shall be payment in full for furnishing and installing the module (or Data Key) complete with all necessary connections and equipment for proper operations.

MASTER CONTROLLER.

Revise Articles 860.02 and 860.03 of the "Standard Specifications" to read:

The Master Controller shall be the latest model available that is compatible with "Aries" software, currently in use by LCDOT. The minimum baud rate for fiber optic interconnected signal systems shall be 9600 bps.

Functional requirements in addition to those in Section 863 of the Standard Specification include:

The cabinet shall be provided with an outdoor network interface for termination of the telephone service. It shall be mounted to the inside of the cabinet in a location suitable to provide access for termination of the telephone service at a later date. The interface shall be equipped with a standard Three-Electrode Heavy Duty Gas Tube Surge Arrestor. The cabinet shall be equipped with a US robotics modem, minimum 56K baud rate or approved equal.

FIBER OPTIC CABLE.

Revise Section 871 of the "Standard Specifications" to read:

This work shall consist of furnishing and installing Fiber Optical cable in conduit with all accessories and connectors according to Section 871 of the "Standard Specifications". The cable shall be of the type, size, and the number of fibers specified, with six fibers per tube.

The control cabinet distribution enclosure(s) shall be Corning Model WCH-02P, WCH-04P, or an approved equivalent, capable of accommodating the required number of fibers.

Both ends of each section of fiber optic cable being installed shall be spliced and/or terminated with approved mechanical connectors according to the following: This includes installing approved mechanical connectors on existing fibers that are being joined to the new fiber optic cable.

<u>Multimode</u>: The contractor shall coordinate with the equipment vendor, and shall terminate as many multimode fibers as are necessary to establish proper communications with signal controllers and/or video transmission equipment. In addition, the contractor shall terminate four unused multimode fibers, and shall label them "spare". All multimode terminations shall be ST compatible connectors with ceramic ferrules.

Singlemode: The contractor shall splice and/or terminate the number of singlemode fibers shown on the project plans, if any. Singlemode fiber terminations shall utilize pre-fabricated,

factory-terminated pigtails fusion spliced to bare fibers. All fusion splices shall be secured on Corning splice trays, Models M67-068, M67-110, or approved equivalent, capable of accommodating the required number of fusion splices. Unused fibers terminated according to the plans shall be labeled "spare". All single-mode connectors shall be SC compatible, with ceramic ferrules.

Fibers not attached to the distribution enclosure shall be capped and sealed. A minimum of 13 feet of slack cable shall be provided for the controller cabinet. The controller cabinet slack cable shall be stored as directed by the Engineer.

Fiber Optic cable may be gel filled or have an approved water blocking tape.

Basis of Payment. The work shall be paid for at the contract unit price per foot for FIBER OPTIC CABLE IN CONDUIT, NO. 62.5/125, 24 FIBER (12 MULTIMODE AND 12 SINGLEMODE) or FIBER OPTIC CABLE IN CONDUIT, NO. 62.5/125, 36 FIBER (12 MULTIMODE AND 24 SINGLEMODE) for the cable in place, including distribution enclosure(s), all connectors, pigtails, splice trays, and the required number of terminations described above. Additional fiber terminations and/or splices required by the Engineer, (not included in this item), shall be paid for as TERMINATE FIBER IN CABINET and/or SPLICE FIBER IN CABINET.

TERMINATE FIBER IN CABINET.

This work shall consist of terminating existing or new fibers in field cabinets or buildings as indicated on the plans or as directed by the Engineer.

All multi-mode connectors shall be ST compatible, with ceramic ferrules. Singlemode fiber terminations shall utilize pre-fabricated, factory-terminated (SC compatible) pigtails fusion spliced to bare fibers. All fusion splices shall be secured on Corning splice trays, Models M67-068, M67-110, or approved equivalent, capable of accommodating the required number of fusion splices. Splice trays shall be incidental to TERMINATE FIBER IN CABINET, and shall not be paid for separately.

The quality of all fiber splices shall be verified by testing and documentation in accordance with Article 802.08(b) of the "Standard Specifications", to the satisfaction of the Engineer.

Basis of Payment: This work shall be paid for at the contract unit price each for each fiber terminated in a field cabinet or inside a building as TERMINATE FIBER IN CABINET, which will be payment in full for terminating each required multimode or singlemode fiber, including all connectors, pigtails, splice trays, testing and documentation. The splicing of pigtails for singlemode fibers is included in the cost of TERMINATE FIBER IN CABINET, and shall not be paid for

separately. This pay item shall <u>not</u> be used to pay for fiber terminations and/or splices completed to meet the requirements of FIBER OPTIC CABLE IN CONDUIT.

SPLICE FIBER IN CABINET.

This work shall consist of fusion splicing singlemode fibers in a field cabinet or inside a building as indicated on the plans and as directed by the Engineer. Splices shall be secured in fiber optic splice trays within fiber optic distribution enclosures. The splice trays shall be Corning Models M67-068, M67-110, or approved equivalent, capable of accommodating the required number of fusion splices. Splice trays shall be incidental to SPLICE FIBER IN CABINET and shall not be paid for separately. The quality of all fiber splices shall be verified by testing and documentation in accordance with Article 802.08(b) of the "Standard Specifications", to the satisfaction of the Engineer.

All optical fibers shall be spliced to provide continuous runs. Splices shall be allowed only in equipment cabinets except where otherwise shown on the Plans.

All splices shall be made using a fusion splicer that automatically positions the fibers using a system of light injection and detection. The Contractor shall provide all equipment and consumable supplies.

Basis of Payment: This work shall be paid for at the contract unit price each for SPLICE FIBER IN CABINET, which will be payment in full for all fusion splicing, fiber optic splice trays, testing and documentation, at a cabinet or building location shown on the plans and as directed by the Engineer. This pay item shall <u>not</u> be used to pay for fiber terminations and/or splices completed to meet the requirements of FIBER OPTIC CABLE IN CONDUIT.

FIBER OPTIC TRACER CABLE.

The cable shall meet the requirements of Section 817 of the "Standard Specifications", except for the following:

In order to trace the fiber optic cable after installation, an XLP black insulated copper cable No. 14 shall be pulled in the same conduit as the fiber optic cable. The tracer cable shall be continuous, extended into the controller cabinet and terminated on a barrier-type terminal strip mounted on the side wall of the controller cabinet. The barrier-type terminal strip and tracer cable shall be clearly marked and identified. In order to minimize the number of splices required, the tracer cable shall incorporate maximum lengths of cable supplied by the manufacturer. Splicing of the tracer cable will be allowed at the handholes only. The tracer cable splice shall use a Western Union splice soldered with resin core flux. All exposed surfaces of the solder shall be smooth. Splices shall be soldered using a soldering iron. Blowtorches or other devices

which oxidize copper cable shall not be allowed for soldering operations. The splice shall be covered with underwater grade WCSMW 30/100 heat shrink tube, minimum length four (4) inches and with a minimum one (1) inch coverage over the XLP insulation.

Basis of Payment: The tracer cable shall be paid for separately as ELECTRIC CABLE IN CONDUIT, TRACER, NO. 14 1C per foot, which price shall include all associated labor and material for installation.

CONCRETE FOUNDATIONS

Add the following to Article 878.03 of the "Standard Specifications":

All anchor bolts shall be according to Article 1006.09, except all anchor bolts shall be hot dipped galvanized the full length of the anchor bolt including the hook.

Concrete Foundations, Type A for Traffic Signal Posts shall provide anchor bolts with the bolt pattern specified within the "District 1 Standards Traffic Signal Design Details". All Type A foundations shall be a minimum depth of forty-eight (48) inches.

Concrete Foundations, Type C (Special) for Traffic Signal Cabinets with Uninterruptible Power Supply (UPS / Battery Back-Up) cabinet installations shall be constructed a minimum of fortyeight (48) inches long by thirty-one (31) inches wide, and shall have a minimum depth of fortyeight (48) inches. An integral concrete pad foundation for the UPS cabinet shall be constructed a minimum of thirty-one (31) inches long by twenty (20) inches wide by ten (10) inches deep. The UPS cabinet pad foundation shall be integral to the side of the signal cabinet foundation, and shall be constructed on the same side as the signal cabinet power panel. An L-Shaped concrete apron shall be constructed along the entire front of the signal cabinet foundation, the entire side of the UPS cabinet foundation, and the entire front of the UPS cabinet foundation. This concrete apron shall be a minimum of thirty-six (36) inches wide by four (4) inches deep. Anchor bolts shall be provided and spaced according to the cabinet manufacturer's specifications.

Concrete Foundations, Type D for Traffic Signal Cabinets shall be constructed a minimum of forty-eight (48) inches long by thirty-one (31) inches wide, and shall have a minimum depth of forty-eight (48) inches. The concrete apron at the signal cabinet shall be constructed a minimum of thirty-six (36) inches wide by forty-eight (48) inches long by four (4) inches deep. Anchor bolts shall be provided and spaced according to the cabinet manufacturer's specifications.

Concrete Foundations, Type E for Mast Arm and Combination Mast Arm Poles shall meet the following requirements:

The Resident Engineer shall approve the foundation excavation prior to placing any concrete. Foundations for combination mast arm poles shall provide an extra $2\frac{1}{2}$ " duct.

DETECTOR LOOP

Revise Section 886 of the "Standard Specifications" to read:

A minimum of seven (7) working days prior to the Contractor cutting loops, the Engineer shall mark the location of the proposed loops and contact the Traffic Engineer (847) 377-7400 to inspect and approve the layout. When preformed detector loops are installed, the Contractor shall have them inspected and approved prior to the placement of the concrete surface, using the same notification process as above.

Loop detectors shall be installed according to the requirements of the "District 1 Standard Traffic Signal Design Details". Saw-cuts (homeruns on preformed detector loops) from the loop to the edge of pavement shall be made perpendicular to the edge of pavement in order to minimize the length of the saw cut (homerun), unless otherwise directed by the Engineer or as shown on the plans. Polyethylene unit duct shall be used for detector loop raceways to the handholes. Unit duct shall meet the requirements of NEC Article 343. All unit duct used for traffic signal loop detector runs shall be incidental to the price of the detector loop.

The detector loop cable insulation shall be labeled with the cable specifications. Each detector loop lead-in wire shall be labeled in the handhole using a Panduit 250W175C waterproof tag or approved equal. The tag will be secured to each wire with nylon ties.

The resistance to ground for new detector loops shall be a minimum of 500 megaohms under any conditions of weather or moisture. Inductance shall be more than 50 microhenries and less than 700 microhenries. Quality readings shall be more than 5. All new or replacement lead-in cables shall be connected to the loop interface panel using appropriate crimp-on, spade type connectors. Detector loop measurements shall include the saw cut and the length of the loop lead-in to the edge of pavement. The lead-in wire, including all necessary connections for proper operations, from the edge of pavement to the handhole, shall be incidental to the price of the detector loop. Unit duct, trench and backfill, and drilling of pavement or handholes shall be incidental to detector loop quantities.

The location of each dive hole shall be marked on the face of the curb, the edge of pavement or

the handhole, with a saw cut 1/4 inch deep by 4 inches long.

- (a) Type I: Each detector loop, which is to be installed in new asphalt pavement, must be placed in the pavement below the surface course. Each detector loop, which is to be installed in an existing asphalt or concrete pavement, shall be located to miss existing pavement cracks, if possible. Loop sealant used to seal new loops shall consist of a two-component thixotropic, chemically-cured polyurethane. The sealant will be Chemque Q-Seal 295, Perol Elastic Cement A/C Grade or an approved equal. The sealant shall be installed 1/8 inch below the pavement surface. Excess sealant, which accumulates on the surface, shall be removed immediately. Loop sealant used to reseal existing loops shall be composed of an asphalt-based compound. The sealant will be Doseal 230 or an approved equal.
- (b) Preformed. This work shall consist of furnishing and installing a rubberized heat resistant preformed traffic signal loop in accordance with the "Standard Specifications", except for the following:

Preformed detector loops shall be installed in new pavement constructed of portland cement concrete and shall be placed in the substrate. Loop lead-ins shall be protected to the satisfaction of the Engineer.

Handholes shall be placed next to the shoulder or back of curb when preformed detector loops enter the handhole.

Preformed detector loops shall be factory assembled. Homeruns and interconnects shall be pre-wired and shall be an integral part of the loop assembly. The loop configurations. and homerun lengths shall be assembled for the specific application. The loop and homerun shall be constructed using 11/16-inch outside diameter (minimum), 3/8-inch inside diameter (minimum) Class A oil resistant synthetic cord-reinforced hydraulic hose with 250 psi internal pressure rating. Hose for the loop and homerun assembly shall be one continuous piece. No joints or splices shall be allowed in the hose except where necessary to connect homeruns or interconnects to the loops. This will provide maximum wire protection and loop system strength. Hose tee connections shall be heavy-duty high temperature synthetic rubber. The tee shall be of proper size to attach directly to the hose, minimizing glue joints. The tee shall have the same flexible properties as the hose to insure that the whole assembly can conform to pavement movement and shifting without cracking or breaking. The wire used shall be #16 THWN stranded copper. The number of turns in the loop shall be application specific. Homerun wire pairs shall be twisted a minimum of four turns per foot. No wire splices will be allowed in the preformed loop assembly. The loop and homeruns shall be filled and sealed with a flexible sealant to insure complete moisture blockage and further protect the wire.

To minimize the length of time that a signal operates without vehicle detection, detector loops for active traffic signal installations shall be installed in a timely manner as follows:

If in the opinion of the Engineer construction conditions are suitable for loop installation(s), the Engineer shall notify the Contractor to proceed. The detector loops shall be installed and fully operational within fourteen (14) calendar days following notification to proceed by the Engineer. This 14-day period shall be in effect throughout the entire year, including the off season, regardless of the Contractor's working day status. Failure by the Contractor to complete the loop installation(s) within the specified timeframe shall result in liquidated damages in the amount of \$500.00 per calendar day, per occurrence.

Basis of Payment. This work shall be paid for at the contract unit price per foot for DETECTOR LOOP, TYPE I or PREFORMED DETECTOR LOOP as specified in the plans, which price shall be payment in full for furnishing and installing the detector loop and all related connections for proper operation.

EMERGENCY VEHICLE PRIORITY SYSTEM

Revise Section 887 of the "Standard Specifications" to read:

If not marked in the Contract plans, it shall be the Contractor's responsibility to contact the municipality or fire district to verify the brand of emergency vehicle preemption equipment to be installed prior to the contract bidding. The equipment must be of the latest type manufactured and must be completely compatible with all components of signal equipment currently in use by the County.

All new installations shall be equipped with confirmation beacons as shown on the District 1 "Standard Traffic Signal Design Details". The confirmation beacon shall consist of a 150 watt Par 38 flood lamp for each direction of preemption. The lamp shall have an adjustable mount with a weatherproof enclosure for cable splicing. All hardware shall be cast aluminum or stainless steel. Holes drilled into signal poles, mast arms, or posts shall require rubber grommets to prevent chafing of wires. In order to maintain uniformity between communities, the confirmation beacons shall indicate when the control equipment receives the preemption signal. The preemption movement shall be signalized by a flashing indication at the rate specified by Section 4K.01 of "MUTCD". The stopped preempted movements shall be signalized by a continuous indication.

All light operated systems shall operate at a uniform rate of $14.035 \text{ hz} \pm 0.002 \text{ hz}$, or as otherwise required by the Traffic Engineer, and provide compatible operation with other light systems currently being operated in the County.

Basis of Payment. The work shall be paid for at the contract unit price each for furnishing and installing LIGHT DETECTOR and LIGHT DETECTOR AMPLIFIER. Furnishing and installing the confirmation beacon shall be incidental to the cost of the Light Detector. The light detector amplifier shall be paid for on a basis of (1) one each per intersection controller and shall provide operation for all movements required in the pre-emption phase sequence.

TEMPORARY TRAFFIC SIGNAL INSTALLATION

Add the following to Section 890 of the "Standard Specifications":

Only an approved equipment vendor will be allowed to assemble the temporary traffic signal cabinet. Also, an approved equipment vendor shall assemble and test a temporary railroad traffic signal cabinet. (Refer to the "Inspection of Electrical Systems" specification) A representative of the approved control equipment vendor shall be present at the temporary traffic signal turn-on inspection.

Only controllers compatible with "*icons*" software (NTCIP) or "Aries" software, currently in use by LCDOT, will be approved for use at temporary signal locations. Controller software compatibility requirements are based upon the controller's location in the communication system, and shall be as shown on the plans. All controllers used for temporary traffic signals shall be fully-actuated NEMA microprocessor based with RS232 data entry ports compatible with existing monitoring software, installed in NEMA TS-1 or TS-2 cabinets with 8 phase back panels, capable of supplying 255 seconds of cycle length and individual phase length settings up to 99 seconds. On projects with one lane open and two way traffic flow, such as bridge deck repairs, the temporary bridge signal controller shall be capable of providing an adjustable all red clearance setting of up to 30 seconds in length. All controllers used for temporary traffic signals shall meet or exceed the requirements of Section 857 of the "Standard Specifications" with regards to internal time base coordination and preemption.

All temporary traffic signal cabinets shall have a closed bottom made of aluminum alloy. The bottom shall be sealed along the entire perimeter of the cabinet base to ensure a water, dust and insect-proof seal. The bottom shall provide a minimum of two (2) 4-inch diameter holes to run the electric cables through. The 4-inch diameter holes shall have a bushing installed to protect the electric cables and shall be sealed after the electric cables are installed.

The stand which supports the temporary traffic signal cabinet shall be constructed of lumber and plywood that has been pressure-treated to protect against rot, mold, and insects.

Grounding shall be provided for the temporary traffic signal cabinet meeting or exceeding the applicable portions of the National Electrical Code, Section 807 of the "Standard Specifications" and the District 1 Traffic Signal Specifications for "Grounding of Traffic Signal Systems".

All traffic signal head sections shall be twelve (12) inches. The temporary traffic signal heads shall be placed as indicated on the temporary traffic signal plan or as directed by the Traffic Engineer. The Contractor shall furnish enough cable slack to relocate heads to any position on the span wire or at locations illustrated on the plans for construction staging. The temporary traffic signal shall remain in operation during all signal head relocations. Each temporary traffic signal head shall have its own cable from the controller cabinet to the signal head.

For temporary traffic signal installations within closed loop system(s), the controller shall be compatible with the existing traffic signal system master controller. The existing system interconnect is to be maintained as part of the Temporary Traffic Signal Installation specified on the plan. The interconnect shall be installed into the temporary controller cabinet as per the notes or details on the plans. Refer to the INTERRUPTION OF COMMUNICATION requirements described earlier. All labor and equipment required to install and maintain the existing interconnect shall be incidental to the item TEMPORARY TRAFFIC SIGNAL INSTALLATION.

All emergency vehicle priority equipment (light detectors, light detector amplifiers, confirmation beacons, etc.) as shown on the temporary traffic signal plans shall be provided by the Contractor. It shall be the Contractor's responsibility to contact the municipality or fire district to verify the brand of emergency vehicle priority equipment to be installed prior to the contract bidding. The equipment must be completely compatible with all components of signal equipment currently in use by the County. All light operated systems shall operate at a uniform rate of 14.035 hz ± 0.002 , or as otherwise required by the Engineer. All labor and material required to install and maintain the Emergency Vehicle Priority system shall be incidental to the item Temporary Traffic Signal Installation.

All temporary traffic signal installations shall have approved vehicular detection and approved pedestrian push buttons installed as shown on the plans or as directed by the Engineer. Vehicular detection shall be provided by video sensors, microwave sensors, or detector loops, and shall be paid for separately. The Contractor shall install, wire, and adjust the alignment of the vehicular detection system in accordance with the manufacturer's recommendations and requirements. When directed by the Engineer, this item shall also include operational items such as: controller database changes, timing changes, activation/deactivation of phases, relocation of signal heads, relocation / reconfiguration of detectors (microwave and/or video), and bagging / unbagging signal heads. A representative of the approved control equipment vendor shall be present and assist the contractor in setting up the vehicular detection system. On temporary traffic signal

installations with detector loops, polyethylene unit duct shall be used for detector loop raceways from the saw-cut to 10 feet up the wood pole, unless otherwise shown on the plans. Unit duct shall meet the requirements of NEC Article 343. All unit duct used for traffic signal loop detector runs shall be incidental to the price of the detector loop.

All existing street name and intersection regulatory signs shall be removed from existing poles and relocated to the temporary signal span wire. If new mast arm assemblies and posts are specified for the permanent signals, the signs shall be relocated to the new equipment at no extra cost.

The Contractor shall not be required to pay the energy charges for the operation of the existing traffic signal installation. If the installation replaces an existing signal, the Contractor shall not be required to pay the energy charges for the operation of the temporary traffic signal. The Contractor shall pay the energy charges for all other temporary traffic signal installations.

The Contractor shall furnish all control equipment for the temporary traffic signals(s) unless otherwise stated in the plans. On projects with multiple temporary traffic signal installations, all controllers shall be of the same manufacturer and model number with current software installed.

Maintenance shall meet the requirements of the "Standard Specifications" and District 1 Specifications for "Maintenance of Existing Traffic Signal Installation". Maintenance of temporary signals and of the existing signals shall be incidental to the cost of this item. When temporary traffic signals are to be installed at locations where existing signals are presently operating, the Contractor shall be fully responsible for the maintenance of the existing signal installation as soon as he begins any physical work on any portion of the project. Maintenance responsibility of the existing signals shall be incidental to the item TEMPORARY TRAFFIC SIGNAL INSTALLATION. In addition, a minimum of seven (7) days prior to assuming maintenance of the existing traffic signal installation(s) under this contract, the Contractor shall contact the Traffic Engineer (847) 377-7400 to request an inspection of the installation(s).

Temporary Traffic Signals for bridge projects shall follow the State Standards, "Standard Specifications", District 1 Traffic Signal Specifications, and any plans for Bridge Temporary Traffic Signals included in the plans. The installation shall meet the above requirements for TEMPORARY TRAFFIC SIGNAL INSTALLATION. In addition, all electric cable shall be aerially suspended, at a minimum height of 18 feet, on temporary wood poles (Class 5 or better) of 45 feet minimum height. The signal heads shall be span-wire-mounted or bracket-mounted to the wood pole or as directed by the Engineer. The Controller cabinet shall be mounted to the wood pole or as directed by the Engineer. All approaches for temporary traffic signals for bridge projects shall have microwave vehicle sensors or video vehicle detection, as shown on the plans or as approved by the Engineer.

Basis of Payment: This work shall be paid for at the contract unit price each for TEMPORARY TRAFFIC SIGNAL INSTALLATION which shall include all costs for the installation, modification, maintenance, operational items, complete removal of the temporary traffic signal, and all material required to complete the work.

REMOVE EXISTING TRAFFIC SIGNAL EQUIPMENT.

Add the following to Article 895.05 of the "Standard Specifications":

The traffic signal equipment, which is to be removed and will become the property of the Contractor, shall be disposed of by the Contractor outside the right-of-way at his/her own expense.

The Contractor shall safely store and arrange for delivery of all equipment that will remain the property of LCDOT. The Contractor shall deliver, unload and stack the equipment at the owner's facility, as directed by the Engineer, within 30 days of removing it from the traffic signal installation. The Contractor shall provide three (3) copies of a list of equipment that is to remain the property of LCDOT including model and serial numbers where applicable. The Contractor shall also provide a copy of the contract plan or special provisions showing the quantities and type of equipment to be delivered. Controllers and peripheral equipment from the same location shall be boxed together (equipment from different locations may not be mixed) and all boxes and controller cabinets shall be clearly marked or labeled with the location from which they were removed. The Contractor shall be responsible for the condition of the traffic signal equipment from the time of removal until the acceptance of a receipt written by the owner indicating that the items have been returned in good condition.

Traffic signal equipment which is lost or not returned to the County for any reason shall be replaced with new equipment meeting the requirements of these Specifications.

PEDESTRIAN PUSH-BUTTON

Replace Article 1074.02 of the "Standard Specifications" with the following:

Pedestrian Push-button assembly shall be ADA compliant, 3-inch round style, highly vandal resistant, non-moving, pressure activated, with a solid-state Piezo switch actuator that cannot be stuck in an "on" or constant call position. A momentary (non-latching) red LED and audible tone shall be provided to confirm an actuation. The housing, or bezel, of the assembly shall be solid aluminum and powder coated yellow. The button shall be stainless steel or nickel-plated aluminum.

Pedestrian Push-button assembly shall be a Campbell Company 4 EVR 120, a Polara BullDog BDLM2-Y, or approved equivalent.

The pedestrian station shall be a Campbell Company 57H Station, or approved equivalent. The pedestrian station shall be powder coated black to match ornamental (Special) mast arm poles and signal posts. The pedestrian station shall be unpainted to match unpainted galvanized mast arm poles and signal posts.

The station shall be installed with a 5-inch by 7³/₄-inch Campbell Company vandal resistant sign, according to the following: Where pedestrian signal heads are used, pedestrian signs shall provide the "Push Button for" legend, with the Walking Man symbol and arrow (R10-4b). Where no pedestrian signal heads are used, pedestrian signs shall provide the "Push Button for Green Light" legend with arrow (R10-3 with arrow), or as specified on the plans.

Refer to STEEL MAST ARM ASSEMBLY AND POLE (SPECIAL), STEEL COMBINATION MAST ARM ASSEMBLY AND POLE (SPECIAL), and/or TRAFFIC SIGNAL POST (SPECIAL) for additional installation requirements.

Basis of Payment: This work shall be paid for at the contract unit price each for PEDESTRIAN PUSH BUTTON. The unit price shall include furnishing and installing the pedestrian station, push button, sign, and all necessary equipment and connections for proper operations. Electric cable in conduit shall be paid for separately.

Signal modification projects may require both new pedestrian buttons (described above) and existing pedestrian buttons remaining in operation. The County desires to have all buttons at a particular traffic signal be similar in appearance and operation. The contractor should advise the Traffic Engineer if a different button should be installed in order to match the existing ones.

CONTROLLER CABINET AND PERIPHERAL EQUIPMENT.

Add the following to Article 1074.03 of the "Standard Specifications":

Cabinets shall be designed for NEMA TS2 Type 1 operation. All cabinets shall be pre-wired for a minimum of eight (8) phases of vehicular, four (4) phases of pedestrian, and four (4) phases of overlap operation. Individual load switches shall be provided for each vehicle, pedestrian, and right turn overlap phase.

Cabinets – Controller cabinets shall have a footprint of approximately 44 inches wide by 26 inches deep. Type IV cabinets shall be 65 inches high, and shall provide a third shelf for mounting additional equipment. Type V cabinets shall be 77 inches high. Cabinets shall be fabricated of 1/8" thick unpainted aluminum alloy 5052-H32. The surface shall be smooth, free of marks and scratches. All external hardware shall be stainless steel.

- Cabinet Doors Provide front and rear doors of NEMA type 3R construction with cellular neoprene gasket that is rain tight. Door hinges shall be continuous 14-gauge stainless steel and shall be secured with ¼-20 stainless steel carriage bolts.
- Controller Harness Provide a TS2 Type 2 "A" harness in addition to the TS2 Type 1 harness.
- Surge Protection EDCO Model SHA-1250 with failure indicator, or approved equivalent.
- BIU Containment screw required.
- Switch Guards All switches shall be guarded.
- Heating One (1) 200-watt, thermostatically-controlled, Hoffman electric heater, or approved equivalent.
- Plan & Wiring Diagrams 12" x 16" moisture sealed container attached to door.
- Detector Racks –

Configuration #1, Half-size rack, to be used when few, if any, detector loops are required. Fully wired to support one BIU, eight channels of vehicle detection, and four channels of Emergency Vehicle Preemption (EVP).

Configuration #2, Full-size rack, to be used when the required detector loops cannot be accommodated by the half-size rack. Fully wired to support one BIU, sixteen channels of vehicle detection, and four channels of EVP.

- Field Wiring Labels All field wiring shall be labeled.
- Field Wiring Termination Approved channel lugs required.
- Power Supply Provide a nonconductive shield.
- Circuit Breaker The signal circuit breaker shall be sized for the proposed load, but shall not be rated less than thirty (30) amps.
- Police Door Provide wiring and termination for plug-in manual phase advance switch.
- Railroad Pre-Emption Test Switch Eaton 8830K13 SHA 1250 or approved equivalent.

FULL ACTUATED CONTROLLER AND TYPE IV CABINET, SPECIAL FULL ACTUATED CONTROLLER AND TYPE V CABINET, SPECIAL

This item shall comply with Sections 857 and 863 of the "Standard Specifications" for Road and Bridge Construction, and shall also comply with the following requirements:

The controller shall meet the requirements for NEMA-TS2 standards for a Type 1 Cabinet.

The controller shall be the latest model available that is compatible with "*icons*" software (NTCIP) or "Aries" software, currently in use by LCDOT. Controller software compatibility requirements are based upon the controller's location in the communication system, and shall be as shown on the plans. The controller shall be equipped with an Ethernet port and a removable data key to save the controller database.

The cabinet shall be 65 inches high, and shall provide a third shelf for mounting additional equipment. Also, the cabinet shall have front and rear doors of NEMA type 3R construction with cellular neoprene gasket that is rain tight. Door hinges shall be continuous 14-gauge stainless steel and shall be secured with ¹/₄-20 stainless steel carriage bolts. Standard equipment shall include a three-point locking system that secures the door at the top, bottom and center. A corbin lock with two keys shall also be furnished. The front and rear doors shall be equipped with a two-position doorstop, one at 90° and one at 120°.

Basis of Payment: This item will be paid for at the contract unit price each for FULL ACTUATED CONTROLLER AND TYPE IV CABINET, SPECIAL or FULL ACTUATED CONTROLLER AND TYPE V CABINET, SPECIAL which price shall be payment in full for furnishing and installing the cabinet and controller, complete with necessary connections and equipment for proper operation, at a location designated by the Engineer. If required, the transceiver shall be considered incidental to the cost of this item. Removal of an existing controller, and its return to the County, shall also be incidental to the cost of this item.

TRAFFIC ACTUATED CONTROLLER AND CABINET INTERCONNECTED WITH RAILROADS.

Add the following to Article 1074.03 of the "Standard Specifications" to read:

Cabinets shall be NEMA TS2 Type 1 design, meeting the requirements of CONTROLLER CABINET AND PERIPHERAL EQUIPMENT and FULL ACTUATED CONTROLLER AND TYPE IV CABINET, SPECIAL or FULL ACTUATED CONTROLLER AND TYPE V CABINET, SPECIAL. In addition, the following shall apply to railroad interconnected equipment:.

Only an approved traffic signal equipment supplier shall assemble railroad interconnected controllers and cabinets. The equipment shall be tested and approved in the equipment supplier's District 1 approved facility prior to field inspection.

The pedestrian clearance during railroad preemption will be limited to a flashing "Don't Walk" interval, equal in length to the vehicle yellow clearance interval, and shall time concurrently with the vehicle yellow clearance.

The terminal facility shall be wired so as to provide supervision of all essential pre-emption components. This wiring shall cause the facility to transfer to or remain in flashing operation in the event any critical component is missing, not connected or failed. Interface relays shall be wired so as to be in the energized state during normal (non-pre-empt) operation. Failure of a relay coil shall open the supervision loop and cause the intersection to transfer to flashing

operation. Each critical element such as controller harnesses and interface relays shall be wired to form a series loop which must be complete for normal operation.

A method of supervising the 6-conductor cable interconnecting the traffic and railroad facilities shall provide flashing operation during failed cable conditions. Upon detection of a failed railroad interconnect the controller shall provide one (1) track clearance green interval and shall enter flashing operation at end of track clearance yellow interval. Such flashing operation must be manually reset. The supervision circuit shall, within reason, be capable of detecting failure of the supervision circuit components themselves, and shall provide fail-safe operation immediately upon detecting any failure.

The interconnect to the railroad facility shall be such that demand for pre-emption begins when the railroad flashers begin to flash and ends when railroad gates begin to rise.

An IDOT approved method of controller security shall be implemented to assure data integrity and to preclude changes to critical data. The method shall include a means for the controller to continuously verify the controller/cabinet CRC (cycle redundancy check) match. The CRC will be developed based on preemptor entries, unit data (including phases in use, sequence and ring structure, etc.), overlap assignment and timing, firmware version, and any special memory content necessary for proper operation. Where data is stored in a data module, a spare data module shall be provided to the Engineer.

The controller will provide for immediate track clearance green re-service upon receipt of each subsequent preempt demand. During the re-service all normal vehicle clearance intervals, including red revert, will be respected.

The cabinets shall be equipped with a labeled test switch for the railroad interconnected preemption line which will place a call in the controller's railroad preemption phase and also will acknowledge power to the interconnect line. The switch shall automatically return to normal position upon release.

UNINTERRUPTIBLE POWER SUPPLY (UPS)

This specification sets forth the minimum requirements for an uninterruptible power system with battery back-up, for a traffic signal. The system is comprised of the UPS or Inverter unit, bypass-switch, batteries, cabinet, and related wiring harnesses.

UPS (Inverter Unit)

The UPS shall produce a fully regenerated, conditioned, regulated pure sine wave 120-volt AC (+/-4%) power output in all operational modes to all traffic control equipment.

The inverter unit shall be line-interactive. The electronic control circuit shall constantly sample the AC input. The UPS shall provide a steady 120v AC from an input source as low as 85 volts and as high as 135volts AC before using the inverter / battery to provide 120 volts to the load.

The switching to battery/inverter will occur in less than 4 milliseconds after utility voltage fluctuations or deviations travel outside preset parameters. The inverter's output shall be pure clean sine wave with an efficiency of 94% at 100% load. The inverter circuit shall be capable of high duty cycle operation.

The UPS shall be rated at Unity power factor (1000 watts) for continuous operation. The UPS shall be capable of providing an overload output rating of 150% of rated output for 10 minutes at Unity power factor (1500 watts).

In case of UPS failure and or battery depletion, the UPS will ensure upon the return of utility power that the utility power will be failsafe-bypassed to the traffic signal controller. An external manual bypass shall provide a secondary redundant path for the utility power if the internal UPS bypass fails. The UPS shall be capable of operating in a bypass mode until the depleted batteries have recharged to a predetermined state, and then resume full on-line operation. The UPS shall be capable of hot swapping the batteries or battery bank, without shutting down the UPS

The UPS Front Panel shall have the following: A/C Input / Output circular connector, battery connector, multi-function dial timer, LCD display for counting power interruptions, real-time voltage meter and amp/watt meter, circular connector containing dry contact closure for UPS Fail, On Battery, Flash, Low Battery, and Alarm. The front panel shall also have LED indicators for AC/Battery power present, UPS Fault, Overload, Low Battery, and Ground Fault.

The UPS shall interface with the traffic signal controller or master controller to provide the "On Battery" alarm to the Lake County Division of Transportation facilities over the normal fiber optic/dial-up communication channels. The "On Battery" alarm must be wired to the Alarm 2 Function of the traffic signal controller back panel. The connector shall be rated for 150 amps DC.

Bypass Switch

The Bypass Switch shall consist of one main manual switch, which provides a means of placing the UPS into a bypassed position without interruption of the power to the intersection. A second switch provides a means of isolating the AC utility from the UPS. This provides a means of testing the UPS/Battery back-up by turning off the AC utility to the UPS with the UPS in normal operation. Both of these switches shall be rated 20 amps at 600 volts.

The Bypass Switch AC connections consist of two circular locking Input/Output connectors, phased to the UPS AC harness. This switch will include an alternate-source input connection, which provides a means of connecting a generator or alternate utility source. The Bypass Switch case shall be constructed of aluminum.

Batteries

This system shall be comprised of four (4) or six (6) 12-volt batteries, as required, to provide a minimum two (2) hours of normal signal operation followed by a minimum four (4) hours of flashing red operation. Non-essential items such as streetlights, illuminated street name signs, cabinet lamps and fans, EVPS confirmation beacons, and video monitors do not need to be connected to the UPS. Batteries shall be Optima Spiral Cell, blue top, deep cycle batteries, with a 55 Ah capacity, or an approved equal. The battery cable shall consist of a quick release connector rated at 150 amps. The connector shall have recessed pins and be polarized to prevent accidental cross connecting of the battery string to the UPS.

Cabinet

The cabinet shall be a California Chassis aluminum cabinet, Part Number FCU104013, with a natural aluminum mill finish, or approved equal.

The external cabinet dimensions shall be 41 inches tall by 25 inches wide by 16 inches deep, excluding the door. The cabinet shall house all batteries, the UPS, the Bypass Switch, and the wiring harnesses.

When being installed at an existing traffic signal cabinet, the cabinet for the UPS shall rest on the traffic signal cabinet foundation and shall also be secured to the right side of the traffic signal cabinet. For new traffic signal cabinets, the foundation and UPS cabinet installation shall be according to IDOT Standard 878001-04.

The cabinet shall provide an external connection for an AC generator to power the signals, if necessary, during an extended utility power outage. The external connection shall be a NEMA Style 5-15 male flanged receptacle, and shall be securely covered by a screw-on aluminum plate with a rubber gasket.

The UPS shall be equipped with an integrated safety ("Tip") switch that will interrupt inverter output power in the event of a cabinet knockdown. The safety switch may be either internal to the inverter unit, or mounted inside the UPS cabinet. The safety switch shall be designed to interruptoutput power in the event that the inverter is tilted more than twenty degrees on any axis. The switch shall be mechanically latching to ensure that power is not automatically restored to the UPS until the system is reset.

A blue LED indicator light shall be mounted on the side of the UPS cabinet facing traffic and shall illuminate to indicate when the utility power has been disrupted and the UPS is in operation. The light shall be a minimum 1" diameter, and bright enough to be visible from the driving lanes in the daylight.

Basis of Payment: This item shall be paid for at the contract unit price, each, for furnishing and installing the UNINTERRUPTIBLE POWER SUPPLY (UPS). The price shall include the UPS/Inverter unit, Bypass Switch, Batteries, Cabinet, wiring harnesses, and all associated equipment and materials necessary for proper operation.

CABINET NEATNESS

The Contractor shall assure that all wiring and peripheral equipment in any new traffic signal cabinet is in a neat and orderly fashion that is acceptable to the Engineer. This applies to controller cabinets, master cabinets, railroad cabinets, communication cabinets, electrical service cabinets, or any other new cabinet called for in the project plans.

All conduit entrances into the cabinet shall be sealed with a pliable waterproof material. Electrical cables inside the cabinet shall be neatly trained along the base and back of the cabinet. Each conductor shall be connected individually to the proper terminal, and the spare conductors shall be bound into a neat bundle. All cables, including those for signals, vehicle detection, pushbuttons, emergency vehicle preemption, video transmission, and communication shall be neatly arranged and bundled within the cabinet to the satisfaction of the Engineer. Each cable shall be marked with an identification number which corresponds to the number and description on the cabinet cable log.

In the case of an existing cabinet that is being modernized or modified, the new cables being installed shall be trained, bundled and labeled to the satisfaction of the Engineer. When working inside an existing cabinet, the Contractor shall minimize disturbance to existing cables and cabinet wiring. Any existing cables and cabinet wiring disturbed by the Contractor shall be re-trained, bundled, and/or labeled to the satisfaction of the Engineer.

The County shall not accept maintenance of the traffic signal installations until the requirements of this specification are satisfied. The cost for this work shall be considered incidental to the cost of the associated pay item.

VENDOR REPRESENTATION

Under this provision, the Engineer reserves the right to request the equipment vendor be present at the activation of new traffic equipment. Equipment covered under this provision includes signal heads, cabinets, controllers, amplifiers, preemption, video detection/monitoring, communication/transmission, fiber-optic/telemetry, radio, microwave, infra-red, illuminated signs, streetlights, push buttons, lighted crosswalks, uninterruptible power supplies, and any other new equipment being installed and activated.

This provision is in addition to the requirement contained herein that the Contractor provide a representative from the control equipment vendor to attend the traffic signal inspection for both permanent and temporary traffic signal "turn-ons".

Any costs associated with equipment vendor representation shall not be paid for separately, but shall be incidental to the cost of the associated traffic equipment being activated. Any unforeseen costs incurred by the Contractor to provide this representation shall not be the responsibility of the County.

ELECTRIC CABLE.

Delete "or stranded, and No. 12 or" from the last sentence of Article 1076.04 (a) of the "Standard Specifications".

The electric service cable shall have an XLP jacket. All other cable jackets shall be polyvinyl chloride, meeting the requirements of IMSA 19-1 or IMSA 20-1. The jacket color for signal cable shall be black. The jacket color for lead-in and communications cable shall be gray. All cabling between the signal cabinet and the signal heads shall be solid copper, not multi-stranded. Heat shrink splices shall be used according to the District 1 "Standard Traffic Signal Design Details".

STEEL MAST ARM ASSEMBLY AND POLE STEEL COMBINATION MAST ARM ASSEMBLY AND POLE

Add the following to Article 1077.03 of the "Standard Specifications":

The poles for all mast arms and combination mast arms, up to and including forty (40) feet in length, shall be manufactured with an eighteen (18)-inch bolt circle at the foundation base plate.

The poles for all mast arms and combination mast arms forty-two (42) feet long and longer shall be manufactured with a twenty-one (21)-inch bolt circle.

Traffic signal mast arms shall be one-piece construction, unless otherwise approved by the Engineer. All mast arms and poles shall be galvanized.

Luminaire arms shall be galvanized steel, truss style, clamp-on, and a minimum fifteen (15) feet in length. Luminaires shall be "cobra head" style, with a minimum mounting height of forty (40) feet.

The base of the mast arm pole shall be protected by a Component Products bolt-on galvanized metal shroud or an approved equal, in lieu of stainless steel screening.

STEEL MAST ARM ASSEMBLY AND POLE (SPECIAL). STEEL COMBINATION MAST ARM ASSEMBLY AND POLE (SPECIAL).

Add the following to Article 1077.03 of the "Standard Specifications":

The poles for all mast arms and combination mast arms, up to and including forty (40) feet in length, shall be manufactured with an eighteen (18)-inch bolt circle at the foundation base plate. The poles for all mast arms and combination mast arms forty-two (42) feet long and longer shall be manufactured with a twenty-one (21)-inch bolt circle.

Ornamental bases for mast arm poles shall be either cast iron or cast aluminum. All mast arms, mast arm poles, luminaire arms, cast iron bases, and any exposed steel hardware shall be hotdipped galvanized, and then painted black by the supplier/manufacturer. Cast aluminum bases shall also be painted black by the supplier/manufacturer.

All ornamental bases shall fit tightly around the poles, with little or no gap at the top of the ornamental base. Two-piece ornamental bases shall fit together tightly, with little or no gap between the two pieces. All bases shall fit securely on top of the foundation, and shall not easily move or wobble.

Pedestrian pushbutton stations shall be mounted to ornamental mast arm bases according to the following: The top and bottom of the station shall be secured by drilling, tapping, and installing a 3/8-inch stainless steel threaded bolt, lock washer, and hex nut. Do not use self-tapping screws. The pushbutton station shall be plumb. Spacers made of 3/4-inch aluminum conduit shall be installed behind the station.

Luminaire arms shall be steel, truss style, clamp-on, and a minimum fifteen (15) feet in length. Luminaires shall be "cobra head" style and painted black by the supplier/manufacturer. Minimum mounting height for luminaires shall be forty (40) feet.

All (Special) steel mast arm assemblies and poles (including combination mast arm assemblies) shall be manufactured and/or supplied by Sternberg Vintage Lighting, Valmont, Beacon or approved equal, according to the following:

- Round, tapered, 16-sharp fluted pole.
- Round, tapered, smooth, standard-curved, flange-connected, traffic signal mast arm
- Hamilton Series (6400D) ornamental base (Sternberg).
- MainStreet Series (200SJ) ornamental base (Beacon).

TRAFFIC SIGNAL POST.

Add the following to Article 1077.01 (d) of the "Standard Specifications":

Posts and bases shall be steel and hot-dipped galvanized.

TRAFFIC SIGNAL POST (SPECIAL).

Add the following to Article 1077.01 of the "Standard Specifications":

All Traffic Signal Posts (Special) shall be sixteen (16) feet in height, extruded aluminum, unless otherwise specified on the plans. All ornamental bases for Traffic Signal Post (Special) shall be cast aluminum.

All Traffic Signal Posts (Special) and associated ornamental bases shall be assembled and painted black at the factory. All exposed steel hardware shall be hot-dipped galvanized, and then painted black.

Pedestrian pushbutton stations shall be mounted to ornamental signal posts according to the following: The top and bottom of the station shall be secured by drilling, tapping, and installing a 3/8-inch stainless steel threaded bolt. Do not use self-tapping screws. The pushbutton station shall be plumb. Spacers made of 3/4-inch aluminum conduit shall be installed behind the station.

All ornamental bases shall fit tightly around the poles, with little or no gap at the top of the ornamental base. Two-piece ornamental bases shall fit together tightly, with little or no gap between the two pieces. All bases shall fit securely on top of the foundation, and shall not easily move or wobble.

All Traffic Signal Posts (Special) and associated ornamental bases shall be manufactured and/or supplied by Sternberg Vintage Lighting, Valmont, Beacon, or approved equal, according to the following:

- Round, straight (non-tapered), five (5)-inch diameter, 12-flat fluted post.
- A ball center cap for the top of the post, instead of a tenon.
- Hamilton Series (5400D) ornamental base, approximately forty-three (43) inches tall. (Sternberg)
- MainStreet Series (100SJ) ornamental base, approximately forty-three (43) inches tall. (Beacon)

INDUCTIVE LOOP DETECTOR

Add the following to Article 1079.01 of the "Standard Specifications":

All new inductive loop detectors (amplifiers) shall have a liquid crystal display to view all detector operation, loop diagnostics, loop frequency, inductance, change of inductance readings, and programmable features. When rack space allows, new amplifiers shall be rack-mounted. When the detector rack is full, shelf-mounted amplifiers may be allowed. Shelf-mounted amplifiers shall utilize multi channels to minimize the required shelf space.

ILLUMINATED SIGN, LED

This-work-shall-consist-of-furnishing-and-installing-an-illuminated-sign-with-light-emitting-diodes.

The light emitting diode (LED) blank out signs shall be manufactured by National Sign & Signal Company, or an approved equal and consist of a weatherproof housing and door, LEDs and transformers.

The LED blank out sign shall provide the correct symbol and color for "NO LEFT TURN" OR "NO RIGHT TURN" indicated in accordance with the requirements of the "Manual on Uniform Traffic Control Devices". The message shall be formed by rows of LEDs.

The message shall be clearly legible and highly visible, under any lighting conditions, within a 15-degree cone centered about the optic axis. The sign face shall be 24 inches by 24 inches. The sign face shall be completely illegible when not illuminated. No symbol shall be seen under any ambient light condition when not illuminated.

All LEDs shall be T-1 $\frac{3}{4}$ and have an expected lamplife of 100,000 hours. Operating wavelengths will be Red-626nm, Amber-590nm, and Bluish/Green-505nm. Transformers shall be rated for the line voltage with Class A insulation and weatherproofing. The sign shall be designed for operation over a range of temperatures from -35F to +165 F (-37C to +75C).

The LED module shall include the message plate, high intensity LEDs and LED drive electronics. Door panels shall be flat black and electrical connections shall be made via barrier-type terminal strip. All fasteners and hardware shall be corrosion resistant stainless steel.

The housing shall be constructed of extruded aluminum. All corners and seams shall be heli-arc welded to provide a weatherproof seal around the entire case. Hinges shall be continuous full-length stainless steel. Signs shall have stainless steel hardware and provide tool free access to the interior of the sign. Doors shall be 0.125-inch thick extruded aluminum with a 3/16-inch x 1-inch neoprene gasket and sun hood. The sign face shall have a polycarbonate, matte clear, lexan face plate. Drainage shall be provided by four drain holes at the corners of the housing. The finish on the sign housing shall include two coats of exterior enamel applied after the surface is acid-etched and primed with zinc-chromate primer.

Mounting hardware shall be black polycarbonate or galvanized steel and similar to mounting Signal Head hardware and brackets specified herein.

Basis of Payment: This work shall be paid for at the unit price each for ILLUMINATED SIGN, LED.

LED INTERNALLY ILLUMINATED STREET NAME SIGN

This work shall consist of furnishing a street name sign which is internally illuminated with light emitting diodes, and installing the sign on a traffic signal mast arm or span wire.

The sign shall be manufactured by Carmanah Technologies (Model R409), or Traffic Signs, Inc., (with a GELcore LED Light Engine), or approved equivalent.

The sign shall display the designated street name clearly and legibly in the daylight hours without being energized. When energized, the entire surface of the sign panel shall be evenly illuminated, and the light transmission factor shall provide a letter to background brightness ratio adequate for nighttime legibility. The sign face/panels shall be 0.125-inch translucent, high-impact, UV resistant polycarbonate. All surfaces shall be free of blemishes in the plastics or coating that might impair the service or detract from the general appearance of the sign. The sign frame shall be painted black with a durable powder coated process.

Street name signs shall have double-sided message, with the following exception: At locations where one side of a particular sign will not be visible to vehicular traffic, such as a "T" intersection, that sign shall be single-sided. The street name/legend and border shall be as shown on the plans. The font shall be ClearviewHwy 5-W.

Both sides of each sign shall have legend and border made of 3M/Scotchlite Series 4090T translucent white diamond grade sheeting (DG³T), overlaid by 3M/Scotchlite Series 1177 transparent green, electronically cutable film, or approved equivalent.

The sign shall be mounted on the mast arm three feet to the right of the furthest right signal head, as viewed by the approaching traffic.

Each sign shall be activated by a photocell mounted/installed on the side of the sign frame

The Manufacturer/Vendor shall supply shop drawings of the fixtures, sign, sign message and mounting hardware for approval. All hardware used to install the sign shall be in accordance with the manufacturer's recommendations.

Basis of Payment: This work will be paid for at the contract unit price each for furnishing and installing LED INTERNALLY ILLUMINATED STREET NAME SIGN, of the size specified, complete in place, including photocell and all related hardware, wiring, and connections required for proper operations.

RE-OPTIMIZE TRAFFIC SIGNAL SYSTEM

This work shall consist of providing a revised Signal Coordination and Timing (SCAT) Report and implementing optimized timings to an existing previously optimized closed loop trafficsignal system. This work is required due to the addition of a signalized intersection to an existing system or a modification of an existing signalized intersection which affects the quality of an existing system's operation. <u>MAINTENANCE OF THE SUBJECT INTERSECTION SHALL</u> <u>NOT BE TRANSFERRED TO THE COUNTY UNTIL THIS WORK IS COMPLETED AND</u> <u>ACCEPTED</u>.

After the new signalized intersection is added or the existing signal is modified, the traffic signal system shall be re-optimized by an approved consultant. The Contractor shall contact the County Traffic Engineer at (847) 377-7400 for a listing of approved consultants.

A listing of existing signal equipment, interconnect information and existing phasing/timing patterns may be obtained from the Lake County Traffic Engineering Department, if available and as appropriate. The consultant shall consult with the County Traffic Engineer prior to optimizing the system to determine if any extraordinary conditions exist that would affect traffic flows in the vicinity of the system; in which case, the consultant may be instructed to wait until the conditions return to normal or to follow specific instructions regarding the re-optimization.

Traffic counts shall be taken at the subject intersection no sooner than 30 days after the traffic signals are approved for operation by the County Traffic Engineer. Seven day/twenty-four hour automatic traffic recorder counts will be required and manual turning movement counts shall be conducted from 6:30 a.m. to 9:30 a.m., 11:00 a.m. to 1:00 p.m. and 3:30 p.m. to 6:30 p.m. on typical weekday from midday Monday to midday Friday, and if necessary, on the weekend. Additional manual turning movement counts may be necessary if heavy traffic flows exist during off peak hours. The turning movement counts shall identify cars, heavy vehicles, buses, and pedestrian movements.

A Capacity Analysis shall be conducted at the subject intersection to determine its level of service and degree of saturation. Appropriate signal timings shall be developed for the subject intersection and existing timings shall be utilized for the rest of the intersections in the system with minor adjustments if necessary. Changes to the cycle lengths and offsets for the entire system may be required due to the addition/modification of the subject intersection. Both volume and occupancy shall be considered when developing the re-optimized timing program. Signal system optimization analyses shall be conducted utilizing SYNCHRO, PASSER II, TRANSYT 7F, SIGNAL 2000 or other appropriate approved computer software.

If the system is being re-optimized due to the addition of a signalized intersection, all the intersections shall be re-addressed according to the current standard of District One. The proposed signal timing plan shall be forwarded to LCDOT for review prior to implementation.

The timing plan shall include a traffic responsive program and a time-of-day program which may be used as a back-up system. After downloading the system timings, the consultant shall make fine_tuning_adjustments_to_the_timing_in_the_field_to_alleviate_observed_adverse_operating_ conditions and to enhance signal coordination.

The consultant shall furnish to LCDOT an original and two copies of the revised SCAT Report for the re-optimized system. The report shall contain the following: turning movement and automatic traffic recorder counts, capacity analyses for each count period, computer optimization analysis for each count period, proposed implementation plans and summaries including system description, analysis methodology, method of effectiveness comparison results and special recommendations and/or observations. Copies of the entire database including intersection displays and zone displays shall be furnished to LCDOT.

Basis of Payment: This work shall be paid for at the contract unit price per lump sum for RE-OPTIMIZE TRAFFIC SIGNAL SYSTEM, which price shall be payment in full for performing all work described herein.

SIGNAL HEADS.

Add the following to Section 1078 of the "Standard Specifications" to read:

All vehicle signal and pedestrian signal heads shall provide 12-inch displays, with glossy black polycarbonate housings, with the following exception: At locations where existing yellow polycarbonate heads will remain, all new signal heads shall be yellow to match the existing ones. Connecting hardware and mounting brackets shall be polycarbonate, the same color as the heads, or galvanized. A corrosive resistant anti-seize lubricant shall be applied to all metallic mounting bracket joints, and shall be visible to the inspector at the signal turn-on. Post-top mounting collars are required on all posts, and shall be constructed of the same material as the brackets. Where required, incandescent bulbs shall be manufactured by Duratest, Sylvania or an approved equal. Signal heads shall be positioned according to the District 1 "Standard Traffic Signal Design Details".

SIGNAL HEAD, LIGHT EMITTING DIODE (LED)

This work shall consist of furnishing and installing a traffic signal head or pedestrian signal head with light emitting diodes (LED) of the type specified in the plan or retrofitting an existing traffic signal head with a traffic signal module or pedestrian signal module with LEDs as specified in the plans.

LED signal heads (All Face and Section Quantities), (All Mounting Types) shall conform fully to the requirements of Sections 880 and 881 and Articles 1078.01 and 1078.02 of the ""Standard Specifications" for Road and Bridge Construction," and amended herein:

The LED signal modules shall be replaced or repaired if an LED signal module fails to function as intended due to workmanship or material defects within the first <u>60 months</u> from the date of delivery. LED signal modules which exhibit luminous intensities less than the minimum values specified in Table 1 of the ITE Vehicle Traffic Control Signal Heads: Light Emitting Diode (LED) Circular Signal Supplement (VTCSH) or show signs of entrance of moisture or contaminants within the first <u>60 months</u> of the date of delivery shall be replaced or repaired. The manufacturer's written warranty for the LED signal modules shall be dated, signed by an Officer of the company and included in the product submittal to the County.

The lens of the module shall be tinted with a wavelength-matched color to reduce sun phantom effect and enhance on/off contrast. The tinting shall be uniform across the lens face, and shall not affect chromaticity.

Each module shall have a symbol of the type of module (i.e. circle, arrow, etc.) in the color of the module. The symbol shall be 1 inch in diameter. Additionally, the color shall be written out in $\frac{1}{2}$ -inch letters next to the symbol.

The LEDs utilized in the modules shall be AlInGaP technology for red, yellow, Portland orange (pedestrian) and white (pedestrian) indications, and GaN for green indications, and shall be the ultra bright type rated for 100,000 hours of continuous operation from -40°C to +74°C.

Maximum power consumption for LED modules is per Table 2.

Retrofit Traffic Signal Module:

All other specifications apply unless specifically superceded in this section.

- 1. Each Retrofit module (12-inch circular or 12-inch arrow indications) shall be designed to be installed in the doorframe of a standard traffic signal housing. The Retrofit module shall be sealed in the doorframe with a one-piece EPDM (ethylene propylene rubber) gasket.
- 2. The lens of the Retrofit module shall be integral to the unit, shall be convex with a smooth outer surface and made of plastic or of glass.
- 3. Each Retrofit module shall be a sealed unit to include all parts necessary for operation (a printed circuit board, power supply, a lens and gasket, etc.), and shall be weatherproof after installation and connection.

12-Inch Arrow Module:

All other specifications apply unless specifically superceded in this section.

- 1. The arrow module shall meet specifications stated in Section 9.01 of the Equipment and Material Standards of the Institute of Transportation Engineers, Chapter 2 (Vehicle Traffic Control Signal Heads) for arrow indications.
- 2. The LEDs arrow indication shall be a solid display with a minimum of three (3) outlining

rows of LEDs and at least one (1) fill row of LEDs.

12-inch Programmed Visibility (PV) Module:

All other specifications apply unless specifically superceded in this section.

- 1. The module shall be designed and constructed to be installed in a PV signal housing without modification to the housing.
- 2. The LEDs shall be spread evenly across the module

12-inch Pedestrian Module:

All other specifications apply unless specifically superceded in this section.

- 1. Each pedestrian signal LED module shall provide the ability to actuate the solid upraised hand and the solid walking person on one 12-inch section.
- 2. Two (2) pedestrian sections shall be installed. The top section shall be wired to illuminate only the upraised hand and the bottom section shall be the walking man.
- 3. "Egg Crate" type sun shields are not permitted. All figures must be a minimum of 9 inches in height and easily identified from a distance of 120-feet.
- 4. All pedestrian signals at an intersection shall be the same type and have the same display. No mixing of multiple types of pedestrian traffic signals will be permitted.

Basis of Payment.

This item shall be paid for at the contract unit price each for SIGNAL HEAD, LED, of the type specified, or PEDESTRIAN SIGNAL HEAD, LED, of the type specified, which price shall be payment in full for furnishing the equipment described above including signal head, LED(s) modules, all mounting hardware, and installing them in satisfactory operating condition.

When installed in an existing signal head, this item shall be paid for at the contract unit price each for SIGNAL HEAD, LED of the type specified, RETROFIT, or PEDESTRIAN SIGNAL HEAD, LED, of the type specified, RETROFIT, which price shall be payment in full for furnishing the equipment described above including LED(s) modules, all mounting hardware, and installing them in satisfactory operating condition.

The type specified will indicate the number of signal faces, the number of signal sections, and the method of mounting.

PEDESTRIAN COUNTDOWN SIGNAL HEAD, LIGHT EMITTING DIODE (LED)

This work shall consist of furnishing and installing a pedestrian countdown signal head, with light emitting diodes (LED) of the type specified in the plan or retrofitting an existing pedestrian traffic signal head with a pedestrian countdown signal module with LEDs as specified in the plan.

PEDESTRIAN COUNTDOWN SIGNAL HEAD, LIGHT EMITTING DIODE, shall conform fully to the SIGNAL HEAD, LIGHT EMITTING DIODE specification, with the following modifications:

Pedestrian Countdown Signal Heads, including Retrofit type, shall not be used at signalized intersections where traffic signals and railroad warning devices are interconnected.

Pedestrian Countdown Signal Heads, including Retrofit type, shall measure 12 inches x 12 inches, with 9-inch high countdown numerals, and form the time display utilizing two rows of LEDs.

Pedestrian Countdown Signal Heads shall consist of two (2) 12-inch by 12-inch modules aligned vertically. The top module of the unit shall be an LED message-bearing surface supplied with overlapping full "HAND" and full "MAN" symbols that comply with the ITE Pedestrian Traffic Control Signal Indications (PTCSI) standard for these symbols. The bottom module of the unit shall house a LED countdown traffic signal consisting of a two digit numerical display ("00" to "99") a minimum of nine (9) inches in height. The counter shall begin countdown at the beginning of the pedestrian clearance interval as the pictogram of the hand starts flashing. The counter shall execute a countdown of the time, in seconds, of the pedestrian clearance interval synchronized with the controller and ending at (0) at the expiration of the clearance interval. The counter shall be blank at all other times.

Retrofit Pedestrian Countdown Signal Module:

The Retrofit module shall be applicable where two (2) LED pedestrian signal sections exist, each with the Upraised Hand and Walking Person overlaid with the top section wired to illuminate only the Upraised Hand and the bottom section wired to illuminate only the Walking Person. The top section shall be re-wired to provide illumination of either of the displays, depending on the interval or phase. The contractor shall remove the existing bottom pedestrian overlay module and install a new countdown module.

Basis of Payment.

This item shall be paid for at the contract unit price each for PEDESTRIAN COUNTDOWN SIGNAL HEAD, LED, of the type specified, which shall be payment in full for furnishing the equipment described above including LED(s) modules, all mounting hardware, and installing them in satisfactory operating condition. The type specified will indicate the number of faces and the method of mounting.

When installed in an existing signal head, this item shall be paid for at the contract unit price each for PEDESTRAIN COUNTDOWN SIGNAL HEAD, LED, RETROFIT, which price shall be payment in full for furnishing the equipment described above including LED(s) modules, all mounting hardware, and installing them in satisfactory operating condition.

TRAFFIC SIGNAL BACKPLATE, LOUVERED, ALUMINUM.

Replace the first sentence of Article 1078.03 of the "Standard Specifications" with "All backplates shall be aluminum" and louvered".

VIDEO DETECTION SYSTEM COMPLETE INTERSECTION

This specification sets forth the minimum requirements for a system that monitors vehicles on a

roadway via processing of video images and provides detector outputs to a traffic controller or similar device. This work shall consist of furnishing and installing an Autoscope Solo Terra or approved equal video vehicle detection system at one signalized intersection, including all necessary hardware, cable and accessories necessary to complete the installation in accordance with the manufacturer's specifications.

The Autoscope Solo Machine Vision Processor (MVP) is normally installed on top of the luminaire arm. However, occasionally overhead utility wires obstruct the camera's field of view and prevent proper detector placement. When this occurs, the camera shall be installed on a J-hook below the luminaire arm.

In order for the Traffic Engineer to manipulate detection zones and view the video signal over a high-speed connection, the VIDEO DETECTION SYSTEM COMPLETE INTERSECTION must be connected to either the LCDOT Gigabit Ethernet network or a VIDEO TRANSMISSION SYSTEM.

If the VIDEO DETECTION SYSTEM COMPLETE INTERSECTION is being connected to the Gigabit Ethernet network, then a LAYER II (DATA LINK) SWITCH and/or a LAYER III (NETWORK) SWITCH will be required. Layer II and Layer III switches shall be installed according to the plans, and shall be paid for separately.

If the VIDEO DETECTION SYSTEM COMPLETE INTERSECTION is being connected to a new or existing VIDEO TRANSMISSION SYSTEM, then fiber-optic video/data transmitters and receivers may be required. Fiber-optic video/data transmitters and receivers are necessary whenever the VIDEO DETECTION SYSTEM COMPLETE INTERSECTION and the VIDEO TRANSMISSION SYSTEM are installed at separate signalized intersections. When required, fiber-optic video/data transmitters and receivers shall be installed according to the plans, and shall be included in the cost of this item. The VIDEO TRANSMISSION SYSTEM shall be paid for separately.

The system shall consist of integrated machine vision processor sensors (MVPs), an interface panel, and a detector interface card. The quantity of MVP sensors included with this pay item shall be as shown on the plans. The system shall also include a ten-inch color VGA monitor with BNC connector for video input. At signalized intersections that are not connected to the LCDOT Gigabit Ethernet network, a four-channel, real-time, color quad switcher unit shall be provided to select video input to the monitor. Vehicle detection zones shall be user-defined through interactive graphics by placing lines and/or boxes in an image on a VGA monitor. The system shall calculate traffic parameters in real-time and provide local non-volatile data storage for later downloading and analysis.

I. Introduction

The video vehicle detection system shall be easily configurable and expandable to meet traffic management applications such as intersection control, traffic monitoring, incident management, and traffic data collection. The system shall be composed of the following components:

- A machine vision processor (MVP) sensor that provides vehicle detection, JPEG video compression, and communications with other subsystems.
- Detector Interface Card
- A Windows-based communications and Windows-based applications software for setup and system configuration as well as any continued monitoring and data collection, if required.
- System communications that shall operate over any appropriate serial and/or Ethernet communications links provided by the systems integrator.
- An integrated color camera, zoom lens, and machine vision processor all in one unit; direct, real-time iris and shutter speed control; with single-frame, JPEG image compression.
- The system shall also have easily configured IP addressing for the MVP sensor field network.

II. MVP Sensor

The MVP sensor shall combine an integrated high-speed, color imaging CCD array with zoom lens optics, image-processing hardware and a general-purpose CPU bundled into a sealed enclosure. The sensor shall be equipped with a sunshield to reflect solar heat and to shield the CCD array and faceplate from direct exposure to the sun. The sensor shall also be equipped with a faceplate heater to prevent accumulated ice, snow, or condensation from obscuring the view of the camera. The general-purpose CPU shall directly control the optics and camera electronics.

The lens shall be pre-focused at the factory and shall not require field adjustment. The zoom optics shall maintain focus throughout the operating range from 7 to 74 degrees horizontal field of view (5 to 58 degrees vertical field of view). At an operator's request, the MVP sensor shall temporarily switch to surveillance mode operation, which allows the operator to zoom the lens.

The MVP sensor shall provide color analog video output at 30 frames per second, and shall process a minimum of twenty (20) detector zones placed anywhere in the field of view of the sensor. The analog video output shall provide graphics overlay that indicates the current real-time detection state.

MVP Sensor External Interfaces

The external interfaces to the MVP sensor shall include the following:

Network Communications Port

There shall be a field network communications port to configure and provide general communications and data retrieval. The MVP sensor shall use a full- or half-duplex, RS-485, 4-wire electrical network to facilitate communications with a Windows computer. This port shall

be used to update the embedded software and to interact with applications software for the various detection requests supported by the MVP sensor.

Detector I/O Port

The MVP sensor detector port shall use a dedicated, RS-485 2-wire, half-duplex interface between the MVP sensor and a detector interface card. The real-time state of traffic controller phase inputs shall be transmitted to the MVP sensor. The detector interface card shall subsequently translate the detection states to a traffic signal controller.

Differential Video

The MVP sensor shall output full motion, differential analog video over a single, twisted pair.

Power

The MVP sensor shall operate on 24 VAC at 50/60 Hz or 24 VDC. The camera and processor electronics and power supply shall consume a maximum of 10 watts. The integrated faceplate heater shall consume a maximum of 5 watts.

MVP Sensor Vehicle Detection Requirements

The MVP sensor shall be able to be programmed with a variety of detector types which can perform the following functions:

- Presence/passage detection of moving and stopped vehicles.
- Detection based on the direction of travel.
- Measure vehicle speed and length and provide five (5) classes of vehicles based on length.
- Detect incident shock waves using effective detection algorithms.
- Generate alarm status based on the detection of shock waves, wrong-way vehicles, stopped vehicles, red-light runners, or other operator-defined traffic conditions.
- Combine the output of multiple detectors with logical operators and modify the combined state based on delay or extension timers.

Detection Zone Programming

A VGA monitor shall display the detection zones superimposed on images of traffic scenes. A mouse and keyboard shall be used to place, size, and orient detection zones and edit previously defined detector configurations. It shall also be possible to download detector configurations from the computer to the MVP sensor and upload the current detector configuration that is running in the MVP sensor.

Count Detection Performance

Using an MVP sensor installed for optimal viewing, the system shall be able to accurately count vehicles with at least 96% accuracy under normal operating conditions (day and night), and at least 93%-accuracy under artifact conditions. Artifact conditions are combinations of weather andlighting conditions that result from shadows, fog, rain, snow, etc. The volume count shall be accumulated for all traveled lanes, and accumulated over time intervals that contain a minimum of one hundred (100) vehicles to ensure statistical significance.

Demand Presence Detection Performance

The system shall be able to accurately provide demand presence detection. The demand presence accuracy shall be based on the ability to enable a protected turning movement on an intersection stop line, when a demand exists. The probability of not detecting a vehicle for demand presence shall be less than 1-percent error under all operating conditions. In the presence of artifact conditions, the MVP sensor shall minimize extraneous (false) protected movement calls to less than 7%.

Speed Detection Performance

The MVP sensor shall accurately measure average speed of multiple vehicles with more than 98% accuracy under all operating conditions for approaching and receding traffic. The MVP sensor shall accurately measure individual vehicle speeds with more than 95% accuracy under all operating conditions for vehicles approaching the sensor and 90% accuracy for vehicles receding from the sensor.

MVP Sensor Enclosure

The MVP sensor and lens assembly shall be housed in an environmental enclosure that provides the following capabilities:

- The enclosure shall be waterproof and dust-tight to NEMA-4 specifications, and shall have the option to be pressurized with dry nitrogen to 5 ± 1 psi.
- The enclosure shall allow the MVP sensor to operate satisfactorily over an ambient temperature range from -34 degrees C to +60 degrees C while exposed to precipitation as well as direct sunlight.
- The enclosure shall allow the image sensor horizon to be rotated during field installation.
- A faceplate heater shall prevent the formation of ice and condensation in cold weather.

MVP Sensor Electrical

All video connections from the sensor shall be isolated from earth ground. The video output, communication, and power stages of the sensor shall include transient protection to prevent damage to the sensor. The MVP sensor shall meet CE, FCC, and UL requirements for safety and EMI.

III. Communications (Video Interface) Panel Requirements

The communications interface panel shall provide a terminal block for terminating power, as well as terminations for two twisted-pair wires for network communications to the MVP sensor, one twisted-pair for output from the MVP sensor, and one twisted-pair for detector port-communications. The panel shall also provide two sets of terminations for two twisted-pair wires for a point-to-point field network. The communications interface panel shall also provide transient protection and a DB9 connector for an optional traffic signal controller interface. This panel shall include a Gigabit Ethernet port and a serial port.

IV. Detector Interface Card

The system shall use a defined communication protocol (detector port protocol) between the MVP sensors and the detector interface card. The protocol shall be used to communicate TS1 input pins, TS1 output pins, TS2 detector states, and TS2 phase states.

V. Camera Protection / Installation Requirements

To protect the video detection cameras from electrical surges, the communications interface panel shall be grounded as follows:

- 1. The chassis sheet metal must be tied to ground with the supplied ground wire and stud.
- 2. All shield wires should be tied to the chassis ground stud.
- 3. Terminal position three (3) of each of the camera terminations shall be tied to the ground stud.
- 4. All extra/spare wires in the Autoscope MVP cable should be tied to ground.

VI. Basis of Payment

This item will be paid for at the contract unit price each for VIDEO DETECTION SYSTEM COMPLETE INTERSECTION which price shall be payment in full for furnishing all associated equipment required, installing the system at one signalized intersection, and placing the system in operation to the satisfaction of the Engineer.

REMOTE-CONTROLLED VIDEO SYSTEM

This pay item shall include providing and installing a remote-controlled video system at a location designated by the Engineer. The remote-controlled video system shall be a PELCO Spectra IV SE Series Discreet Dome System or approved equal. This pay item shall include a color camera (minimum 35x optical zoom), dome assembly, all mounting hardware, connectors, cables, and related equipment necessary to complete the installation in accordance with the manufacturer's specifications.

The contractor shall contact the Traffic Engineer prior to installing the Pelco camera and associated wiring, to receive final approval on the camera location

In order for the Traffic Engineer to control the camera remotely and view the video signal over a high-speed connection, the REMOTE-CONTROLLED VIDEO SYSTEM must be connected to either the LCDOT Gigabit Ethernet network or a VIDEO TRANSMISSION SYSTEM.

If the REMOTE-CONTROLLED VIDEO SYSTEM is being connected to the Gigabit Ethernet network, then a LAYER II (DATA LINK) SWITCH and/or a LAYER III (NETWORK) SWITCH will be required. Layer II and Layer III switches shall be installed according to the plans, and shall be paid for separately.

If the REMOTE-CONTROLLED VIDEO SYSTEM is being connected to a new or existing VIDEO TRANSMISSION SYSTEM, then fiber-optic video/data transmitters and receivers may be required. Fiber-optic video/data transmitters and receivers are necessary whenever the REMOTE-CONTROLLED VIDEO SYSTEM and the VIDEO TRANSMISSION SYSTEM are installed at separate signalized intersections. When required, fiber-optic video/data transmitters and receivers shall be installed according to the plans, and shall be included in the cost of this item. The VIDEO TRANSMISSION SYSTEM shall be paid for separately.

Basis of Payment: This item will be paid for at the contract unit price each for REMOTE-CONTROLLED VIDEO SYSTEM, which price shall be payment in full for furnishing all associated equipment required, installing the system complete and in place, and placing the system in operation to the satisfaction of the Engineer.

CAMERA MOUNTING ASSEMBLY.

This work shall consist of modifying an existing traffic signal mast arm pole to accommodate an extension pole suitable for mounting a CCTV Camera. The pole extension shall be a 20-foot long, 4-inch diameter, Schedule 80 galvanized steel pipe and fastened to the existing mast arm pole with adjustable, galvanized steel clamps as indicated in the plans.

Basis of Payment: This work shall be paid for at the contract unit price each for CAMERA MOUNTING ASSEMBLY, which shall include all necessary mounting hardware, labor, and incidentals necessary to securely fasten the assembly to an existing pole and placing the camera in operation to the satisfaction of the Engineer. The camera, cables, connectors, and related equipment shall be paid for separately as part of REMOTE-CONTROLLED VIDEO SYSTEM.

VIDEO TRANSMISSION SYSTEM

General

This specification sets forth the minimum requirements for a video transmission system that allows a user to transmit video output from multiple cameras to a remote location, via video transmitter(s) and a high-speed communication link.

The VIDEO TRANSMISSION SYSTEM may be installed in either the intersection traffic signal cabinet or in the VIDEO-COMMUNICATIONS CABINET. The Cabinet shall be paid for separately.

The VIDEO TRANSMISSION SYSTEM may include the relocation of existing video transmitter(s), ISDN modems, and/or high-speed Internet modem(s) to a new traffic signal cabinet. The relocation of such existing equipment to a new traffic signal cabinet shall be performed as directed by the Engineer and included in the cost of the VIDEO TRANSMISSION SYSTEM. Any item damaged during removal, storage, or reinstallation shall be repaired or replaced in kind to the satisfaction of the Engineer at the Contractor's expense.

System Components

The system shall consist of video transmitter(s) (ADPRO Fast Tx or approved equal), high-speed Internet modem(s), and related connection cables.

High-Speed Internet Modem

The high-speed Internet modem shall be provided by the County or the Internet Provider.

Basis of Payment: This item will be paid for at the contract unit price each for VIDEO TRANSMISSION SYSTEM, which price shall be payment in full for furnishing and/or relocating all associated equipment required, installing the system complete and in place, and placing the system in operation to the satisfaction of the Engineer

LAYER II (DATA LINK) SWITCH

This specification sets forth the minimum requirements for a layer two Ethernet switch that will transmit data from one traffic signal cabinet to another traffic signal cabinet containing a layer two switch or a layer three (Network) switch.

The layer two switch shall be a Cisco Catalyst 2955 Series Intelligent Ethernet Switch, or approved equal. This pay item shall include the layer two switch, one Bosch VidQuad digital video processor (Model LTC 2377/60), one video encoder/decoder (CODEC) for the video detection cameras at the intersection (if applicable), and one video encoder/decoder (CODEC) for the PTZ camera at the intersection (if applicable). The video CODEC(s) shall be Optelecom Model C-40, or approved equivalent. Other video CODECs submitted for approval must be compatible with the Lake County Passage Advanced Traffic Management System (ATMS) software and VideoLAN VLC Media Player Release 0.8.6 or later.

The Layer II (Data Link) Switch and Video CODEC shall be procured from Delcan, the County's Passage engineering consultant. Delcan shall program this equipment for the appropriate location in the County's communication network. The County's Passage Traffic Signal Software supplier shall acquire the pre-programmed switch and video CODEC from Delcan, and install in signal cabinets and/or communication cabinets, as required.

If the layer two switch is interconnected to other signalized intersections that deploy video detection without the use of switches, this pay item shall then also include all necessary video multiplexers, video and data transmitters, video encoders, and all necessary connections for proper video/data communications.

Basis of Payment: This item will be paid for at the contract unit price each for LAYER II (DATA LINK) SWITCH, which price shall be payment in full for furnishing and installing the switch, the digital video processor, the CODEC(s), media converters, terminal servers, and all necessary connectors, cables, hardware, software, other peripheral equipment, and placing it in operation to the satisfaction of the Engineer.

LAYER III (NETWORK) SWITCH

This specification sets forth the minimum requirements for a layer three switch that will transmit video data from one traffic signal cabinet to another traffic signal cabinet or to another location having a layer three switch.

The layer three switch shall be a Cisco Catalyst 3550 Series Intelligent Ethernet Switch, or approved equal. This pay item shall include the layer three switch, one Bosch VidQuad digital video processor (Model LTC 2377/60), one video encoder/decoder (CODEC) for the video detection cameras at the intersection (if applicable), and one video encoder/decoder (CODEC) for the PTZ camera at the intersection (if applicable). The video CODEC(s) shall be Optelecom Model C-40, or approved equivalent. Other video CODECs submitted for approval must be compatible with the Lake County Passage Advanced Traffic Management System (ATMS) software and VideoLAN VLC Media Player Release 0.8.6 or later.

The Layer III (Network) Switch and Video CODEC shall be procured from Delcan, the County's Passage engineering consultant. Delcan shall program this equipment for the appropriate location in the County's communication network. The County's Passage Traffic Signal Software supplier shall acquire the pre-programmed switch and video CODEC from Delcan, and install in signal cabinets and/or communication cabinets, as required.

If the layer three switch is interconnected to other signalized intersections that deploy video detection without the use of switches, this pay item shall then also include all necessary video multiplexers, video and data transmitters, video encoders, and all necessary connections for proper video/data communications.

Basis of Payment: This item will be paid for at the contract unit price each for LAYER III (NETWORK) SWITCH, which price shall be payment in full for furnishing and installing the switch the digital video processor, the CODEC(s), media converters, terminal servers, and all necessary connectors, cables, hardware, software, other peripheral equipment, and placing it in operation to the satisfaction of the Engineer.

VIDEO COMMUNICATIONS CABINET.

This specification sets forth the minimum requirements for a video communications cabinet to be installed at the location(s) shown in the plans. The cabinet shall house the fiber optic termination equipment, layer three switches, and/or video transmission system, all of which will be paid for separately.

The Video Communications Cabinet shall be a Model 332 (Type 170) Controller Cabinet, with heat exchanger, or approved equal. The heat exchanger shall be thermostatically controlled to maintain the temperature between 32°F and 122°F within the enclosure. The cabinet shall be constructed of 0.125"-thickness, alloy-5052 sheet aluminum. The surface shall have a smooth, natural aluminum mill finish. The cabinet shall measure 24" wide x 30" deep x 55" high.

The communications cabinet shall have front and rear doors of NEMA type 3R construction with cellular neoprene gasket that is rain tight. Door hinges shall be continuous 14-gauge stainless

steel and shall be secured with ¹/₄-20 stainless steel carriage bolts. Standard equipment shall include a three-point locking system that secures the door at the top, bottom and center. A corbin lock-with two-keys shall also be furnished. The front and rear doors shall be equipped with a two-position doorstop, one at 90° and one at 120°. Door locking rods are ¹/₄" x ³/₄" aluminum turned edgeways with 1" nylon rollers. Door handles shall be cast aluminum.

The cabinet shall be base mounted and equipped with inside flanges and anchoring holes in the front and back of the cabinet for anchoring to a base.

The cabinet shall be equipped with a 19" Electronic Industries Association (EIA) rack using 1.75" hole spacing for the purpose of mounting rack-mountable cabinet equipment. The cabinet shall include a splice enclosure, Corning Cable Systems CSH-05U, or approved equal, mounted on the 19" rack.

The cabinet shall also be equipped with a CCTV Power Distribution Assembly and a pull-out drawer/ shelf assembly.

The cabinet shall include one (1) 200-watt, thermostatically-controlled, Hoffman electric heater, or approved equivalent.

A power panel shall be included with the cabinet and shall include the following:

- 50-amp circuit breaker. This circuit breaker shall supply power to all devices in the cabinet.
- The main breaker shall be thermal magnetic type, U.L. listed for HACR service, with a minimum of 20,000 amp interrupting capacity.
- Two 15-amp load breakers with minimum 10,000 amp interrupting capacity.
- Two 20-amp load breakers with minimum 10,000 amp interrupting capacity.
- An EDCO model SHA-1250 surge arrestor, with fault indicator, or approved equivalent.
- A 15-position neutral bus bar capable of connecting three #12 wires per position.
- A 7-position ground bus bar capable of connecting three #12 wires per position.
- A NEMA type 5-15R GFI convenience outlet.
- A power supply with input voltage AC100-120/220-240V (switchable) 47-63 Hz, output voltage 24VDC (+5%, -1%), overload protection, and minimum operating temperature range -10° to +60°C. The power supply must be compatible with Cisco Catalyst 2955 Series switch.

The heat exchanger shall be mounted on the side of the communications cabinet and conform to the following specifications.

- Maximum dimensions of 47 inches high x 15 inches wide x 11 inches deep
- The unit shall provide closed-loop system cooling and heating
- Unit shall be fully gasketed and maintain the NEMA 3R enclosure rating

- Shall utilize a high efficiency, convoluted, refrigerant-free, aluminum heat transfer element
- Shall operate under maximum enclosure temperature of 150°F and maximum ambient temperature of 131°F
- The unit shall dissipate a minimum of 54 Watts per °F
- Shall operate on 115 VAC, 60 Hz
- Unit shall be UL listed

Basis of Payment: This item will be paid for at the contract unit price each for VIDEO COMMUNICATIONS CABINET, which price shall be payment in full for furnishing all associated equipment and labor, and installing the cabinet as shown on the plans and to the satisfaction of the Engineer. The concrete foundation for the cabinet shall be paid for separately.

RELOCATE EXISTING VIDEO DETECTION SYSTEM (COMPLETE INTERSECTION).

This work shall consist of the removal, storage, and relocation of an existing video detection system (complete intersection) from one traffic signal installation (temporary or permanent) to another traffic signal installation (temporary or permanent). This item shall also include the relocation of the remote-controlled video system according to the plans.

The video detection system (complete intersection) shall be removed and relocated as shown in the plans. Any damage sustained to the video detection system during removal, storage, transport, and/or reinstallation operations shall be repaired or replaced in kind to the satisfaction of the Engineer at the Contractor's expense.

Basis of Payment: This item will be paid for at the contract unit price each for RELOCATE EXISTING VIDEO DETECTION SYSTEM (COMPLETE INTERSECTION), which price shall be payment in full for disconnecting the existing video detection system, remote-controlled video system, packaging/storing it, transporting it, and relocating it to the new location complete and operating to the satisfaction of the Engineer.

RELOCATE EXISTING REMOTE-CONTROLLED VIDEO SYSTEM.

This work shall consist of the removal, storage, and relocation of an existing remote-controlled video system from one traffic signal installation (temporary or permanent) to another traffic signal installation (temporary or permanent). This pay item shall be used when only the remote-controlled video system is being relocated. This pay item shall not be used when the remote-controlled video system is being relocated as part of RELOCATE EXISTING VIDEO DETECTION SYSTEM (COMPLETE INTERSECTION).

The remote-controlled video system shall be removed and relocated as shown in the plans. Any damage sustained to the remote-controlled video system during removal, storage, transport,

and/or reinstallation operations shall be repaired or replaced in kind to the satisfaction of the Engineer at the Contractor's expense.

Basis of Payment: This item will be paid for at the contract unit price each for RELOCATE EXISTING REMOTE-CONTROLLED VIDEO SYSTEM, which price shall be payment in full for disconnecting the existing remote-controlled video system, packaging/storing it, transporting it, and relocating it to the new location complete and operating to the satisfaction of the Engineer.

RELOCATE EXISTING SWITCH.

This work shall consist of the removal, storage, and relocation of an existing layer two or layer three switch from one traffic signal installation to another traffic signal installation.

The switch shall be removed and relocated as shown in the plans. Any damage sustained to the switch during removal, storage, transport, and/or reinstallation operations shall be repaired or replaced in kind to the satisfaction of the Engineer at the Contractor's expense.

Basis of Payment: This item will be paid for at the contract unit price each for RELOCATE EXISTING SWITCH, which price shall be payment in full for disconnecting the existing switch, packaging/storing it, transporting it, and relocating it to the new location complete and operating to the satisfaction of the Engineer.

COAXIAL CABLE IN CONDUIT

This work shall consist of furnishing and installing a Belden 8281 RG-59U Type Coaxial Cable or approved equal. The cable shall be a 75-ohm coaxial cable with 20 AWG solid bare copper conductor, tinned copper double-braided shield (96% min), and black polyethylene jacket. The nominal outside diameter shall be 0.304 inches. Amphenol 31-71032 (or equivalent) BNC plug connectors shall be used at both the PTZ camera and traffic signal cabinet ends of the cable. An Amphenol CLT-2 crimping tool is required for the termination. No splices shall be allowed in the cable between the PTZ camera and the traffic signal cabinet.

Basis of Payment: This work will be paid for at the contract unit price per foot for COAXIAL CABLE IN CONDUIT, which price shall be payment in full for furnishing the material, making all electrical connections and installing the cable complete, measured as specified herein.

ELECTRIC CABLE IN CONDUIT, COMMUNICATION, NO. 16, 5½ PAIR

This work shall consist of furnishing and installing a Belden YC46223 communications cable, or approved equal, in existing and/or new conduit. This Belden cable has a color code that matches the MVP cable currently in use by the County. The cable shall consist of 16 AWG stranded bare

copper twisted-pair conductors, with PVC insulation, and PVC jacket with nylon ripcord. The nominal outside diameter shall be 0.502-inch.

The communications cable, No. 16, $5\frac{1}{2}$ pair shall be spliced to the MVP Cable in the base of the signal mast arm pole on which the MVP is mounted. The MVP cable shall be provided by the MVP manufacturer. The communications cable shall be provided by the Contractor. The conductors from the two cables shall be spliced using the 3M Scotchlok gel-filled splice tabs (part number 314). Each splice shall be individually protected with shrink tubing. The individual splices shall also be bundled together and protected with shrink tubing. The cost of all work associated with splicing the cables shall be considered incidental to the cost of the communications cable, No. 16, $5\frac{1}{2}$ pair.

Basis of Payment: This work will be paid for at the contract unit price per foot for ELECTRIC CABLE IN CONDUIT, COMMUNICATION NO. 16, 5½ PAIR, which price shall be payment in full for furnishing, installing and making all electrical connections necessary for proper operation.

TRENCH AND BACKFILL FOR ELECTRICAL WORK

Effective: January 1, 2007

Revise the first sentence of Article 819.03(a) of the Standard Specifications to read:

"Trench. Trenches shall have a minimum depth of 30 in. (760 mm) or as otherwise indicated on the plans, and shall not exceed 12 in. (300 mm) in width without prior approval of the Engineer."

CONDUIT PUSHED, 4" DIA., GALVANIZED STEEL

The conduit shall meet the requirements of Section 810 of the Standard Specifications, the UNDERGROUND RACEWAYS special provision, and the following:

All buried conduits shall be placed at a minimum depth of 30 inches, except under railroad tracks, where the minimum depth shall be five (5) feet, as measured from the final surface grade to the top of the conduit. All conduit couplings shall be threaded.

LUMINAIRE, SODIUM VAPOR, HORIZONTAL MOUNT, 310 WATT LUMINAIRE, SODIUM VAPOR, HORIZONTAL MOUNT, 400 WATT LUMINAIRE, SODIUM VAPOR, VERTICAL MOUNT, 310 WATT

This item shall consist of furnishing and installing a pole/mast arm-mounted luminaire in accordance with Section 821 of the Standard Specifications and as described herein.

Horizontal mount 310 and 400 watt luminaires shall be the 'cobra head' type. Vertical mount 310 watt luminaires shall be Holophane model number MP310HPMTB4 S-67533 or approved equivalent.

The luminaire shall have a separate access door for the installation and service of the ballast and electrical components.

Unless otherwise indicated, the light distribution shall be full-cutoff Type III, as defined in the "American National Standard Practice for Roadway Lighting" as approved July 21, 1983 by the "American National Standards Institute" (ANSI).

The luminaires shall have a black finish.

The luminaire photometric performance shall produce results equal to or better than those listed in the applicable Luminaire Performance Table or tables included in these Special Provisions or shown on the plans. Submittal information shall include computer calculations based on the controlling given conditions, which demonstrate achievement of all listed performance requirements. The computer calculations shall be done in accordance with I.E.S. recommendations and the submitted calculations shall include point-by-point illuminance, luminance and veiling luminance as well as listings of all indicated averages and ratios. The program used to perform the calculations shall be identified on the submittal.

In addition to computer printouts of photometric performance, submittal information shall include:

- Descriptive literature.
- Isofootcandle chart of horizontal foot-candles.
- Utilization curve.
- Isocandela diagram.
- Luminaire classification per ANSI designation.
- Candlepower values at every 2.5 degree intervals.
- Candlepower tables are to be provided on 88.90 mm (3 1/2") diskette in the I.E.S. format.

This item shall consist of furnishing, installing, and connecting the pole wire to the underground distribution system. The pole wire shall be (three) 3-1/C No. 10 AWG 600 volt insulated copper conductor, USE/XLP, stranded in conformance with ASTM B-8. It shall be installed from the luminaire terminal blocks to the pole handhole, as applicable, per Sections 821 and 1066.09 for Roadway Lighting pole wire between the underground distribution system and the luminaire in a moisture-proof manner. The colors shall be black, red, and green. The wire is to run inside the pole and mast arm. The pole wire and all necessary connections of pole wire to the terminals including the use of splices as described in the details shall be included in the unit cost of the this item.

The Contractor shall furnish and install In-line fuse holder(s) and fuse(s) on all leads shall be in accordance with Article 1065.01 of the standard specifications and as follows:

Fuse holders of the in-line quick disconnect breakaway type shall be used on all light pole installations in the base of each lighting standard. The fuse holder shall have a minimum rating of 30 amps and be sized for 13/32" x 1 1/2" fuses. Fuse holder shall be Edison HEB-AW-RLC-A 30A 600V for load/line and HET-AW-RLC-A for neutral or equal as approved by Engineer.

Wires shall be carefully stripped only as far as needed for connection to the device. Overstripping shall be avoided. An oxide inhibiting lubricant shall be applied to the wire for minimum connection resistance before the terminals are crimped-on. Crimping shall be performed in accordance with the fuse holder manufacturer's recommendations. The exposed metal connecting portion of the assembly shall be taped with two half-lapped wraps of electrical tape and then covered by the specified insulating boot. The fuse holder shall be installed such that the fuse side is connected to the pole wire (load side) and the receptacle side of the holder connected to the line side.

In-line fuse holder(s) shall be provided on all neutral conductors with a solid slug in place of the fuse in the base of each lighting standard.

Fuses for fuse holders on line/load cable to pole wire connection shall be Type MEQ or MEM equal 10 ampere rating.

BASIS OF PAYMENT

This item shall be paid for at the contract unit price EACH for LUMINAIRE, SODIUM VAPOR, HORIZONTAL MOUNT, of the type specified, which shall be payment in full for the work described herein.

This work shall-consist of furnishing and installing an aluminum light pole of the specified mountingheight and mast arm(s) of the specified length at the locations shown on the plans in accordance with the details, Section 830 of the Standard Specifications, District One Recurring Special Provisions for Roadway Lighting and as described herein.

All light poles shall have a black finish.

BASIS OF PAYMENT

This item shall be paid for at the contract unit price EACH for LIGHT POLE, ALUMINUM, 45 FT. M.H., 15 FT. MAST ARM, which shall be payment in full for the work as described herein.

REMOVE EXISTING HANDHOLE

This work shall be completed in accordance with the applicable portions of Article 895.05(b) of the Standard Specifications, the following shall be added to the specification.

BASIS OF PAYMENT: Removal of the existing handhole will be paid for at the contract unit price per each for REMOVE EXISTING HANDHOLE, which payment shall be full compensation for all labor, equipment, and disposal necessary to complete the work.

REMOVE EXISTING CONCRETE FOUNDATION

This work shall be completed in accordance with the applicable portions of Article 895.05(c) of the Standard Specifications, the following shall be added to the specification.

BASIS OF PAYMENT: Removal of the existing concrete foundation will be paid for at the contract unit price per each for REMOVE EXISTING CONCRETE FOUNDATION, which payment shall be full compensation for all labor, equipment and disposal necessary to complete the work.

PLUG EXISTING SANITARY SEWERS

This work shall be completed in accordance with the applicable portions of Article 550.05 of the Standard Specifications and the Plan Detail, the following shall be added to the specification.

BASIS OF PAYMENT: Plugging the existing sanitary sewers will be paid for at the contract unit price per each for PLUG EXISTING SANITARY SEWERS, which payment shall be full

compensation for all labor, equipment and materials necessary to complete the work.

SANITARY MANHOLES TO BE REMOVED

This work shall be completed in accordance with the applicable portions of Section 605 of the Standard Specifications.

BASIS OF PAYMENT: Removal of the existing sanitary manholes will be paid for at the contract unit price per each for SANITARY MANHOLES TO BE REMOVED, which payment shall be full compensation for all labor, equipment and disposal necessary to complete the work.

DOUBLE HANDHOLE REMOVAL

This work shall be completed in accordance with the applicable portions of Article 895.05(b) of the Standard Specifications, the following shall be added to the specification.

BASIS OF PAYMENT: Removal of the existing double handhole will be paid for at the contract unit price per each for DOUBLE HANDOLE REMOVAL, which payment shall be full compensation for all labor, equipment, and disposal necessary to complete the work.

ABANDON AND FILL EXISTING SANITARY MANHOLE

This work shall be completed in accordance with the applicable portions of Article 605.04 of the Standard Specifications and the Plan Detail.

BASIS OF PAYMENT: Abandoning and filling of the existing sanitary manholes will be paid for at the contract unit price per each for ABANDON AND FILL EXISTING SANITARY MANHOLE, which payment shall be full compensation for all labor, equipment and materials necessary to complete the work.

SANITARY SEWER

This work shall be done in accordance with Section 30 of the Water and Sewer Main Specifications except as herein modified. Pipe material shall be polyvinyl chloride (PVC) sewer pipe with SDR 26 rating or ductile iron pipe, ASTM D3034 or ASTM F-679-89 depending on size as indicated in the plans. Pipe bedding and initial backfill shall be Crushed Stone, Gradation CA-6 (Class 1B per ASTM D2321-00) and Crushed Stone, Gradation CA-7 (Class 1A per ASTM D2321-00) and be placed in accordance with Section 30 and the Plan Details. Testing for

acceptance of sanitary sewers shall be done in accordance with Article 31-1.11 of the Water and Sewer Main Specifications. Method A (Exfiltration of air under pressure) for PVC and deflection testing per Section 31-1.11 B (4) shall be used.

Televising per NSSD Requirements. All sanitary sewer extensions shall be televised in the presence of North Shore Sanitary District personnel after having notified the district a minimum of 24 hours prior to televising. A copy of the tapes in VHS format is to be submitted to the district for approval.

Measurement. Sanitary sewers shall be measured per foot regardless of depth. No measurement shall be made for testing of the sewer pipe.

Payment. SANITARY SEWER shall be paid for at the contract unit price per foot of the size specified which price shall be full compensation for all labor, equipment, and materials necessary to complete the work. The testing for acceptance shall not be paid for separately but shall be considered included to the cost of the sanitary sewer.

PROPOSED STORM SEWER CONNECTION TO EXISTING MANHOLE

Description: This work shall consist of connecting a proposed storm sewer to an existing manhole. The work shall be done in accordance with the applicable portions of Sections 502 and 550 of the Standard Specifications.

Construction: The Contractor shall carefully core into the existing structure at the line and grades as shown on the Contract Drawings. After the storm sewer is installed, the manhole shall be mortared with a non-shrink concrete grout.

Basis of Payment: The work shall be paid for at the contract unit price each for PROPOSED STORM SEWER CONNECTION TO EXISTING MANHOLE, which price shall be full compensation for all labor, equipment, and materials necessary to complete the work.

PROPOSED MANHOLE/CATCH BASIN CONNECTION OVER EXISTING STORM SEWER

Description: This work shall consist of installing a new manhole/catch basin over an existing storm sewer. The work shall be done in accordance with the applicable portions of Sections 502 and 550 of the Standard Specifications.

Construction: The Contractor shall carefully remove the existing storm sewer which falls

within the structure. After the manhole/catch basin is installed, the manhole/catch basin shall be mortared with a non-shrink concrete grout.

Basis of Payment: The work shall be paid for at the contract unit price each for PROPOSED MANHOLE/CATCH BASIN CONNECTION OVER EXISTING STORM SEWER, which price shall be full compensation for all labor, equipment, and materials necessary to complete the work.

DUCTILE IRON WATER MAIN, (POLYETHYLENE WRAPPED)

This work includes furnishing and installing ductile iron water main, pressure class 350 with polyethylene wrap. The work shall be done in accordance with Sections 20, 22, 40 and 41 of the Water and Sewer Main Specifications and the details shown on the Plans. The minimum depth of cover over the water main shall be 5'-6". The pipe and the fittings shall be protected by loosely wrapping with polyethylene sheets installed per AWWA C105/ANSI A21.5-93.

<u>Material</u>: The ductile iron water main shall be in conformance with Section 40-2.02 of the Water and Sewer Main Specifications and shall be pressure Class 350 with push-on joints. The polyethylene sheet shall comply with A.S.T.M. D1248, with a thickness of not less than eight mils. The fittings shall be in conformance with Section 40-2.05A of the Water and Sewer Main Specifications and shall be pressure Class 350 with mechanical joints. The ductile iron pipe and fittings shall have a cement-mortar lining in accordance with AWWA C104/ANSI A21.4.

Excavation, Bedding and Backfilling: This work shall be performed in accordance with Sections 20 and 22 of the Water and Sewer Main Specifications and the detail shown on the Plans. Granular bedding, 6 inches thick, shall be installed under all water main. Additional granular material to 12 inches above the pipe shall be installed. Granular material from 6 inches below the bottom of the pipe to 12 inches above the top of the pipe shall <u>not</u> be paid for separately but shall be considered incidental to the pay item. All locations shall be backfilled in conformance with the detail shown on the Plans. Any sheeting or shoring required for open-cut trenches shall be provided and installed as incidental to the Contract. Sheeting or shoring shall comply with any governing Federal or State agencies, laws and local ordinances.

<u>Restrained Joints</u>: To prevent movement of water main under pressure, vertical fitting joints (bends) shall be restrained with EBAA Iron MEGALUG series 1700 Pipe Harness (MEGALUG) or Engineer approved equal. The MEGAPLUG Joint restraints for vertical bends shall be paid for as part of the unit price per each for DUCTILE IRON WATER MAIN BEND, 45 DEGREE (POLYETHYLENE WRAPPED) of the size specified. Horizontal fittings (tees, bends, crosses) shall be restrained with concrete thrust blocks in accordance with the details. The cost of concrete thrust blocking shall be included to the price of the horizontal fittings.

<u>Pressure and Leakage Testing</u>: After a maximum of 1,200 lineal feet of water main has been laid and partially backfilled, all pipe, fittings, joints and valves shall be subjected to a hydrostatic pressure of 125 psig in accordance with Section 41-2.13. The above pressure shall hold without loss and without further application of pressure for at least 60 minutes. Upon satisfactorily maintaining 125 psig the water main, fittings, joints and valves will be subjected to system pressure for 24 hours. The maximum allowable leakage, as determined by meter, shall be in accordance with Section 41-2.13 of the Water and Sewer Main Specifications. In the event that the measured leakage exceeds that which is allowable, the Contractor shall remedy all leaks and the pressure and leakage tests will be repeated. The water main will not be accepted until the leakage is less than the allowable stated above.

It shall be the Contractor's responsibility to furnish all material and labor to complete the testing. The Contractor shall satisfy himself that the tests can be successfully completed prior to requesting the Engineer's presence for the official tests.

The Contractor shall notify the Engineer at least 48 hours in advance of the time that official tests will be made. Depending on traffic conditions, public hazard, or other reasons, the Engineer may direct when tests of completed sections of mains shall be made, and may order such tests to be made in relatively short sections. Testing shall not be paid for separately but shall be considered incidental to the Contract.

<u>Disinfection</u>: After a maximum of 1,200 lineal feet of water main has passed the hydrostatic pressure test, the Contractor shall furnish the equipment and the materials necessary to properly disinfect the system in accordance with Section 41-2.14 of the Water and Sewer Main Specifications. All taps required for disinfection shall be provided by the Contractor.

After the system has been disinfected and then flushed so as to be free of chlorine, the Contractor using proper sampling bottles, shall collect water samples from the new system. These samples shall be shipped to a state approved laboratory for bacteriological analysis. Satisfactory samples must be obtained on two consecutive days.

The City will not accept the new work until notification has been received from the laboratory that the samples examined showed that the water from the new work is at least equal in bacteriological quality to that of the water served to the public from the existing water supply system if the new work is in connection with an existing system, or in the case of a new system, that the new work was free of contamination at the time the samples were collected.

The cost of the disinfection and bacteriologic analysis shall be considered included to the cost of the ductile iron water main (polyethylene wrapped).

The existing water main shall continue to provide service through the construction of the proposed water main and will not be shut off until the new work has been accepted by the City.

This work shall be paid for at the contract unit price per foot for DUCTILE IRON WATER MAIN, (POLYTHYLENE WRAPPED), of the size specified which price shall include all labor, equipment, materials and disinfection required to complete the work described above. Horizontal fittings (tees, bends, crosses) shall be paid for at the contract unit price per each for DUCTILE IRON WATER MAIN BEND, REDUCER, TEE or CROSS, (POLYETHLENE WRAPPED), of the size specified which price shall include all labor, equipment, materials and disinfection required to complete the work described above.

DUCTILE IRON WATER MAIN WITH VYTON GASKETS

This work shall be completed in accordance with the applicable portions of item DUCTILE IRON WATER MAIN, (POLYETHYLENE WRAPPED) except as follows:

The rubber gaskets shall be Vyton F push-on gaskets. The rubber gaskets that are shipped with the pipe shall be removed and replaced with Vyton F gaskets in the areas that test positive for hydrocarbons as shown on the plans or as directed by the Engineer.

This work shall be paid for at the contract unit price per foot for DUCTILE IRON WATER MAIN WITH VYTON GASKETS, of the size specified, which price shall include all labor, equipment, materials and disinfection required to complete the work described above.

VYTON GASKETS

This work shall include furnishing and installing Vyton F rubber gaskets in water main fittings and valves in areas that test positive for hydrocarbons as shown on the plans or as directed by the Engineer.

The rubber gaskets furnished with these valves and fittings shall be removed and replaced with Vyton F mechanical joint gaskets of the size of each fitting or valve.

This work shall be paid for at the contract unit price per each for VYTON GASKETS, MJ of the size specified, which price shall include all labor, equipment, and materials required to complete the work described above.

BOLLARDS

<u>Description</u>. This work shall consist of furnishing and installing bollards at locations shown on the plans or as directed by the Engineer. The bollards shall be comprised of a five-inch diameter galvanized steel pipe filled with concrete and finished (after the concrete is placed) with high-visibility semi-gloss yellow paint of a quality and durability suitable for coverage over galvanized steel pipe. The bollard will be installed as shown on the plan details.

<u>Basis of Payment.</u> This item shall be paid for at the contract unit price per each for BOLLARDS, which shall be payment in full for the work as described herein.

TEMPORARY PAVEMENT PATCH

This work shall consist of removing and patching the existing pavement after the placement of the proposed sanitary and storm sewer and trench backfill at locations as shown on the plans or as directed by the Engineer.

The temporary pavement shall be constructed in accordance with Sections 202, 205 and 406 of the Standard Specifications and details in the plans except as her in specified. The thickness of the temporary pavement shall be six inches.

Trench backfill will be paid for according to Article 208.04.

This work shall be paid for at the contract unit price per square yard for TEMPORARY PAVEMENT PATCH.

FIRE HYDRANT COMPLETE

This work shall consist of furnishing and installing a new fire hydrant with 6" auxiliary gate valve, valve box, mainline mechanical joint tee (16" x 6" or 12" x 6") and 6" pipe from main to hydrant. The work shall be done in accordance with Section 45 of the Water and Sewer Main Specifications and the detail on the Plans. The auxiliary valve shall have mechanical joints.

It shall be the responsibility of the Contractor and hydrant manufacturer to certify that the hydrant, gate valve and valve box furnished are in compliance with the specified material and are capable of withstanding test procedures when properly installed.

S.P. 119

The fire hydrant shall be a Mueller Centurion with breakaway flange and an auxiliary valve and valve box in accordance with City requirements. The fire hydrant shall be loosely wrapped with polyethylene sheeting in accordance with the Ductile Iron Water Main, Special Provision.

Hydrants shall be installed at the locations shown on the Plans. They shall be plumb and set on a concrete base so that the lowest hose connection is at least twenty-four (24) inches above the surrounding finished grade. Break-away flange shall be set a minimum of 3" and a maximum of 6" above finished grade. All hydrants shall be inspected in the field upon delivery to the job site to insure proper operation before installation. A minimum of 1/4 cubic yard of washed coarse stone shall be placed at and around the base of the hydrant to insure proper drainage of the hydrant after use. Care shall be taken to insure that weep holes are not covered. The mainline mechanical joint tee, 6" gate valve and fire hydrant shall be restrained with EBAA Iron MEGALUG Series 1700 Pipe Harness or Engineer approved equal.

This work will be paid for at the contract unit price per each for FIRE HYDRANT COMPLETE, which price shall include all materials, labor and equipment required to complete the work as described above.

RELOCATE EMERGENCY VEHICLE PRIORITY SYSTEM

This work shall consist of removing and reinstalling the existing light detector and light detector amplifier as shown on the plans or as directed by the Engineer.

This work shall be completed in accordance with the applicable portions of Section 887 of the Standard Specifications.

BASIS OF PAYMENT: This work will be paid for at the contract unit price each for RELOCATE LIGHT DETECTOR and RELOCATE LIGHT DETECTOR AMPLIFIER, which payment shall be full compensation for all labor and equipment necessary to complete the work.

RETAINING WALL

This item shall consist of constructing a concrete retaining wall as shown in the retaining wall detail and in accordance with the applicable portions of Section 503 of the Standard Specifications.

This work will be paid for at the contract unit price per foot for RETAINING WALL, which price shall include all labor, equipment, and materials required to complete the work as specified. All costs for excavation, backfill, joints and epoxy coated reinforcement bars shall be included

in the contract unit price for RETAINING WALL.

PLUG WATER MAIN, 6"

At locations specified on the Plans or as specified by the Engineer, existing six-inch water main shall be plugged as described below. This work includes all labor, equipment, and material necessary to excavate, plug, and backfill the existing water main. Plugs must be installed for both the portion of the water main to remain in service and the water main to be abandoned. The plug for the water main to remain in service shall consist of a restrained plug or cap attached to the nearest pipe joint or fitting. A concrete thrust block must be poured to further support the plug. The water main to be abandoned must be plugged with either brick and mortar or concrete.

This work will be paid for at the contract unit price per each for PLUG WATER MAIN, 6".

GATE VALVES

This work shall be completed in accordance with Section 42 of the Water and Sewer Main Specifications. The valves shall be resilient wedge gate valves with mechanical joints of a manufacturer approved by the City. All 16" valves shall be enclosed within a valve vault to be paid for separately as VALVE VAULTS, 5' DIAMETER. All valves 12" and smaller shall be installed with a valve box of the same size as the gate valve, to be paid for separately except in the case of 6" auxiliary valves in which the valve and valve box are incidental to FIRE HYDRANT COMPLETE. 12" valve boxes shall be paid for separately as VALVE 12".

This work shall be paid for at the contract unit price per each for GATE VALVES of the specified size which price shall include all labor and materials necessary to complete the work as described above.

TEST HOLE

This item shall consist of excavation to locate existing utilities at locations where conflict is possible within the proposed construction.

Test holes will be dug at locations authorized by the Engineer. The Contractor shall be responsible for notifying the utilities concerned.

The test hole shall be of a size and depth sufficient to identify and establish locations of existing utilities. Utility damage by the Contractor shall be repaired at the expense of the Contractor.

After the Contractor has verified the location of the utility, the test hole shall be backfilled with either the excavated material or Trench Backfill, as directed by the Engineer. Any excess material shall be disposed of in accordance with Article 202.03 of the Standard Specifications.

Basis Of Payment. This work will be paid for at the contract unit price EACH for TEST HOLE which price shall include all labor and equipment necessary to complete the work as specified. Trench backfill will not be paid for separately, but shall be incidental to TEST HOLE.

CONNECTION TO EXISTING SANITARY SERVICE

This work shall be in accordance with Section 34 of the Water and Sewer Main Specifications except as modified herein.

Service line connections will only be required for existing services that tie into the proposed sewer.

An adjustable repair coupling approved by the Engineer shall be used to make the connection between the existing service and proposed service pipe. The existing pipe shall be cut in a workmanlike manner and cleaned to provide a good working surface for the coupler. This item also includes removing any existing sanitary service pipe that is in conflict with the proposed service pipe. Proposed service pipe is paid for separately.

This work shall be paid for at the contract unit price per each for **SANITARY SERVICE CONFECTION** which price shall include all labor, materials, reducers, riser elbows, and equipment necessary to complete the work shown on the plans or as directed by the Engineer. The excavated area shall be backfilled with CA-6 material to the satisfaction of the Engineer and will not be paid for separately, but should be included in the cost to connect the sanitary service.

CONNECTION TO EXISTING WATER MAINS (NON-PRESSURE)

This work shall consist of connecting the proposed water main to existing water mains at the locations shown on the plans or as directed by the Engineer. The work shall be done in accordance with Section 41-2.10 of the Water and Sewer Specifications and as herein modified.

The Contractor shall notify the City 24 hours prior to making the connection. All valves required to be closed for the connection shall be operated by City personnel only.

The work shall include the following:

1. Removing existing water main to be abandoned that interferes with the connection.

2. Making the connection with a cutting-in-sleeve and/or the fittings (bend, cross or tee) as indicated on the Plans.

All connections shall have mechanically restrained joints, as approved by the Engineer.

This work shall be paid for at the contract unit price per each for CONNECTION TO EXISTING WATER MAINS (NON-PRESSURE) of the specified size, which price shall include all labor, equipment, materials and incidentals required to complete the work described above.

No additional compensation shall be allowed for premium overtime as noted in Section 41-2.10.

SANITARY SEWER SERVICE

This work shall consist of installing new sanitary sewer services at the locations shown on the plans or as directed by the Engineer. The work and materials shall conform to Section 34 of the Water and Sewer Main Specifications and the details shown on the plans.

The new service pipe material shall be polyvinyl chloride (PVC) with a SDR 26 rating. Each service line shall be connected to the new sanitary main by a PVC tee fitting paid for separately as PVC TEE of the size specified.

When the depth of the new sanitary service exceeds 12 feet, a riser shall be used to raise the pipe to a maximum of 9 feet below grade. A No-Shear Flex Coupler or Engineer approved equal shall be used to connect the new pipe to the existing sewer service at the right-of-way line.

This work shall be paid for at the contract unit price per lineal foot for SANITARY SEWER SERVICE of the specified size, which price shall include shall include all labor, materials, and incidentals necessary to complete the work. Any risers including all needed fittings to meet the requirements of this special provision shall not be paid for separately, but shall be measured along the centerline of the pipe and paid for as part of this pay item. All labor, materials, and incidentals required to connect the new service pipe to the existing service pipe shall be considered included to this pay item. The removal and disposal of any existing service pipe within the right-of-way that interferes with installing the new sanitary sewer service shall also be considered included to this pay item.

LIGHT POLE, ORNAMENTAL

Description. This item shall consist of furnishing and installing a round, tapered aluminum — ornamental light pole complete with aluminum roadway mast arm, aluminum pedestrian arm, wrap around two piece cast aluminum base, festoon outlet and all required hardware and wiring as specified herein and as shown on the contract drawings.

The design, style and dimensions of the cast aluminum base, pole and arm shall be as follows or approved equivalent as shown on the contract drawings.

Pole:Holophane NYF30POLERTF-CA/BKRoadway mast arm:Holophane BHC72/1-CA/BKRoadway luminaire fitter:Holophane BHLF/200-SCA/BKClam shell base:Holophane NY24CSB-CA/BKPedestrian mast arm:Holophane LBWB-CA/BK

The pole shall have a black finish applied as recommended by the manufacturer.

Basis Of Payment. This item shall be paid for at the contract unit price each for LIGHT POLE, ORNAMENTAL, which shall be payment in full for the work described herein.

LIGHTING CONTROLLER TYPE CB-RCS 100AMP-240VOLT

This work shall consist of furnishing, delivering and installing a lighting controller per Section 825 of the Standard Specifications and as modified in this special provision.

The cabinet shall be unfinished.

The concrete foundation as shown on the plans, the installation of the photo-electric cell including the wiring and conduit for the photo electric cell, the removal of the shorting cap from the existing light pole luminaire and any associated rewiring due to its removal, and the installation of a ground rod at the controller and at the service connection shall be included in the cost of this item. The photoelectric cell shall be placed on the existing light pole as shown on the plans or as directed by the Engineer.

The cabinet shall have a name plate embossed with the words 'City of North Chicago Street Lighting – Controller X' in 1-1/2" letters, where the X is the controller letter from the plans. The nameplate should be mounted to the door of the cabinet, centered horizontally and 18" below the top of the door.

The Contractor shall install an approved CECHA electrical meter housing to the outside of the controller cabinet. The Contractor shall provide all necessary labor, material, equipment and

coordination with ComEd to establish the electrical service connection to the ComEd facilities. This shall not be paid for separately but shall be included in the cost of this item.

The electrical connection at the service point shall be performed by ComEd personnel. The Contractor shall provide an adequate length of electrical cable to make the connection to the service, approximately 40 feet. This electrical cable shall be coiled at the base of the pole where the service point is located. The cost of the electrical cable shall be paid for separately as ELECTRIC CABLE IN CONDUIT, 600 VOLT (XLP TYPE USE-2) 1/C NO. 2/0.

This work shall be paid for at the contract unit price per each for LIGHTING CONTROLLER TYPE CB-RCS 100AMP-240VOLT, which price included all labor, material, and equipment necessary to complete this work.

SANITARY SEWER BYPASS PUMPING

This work shall be in accordance with all applicable IEPA and Lake County Health Department regulations.

SANITARY SEWER BYPASS PUMPING may be required depending on construction sequencing and shall be determined at the preconstruction meeting. In the event that a live manhole needs to be taken out of service to construct a proposed manhole, SANITARY SEWER BYPASS PUMPING shall transfer raw sewage from one manhole upstream to one manhole downstream of the manhole to be taken out of service. All work shall be performed in a sanitary manner and in a way as to not interrupt service in the sewer. Contact Engineer at least 24 hours prior to taking manhole out of service.

This work shall be paid for at the contract price unit price per hour for SANITARY SEWER BYPASS PUMPING, which shall include labor and materials.

WATER SERVICE CONNECTION

This work shall be completed in accordance with the detail shown on the Plans and Section 40-2.06C and 41-2.12 of the Water and Sewer Main Specifications. The pay item shall consist of furnishing and installing a corporation stop, service saddle, curb stop and curb box of the encountered size. The work shall also include reconnecting the existing water service to the new curb stop with any necessary copper pipe and fittings. The saddle shall be epoxy coated, stainless steel and double banded of a manufacturer approved by the City. The corporation and curb stops and curb box shall be as manufactured by the Mueller Co. with the model to be approved by the City.

This work shall be paid for at the contract unit price per each for WATER SERVICE CONNECTION which price shall include all materials and workmanship to complete the workas described above. This work does not include copper water service piping, which is paid for separately as COPPER SERVICE, TYPE K.

STEEL CASING PIPE BORED AND JACKED

Provide all labor, materials, equipment and services required to furnish and install all steel casings bored and jacked under the Elgin Joliet & Eastern (E. J. & E.) Railroad as shown on the plans and/or specified herein.

SUBMITTALS

Descriptive literature, catalog cuts, and dimensional prints clearly indicating all dimensions and materials of construction, shall be submitted on all items specified herein to the ENGINEER for review before ordering.

At the time of submission, the CONTRACTOR shall, in writing, call ENGINEER's attention to any deviations that the submittals may have from the requirements of the plans and specifications.

RAILROAD CROSSINGS

Where designated on the plans, crossings beneath maintained railroads not to be disturbed shall be accomplished by boring and jacking a steel casing pipe in place to the limits and elevations shown on the drawings.

An approach trench or pit shall be dug at the forward end of the proposed crossing to a depth sufficient to form a vertical face at least one foot higher that the top of the pipe and large enough to provide ample working room. The size and height of this vertical face may be varied, but in all cases the adjacent soils shall be adequately protected from caving, sloughing, or eroding. After the pipe is installed, the excavated area not occupied by the pipe shall be backfilled according to Article 550.07 of the Standard Specifications.

Sloping, sheeting, or shoring shall be provided in accordance with Section 20-2.08 of the Standard Specifications for Water and Sewer Main Construction.

When groundwater is present, a dewatering system of sufficient capacity to handle the flow shall be maintained at the site. The dewatering system shall be equipped with screens or filter media sufficient to prevent the displacement of fines. Equipment shall be operated to maintain a satisfactory working environment.

Casing pipe shall be steel, plain end, have a minimum yield point strength of 35,000 psi and conform to ASTM A 252 Grade 2 or ASTM A 139 Grade B without hydrostatic tests. The steelpipe shall have welded joints and be in at least 18 foot lengths (except last section, if a shorter section is needed to obtain total casing length). The exterior of the casing pipe shall be coated with coal tar epoxy or bituminous asphalt. All joints between lengths shall be solidly butt-welded with a smooth non-obstructing joint inside. The casing pipe shall be installed without bends.

Steel casing pipe diameter and wall thickness shall not be less than the following:

Larger diameter casing pipes may be substituted by the CONTRACTOR, but there shall be no extra payment for this substitution. The E. J. & E. Railroad must approve any changes in casing pipe diameter or thickness. The Railroad Crossing Permit shall govern if it specifies or requires a casing pipe thickness greater than indicated above. Permit approval sheets will be included in the bid documents.

<u>All railroad crossing carrier pipe shall be Ductile Iron restrained joint Class 56 pipe</u>, in accordance with AWWA C151/ASTM A21.51 (latest revision) unless otherwise indicated on the plans and the Railroad Crossing Permit. The carrier pipe shall be installed after the casing pipe is in place, and shall extend a minimum of two (2) feet beyond each end of the casing to facilitate making joint connections. The carrier pipe shall be braced within the casing pipe to preclude possible flotation.

Stainless steel casing spacers shall be installed on 6-foot centers on the carrier pipe within the casing pipe. Casing spacers shall be bolt-on style with a shell made in two (2) sections of heavy T-304 stainless steel. Connecting flanges shall be ribbed for extra strength. The shell shall be

lined with a PVC liner .090" thick with a Durometer "A" 85-90 hardness. All nuts and bolts are to be 18-8 stainless steel. Runners shall be made of ultra high molecular weight polymer with inherent high abrasion resistance and a low coefficient of friction. Runners shall be supported by risers made of heavy t-304 stainless steel. The supports shall be mig welded to the shell and all welds shall be fully passivated. The height of the supports and runners combined shall be sufficient to keep the carrier pipe at least 0.75" from the casing pipe wall at all times. Casing spacers shall be made by Cascade Waterworks MFG. Co., Pipeline Seal & Insulator, Inc., or Engineer approved equal.

In lieu of stainless steel casing spacers, hardwood blocks, formed to fit the carrier and casing pipes, may be used to support the carrier pipe within the casing. Blocks shall be at least 4"x4"x24" in size. Blocks shall be strapped on each side of each joint of the carrier pipe and at intermediate positions so as not to exceed 6 foot spacing (center to center) between blocks. Enough blocks shall be used around the circumference of the pipe to prevent the carrier pipe from rotating off the blocks as it is pushed through the casing pipe. Hardwood blocks shall be fastened to the carrier pipe with stainless steel straps.

At each end of the casing pipe, the carrier pipe shall be wrapped with two (2) layers of roofing felt. The wrapping shall extend a minimum of 12 inches in each direction from the end of the casing pipe. After the carrier pipe has been installed, inspected, tested and wrapped as specified, the annular space between the carrier pipe and the casing pipe shall be filled with AASHTO M43 size #9 washed pea gravel. The annular space at both ends of the casing pipe shall be sealed with brick in a manner acceptable to the ENGINEER. Weep holes shall be provided in the closure at the lower end of the annular space between the carrier pipe and the casing pipe and the casing pipe to facilitate drainage.

All water or sewer line crossings of railroads shall be prominently marked at railroad right-ofway lines, on both sides of the track crossing, by durable, weatherproof signs located over the center of the water or sewer line. When possible, signs shall be located so that when standing at one sign, the other marker is visible. Signs shall show the following:

- 1. Name and address of OWNER.
- 2. Contents of pipe
- 3. Pressure in pipe
- 4. Pipe depth below grade at point of sign
- 5. Emergency telephone number in event of pipe rupture

The boring method shall consist of pushing the pipe into the earth with a boring auger rotating within the pipe to remove the spoil.

- 1. The front of the pipe shall be provided with mechanical arrangements or devices that will positively prevent the auger from leading the pipe so that there will be no unsupported excavation ahead of the pipe.
- 2. The auger and cutting head arrangement shall be removable from within the pipe in the event an obstruction is encountered. If the obstruction cannot be removed without excavation in advance of the pipe, the pipe shall be abandoned in place and immediately filled with coarse sand rammed in or grout pumped in.
- 3. The over-cut by the cutting head shall not exceed the outside diameter of the pipe by more than 2-inch. If voids should develop or if the bored hole diameter is greater than the outside diameter of the pipe by more than approximately 1-inch, grouting or other approved methods must be used to fill such voids.
- 4. The face of the cutting head shall be arranged to provide a reasonable obstruction to the free flow of soft or poor material.
- 5. Any method which does not have this boring arrangement will not be permitted. The CONTRACTOR's boring arrangement plans and methods must be submitted to, and approved by, the Chief Engineer of the E. J. & E. Railroad.

The CONTRACTOR must adhere to all safety requirements of the railway line involved in the crossing.

- 1. All operations shall be conducted so as not to interfere with, interrupt, or endanger the operation of trains nor damage, destroy, or endanger the integrity of railroad facilities. The CONTRACTOR shall provide written acknowledgment to the railway line that the CONTRACTOR and its employees have received, read, and understood the safety rules. Operations will be subject to inspection at any and all times.
- 2. All cranes, lifts, or other equipment that will be operated in the vicinity of the railroad's electrification and power transmission facilities shall be electrically grounded in an approved manner.
- 3. At all times, while work is in progress, a field supervisor with no less than twelve (12) months experience in the operation of the equipment being used shall be present. If boring equipment or similar machines are being used, the machine's operator shall also have a minimum of twelve (12) months experience in the operation of the equipment being used.

4. Whenever equipment or personnel are working closer than fifteen (15) feet from the centerline of an adjacent track, that track shall be considered to be obstructed. Operations shall be conducted no less than this distance, and operations closer than fifteen (15) feet from the centerline of the track shall be conducted only with the permission of, and as directed by, a duly qualified railroad employee present at the site of the work.

All railroad costs incurred by the railway line due to work associated with the crossing (inspection, flagging, track work, etc.) shall be paid by the CONTRACTOR.

The CONTRACTOR shall notify the railway line's Area Engineer a minimum of 14 working days prior to the desired start of construction.

The City reserves the right to make reasonable adjustments in the limits and lengths of all bores without affecting the unit price.

CONTRACTOR'S RESPONSIBILITIES:

Obtain a copy of the Railroad Crossing Permit before beginning construction. Attend a preconstruction meeting at the construction site with the Railroad Inspector, ENGINEER, and CONTRACTOR being present.

Construct the pipeline across the railroad property subject to the following terms and conditions. These terms and conditions shall apply during the construction period and remain in effect until the Maintenance Bond has been released:

- 1. The pipeline shall be constructed and maintained at such time or times, in such manner, with such material and under such general conditions as shall be satisfactory to and approved by the chief engineering officer of the Railway, or his duly authorized agent. The pipeline shall be constructed and maintained in accordance with American Railway Engineering Association "Specifications for Pipelines for Conveying Flammable and Non-Flammable Substances," Part 5, Pipelines, dated 1972 and shall be at least 3.0 feet below the surface of the ground and below the bottom of ditches of the Railway and at points where the pipeline passes under the track it shall be at least 5.5 feet below base of rail, and shall not interfere with the proper and safe use and operation of the property of the Railway. After completing the construction of the pipeline, the premises of the Railway shall be restored to the same or as good conditions as they were in, prior to commending the construction of such pipeline.
- 2. All of the acts to be performed by the CONTRACTOR, or by the CONTRACTOR's agents, or servants of the CONTRACTOR, in connection with the construction of the

pipeline, or in connection with any repair, shall be performed at the sole risk and expense of the CONTRACTOR.

- 3. The CONTRACTOR shall and will indemnify and save harmless the City and the Railway, its officers, agents and employees, from and against any and all detriment, damages, losses, claims, demands, suits, costs or expenses covering damage to property or injury to or death of persons, which the Railway, its officers, agents or employees, may suffer sustain or be subject to, directly or indirectly, caused either wholly or in part by reason of the construction or repair of the pipeline, except where detriment, damages, losses, claims, demands, suits, costs or expenses are due to the sole negligence of the Railway.
- 4. It is agreed that in no event shall any pipe, or other structures, be placed under the tracks or upon the property of the Railway, except those mentioned or shown on the plans, without the express permission in writing from the City and the Railway.
- 5. Insurance
 - a. During the period of construction or any period of maintenance, repair, of the pipeline, the CONTRACTOR shall insure the obligations in a manner and with a company satisfactory to the City and the Railway and with a combined single limit (bodily injury, death or property damage) of not less than \$2,000,000.
 - b. The CONTRACTOR shall furnish the City and the Railway with a Railroad Protective Liability Insurance Policy naming Railway as the named insured and issued to the CONTRACTOR, with a combined single limit of \$2,000,000 for all damages arising out of bodily injury, death, property damage liability and physical damage to property liability per occurrence with an aggregate limit of \$6,000.000.
 - c. Evidence of such insurance (Certificate of Insurance for the General Liability insurance policy and the original policy of Railroad Protective Liability insurance) must be furnished to and approved by the City and the Railway, prior to occupancy of the Railway's property or commencement of construction on Railway's premises.
- 6. The Agreements herein contained shall be binding upon the heirs, executors, administrators, lessees, successors and assigns of the CONTRACTOR.
- 7. CONTRACTOR shall not create or permit to be created or to exist in or about said pipeline any nuisance, public or private, during the continuance of this agreement, and CONTRACTOR hereby agrees to save and keep harmless the City and the Railway, its

officers, agents and employees, from any suit or claim growing out of any nuisance arising from the presence, use or operation of the CONTRACTOR in violation of any applicable laws, ordinances or governmental regulations, including, without limitation, laws, ordinances and governmental regulations controlling air, water, noise, solid wastes and other pollution.

BASIS OF PAYMENT

The steel casing pipe required to be bored and jacked under railroads will be measured from end to end of the completed cover pipe in place, and paid for at the Contract unit price per foot for STEEL CASING PIPE BORED AND JACKED of the size specified, complete in place, which price shall include the casing pipe, the casing spacers, material for blocking the ends, pea gravel, weatherproof signs, excavation, boring pits, receiving pits, sheeting, bracing, backfilling, grouting, and all other items necessary for its construction as shown on the plans and/or described in the specifications.

STORM SEWERS, CLASS A, DRILLED OR PUSHED 36"

This work shall consist of installing storm sewer with rubber gasket joints within the casing pipe under the E J & E Railroad as shown on the plans or as directed by the Engineer.

This work shall be completed in accordance with the applicable portions of item STORM SEWER, RUBBER GASKET.

BASIS OF PAYMENT: This work will be paid for at the contract unit price per foot for STORM SEWERS, CLASS A, DRILLED OR PUSHED 36", which payment shall be full compensation for all labor, equipment, and materials necessary to complete the work.

DUCTILE IRON WATER MAIN, PUSHED IN STEEL CASING, 16"

This work shall consist of installing mechanically jointed ductile iron water main within the casing pipe under the E J & E Railroad as shown on the plans or as directed by the Engineer.

This work shall be completed in accordance with the applicable portions of item DUCTILE IRON WATER MAIN, (POYETHYLENE WRAPPED).

BASIS OF PAYMENT: This work will be paid for at the contract unit price per foot for DUCTILE IRON WATER MAIN, PUSHED IN STEEL CASING, 16", which payment shall be full compensation for all labor, equipment, and materials necessary to complete the work.

SANITARY SEWER, PUSHED IN STEEL CASING, 18"

This work shall consist of installing sanitary sewer within the casing pipe under the E J & E Railroad as shown on the plans or as directed by the Engineer.

This work shall be completed in accordance with the applicable portions of item SANITARY SEWER.

BASIS OF PAYMENT: This work will be paid for at the contract unit price per foot for SANITARY SEWER, PUSHED IN STEEL CASING, 18", which payment shall be full compensation for all labor, equipment, and materials necessary to complete the work.

FENCE REMOVAL

This work shall consist of removing existing fence of all types at the locations shown on the Plans or as directed by the Engineer. The Contractor shall properly dispose of the fence at a suitable off-site location. This work shall also include the removal of any concrete foundations.

The holes formed by removal of the fence posts/concrete foundations shall be backfilled with sand as directed by the Engineer. This work shall be considered included to this pay item.

This work shall be paid for at the contract unit price per foot for FENCE REMOVAL.

PRESSURE CONNECTION

This work shall include furnishing and installing tapping sleeves and valves of the sizes shown on the Plans. The valve shall have mechanical joints. This work shall be in accordance with Section 46 of the Water and Sewer Specifications.

This work will be paid for at the contract unit price per each for PRESSURE CONNECTION 6" X 6", PRESSURE CONNECTION 12" X 6" (sleeves 12", valve 6") and PRESSURE CONNECTION 12" X 12" (sleeves 12", valve 12"). A valve vault, paid for separately as VALVE VAULTS, of the size specified, shall enclose the valve for the pressure connection. The pay items shall include all materials, labor and equipment necessary to excavate, install, and backfill the pressure connection.

PROPOSED STORM SEWER CONNECTION TO EXISTING CULVERT

This work shall consist of making a storm sewer connection to the existing box culvert as shown in the plans and as directed in Sections 502 and 550 of the Standard Specifications.

The Contractor shall carefully core into the existing box culvert the same size as the external diameter of the proposed storm sewer at the line and grade as shown in the plans. The protusion of the proposed storm sewer into the existing box culvert must not exceed a maximum of one inch. After the storm sewer is installed, the box culvert shall be mortared with a non-shrink concrete grout.

The work shall be paid for at the contract unit price per each for PROPOSED STORM SEWER CONNECTION TO EXISTING CULVERT.

UNIT DUCT, 600V, 7-1/C NO. 4, 1/C NO. 6 GROUND, (EPR-TYPE RHW), 2" DIA. POLYETHYLENE

This work shall consist of furnishing and installing a duct of the size specified and the number, size and type of electrical conductors specified in accordance with Section 816 of the Standard Specifications except as herein modified.

CONDUCTORS

All electrical cables shall be color-coded. Eight wire runs of cable shall be color-coded one black, one red, one orange, one blue, one brown, one yellow, one white and one green.

INSTALLATION

Directional boring shall be used to install all unit ducts.

The directional boring unit shall be equipped with a guide head with multiple transmitter frequencies to ensure tracking accuracy.

The directional boring technique used shall be capable of detecting voltage.

The boring machine engine should be capable of being idled from the operator's station in order to reduce engine noise when possible.

The boring machine utilized at any given point in the installation of the unit duct shall be the smallest possible for the job. The Contractor shall provide the Engineer with proposed locations for the boring machine and approximate size of the boring machine to be used before commencing. Depending on the specific location, the Engineer may call for a specific placement of the boring machine to minimize interference with pedestrian and vehicular traffic. Public alleys and parkways are available for placement of the boring machine. If placement precludes the safe passage of pedestrians the sidewalk shall be closed per I.D.O.T. Standard 701801. The Engineer shall give final determination on any boring machine set-up as to whether the proximity is safe and appropriate for pedestrian passage.

The Contractor may, at his/her option, install short runs of unit duct by means of a trenching method at locations approved by the Engineer. Trenching will not be permitted at locations where it will be an inconvenience or hazard to the public. No extra payment will be allowed for any additional labor, materials, or equipment but shall be paid for as specified below.

Basis Of Payment. This work shall be paid for at the contract unit price per FOOT of UNIT DUCT, for the number of conductors indicated which price shall include all labor, material and equipment necessary to install the unit duct in a manner described herein.

ORNAMENTAL LUMINAIRE, SODIUM VAPOR, 70 WATT

This item shall consist of furnishing and installing a Holophane 'Syracuse' decorative luminaire, Holophane catalog number SY070HPMTLB3RSB S-67512 or approved equivalent. The luminaire shall be a Syracuse Style Granville Series with a black finish. The lamp shall be a 70 watt high pressure sodium unit with a medium base operating at 240 volts. The ballast shall be a high power factor reactor autotransformer type.

BASIS OF PAYMENT

This item shall be paid for at the contract unit price EACH for ORNAMENTAL LUMINAIRE, SODIUM VAPOR, 70 WATT which shall be payment in full for the work, as described herein.

HEAVY DUTY HANDHOLE REMOVAL

This work shall be completed in accordance with the applicable portions of Article 895.05(b) of the Standard Specifications, the following shall be added to the specification.

Removal of the existing heavy duty handhole will be paid for at the contract unit price per each for HEAVY DUTY HANDHOLE REMOVAL, which payment shall be full compensation for all labor, equipment and disposal necessary to complete the work.

PAVEMENT IMPRINTING

Description. This work shall consist of imprinting the proposed pavement at the crosswalk locations shown on the plans or where directed by the Engineer.

Materials. The imprinting shall be created by mixing StreetBond Standard Formula or Engineer approved equal to hot-mix asphalt and applying an offset brick stamping pattern. The color shall be red brick.

Construction Requirements. The contractor shall follow the procedures detailed by the latest version of StreetPrint application procedures as issued by Integrated Paving Concepts, Inc. or approved equal. Stamping shall begin once the hot-mix asphalt has reached the required density and there is still enough heat in the mix to permit imprinting the full depth of the pattern forms. Patterning shall be achieved using steel rollers and vibratory plates and shall be of consistent depth.

StreetBond shall never be applied in air temperatures of less than 45 degrees F or within 24 hours of expected precipitation. The StreetBond products shall be spray applied for a total of five applications with a surface build not less than 50 mils in thickness. StreetBond shall be allowed to dry for 24 hours prior to opening the pavement to traffic.

StreetBond Sealer shall be spray applied to coat the entire imprinted surface. The contractor shall provide masking to prevent overspray onto adjacent surfaces. StreetBond Sealer Concentrate shall be tinted using StreetBond resin products to match the StreetBond formula used in the imprinting.

Basis of Payment. This work will be paid for at the contract unit price per square foot **BITUMINOUS** PAVEMENT IMPRINTING, which shall include all labor, material, and equipment necessary to complete the work as described above.

COPPER SERVICE, TYPE K 1" BORED

New water service lines shall be bored from the new main to the new curb stop at the locations shown on the Plans or as directed by the Engineer. The boring shall not be paid for separately, but shall be included in the unit price for the pay item. The work shall also include excavating for the boring and receiving pits, any necessary shoring required per OSHA and backfilling the boring and receiving pits once operations are completed.

The water service pipe shall be 1 inch diameter copper water tube, Type K, soft temper, for underground service conforming to Section 40-2.06A of the Water and Sewer Main Specifications.

This work shall be paid for at the contract unit price per foot for COPPER SERVICE, TYPE K 1" BORED, which price shall include all pipe fittings required and all work as described above.

COPPER SERVICE, TYPE K 2" BORED

New water service lines shall be bored from the new main to the new curb stop at the locations shown on the Plans or as directed by the Engineer. The boring shall not be paid for separately, but shall be included in the unit price for the pay item. The work shall also include excavating for the boring and receiving pits, any necessary shoring required per OSHA and backfilling the boring and receiving pits once operations are completed.

The water service pipe shall be 2 inch diameter copper water tube, Type K, soft temper, for underground service conforming to Section 40-2.06A of the Water and Sewer Main Specifications.

This work shall be paid for at the contract unit price per foot for COPPER SERVICE, TYPE K 2" BORED, which price shall include all pipe fittings required and all work as described above.

COPPER SERVICE, TYPE K 1" TRENCHED

New water service lines shall be trenched from the new main to the new curb stop at the locations shown on the Plans or as directed by the Engineer. The work shall be completed in accordance with Section 41-2.11 of the Water and Sewer Main Specifications. The trenching shall not be paid for separately but shall be included in the unit price for the pay item.

The water service pipe shall be 1 inch diameter copper water tube, Type K, soft temper, for underground service conforming to Section 40-2.06A of the Water and Sewer Main Specifications.

This work shall be paid for at the contract unit price per foot for COPPER SERVICE, TYPE K 1", TRENCHED, which price shall include all pipe fittings required and all work as described above.

COPPER SERVICE, TYPE K 2" TRENCHED

New water service lines shall be trenched from the new main to the new curb stop at the locations shown on the Plans or as directed by the Engineer. The work shall be completed in accordance with Section 41-2.11 of the Water and Sewer Main Specifications. The trenching shall not be paid for separately but shall be included in the unit price for the pay item.

The water service pipe shall be 2 inch diameter copper water tube, Type K, soft temper, for underground service conforming to Section 40-2.06A of the Water and Sewer Main Specifications.

This work shall be paid for at the contract unit price per foot for COPPER SERVICE, TYPE K 2", TRENCHED, which price shall include all pipe fittings required and all work as described above.

FILL EXISTING SANITARY SEWERS

This work shall consist of filling the annular space of existing sanitary sewers that will be abandoned with controlled low strength material.

All materials shall conform to section 1019 of the Standard Specifications.

<u>Method of Measurement.</u> FILL EXISTING SANITARY SEWERS will be measured and calculated for payment in cubic yards to the nearest 0.1 cubic yards as completed.

<u>Basis of Payment.</u> Payment for FILL EXISTING SANITARY SEWERS, measured as specified, will be made at the contract unit price per cubic yard, which shall constitute full compensation for furnishing, testing, mixing, transporting and placing material; and for furnishing all labor, equipment, tools, and incidentals necessary to complete the work as specified.

FILL EXISTING WATER MAINS

This work shall consist of filling the annular space of existing water mains that will be abandoned with controlled low strength material.

All materials shall conform to section 1019 of the Standard Specifications.

<u>Method of Measurement.</u> FILL EXISTING WATER MAINS will be measured and calculated for payment in cubic yards to the nearest 0.1 cubic yards as completed.

Basis of Payment. Payment for FILL EXISTING WATER MAINS, measured as specified, will

be made at the contract unit price per cubic yard, which shall constitute full compensation for furnishing, testing, mixing, transporting and placing material; and for furnishing all labor, equipment, tools, and incidentals necessary to complete the work as specified.

REMOVE EXISTING WATER VALVE

This work shall consist of the removal of existing water values at locations shown on the plans. Existing water main to be abandoned in place shall be capped and the water main that will remain in service shall be plugged. These existing water values shall be delivered to the Department of Public Works.

This work shall be paid at the contract unit price per each for REMOVE EXISTING WATER VALVE, which shall include the cost of all labor, materials, and equipment necessary to remove the water valve and cut and cap existing water mains as detailed in the Sewer and Water Specifications and to the satisfaction of the Engineer.

LIGHT POLE FOUNDATION, 24" DIAMETER, OFFSET

This work shall consist of the installation of an offset light pole foundation as directed by the Engineer. The detail for the offset foundation shall meet the IDOT standard for "Offset Foundation". It shall include all labor, material, and equipment to perform the work.

Basis Of Payment. The cost of the LIGHT POLE FOUNDATION, 24" DIAMETER, OFFSET shall be paid for at the Contract Unit Price per foot, measured along the centerline of the foundation, which price includes all labor, material, and equipment necessary to complete this work.

MODIFY EXISTING CONTROLLER CABINET

This work shall consist of modifying an existing controller as shown on the Video System Schematic detail and in accordance with the applicable portions of Section 895 of the Standard Specifications.

BASIS OF PAYMENT: This work will be paid for at the contract unit price each for MODIFY EXISTING CONTROLLER CABINET, which payment shall be full compensation for all labor and equipment necessary to complete the work.

INLET FILTER CLEANING

Effective: February 7, 2007

<u>Description</u>. This work shall consist of cleaning sediment from each assembled inlet filter. The Engineer will designate the need for cleaning based on the rate of debris and silt collected at each inlet filter location.

Cleaning of the inlet filter shall consist of inspecting and cleaning (includes removal and proper disposal of debris and silt that has accumulated in the filter fabric bag) by vactoring, removing and dumping or any other method approved by the Engineer.

<u>Method of Measurement</u>. Cleaning of the inlet filter shall be measured for payment each time that the cleaning work is performed at each of the inlet filter locations.

<u>Basis of Payment</u>. The work will be paid for at the contract unit price per each for INLET FILTER CLEANING.

1. Site Description

a. The following is a description of the construction activity which is the subject of this plan (use additional pages, as necessary):

The project involves the reconstruction of Martin Luther King Drive from Green Bay Road to IL Route 137 (Sheridan Road). This includes reconstruction on Lewis Ave and Commonwealth Avenue. The work involves pavement reconstruction, curb and gutter removal and replacement, sidewalks, and improvments to storm sewer system, watermain, sanitary sewer, lighting, and signals.

- The following is a description of the intended sequence of major activities which will disturb soils for major portions of the construction site, such as grubbing, excavation and grading (use additional pages, as necessary):
 STAGE 1:
- c. The total area of the construction site is estimated to be <u>12.1</u> acres. The total length of the roadway improvements is approximately 5900' with a 66' right-of way. The side streets have an area of about 3.2 acres.

The total area of the site that it is estimated will be disturbed by excavation, grading or other activities is ______12.1_acres.

- d. The estimated runoff coefficients of the various areas of the site after construction activities are completed are contained in the project drainage study which is hereby incorporated by reference in this plan. Information describing the soils at the site is contained either in the Soils Report for the project, which is hereby incorporated by reference, or in an attachment to this plan.
- e. The design/project report, hydraulic report, or plan documents, hereby incorporated by reference, contain site map(s) indicating drainage patterns and approximate slopes anticipated after major grading activities, areas of major soil disturbance, the location of major structural and nonstructural controls identified in the plan, the location of areas where stabilization practices are expected to occur, surface waters (including wetlands), and locations where storm water is discharged to a surface water.
- f. The names of receiving water(s) and areal extent of wetland acreage at the site are in the design/project report or plan documents which are incorporated by reference as a part of this plan.

The receiving water for this project is Pettibone Creek.

2. Controls

This section of the plan addresses the various controls that will be implemented for each of the major construction activities described in 1.b. above. For each measure discussed, the contractor that will be responsible for its implementation is indicated. Each such contractor has signed the required certification on forms which are attached to, and a part of, this plan:

a. Erosion and Sediment Controls

- (i) Stabilization Practices. Provided below is a description of interim and permanent stabilization practices, including site-specific scheduling of the implementation of the practices. Site plans will ensure that existing vegetation is preserved where attainable and disturbed portions of the site will be stabilized. Stabilization practices may include: temporary seeding, permanent seeding, mulching, geotextiles, sod stabilization, vegetative buffer strips, protection of trees, preservation of mature vegetation, and other appropriate measures. Except as provided in 2.a.(i).(A) and 2.b., stabilization measures shall be initiated as soon as practicable in portions of the site where construction activities have temporarily or permanently ceased, but in no case more than 14 days after the construction activity in that portion of the site has temporarily or permanently ceased on all disturbed portions of the site where construction activity will not occur for a period of 21 or more calendar days.
 - (A) where the initiation of stabilization measures by the 14th day after construction activity temporarily or permanently ceases is precluded by snow cover, stabilization measures shall be initiated as soon as practicable thereafter.

Description of Stabilization Practices (use additional pages, as necessary):

Trees and hedges on the construction side will be removed or protected. Temporary seeding will be placed along Martin Luther King Drive, Lewis Avenue, and Commonwealth Avenue once excavation begins. Permanent seeding or sodding will be placed in the disturbed areas after construction work has finished.

(ii) Structural Practices. Provided below is a description of structural practices that will be implemented, to the degree attainable, to divert flows from exposed soils, store flows or otherwise limit runoff and the discharge of pollutants from exposed areas of the site. Such practices may include silt fences, earth dikes, drainage swales, sediment traps, check dams, subsurface drains, pipe slope drains, level spreaders, storm drain inlet protection, rock outlet protection, reinforced soil retaining systems, gabions and temporary or permanent sediment basins. The installation of these devices may be subject to Section 404 of the Clean Water Act.

Description of Structural Practices (use additional pages, as necessary):

Perimeter erosion barrier will be installed adjacent to construction area to keep sediment-laden water from flowing out of construction limits. Inlet filters will be used at the inlets to the existing and proposed storm sewer system.

b. Storm Water Management

Provided below is a description of measures that will be installed during the construction process to control pollutants in storm water discharges that will occur after construction operations have been completed. The installation of these devices may be subject to Section 404 of the Clean Water Act.

(I) Such practices may include: storm water detention structures (including wet ponds); storm water retention structures; flow attenuation by use of open vegetated swales and natural depressions; infiltration of runoff on site; and sequential systems (which combine several practices). The practices selected for implementation were determined on the basis of the technical guidance in Section 10-300 (Design Considerations) in Chapter 10 (Erosion and Sedimentation Control) of the Illinois Department of Transportation Drainage Manual. If practices other than those discussed in Section 10-300 are selected for implementation or if practices are applied to situations different from those covered in Section 10-300, the technical basis for such decisions will be explained below.

(ii)

Velocity dissipation devices will be placed at discharge locations and along the length of any outfall channel as necessary to provide a non-erosive velocity flow from the structure to a water course so that the natural physical and biological characteristics and functions are maintained and protected (e.g., maintenance of hydrologic conditions, such as the hydroperiod and hydrodynamics present prior to the initiation of construction activities).

Description of Storm Water Management Controls (use additional pages, as necessary):

The increase of impervious area is insignificant. The amount of discharge to the culvert did not change.

c. Other Controls

- (i) Waste Disposal. No solid materials, including building materials, shall be discharged into Waters of the State, except as authorized by a Section 404 permit.
- (ii) The provisions of this plan shall ensure and demonstrate compliance with applicable State and/or local waste disposal, sanitary sewer or septic system regulations.

d. Approved State or Local Plans

The management practices, controls and provisions contained in this plan will be in accordance with IDOT specifications, which are at least as protective as the requirements contained in the Illinois Environmental Protection Agency's Illinois Urban Manual, 1995. Procedures and requirements specified in applicable sediment and erosion site plans or storm water management plans approved by local officials shall be described or incorporated by reference in the space provided below. Requirements specified in sediment and erosion site plans or storm water management site plans or site permits or storm water management site plans or site permits approved by local officials that are applicable to protecting surface water resources are, upon submittal of an NOI to be authorized to discharge under permit ILR10 incorporated by reference and are enforceable under this permit even if they are not specifically included in the plan.

Description of procedures and requirements specified in applicable sediment and erosion site plans or storm water management plans approved by local officials:

The project specifies to all IDOT Standard Specifications and Standards.

3. Maintenance

The following is a description of procedures that will be used to maintain, in good and effective operating conditions, vegetation, erosion and sediment control measures and other protective measures identified in this plan (use additional pages, as necessary):

All erosion and sediment control measures will be checked weekly and after each significant rainfall (0.5 inches or greater in a 24 hour period), including seeding and tree protection. The sediment will be controlled using perimeter erosion barriers and drainage structure inlet filters. The Contractor will be responsible for the inspection, maintenance and repair of all sedimentation and erosion control measures. If the engineer notices or is notified of an erosion or sedimentation control deficiency he/she will instruct the Contractor to correct the deficiency.

4. Inspections

Qualified personnel shall inspect disturbed areas of the construction site which have not been finally stabilized, structural control measures, and locations where vehicles enter or exit the site. Such inspections shall be conducted at least once every seven (7) calendar days and within 24 hours of the end of a storm that is 0.5 inches or greater or equivalent snowfall.

- a. Disturbed areas and areas used for storage of materials that are exposed to precipitation shall be inspected for evidence of, or the potential for, pollutants entering the drainage system. Erosion and sediment control measures identified in the plan shall be observed to ensure that they are operating correctly. Where discharge locations or points are accessible, they shall be inspected to ascertain whether erosion control measures are effective in preventing significant impacts to receiving waters. Locations where vehicles enter or exit the site shall be inspected for evidence of off site sediment tracking.
- b. Based on the results of the inspection, the description of potential pollutant sources identified in section 1 above and pollution prevention measures identified in section 2 above shall be revised as appropriate as soon as practicable after such inspection. Any changes to this plan resulting from the required inspections shall be implemented within 7 calendar days following the inspection.
- c. A report summarizing the scope of the inspection, name(s) and qualifications of personnel making the inspection, the date(s) of the inspection, major observations relating to the implementation of this storm water pollution prevention plan, and actions taken in accordance with section 4.b. shall be made and retained as part of the plan for at least three (3) years after the date of the inspection. The report shall be signed in accordance with Part VI. G of the general permit.
- d. If any violation of the provisions of this plan is identified during the conduct of the construction work covered by this plan, the Resident Engineer or Resident Technician shall complete and file an "Incidence of Noncompliance" (ION) report for the identified violation. The Resident Engineer or Resident Technician shall use forms provided by the Illinois Environmental Protection Agency and shall include specific information on the cause of noncompliance, actions which were taken to prevent any further causes of noncompliance, and a statement detailing any environmental impact which may have resulted from the noncompliance. All reports of noncompliance shall be signed by a responsible authority in accordance with Part VI. G of the general permit.

COOPERATION WITH UTILITIES

Effective: January 1, 1999 Revised: January 1, 2007

All references to Sections or Articles in this specification shall be construed to mean specific Section or Article of the Standard Specifications for Road and Bridge Construction, adopted by the Department of Transportation.

Replace Article 105.07 of the Standard Specifications with the following:

"105.07 Cooperation with Utilities. The adjustment of utilities consists of the relocation, removal, replacement, rearrangements, reconstruction, improvement, disconnection, connection, shifting, new installation or altering of an existing utility facility in any manner.

When the plans or special provisions include information pertaining to the location of underground utility facilities, such information represents only the opinion of the Department as to the location of such utilities and is only included for the convenience of the bidder. The Department assumes no responsibility in respect to the sufficiency or the accuracy of the information shown on the plans relative to the location of the underground utility facilities.

Utilities which are to be adjusted shall be adjusted by the utility owner or the owner's representative or by the Contractor as a contract item. Generally, arrangements for adjusting existing utilities will be made by the Department prior to project construction; however, utilities will not necessarily be adjusted in advance of project construction and, in some cases, utilities will not be removed from the proposed construction limits. When utility adjustments must be performed in conjunction with construction, the utility adjustment work will be shown on the plans and/or covered by Special Provisions.

When the Contractor discovers a utility has not been adjusted by the owner or the owner's representative as indicated in the contract documents, or the utility is not shown on the plans or described in the Special Provisions as to be adjusted in conjunction with construction, the Contractor shall not interfere with said utility, and shall take proper precautions to prevent damage or interruption of the utility and shall promptly notify the Engineer of the nature and location of said utility.

All necessary adjustments, as determined by the Engineer, of utilities not shown on the plans or not identified by markers, will be made at no cost to the Contractor except traffic structures, light poles, etc., that are normally located within the proposed construction limits as hereinafter defined will not be adjusted unless required by the proposed improvement.

- (a) Limits of Proposed Construction for Utilities Paralleling the Roadway. For the purpose of this Article, limits of proposed construction for utilities extending in the same longitudinal direction as the roadway, shall be defined as follows:
 - (1) The horizontal limits shall be a vertical plane, outside of, parallel to, and 600 mm (2 ft) distant at right angles from the plan or revised slope limits.
 - In cases where the limits of excavation for structures are not shown on the plans, the horizontal limits shall be a vertical plane 1.2 m (4 ft) outside the edges of structure footings or the structure where no footings are required.
 - (2) The upper vertical limits shall be the regulations governing the roadbed clearance for the specific utility involved.
 - (3) The lower vertical limits shall be the top of the utility at the depth below the proposed grade as prescribed by the governing agency or the limits of excavation, whichever is less.
- (b) Limits of Proposed Construction for Utilities Crossing the Roadway. For the purpose of this Article, limits of proposed construction for utilities crossing the roadway in a generally transverse direction shall be defined as follows:
 - (1) Utilities crossing excavations for structures that are normally made by trenching such as sewers, underdrains, etc. and all minor structures such as manholes, inlets, foundations for signs, foundations for traffic signals, etc., the limits shall be the space to be occupied by the proposed permanent construction unless otherwise required by the regulations governing the specific utility involved.
 - (2) For utilities crossing the proposed site of major structures such as bridges, sign trusses, etc., the limits shall be as defined above for utilities extending in the same general direction as the roadway.

The Contractor may make arrangements for adjustment of utilities outside of the limits of proposed construction provided the Contractor furnishes the Department with a signed agreement with the utility owner covering the adjustments to be made. The cost of any adjustments made outside the limits of proposed construction shall be the responsibility of the Contractor unless otherwise provided.

The Contractor shall request all utility owners to field locate their facilities according to Article 107.31. The Engineer may make the request for location from the utility after receipt of notice from the Contractor. On request, the Engineer will make an inspection to verify that the utility company has field located its facilities, but will not assume responsibility for the accuracy of such work. The Contractor shall be responsible for maintaining the excavations or markers provided by the utility owners. This field location procedure may be waived if the utility owner has stated in writing to the Department it is satisfied the construction plans are sufficiently accurate. If the utility owner does not submit such statement to the Department, and they do not field locate their facilities in both horizontal and vertical alignment, the Engineer will authorize the Contractor in writing to proceed to locate the facilities in the most economical and reasonable manner, subject to the approval of the Engineer, and be paid according to Article 109.04.

The Contractor shall coordinate with any planned utility adjustment or new installation and the Contractor shall take all precautions to prevent disturbance or damage to utility facilities. Any failure on the part of the utility owner, or their representative, to proceed with any planned utility adjustment or new installation shall be reported promptly by the Contractor to the Engineer orally and in writing.

The Contractor shall take all necessary precautions for the protection of the utility facilities. The Contractor shall be responsible for any damage or destruction of utility facilities resulting from neglect, misconduct, or omission in the Contractor's manner or method of execution or nonexecution of the work, or caused by defective work or the use of unsatisfactory materials. Whenever any damage or destruction of a utility facility occurs as a result of work performed by the Contractor, the utility company will be immediately notified. The utility company will make arrangements to restore such facility to a condition equal to that existing before any such damage or destruction was done.

It is understood and agreed that the Contractor has considered in the bid all of the permanent and temporary utilities in their present and/or adjusted positions.

No additional compensation will be allowed for any delays, inconvenience, or damage sustained by the Contractor due to any interference from the said utility facilities or the operation of relocating the said utility facilities.

ALKALI-SILICA REACTION FOR CAST-IN-PLACE CONCRETE (BDE)

Effective: August 1, 2007

<u>Description</u>. This special provision is intended to reduce the risk of a deleterious alkali-silica reaction in concrete exposed to humid or wet conditions. The special provision is not intended or adequate for concrete exposed to potassium acetate, potassium formate, sodium acetate or sodium formate. The special provision shall not apply to the dry environment (humidity less than 60 percent) found inside buildings for residential or commercial occupancy. The special provision shall also not apply to precast products or precast prestressed products.

<u>Aggregate Expansion Values</u>. Each coarse and fine aggregate will be tested by the Department for alkali reaction according to ASTM C 1260. The test will be performed with Type I or II cement having a total equivalent alkali content (Na₂O + $0.658K_2O$) of 0.90 percent or greater. The Engineer will determine the assigned expansion value for each aggregate, and these values will be made available on the Department's Alkali-Silica Potential Reactivity Rating List. The Engineer may differentiate aggregate based on ledge, production method, gradation number, or other factors. An expansion value of 0.05 percent will be assigned to limestone or dolomite coarse aggregates and 0.03 percent to limestone or dolomite fine aggregates (manufactured stone sand); however the Department reserves the right to perform the ASTM C 1260 test.

<u>Aggregate Groups</u>. Each combination of aggregates used in a mixture will be assigned to an aggregate group. The point at which the coarse aggregate and fine aggregate expansion values intersect in the following table will determine the group.

<u>Mixture Options</u>. Based upon the aggregate group, the following mixture options shall be used; however, the Department may prohibit a mixture option if field performance shows a deleterious alkali-silica reaction or Department testing indicates the mixture may experience a deleterious alkali-silica reaction.

Group I - Mixture options are not applicable. Use any cement or finely divided mineral.

Group II - Mixture options 1, 2, 3, 4, or 5 shall be used.

Group III - Mixture options 1, 2 and 3 combined, 4, or 5 shall be used.

Group IV - Mixture options 1, 2 and 4 combined, or 5 shall be used.

For Class PP-3 concrete the mixture options are not applicable, and any cement may be used with the specified finely divided minerals.

a) Mixture Option 1. The coarse or fine aggregates shall be blended to place the material in a group that will allow the selected cement or finely divided mineral to be used.

When a coarse or fine aggregate is blended, the weighted expansion value shall be calculated separately for the coarse and fine aggregate as follows:

Weighted Expansion Value = $(a/100 \times A) + (b/100 \times B) + (c/100 \times C) + \dots$

Where: a, b, c... = percentage of aggregate in the blend; A, B, C... = expansion value for that aggregate.

- b) Mixture Option 2. A finely divided mineral shall be used as described in 1), 2), 3), or 4) that follow. The replacement ratio is defined as "finely divided mineral:portland cement".
 - 1) Class F Fly Ash. For Class PV, BS, MS, DS, SC, and SI concrete and cement aggregate mixture II (CAM II), Class F fly ash shall replace 15 percent of the portland cement at a minimum replacement ratio of 1.5:1.
 - 2) Class C Fly Ash. For Class PV, MS, SC, and SI Concrete, Class C fly ash with 18 percent to less than 26.5 percent calcium oxide content, and less than 2.0 percent loss on ignition, shall replace 20 percent of the portland cement at a minimum replacement ratio of 1:1; or at a minimum replacement ratio of 1.25:1 if the loss on ignition is 2.0 percent or greater. Class C fly ash with less than 18 percent calcium oxide content shall replace 20 percent of the portland cement at a minimum replacement ratio of 1.25:1.

For Class PP-1, RR, BS, and DS concrete and CAM II, Class C fly ash with less than 26.5 percent calcium oxide content shall replace 15 percent of the portland cement at a minimum replacement ratio of 1.5:1.

3) Ground Granulated Blast-Furnace Slag. For Class PV, BS, MS, SI, DS, and SC concrete, ground granulated blast-furnace slag shall replace 25 percent of the portland cement at a minimum replacement ratio of 1:1.

For Class PP-1 and RR concrete, ground granulated blast-furnace slag shall replace 15 percent of the portland cement at a minimum replacement ratio of 1.5:1.

For Class PP-2, ground granulated blast-furnace slag shall replace 25 to 30 percent of the portland cement at a minimum replacement ratio of 1:1.

- Microsilica or High Reactivity Metakaolin. Microsilica solids or high reactivity metakaolin_shall be_added to the mixture_at_a minimum 25_lb/cu yd (15_kg/cu_m) or 27 lb/cu yd (16 kg/cu m) respectively.
- c) Mixture Option 3. The cement used shall have a maximum total equivalent alkali content (Na₂O + 0.658K₂O) of 0.60 percent. When aggregate in Group II is involved, any finely divided mineral may be used with a portland cement.
- d) Mixture Option 4. The cement used shall have a maximum total equivalent alkali content (Na₂O + 0.658K₂O) of 0.45 percent. When aggregate in Group II or III is involved, any finely divided mineral may be used with a portland cement.
- e) Mixture Option 5. The proposed cement or finely divided mineral may be used if the ASTM C 1567 expansion value is ≤ 0.16 percent when performed on the aggregate in the concrete mixture with the highest ASTM C 1260 test result. The ASTM C 1567 test will be valid for two years, unless the Engineer determines the materials have changed significantly. For latex concrete, the ASTM C 1567 test shall be performed without the latex. The 0.20 percent autoclave expansion limit in ASTM C 1567 shall not apply.

If during the two year time period the Contractor needs to replace the cement, and the replacement cement has an equal or lower total equivalent alkali content $(Na_2O + 0.658K_2O)$, a new ASTM C 1567 test will not be required.

<u>Testing</u>. If an individual aggregate has an ASTM C 1260 expansion value > 0.16 percent, an ASTM C 1293 test may be performed by the Contractor to evaluate the Department's ASTM C 1260 test result. The ASTM C 1293 test shall be performed with Type I or II cement having a total equivalent alkali content (Na₂O + 0.658K₂O) of 0.80 percent or greater. The interior vertical wall of the ASTM C 1293 recommended container (pail) shall be half covered with a wick of absorbent material consisting of blotting paper. If the testing laboratory desires to use an alternate container or wick of absorbent material, ASTM C 1293 test results with an alkalireactive aggregate of known expansion characteristics shall be provided to the Engineer for review and approval. If the expansion is less than 0.040 percent after one year, the aggregate will be assigned an ASTM C 1260 expansion value of 0.08 percent that will be valid for two years, unless the Engineer determines the aggregate has changed significantly.

The Engineer reserves the right to verify a Contractor's ASTM C 1293 or 1567 test result. The Engineer will not accept the result if the precision and bias for the test methods are not met.

The laboratory performing the ASTM C 1567 test shall be inspected for Hydraulic Cement - Physical Tests by the Cement and Concrete Reference Laboratory (CCRL) and shall be approved by the Department. The laboratory performing the ASTM C 1293 test shall be inspected for Portland Cement Concrete by CCRL and shall be approved by the Department.

BITUMINOUS MATERIALS COST ADJUSTMENTS (BDE) (RETURN FORM WITH BID)

Effective: November 2, 2006 Revised: January 2, 2007

<u>Description</u>. For projects with at least 1200 tons (1100 metric tons) of work involving applicable bituminous materials, cost adjustments will be made to provide additional compensation to the Contractor, or credit to the Department, for fluctuations in the cost of bituminous materials when optioned by the Contractor. The adjustments shall apply to permanent and temporary hot-mix asphalt (HMA) mixtures, bituminous surface treatments (cover and seal coats), and pavement preservation type surface treatments. The adjustments shall not apply to bituminous prime coats, tack coats, crack filling/sealing, or joint filling/sealing.

The bidder shall indicate on the attached form whether or not this special provision will be part of the contract and submit the completed form with his/her bid. Failure to submit the form, or failure to fill out the form completely, shall make this contract exempt of bituminous materials cost adjustments.

Method of Adjustment. Bituminous materials cost adjustments will be computed as follows.

 - BPI_P = Bituminous Price Index, as published by the Department for the month the work is performed, \$/ton (\$/metric ton).

 - $%AC_V =$ Percent of virgin Asphalt Cement in the Quantity being adjusted. For HMA mixtures, the % AC_V will be determined from the adjusted job mix formula. For bituminous materials applied, a performance graded or cutback asphalt will be considered to be 100% AC_V and undiluted emulsified asphalt will be considered to be 65% AC_V.

Q = Authorized construction Quantity, tons (metric tons) (see below).

For HMA mixtures measured in square yards: Q, tons = $A \times D \times (G_{mb} \times 46.8) / 2000$. For HMA mixtures measured in square meters: Q, metric tons = $A \times D \times (G_{mb} \times 24.99) / 1000$. When computing adjustments for full-depth HMA pavement, separate calculations will be made for the binder and surface courses to account for their different G_{mb} and % AC_{V} .

For bituminous materials measured in gallons:	Q, tons = V x 8.33 lb/gal x SG / 2000
For bituminous materials measured in liters:	Q, metric tons = $V \times 1.0 \text{ kg/L} \times \text{SG} / 1000$

CEMENT (BDE)

Effective: January 1, 2007 Revised: November 1, 2007

Revise Section 1001 of the Standard Specifications to read:

"SECTION 1001. CEMENT

1001.01 Cement Types. Cement shall be according to the following.

(a) Portland Cement. Acceptance of portland cement shall be according to the current Bureau of Materials and Physical Research's Policy Memorandum, "Portland or Blended Cement Acceptance Procedure for Qualified and Non-Qualified Plants".

Portland cement shall be according to ASTM C 150, and shall meet the standard physical and chemical requirements. Type I or Type II may be used for cast-in-place, precast, and precast prestressed concrete. Type III may be used according to Article 1020.04, or when approved by the Engineer. All other cements referenced in ASTM C 150 may be used when approved by the Engineer.

The total of all organic processing additions shall be a maximum of 1.0 percent by weight (mass) of the cement and the total of all inorganic processing additions shall be a maximum of 4.0 percent by weight (mass) of the cement. Organic processing additions shall be limited to grinding aids that improve the flowability of cement, reduce pack set, and improve grinding efficiency. Inorganic processing additions shall be limited to granulated blast-furnace slag according to the chemical requirements of AASHTO M 302 and Class C fly ash according to the chemical requirements of AASHTO M 295.

(b) Portland-Pozzolan Cement. Acceptance of portland-pozzolan cement shall be according to the current Bureau of Materials and Physical Research's Policy Memorandum, "Portland or Blended Cement Acceptance Procedure for Qualified and Non-Qualified Plants".

Portland-pozzolan cement shall be according to ASTM C 595 and shall meet the standard physical and chemical requirements. Type IP or I(PM) may be used for cast-inplace, precast, and precast prestressed concrete, except when Class PP concrete is used. The pozzolan constituent for Type IP shall be a maximum of 21 percent of the weight (mass) of the portland-pozzolan cement. All other cements referenced in ASTM C 595 may be used when approved by the Engineer.

For cast-in-place construction, portland-pozzolan cements shall not be used in concrete mixtures when the air temperature is below 40 °F (4 °C) without permission of the Engineer. If permission is given, the mix design strength requirement may require the Contractor to increase the cement or eliminate the cement factor reduction for a water-

reducing or high range water-reducing admixture which is permitted according to Article 1020.05(b).

The total of all organic processing additions shall be a maximum of 1.0 percent by weight (mass) of the cement. Organic processing additions shall be limited to grinding aids as defined in (a) above. Inorganic processing additions shall not be used.

(c) Portland Blast-Furnace Slag Cement. Acceptance of portland blast-furnace slag cement shall be according to the current Bureau of Materials and Physical Research's Policy Memorandum, "Portland or Blended Cement Acceptance Procedure for Qualified and Non-Qualified Plants".

Portland blast-furnace slag cement shall be according to ASTM C 595 and shall meet the standard physical and chemical requirements. Type I(SM) slag-modified portland cement may be used for cast-in-place, precast, and precast prestressed concrete, except when Class PP concrete is used. All other cements referenced in ASTM C 595 may be used when approved by the Engineer.

For cast-in-place construction, portland blast-furnace slag cements shall not be used in concrete mixtures when the air temperature is below 40 °F (4 °C) without permission of the Engineer. If permission is given, the mix design strength requirement may require the Contractor to increase the cement or eliminate the cement factor reduction for a water-reducing or high range water-reducing admixture which is permitted according to Article 1020.05(b).

The total of all organic processing additions shall be a maximum of 1.0 percent by weight (mass) of the cement. Organic processing additions shall be limited to grinding aids as defined in (a) above. Inorganic processing additions shall not be used.

- (d) Rapid Hardening Cement. Rapid hardening cement shall be used according to Article 1020.04 or when approved by the Engineer. The cement shall be on the Department's current "Approved List of Packaged, Dry, Rapid Hardening Cementitious Materials for Concrete Repairs", and shall be according to the following.
 - (1) The cement shall have a maximum final set of 25 minutes, according to Illinois Modified ASTM C 191.
 - (2) The cement shall have a minimum compressive strength of 2000 psi (13,800 kPa) at 3.0 hours, and 4000 psi (27,600 kPa) at 24.0 hours, according to Illinois Modified ASTM C 109.
 - (3) The cement shall have a maximum drying shrinkage of 0.050 percent at seven days, according to Illinois Modified ASTM C 596.
 - (4) The cement shall have a maximum expansion of 0.020 percent at 14 days, according to Illinois Modified ASTM C 1038.

- (5) The cement shall have a minimum 80 percent relative dynamic modulus of elasticity; and shall not have a weight (mass) gain in excess of 0.15 percent or a weight (mass) loss in excess of 1.0 percent, after 100 cycles, according to Illinois Modified AASHTO T 161, Procedure B. At 100 cycles, the specimens are measured and weighed at 73 °F (23 °C).
- (e) Calcium Aluminate Cement. Calcium aluminate cement shall be used when specified by the Engineer. The cement shall meet the standard physical requirements for Type I cement according to ASTM C 150, except the time of setting shall not apply. The chemical requirements shall be determined according to ASTM C 114 and shall be as follows: minimum 38 percent aluminum oxide (Al₂O₃), maximum 42 percent calcium oxide (CaO), maximum 1 percent magnesium oxide (MgO), maximum 0.4 percent sulfur trioxide (SO₃), maximum 1 percent loss on ignition, and maximum 3.5 percent insoluble residue.

1001.02 Uniformity of Color. Cement contained in single loads or in shipments of several loads to the same project shall not have visible differences in color.

1001.03 Mixing Brands and Types. Different brands or different types of cement from the same manufacturing plant, or the same brand or type from different plants shall not be mixed or used alternately in the same item of construction unless approved by the Engineer.

1001.04 Storage. Cement shall be stored and protected against damage, such as dampness which may cause partial set or hardened lumps. Different brands or different types of cement from the same manufacturing plant, or the same brand or type from different plants shall be kept separate."

DISADVANTAGED BUSINESS ENTERPRISE PARTICIPATION (BDE)

Effective: September 1, 2000 Revised: January 1, 2007

<u>FEDERAL OBLIGATION</u>. The Department of Transportation, as a recipient of federal financial assistance, is required to take all necessary and reasonable steps to ensure nondiscrimination in the award and administration of contracts. Consequently, the federal regulatory provisions of 49 CFR part 26 apply to this contract concerning the utilization of disadvantaged business enterprises. For the purposes of this Special Provision, a disadvantaged business enterprise (DBE) means a business certified by the Department in accordance with the requirements of 49 CFR part 26 and listed in the DBE Directory or most recent addendum.

<u>STATE OBLIGATION</u>. This Special Provision will also be used by the Department to satisfy the requirements of the Business Enterprise for Minorities, Females, and Persons with Disabilities Act, 30 ILCS 575. When this Special Provision is used to satisfy state law requirements on 100 percent state-funded contracts, the federal government has no involvement in such contracts (not a federal-aid contract) and no responsibility to oversee the implementation of this Special Provision by the Department on those contracts. DBE participation on 100 percent state-funded contracts will not be credited toward fulfilling the Department's annual overall DBE goal required by the US Department of Transportation to comply with the federal DBE program requirements.

<u>CONTRACTOR ASSURANCE</u>. The Contractor makes the following assurance and agrees to include the assurance in each subcontract that the Contractor signs with a subcontractor:

The Contractor, subrecipient, or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 49 CFR part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the recipient deems appropriate.

<u>OVERALL GOAL SET FOR THE DEPARTMENT</u>. As a requirement of compliance with 49 CFR part 26, the Department has set an overall goal for DBE participation in its federally assisted contracts. That goal applies to all federal-aid funds the Department will expend in its federally assisted contracts for the subject reporting fiscal year. The Department is required to make a good faith effort to achieve the overall goal. The dollar amount paid to all approved DBE firms performing work called for in this contract is eligible to be credited toward fulfillment of the Department's overall goal.

<u>CONTRACT GOAL TO BE ACHIEVED BY THE CONTRACTOR</u>. This contract includes a specific DBE utilization goal established by the Department. The goal has been included because the Department has determined that the work of this contract has subcontracting opportunities that may be suitable for performance by DBE companies. This determination is based on an assessment of the type of work, the location of the work, and the availability of

DBE companies to do a part of the work. The assessment indicates that, in the absence of unlawful discrimination, and in an arena of fair and open competition, DBE companies can be expected to perform 10% of the work. This percentage is set as the DBE participation goal for this contract. Consequently, in addition to the other award criteria established for this contract, the Department will award this contract to a bidder who makes a good faith effort to meet this goal of DBE participation in the performance of the work. A bidder makes a good faith effort for award consideration if either of the following is done in accordance with the procedures set forth in this Special Provision:

- (a) The bidder documents that firmly committed DBE participation has been obtained to meet the goal; or
- (b) The bidder documents that a good faith effort has been made to meet the goal, even though the effort did not succeed in obtaining enough DBE participation to meet the goal.

<u>DBE LOCATOR REFERENCES</u>. Bidders may consult the DBE Directory as a reference source for DBE companies certified by the Department. In addition, the Department maintains a letting and item specific DBE locator information system whereby DBE companies can register their interest in providing quotes on particular bid items advertised for letting. Information concerning DBE companies willing to quote work for particular contracts may be obtained by contacting the Department's Bureau of Small Business Enterprises at telephone number (217)785-4611, or by visiting the Department's web site at www.dot.il.gov.

<u>BIDDING PROCEDURES</u>. Compliance with the bidding procedures of this Special Provision is required prior to the award of the contract and the failure of the as-read low bidder to comply will render the bid not responsive.

(a) In order to assure the timely award of the contract, the as-read low bidder shall submit a Disadvantaged Business Utilization Plan on Department form SBE 2026 within seven working days after the date of letting. To meet the seven day requirement, the bidder may send the Plan by certified mail or delivery service within the seven working day period. If a question arises concerning the mailing date of a Plan, the mailing date will be established by the U.S. Postal Service postmark on the original certified mail receipt from the U.S. Postal Service or the receipt issued by a delivery service. It is the responsibility of the bidder to ensure that the postmark or receipt date is affixed within the seven working days if the bidder intends to rely upon mailing or delivery to satisfy the The Plan is to be submitted to the Department of submission day requirement. Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764 (Telefax: (217)785-1524). It is the responsibility of the bidder to obtain confirmation of telefax delivery. The Department will not accept a Utilization Plan if it does not meet the seven day submittal requirement and the bid will be declared not responsive. In the event the bid is declared not responsive due to a failure to submit a Plan or failure to comply with the bidding procedures set forth herein, the Department may elect to cause the forfeiture of the penal sum of the bidder's proposal guaranty, and may deny authorization to bid the project if re-advertised for bids. The Department reserves the right to invite any other bidder to submit a Utilization Plan at any time for award consideration or to extend the time for award.

- (b) The Utilization Plan shall indicate that the bidder either has obtained sufficient DBE participation commitments to meet the contract goal or has not obtained enough DBE participation commitments in spite of a good faith effort to meet the goal. The Utilization Plan shall further provide the name, telephone number, and telefax number of a responsible official of the bidder designated for purposes of notification of plan approval or disapproval under the procedures of this Special Provision.
- (c) The Utilization Plan shall include a DBE Participation Commitment Statement, Department form SBE 2025, for each DBE proposed for the performance of work to achieve the contract goal. The signatures on these forms must be original signatures. All elements of information indicated on the said form shall be provided, including but not limited to the following:
 - (1) The name and address of each DBE to be used;

- (2) A description, including pay item numbers, of the commercially useful work to be done by each DBE;
- (3) The price to be paid to each DBE for the identified work specifically stating the quantity, unit price, and total subcontract price for the work to be completed by the DBE. If partial pay items are to be performed by the DBE, indicate the portion of each item, a unit price where appropriate and the subcontract price amount;
- (4) A commitment statement signed by the bidder and each DBE evidencing availability and intent to perform commercially useful work on the project; and
- (5) If the bidder is a joint venture comprised of DBE firms and non-DBE firms, the plan must also include a clear identification of the portion of the work to be performed by the DBE partner(s).
- (d) The contract will not be awarded until the Utilization Plan submitted by the bidder is approved. The Utilization Plan will be approved by the Department if the Plan commits sufficient commercially useful DBE work performance to meet the contract goal. The Utilization Plan will not be approved by the Department if the Plan does not commit sufficient DBE performance to meet the contract goal unless the bidder documents that it made a good faith effort to meet the goal. The good faith procedures of Section VIII of this special provision apply. If the Utilization Plan is not approved because it is deficient in a technical matter, unless waived by the Department, the bidder will be notified and will be allowed no less than a five working day period in order to cure the deficiency.

<u>CALCULATING DBE PARTICIPATION</u>. The Utilization Plan values represent work anticipated to be performed and paid for upon satisfactory completion. The Department is only able to

count toward the achievement of the overall goal and the contract goal the value of payments made for the work actually performed by DBE companies. In addition, a DBE must perform a commercially useful function on the contract to be counted. A commercially useful function is generally performed when the DBE is responsible for the work and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. The Department and Contractor are governed by the provisions of 49 CFR part 26.55(c) on questions of commercially useful functions as it affects the work. Specific counting guidelines are provided in 49 CFR part 26.55, the provisions of which govern over the summary contained herein.

- (a) DBE as the Contractor: 100 percent goal credit for that portion of the work performed by the DBE's own forces, including the cost of materials and supplies. Work that a DBE subcontracts to a non-DBE firm does not count toward the DBE goals.
- (b) DBE as a joint venture Contractor: 100 percent goal credit for that portion of the total dollar value of the contract equal to the distinct, clearly defined portion of the work performed by the DBE's own forces.
- (c) DBE as a subcontractor: 100 percent goal credit for the work of the subcontract performed by the DBE's own forces, including the cost of materials and supplies, excluding the purchase of materials and supplies or the lease of equipment by the DBE subcontractor from the prime Contractor or its affiliates. Work that a DBE subcontractor in turn subcontracts to a non-DBE firm does not count toward the DBE goal.
- (d) DBE as a trucker: 100 percent goal credit for trucking participation provided the DBE is responsible for the management and supervision of the entire trucking operation for which it is responsible. At least one truck owned, operated, licensed, and insured by the DBE must be used on the contact. Credit will be given for the full value of all such DBE trucks operated using DBE employed drivers. Goal credit will be limited to the value of the reasonable fee or commission received by the DBE if trucks are leased from a non-DBE company.
- (e) DBE as a material supplier:
 - (1) 60 percent goal credit for the cost of the materials or supplies purchased from a DBE regular dealer.
 - (2) 100 percent goal credit for the cost of materials or supplies obtained from a DBE manufacturer.
 - (3) 100 percent credit for the value of reasonable fees and commissions for the procurement of materials and supplies if not a regular dealer or manufacturer.

<u>GOOD FAITH EFFORT PROCEDURES</u>. If the bidder cannot obtain sufficient DBE commitments to meet the contract goal, the bidder must document in the Utilization Plan the good faith efforts made in the attempt to meet the goal. This means that the bidder must show

that all necessary and reasonable steps were taken to achieve the contract goal. Necessary and reasonable steps are those which could-reasonably be expected to obtain sufficient DBE participation. The Department will consider the quality, quantity, and intensity of the kinds of efforts that the bidder has made. Mere *pro forma* efforts are not good faith efforts; rather, the bidder is expected to have taken those efforts that would be reasonably expected of a bidder actively and aggressively trying to obtain DBE participation sufficient to meet the contract goal.

- (a) The following is a list of types of action that the Department will consider as part of the evaluation of the bidder's good faith efforts to obtain participation. These listed factors are not intended to be a mandatory checklist and are not intended to be exhaustive. Other factors or efforts brought to the attention of the Department may be relevant in appropriate cases, and will be considered by the Department.
 - (1) Soliciting through all reasonable and available means (e.g. attendance at pre-bid meetings, advertising and/or written notices) the interest of all certified DBE companies that have the capability to perform the work of the contract. The bidder must solicit this interest within sufficient time to allow the DBE companies to respond to the solicitation. The bidder must determine with certainty if the DBE companies are interested by taking appropriate steps to follow up initial solicitations.
 - (2) Selecting portions of the work to be performed by DBE companies in order to increase the likelihood that the DBE goals will be achieved. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate DBE participation, even when the prime Contractor might otherwise prefer to perform these work items with its own forces.
 - (3) Providing interested DBE companies with adequate information about the plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.
 - (4) a. Negotiating in good faith with interested DBE companies. It is the bidder's responsibility to make a portion of the work available to DBE subcontractors and suppliers and to select those portions of the work or material needs consistent with the available DBE subcontractors and suppliers, so as to facilitate DBE participation. Evidence of such negotiation includes the names, addresses, and telephone numbers of DBE companies that were considered; a description of the information provided regarding the plans and specifications for the work selected for subcontracting; and evidence as to why additional agreements could not be reached for DBE companies to perform the work.
 - b. A bidder using good business judgment would consider a number of factors in negotiating with subcontractors, including DBE subcontractors, and would take a firm's price and capabilities as well as contract goals into consideration. However, the fact that there may be some additional costs involved in finding and using DBE companies is not in itself sufficient reason for a bidder's failure to meet the contract DBE goal, as long as such costs are reasonable. Also, the

ability or desire of a bidder to perform the work of a contract with its own organization does not relieve the bidder of the responsibility to make good faith efforts. Bidders are not, however, required to accept higher quotes from DBE companies if the price difference is excessive or unreasonable.

- (5) Not rejecting DBE companies as being unqualified without sound reasons based on a thorough investigation of their capabilities. The bidder's standing within its industry, membership in specific groups, organizations, or associations and political or social affiliations (for example union vs. non-union employee status) are not legitimate causes for the rejection or non-solicitation of bids in the bidder's efforts to meet the project goal.
- (6) Making efforts to assist interested DBE companies in obtaining bonding, lines of credit, or insurance as required by the recipient or Contractor.
- (7) Making efforts to assist interested DBE companies in obtaining necessary equipment, supplies, materials, or related assistance or services.
- (8) Effectively using the services of available minority/women community organizations; minority/women contractors' groups; local, state, and federal minority/women business assistance offices; and other organizations as allowed on a case-by-case basis to provide assistance in the recruitment and placement of DBE companies.
- (b) If the Department determines that the bidder has made a good faith effort to secure the work commitment of DBE companies to meet the contract goal, the Department will award the contract provided that it is otherwise eligible for award. If the Department determines that a good faith effort has not been made, the Department will notify the bidder of that preliminary determination by contacting the responsible company official The preliminary determination shall include a designated in the Utilization Plan. statement of reasons why good faith efforts have not been found, and may include additional good faith efforts that the bidder could take. The notification will designate a five working day period during which the bidder shall take additional efforts. The bidder is not limited by a statement of additional efforts, but may take other action beyond any stated additional efforts in order to obtain additional DBE commitments. The bidder shall submit an amended Utilization Plan if additional DBE commitments to meet the contract goal are secured. If additional DBE commitments sufficient to meet the contract goal are not secured, the bidder shall report the final good faith efforts made in the time allotted. All additional efforts taken by the bidder will be considered as part of the bidder's good faith efforts. If the bidder is not able to meet the goal after taking additional efforts, the Department will make a pre-final determination of the good faith efforts of the bidder and will notify the designated responsible company official of the reasons for an adverse determination.
- (c) The bidder may request administrative reconsideration of a pre-final determination adverse to the bidder within the five working days after the notification date of the determination by delivering the request to the Department of Transportation, Bureau of

Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764 (Telefax: (217)785-1524). Deposit of the request in the United States mail on or before the fifth business day shall not be deemed delivery. The pre-final determination shall become final if a request is not made and delivered. A request may provide additional written documentation and/or argument concerning the issue of whether an adequate good faith effort was made to meet the contract goal. In addition, the request shall be considered a consent by the bidder to The request will be forwarded to the Department's extend the time for award. Reconsideration Officer. The Reconsideration Officer will extend an opportunity to the bidder to meet in person in order to consider all issues of whether the bidder made a good faith effort to meet the goal. After the review by the Reconsideration Officer, the bidder will be sent a written decision within ten working days after receipt of the request for reconsideration, explaining the basis for finding that the bidder did or did not meet the goal or make adequate good faith efforts to do so. A final decision by the Reconsideration Officer that a good faith effort was made shall approve the Utilization Plan submitted by the bidder and shall clear the contract for award. A final decision that a good faith effort was not made shall render the bid not responsive.

<u>CONTRACT COMPLIANCE</u>. Compliance with this Special Provision is an essential part of the contract. The Department is prohibited by federal regulations from crediting the participation of a DBE included in the Utilization Plan toward either the contract goal or the Department's overall goal until the amount to be applied toward the goals has been paid to the DBE. The following administrative procedures and remedies govern the compliance by the Contractor with the contractual obligations established by the Utilization Plan. After approval of the Plan and award of the contract, the Utilization Plan and individual DBE Participation Statements become part of the contract. If the Contractor did not succeed in obtaining enough DBE participation to achieve the advertised contract goal, and the Utilization Plan was approved and contract awarded based upon a determination of good faith, the total dollar value of DBE work calculated in the approved Utilization Plan as a percentage of the awarded contract value shall become the amended contract goal.

- (a) No amendment to the Utilization Plan may be made without prior written approval from the Department's Bureau of Small Business Enterprises. All requests for amendment to the Utilization Plan shall be submitted to the Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764. Telephone number (217) 785-4611. Telefax number (217) 785-1524.
- (b) All work indicated for performance by an approved DBE shall be performed, managed, and supervised by the DBE executing the Participation Statement. The Contractor shall not terminate for convenience a DBE listed in the Utilization Plan and then perform the work of the terminated DBE with its own forces, those of an affiliate or those of another subcontractor, whether DBE or not, without first obtaining the written consent of the Bureau of Small Business Enterprises to amend the Utilization Plan. If a DBE listed in the Utilization Plan is terminated for reasons other than convenience, or fails to complete its work on the contract for any reason, the Contractor shall make good faith efforts to

find another DBE to substitute for the terminated DBE. The good faith efforts shall be directed at finding another DBE to perform at least the same amount of work under the contract as the DBE that was terminated, but only to the extent needed to meet the contract goal or the amended contract goal. The Contractor shall notify the Bureau of Small Business Enterprises of any termination for reasons other than convenience, and shall obtain approval for inclusion of the substitute DBE in the Utilization Plan. If good faith efforts following a termination of a DBE for cause are not successful, the Contractor shall contact the Bureau and provide a full accounting of the efforts undertaken to obtain substitute DBE participation. The Bureau will evaluate the good faith efforts in light of all circumstances surrounding the performance status of the contract, and determine whether the contract goal should be amended.

- (c) The Contractor shall maintain a record of payments for work performed to the DBE participants. The records shall be made available to the Department for inspection upon request. After the performance of the final item of work or delivery of material by a DBE and final payment therefor to the DBE by the Contractor, but not later than thirty calendar days after payment has been made by the Department to the Contractor for such work or material, the Contractor shall submit a DBE Payment Report on Department form SBE 2115 to the Regional Engineer. If full and final payment has not been made to the DBE, the Report shall indicate whether a disagreement as to the payment required exists between the Contractor and the DBE or if the Contractor does not have the full amount of work indicated in the Utilization Plan performed by the DBE companies indicated in the Plan, the Department will deduct from contract payments to the Contractor the amount of the goal not achieved as liquidated and ascertained damages.
- (d) The Department reserves the right to withhold payment to the Contractor to enforce the provisions of this Special Provision. Final payment shall not be made on the contract until such time as the Contractor submits sufficient documentation demonstrating achievement of the goal in accordance with this Special Provision or after liquidated damages have been determined and collected.
- (e) Notwithstanding any other provision of the contract, including but not limited to Article 109.09 of the Standard Specifications, the Contractor may request administrative reconsideration of a decision to deduct the amount of the goal not achieved as liquidated damages. A request to reconsider shall be delivered to the Contract Compliance Section and shall be handled and considered in the same manner as set forth in paragraph (c) of "Good Faith Effort Procedures" of this Special Provision, except a final decision that a good faith effort was not made during contract performance to achieve the goal agreed to in the Utilization Plan shall be the final administrative decision of the Department.

DOWEL BARS (BDE)

Effective: April 1, 2007 Revised: January 1, 2008

Revise the fifth and sixth sentences of Article 1006.11(b) of the Standard Specifications to read:

"The bars shall be epoxy coated according to AASHTO M 284, except the thickness of the epoxy shall be 7 to 12 mils (0.18 to 0.30 mm) and patching of the ends will not be required. The epoxy coating applicator shall be certified according to the current Bureau of Materials and Physical Research Policy Memorandum, "Epoxy Coating Plant Certification Procedure". The Department will maintain an approved list."

ENGINEER'S FIELD OFFICE TYPE A (BDE)

Effective: April 1, 2007 Revised: August 1, 2008

Revise Article 670.02 of the Standard Specifications to read:

"670.02 Engineer's Field Office Type A. Type A field offices shall have a minimum ceiling height of 7 ft (2 m) and a minimum floor space 450 sq ft (42 sq m). The office shall be provided with sufficient heat, natural and artificial light, and air conditioning.

The office shall have an electronic security system that will respond to any breach of exterior doors and windows. Doors and windows shall be equipped with locks. Doors shall also be equipped with dead bolt locks or other secondary locking device.

Windows shall be equipped with exterior screens to allow adequate ventilation. All windows shall be equipped with interior shades, curtains, or blinds. Adequate all-weather parking space shall be available to accommodate a minimum of ten vehicles.

Suitable on-site sanitary facilities meeting Federal, State, and local health department requirements shall be provided, maintained clean and in good working condition, and shall be stocked with lavatory and sanitary supplies at all times.

Sanitary facilities shall include hot and cold potable running water, lavatory and toilet as an integral part of the office where available. Solid waste disposal consisting of two waste baskets and an outside trash container of sufficient size to accommodate a weekly provided pick-up service.

In addition, the following furniture and equipment shall be furnished.

- (a) Four desks with minimum working surface 42 x 30 in. (1.1 m x 750 mm) each and five non-folding chairs with upholstered seats and backs.
- (b) One desk with minimum working surface 48 x 72 in. (1.2 x 1.8 m) with height adjustment of 23 to 30 in. (585 to 750 mm).
- (c) One four-post drafting table with minimum top size of 37 1/2 x 48 in. (950 mm x 1.2 m). The top shall be basswood or equivalent and capable of being tilted through an angle of 50 degrees. An adjustable height drafting stool with upholstered seat and back shall also be provided.
- (d) Two free standing four drawer legal size file cabinet with lock and an underwriters' laboratories insulated file device 350 degrees one hour rating.
- (e) One 6 ft (1.8 m) folding table with six folding chairs.

- (f) One equipment cabinet of minimum inside dimension of 44 in. (1100 mm) high x 24 in. (600 mm) wide x 30 in. (750 mm) deep with lock. The walls shall be of steel with a 3/32 in. (2 mm) minimum thickness with concealed hinges and enclosed lock constructed in such a manner as to prevent entry by force. The cabinet assembly shall be permanently attached to a structural element of the field office in a manner to prevent theft of the entire cabinet.
- (g) One refrigerator with a minimum size of 16 cu ft (0.45 cu m) with a freezer unit.
- (h) One electric desk type tape printing calculator.
- (i) A minimum of two communication paths. The configuration shall include:
 - (1) Internet Connection. An internet service connection using telephone DSL, cable broadband, or CDMA wireless technology. Additionally, an 802.11g/N wireless router shall be provided, which will allow connection by the Engineer and up to four Department staff.
 - (2) Telephone Lines. Three separate telephone lines.
- (j) One plain paper copy machine capable of reproducing prints up to 11 x 17 in. (280 x 432 mm) with an automatic feed tray capable of storing 30 sheets of paper. Letter size and 11 x 17 in. (280 x 432 mm) paper shall be provided.
- (k) One plain paper fax machine with paper.
- (I) Two telephones, with touch tone, where available, and a digital telephone answering machine, for exclusive use by the Engineer.
- (m) One electric water cooler dispenser.
- (n) One first-aid cabinet fully equipped.
- (o) One microwave oven, 1 cu ft (0.03 cu m) minimum capacity.
- (p) One fire-proof safe, 0.5 cu ft (0.01 cu m) minimum capacity.
- (q) One electric paper shredder.
- (r) One post mounted rain gauge, located on the project site for each 5 miles (8 km) of project length."

Revise the first sentence of the first paragraph of Article 670.07 of the Standard Specifications to read:

"The building or buildings fully equipped as specified will be paid for on a monthly basis until the building or buildings are released by the Engineer."

Revise the last sentence of the first paragraph of Article 670.07 of the Standard Specifications to read:

"This price shall include all utility costs and shall reflect the salvage value of the building or buildings, equipment, and furniture which become the property of the Contractor after release by the Engineer, except that the Department will pay that portion of the monthly long distance telephone bills that, when combined, exceed \$150."

EQUIPMENT RENTAL RATES (BDE)

Effective: August 2, 2007 Revised: January 2, 2008

Replace the second and third paragraphs of Article 105.07(b)(4)a. of the Standard Specifications with the following:

"Equipment idled which cannot be used on other work, and which is authorized to standby on the project site by the Engineer, will be paid for according to Article 109.04(b)(4)."

Replace Article 109.04(b)(4) of the Standard Specifications with the following:

- "(4) Equipment. Equipment used for extra work shall be authorized by the Engineer. The equipment shall be specifically described, be of suitable size and capacity for the work to be performed, and be in good operating condition. For such equipment, the Contractor will be paid as follows.
 - a. Contractor Owned Equipment. Contractor owned equipment will be paid for by the hour using the applicable FHWA hourly rate from the "Equipment Watch Rental Rate Blue Book" (Blue Book) in effect when the force account work begins. The FHWA hourly rate is calculated as follows.

FHWA hourly rate = (monthly rate/176) x (model year adj.) x (Illinois adj.) + EOC

Where: EOC = Estimated Operating Costs per hour (from the Blue Book)

The time allowed will be the actual time the equipment is operating on the extra work. For the time required to move the equipment to and from the site of the extra work and any authorized idle (standby) time, payment will be made at the following hourly rate: 0.5 x (FHWA hourly rate - EOC).

All time allowed shall fall within the working hours authorized for the extra work.

The rates above include the cost of fuel, oil, lubrication, supplies, small tools, necessary attachments, repairs, overhaul and maintenance of any kind, depreciation, storage, overhead, profits, insurance, and all incidentals. The rates do not include labor.

The Contractor shall submit to the Engineer sufficient information for each piece of equipment and its attachments to enable the Engineer to determine the proper equipment category. If a rate is not established in the Blue Book for a particular piece of equipment, the Engineer will establish a rate for that piece of equipment that is consistent with its cost and use in the industry. b. Rented Equipment. Whenever it is necessary for the Contractor to rent equipment to perform extra work, the rental and transportation costs of the equipment plus five percent for overhead will be paid. In no case shall the rental rates exceed those of established distributors or equipment rental agencies.

All prices shall be agreed to in writing before the equipment is used."

EROSION AND SEDIMENT CONTROL DEFICIENCY DEDUCTION (BDE)

Effective: April 1, 2007

Revise Article 105.03(a) of the Standard Specifications to read:

"(a) Erosion and Sediment Control Deficiency Deduction. When the Engineer is notified or determines an erosion and/or sediment control deficiency(s) exists, he/she will notify and direct the Contractor to correct the deficiency within a specified time. The specified time, which begins upon notification to the Contractor, will be from 1/2 hour to 1 week based on the urgency of the situation and the nature of the deficiency. The Engineer will be the sole judge.

A deficiency may be any lack of repair, maintenance, or implementation of erosion and/or sediment control devices included in the contract, or any failure to comply with the conditions of the National Pollutant Discharge Elimination System (NPDES) Storm Water Permit for Construction Site Activities. A deficiency may also be applied to situations where corrective action is not an option such as the failure to participate in a jobsite inspection of the project, failure to install required measures prior to initiating earth moving operations, disregard of concrete washout requirements, or other disregard of the NPDES permit.

If the Contractor fails to correct a deficiency within the specified time, a daily monetary deduction will be imposed for each calendar day or fraction thereof the deficiency exists. The calendar day(s) will begin with notification to the Contractor and end with the Engineer's acceptance of the correction. The daily monetary deduction will be either \$1000.00 or 0.05 percent of the awarded contract value, whichever is greater. For those deficiencies where corrective action was not an option, the monetary deduction will be immediate and will be valued at one calendar day."

HMA - HAULING ON PARTIALLY COMPLETED FULL-DEPTH PAVEMENT (BDE)

Effective: January 1, 2008

Revise Article 407.08 of the Standard Specifications to read:

"407.08 Hauling on the Partially Completed Full-Depth Pavement. Legally loaded trucks will be permitted on the partially completed full-depth HMA pavement only to deliver HMA mixture to the paver, provided the last lift has cooled a minimum of 12 hours. Hauling shall be limited to the distances shown in the following tables. The pavement surface temperature shall be measured using an infrared gun. The use of water to cool the pavement to permit hauling will not be allowed. The Contractor's traffic pattern shall minimize hauling on the partially completed pavement and shall vary across the width of the pavement such that "tracking" of vehicles, one directly behind the other, does not occur.

Permissive hauling on the partially completed pavement shall not relieve the Contractor of his/her responsibility for damage to the pavement. Any portion of the full-depth HMA pavement that is damaged by hauling shall be removed and replaced, or otherwise repaired to the satisfaction of the Engineer.

Crossovers used to transfer haul trucks from one roadway to the other shall be at least 1000 ft (300 m) apart and shall be constructed of material that will prevent tracking of dust or mud on the completed HMA lifts. The Contractor shall construct, maintain, and remove all crossovers."

HOT-MIX ASPHALT - TRANSPORTATION (BDE)

Effective: April 1, 2008

Revise Article 1030.08 of the Standard Specifications to read:

***1030.08 Transportation.** Vehicles used in transporting HMA shall have clean and tight beds. The beds shall be sprayed with asphalt release agents from the Department's approved list. In lieu of a release agent, the Contractor may use a light spray of water with a light scatter of manufactured sand (FA 20 or FA 21) evenly distributed over the bed of the vehicle. After spraying, the bed of the vehicle shall be in a completely raised position and it shall remain in this position until all excess asphalt release agent or water has been drained.

When the air temperature is below 60 °F (15 °C), the bed, including the end, endgate, sides and bottom shall be insulated with fiberboard, plywood or other approved insulating material and shall have a thickness of not less than 3/4 in (20 mm). When the insulation is placed inside the bed, the insulation shall be covered with sheet steel approved by the Engineer. Each vehicle shall be equipped with a cover of canvas or other suitable material meeting the approval of the Engineer which shall be used if any one of the following conditions is present.

- (a) Ambient air temperature is below 60 °F (15 °C).
- (b) The weather is inclement.
- (c) The temperature of the HMA immediately behind the paver screed is below 250 °F (120 °C).

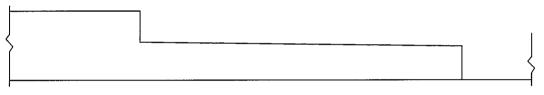
The cover shall extend down over the sides and ends of the bed for a distance of approximately 12 in. (300 mm) and shall be fastened securely. The covering shall be rolled back before the load is dumped into the finishing machine."

NOTCHED WEDGE LONGITUDINAL JOINT (BDE)

Effective: July 1, 2004 Revised: January 1, 2007

<u>Description</u>. This work shall consist of constructing a notched wedge longitudinal joint between successive passes of hot-mix asphalt (HMA) binder course that is placed in 2 1/4 in. (57 mm) or greater lifts on pavement that is open to traffic.

The notched wedge longitudinal joint shall consist of a 1 to 1 1/2 in. (25 to 38 mm) vertical notch at the centerline or lane line, a 9 to 12 in. (230 to 300 mm) uniform taper extending into the open lane, and a second 1 to 1 1/2 in. (25 to 38 mm) vertical notch (see Figure 1).





Equipment. Equipment shall meet the following requirements:

- a) Strike Off Device. The strike off device shall produce the notches and wedge of the joint and shall be adjustable. The device shall be attached to the paver and shall not restrict operation of the main screed.
- b) Wedge Roller. The wedge roller shall have a minimum diameter of 12 in. (300 mm), a minimum weight of 50 lb/in. (9 N/mm) of width, and a width equal to the wedge. The roller shall be attached to the paver.

CONSTRUCTION REQUIREMENTS

<u>Joint Construction</u>. The notched wedge longitudinal joint shall be formed by the strike off device on the paver. The wedge shall then be compacted by the joint roller.

<u>Compaction</u>. Initial compaction of the wedge shall be as close to final density as possible. Final density requirements of the entire binder mat, including the wedge, shall remain unchanged.

<u>Prime Coat</u>. Immediately prior to placing the adjacent lift of binder, the bituminous material specified for the mainline prime coat shall be applied to the entire face of the notched wedge longitudinal joint. The material shall be uniformly applied at a rate of 0.05 to 0.1 gal/sq yd (0.2 to 0.5 L/sq m).

<u>Method of Measurement</u>. The notched wedge longitudinal joint will not be measured for payment.

The prime coat will be measured for payment according to Article 406.13 of the Standard Specifications.

Basis of Payment. The work of constructing the notched wedge longitudinal joint will not be paid for separately but shall be considered as included in the cost of the HMA binder course being constructed.

The prime coat will be paid for according to Article 406.14 of the Standard Specifications.

PAYMENTS TO SUBCONTRACTORS (BDE)

Effective: June 1, 2000 Revised: January 1, 2006

Federal regulations found at 49 CFR §26.29 mandate the Department to establish a contract clause to require Contractors to pay subcontractors for satisfactory performance of their subcontracts and to set the time for such payments.

State law also addresses the timing of payments to be made to subcontractors and material suppliers. Section 7 of the Prompt Payment Act, 30 ILCS 540/7, requires that when a Contractor receives any payment from the Department, the Contractor shall make corresponding, proportional payments to each subcontractor and material supplier performing work or supplying material within 15 calendar days after receipt of the Department payment. Section 7 of the Act further provides that interest in the amount of two percent per month, in addition to the payment due, shall be paid to any subcontractor or material supplier by the Contractor if the payment required by the Act is withheld or delayed without reasonable cause. The Act also provides that the time for payment required and the calculation of any interest due applies to transactions between subcontractors and lower-tier subcontractors and material suppliers throughout the contracting chain.

This Special Provision establishes the required federal contract clause, and adopts the 15 calendar day requirement of the State Prompt Payment Act for purposes of compliance with the federal regulation regarding payments to subcontractors. This contract is subject to the following payment obligations.

When progress payments are made to the Contractor according to Article 109.07 of the Standard Specifications, the Contractor shall make a corresponding payment to each subcontractor and material supplier in proportion to the work satisfactorily completed by each subcontractor and for the material supplied to perform any work of the contract. The proportionate amount of partial payment due to each subcontractor and material supplier throughout the contracting chain shall be determined by the quantities measured or otherwise determined as eligible for payment by the Department and included in the progress payment to the Contractor. Subcontractors and material suppliers shall be paid by the Contractor within 15 calendar days after the receipt of payment from the Department. The Contractor shall not hold retainage from the subcontractors. These obligations shall also apply to any payments made by subcontractors and material suppliers to their subcontractors and material suppliers; and to all payments made to lower tier subcontractors and material suppliers throughout the contracting chain. Any payment or portion of a payment subject to this provision may only be withheld from the subcontractor or material supplier to whom it is due for reasonable cause.

This Special Provision does not create any rights in favor of any subcontractor or material supplier against the State or authorize any cause of action against the State on account of any payment, nonpayment, delayed payment, or interest claimed by application of the State Prompt Payment Act. The Department will not approve any delay or postponement of the 15 day requirement except for reasonable cause shown after notice and hearing pursuant to Section

7(b) of the State Prompt Payment Act. State law creates other and additional remedies available to any subcontractor or material supplier, regardless of tier, who has not been paid for work properly performed or material furnished. These remedies are a lien against public funds set forth in Section 23(c) of the Mechanics Lien Act, 770 ILCS 60/23(c), and a recovery on the Contractor's payment bond according to the Public Construction Bond Act, 30 ILCS 550.

"Handling holes shall be filled with a precast concrete plug and sealed with mastic or mortar, or filled with a polyethylene plug. The plug shall not project beyond the inside surface after installation. When metal lifting inserts are used, their sockets shall be filled with mastic or mortar."

Add the following to Article 542.02 of the Standard Specifications:

"(ee) Handling Hole Plugs1042.16"

Revise the fifth paragraph of Article 542.04(d) of the Standard Specifications to read:

"Handling holes in concrete pipe shall be filled with a precast concrete plug and sealed with mastic or mortar; or filled with a polyethylene plug. The plug shall not project beyond the inside surface after installation."

Add the following to Article 550.02 of the Standard Specifications:

"(o) Handling Hole Plugs......1042.16"

Replace the fourth sentence of the fifth paragraph of Article 550.06 of the Standard Specifications with the following:

"Handling holes in concrete pipe shall be filled with a precast concrete plug and sealed with mastic or mortar; or filled with a polyethylene plug. The plug shall not project beyond the inside surface after installation."

Add the following to Article 602.02 of the Standard Specifications:

"(p) Handling Hole Plugs...... 1042.16(a)"

Replace the fifth sentence of the first paragraph of Article 602.07 of the Standard Specifications with the following:

"Handling holes shall be filled with a precast concrete plug and sealed with mastic or mortar. The plug shall not project beyond the inside surface after installation. When metal lifting inserts are used, their sockets shall be filled with mastic or mortar."

Add the following to Section 1042 of the Standard Specifications:

***1042.16 Handling Hole Plugs.** Plugs for handling holes in precast concrete products shall be as follows.

- (a) Precast Concrete Plug. The precast concrete plug shall have a tapered shape and shall have a minimum compressive strength of 3000 psi (20,700 kPa) at 28 days.
- (b) Polyethylene Plug. The polyethylene plug shall have a "mushroom" shape with a flat round top and a stem with three different size ribs. The plug shall fit snuggly and cover the handling hole.

 - a. For straight bars furnished in cut lengths and with a well-defined yield point, the yield point shall be determined as the elastic peak load, identified by a halt or arrest of the load indicator before plastic flow is sustained by the bar and dividing it by the nominal cross-sectional area of the bar.
 - b. For bars without a well-defined yield point, including bars straightened from coils, the yield strength shall be determined by taking the corresponding load at 0.005 strain as measured by an extensometer (0.5% elongation under load) and dividing it by the nominal cross-sectional area of the bar.
 - c. For bars straightened from coils or bars bent from fabrication, there shall be no upper limit on yield strength; and for bar designation Nos. 3 6 (10 19), the elongation after rupture shall be at least 9%.
 - d. Heat Numbers. Bundles or bars at the construction site shall be marked or tagged with heat identification numbers of the bar producer.
 - e. Guided Bend Test. Bars may be subject to a guided bend test across two pins which are free to rotate, where the bending force shall be centrally applied with a fixed or rotating pin of a certain diameter as specified in Table 3 of ASTM A 706 (A 706M). The dimensions and clearances of this guided bend test shall be according to ASTM E 190.
 - f. Spiral Reinforcement. Spiral reinforcement shall be deformed or plain bars conforming to the above requirements or cold-drawn steel wire conforming to AASHTO M 32.
 - (2) Epoxy Coated Reinforcement Bars. Epoxy coated reinforcement bars shall be according to Article 1006.10(a)(1) and shall be epoxy coated according to AASHTO M 284 (M 284M) and the following.

- a. Certification. The epoxy coating applicator shall be certified according to the current Bureau of Materials and Physical Research Policy Memorandum, "Epoxy Coating Plant Certification Procedure". The Department will maintain an approved list.
- b. Coating Thickness. The thickness of the epoxy coating shall be 7 to 12 mils (0.18 to 0.30 mm). When spiral reinforcement is coated after fabrication, the thickness of the epoxy coating shall be 7 to 20 mils (0.18 to 0.50 mm).
- c. Cutting Reinforcement. Reinforcement bars may be sheared or sawn to length after coating, providing the end damage to the coating does not extend more than 0.5 in. (13 mm) back and the cut is patched before any visible rusting appears. Flame cutting will not be permitted."

REINFORCEMENT BARS - STORAGE AND PROTECTION (BDE)

Effective: August 1, 2008

Revise Article 508.03 of the Standard Specifications to read:

"508.03 Storage and Protection. Reinforcement bars, when delivered on the job, shall be stored off the ground using platforms, skids, or other supports; and shall be protected from mechanical injury and from deterioration by exposure. Epoxy coated bars shall be stored on wooden or padded steel cribbing and all systems for handling shall have padded contact areas. The bars or bundles shall not be dragged or dropped.

When it is necessary to store epoxy coated bars outside for more than two months, they shall be protected from sunlight, salt spray, and weather exposure. The protection shall consist of covering with opaque polyethylene sheeting or other suitable opaque material. The covering shall be secured and allow for air circulation around the bars to minimize condensation under the cover.

When placed in the work the bars shall be free from dirt, detrimental scale, paint, oil, or other foreign substances. A light coating of rust will not be considered objectionable on black bars."

REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES (BDE)

Effective: August 1, 2006 Revised: January 1, 2007

Revise Article 669.01 of the Standard Specifications to read:

"669.01 Description. This work shall consist of the excavation, removal, and proper disposal of contaminated soil, water, and underground storage tanks (UST), their content and associated underground piping to the point where the piping is above the ground, including determining the content types and estimated quantities."

Revise the first paragraph of Article 669.15 of the Standard Specifications to read:

"669.15 Method of Measurement. Non-special waste, special waste, and hazardous waste soil will be measured for payment according to Article 202.07(b) when performing earth excavation, Article 502.12(b) when excavating for structures, or by computing the volume of the trench using the maximum trench width permitted and the actual depth of the trench."

Revise the second paragraph of Article 669.16 of the Standard Specifications to read:

"The excavation, transportation, and disposal of soil and other materials from an excavation determined to be contaminated will be paid for at the contract unit price per cubic yard (cubic meter) for NON-SPECIAL WASTE DISPOSAL, SPECIAL WASTE DISPOSAL, or HAZARDOUS WASTE DISPOSAL."

RETROREFLECTIVE SHEETING, NONREFLECTIVE SHEETING, AND TRANSLUCENT OVERLAY FILM FOR HIGHWAY SIGNS (BDE)

Effective: April 1, 2007

<u>General</u>. This special provision covers retroreflective sheeting and translucent overlay films intended for application on new or refurbished aluminum. The sheeting serves as the reflectorized background for sign messages and as cutout legends and symbols applied to the reflectorized background. Messages may be applied in opaque black or transparent colors.

This special provision also covers nonreflective sheeting for application on new or refurbished aluminum, and as material for cutout legends and symbols applied to the reflectorized background.

All material furnished under this specification shall have been manufactured within 18 months of the delivery date. All material shall be supplied by the same manufacturer.

<u>Retroreflective Sheeting Properties</u>. Retroreflective sheeting shall consist of a flexible, colored, prismatic, or glass lens elements adhered to a synthetic resin, encapsulated by a flexible, transparent plastic having a smooth outer surface and shall meet the following requirements.

Only suppliers whose products have been tested and approved in the Department's periodic Sheeting Study will be eligible to supply material. All individual batches and or lots of material shall be tested and approved by the Department. The Department reserves the right to sample and test delivered materials according to Federal Specification LS-300.

- (a) Adhesive. The sheeting shall have a Class 1, pre-coated, pressure sensitive adhesive according to ASTM D 4956. The adhesive shall have a protective liner that is easily removed when tested according to ASTM D 4956. The adhesive shall be capable of being applied to new or refurbished aluminum and reflectorized backgrounds without additional adhesive.
- (b) Color. The sheeting shall be uniform in color and devoid of streaks throughout the length of each roll. The color shall conform to the latest appropriate standard color tolerance chart issued by the U.S. Department of Transportation, Federal Highway Administration and to the daytime and nighttime color requirements of ASTM D 4956. Sheeting used for side by side overlay applications shall have a Hunter Lab Delta E of less than 3.
- (c) Coefficient of Retroreflection. When tested according to ASTM E 810, without averaging, the sheeting shall have a minimum coefficient of retroreflection as shown in the following tables. The brightness of the sheeting when totally wet shall be a minimum of 90 percent of the values shown when tested according to the standard rainfall test specified in Section 7.10.1 of AASHTO M 268-84.

- (d) Gloss. The sheeting surface shall exhibit a minimum 85 degree gloss-meter rating of 50 when tested according to ASTM D 523.
- (e) Durability. When processed and applied, the sheeting shall be weather resistant.

Accelerated weathering testing will be performed for 1000 hours (300 hours for orange/FO) according to ASTM G 151. The testing cycle will consist of 8 hours of light at 140 °F (60 °C), followed by 4 hours of condensation at 104 °F (40 °C). Following accelerated weathering, the sheeting shall exhibit a minimum of 80 percent of its initial minimum coefficient of retroreflection as listed in the previous tables.

Outdoor weathering will entail an annual evaluation of material placed in an outdoor rack with a 45 degree angle and a southern sun exposure. The sheeting will be evaluated for five years. Following weathering, the test specimens will be cleaned by immersing them in a five percent hydrochloric acid solution for 45 seconds, then rinsed with water and blotted dry with a soft clean cloth. Following cleaning, the applied sheeting shall show no appreciable discoloration, cracking, streaking, crazing, blistering, or dimensional change. The sheeting shall exhibit a Hunter Lab Delta E of 5 or less when compared to the original.

- (f) Shrinkage. When tested according to ASTM D 4956, the sheeting shall not shrink in any dimension more than 1/32 in. (0.8 mm) in ten minutes and not more than 1/8 in. (3 mm) in 24 hours.
- (g) Workability. The sheeting shall show no cracking, scaling, pitting, blistering, edge lifting, inter-film splitting, curling, or discoloration when processed and applied using mutually acceptable processing and application procedures.
- (h) Splices. A single roll of sheeting shall contain a maximum of four splices per 50 yd (45 m) length. The sheeting shall be overlapped a minimum of 3/16 in. (5 mm) at each splice.
- (i) Adhesive Bond. The sheeting shall form a durable bond to smooth, corrosion and weather-resistant surfaces and adhere securely when tested according to ASTM D 4956.
- (j) Positionability. Sheeting, with ASTM D 4956 Class 3 adhesive, used for manufacturing cutout legends and borders shall provide sufficient positionability during the fabrication process to permit removal and reapplication without damage to either the legend or sign background and shall have a plastic liner suitable for use on bed cutting machines. Thereafter, all other adhesive and bond requirements contained in the specification shall apply.

Positionability shall be verified by cutting 4 in. (100 mm) letters E, I, K, M, S, W, and Y out of the positionable material. The letters shall then be applied to a sheeted aluminum blank using a single pass of a two pound roller. The letters shall sit for five minutes and then a putty knife shall be used to lift a corner. The thumb and fore finger shall be used to slowly pull the lifted corner to lift letters away from the sheeted aluminum. The letters shall not tear or distort when removed.

- (k) Thickness. The thickness of the sheeting without the protective liner shall be less than or equal to 0.015 in. (0.4 mm), or 0.025 in. (0.6 mm) for prismatic material.
- (I) Processing. The sheeting shall permit cutting and color processing according to the sheeting manufacturer's specifications at temperatures of 60 to 100 °F (15 to 38 °C) and within a relative humidity range of 20 to 80 percent. The sheeting shall be heat resistant and permit forced curing without staining the applied or unapplied sheeting at temperatures recommended by the manufacturer. The sheeting shall be solvent resistant and capable of being cleaned with VM&P naptha, mineral spirits, and turpentine.

Transparent color and opaque black inks shall be single component and low odor. The inks shall dry within eight hours and not require clear coating. After color processing on white sheeting, the sheeting shall show no appreciable discoloration, cracking, streaking, crazing, blistering, or dimensional change when tested for durability (e). The ink on the weathered, prepared panel shall exhibit a Hunter Lab Delta E of 5 or less when compared to the original.

Transparent color electronic cutting films shall be acrylic. After application to white sheeting, the films shall show no appreciable discoloration, cracking, streaking, crazing, blistering, or dimensional change when tested for durability (e). The films on the weathered, prepared panel shall exhibit a Hunter Lab Delta E of 5 or less when compared to the original.

Transparent colors screened, or transparent acrylic electronic cutting films, on white sheeting, shall have a minimum initial coefficient of retroreflection values of 50 percent for yellow and red, and a minimum 70 percent for green, blue, and brown of the 0.2 degree observation angle/-4.0 degree entrance angle values as listed in the previous tables for the color being applied. After durability testing, the colors shall retain a minimum 80 percent of the initial coefficient of retroreflection.

- (m) Identification. The sheeting shall have a distinctive overall pattern in the sheeting unique to the manufacturer. If material orientation is required for optimum retroreflectivity, permanent orientation marks shall be incorporated into the face of the sheeting. Neither the overall pattern nor the orientation marks shall interfere with the reflectivity of the sheeting.
- (n) Packaging. Both ends of each box shall be clearly labeled with the sheeting type, color, adhesive type, manufacturer's lot number, date of manufacture, and supplier's name. Material Safety Data Sheets and technical bulletins for all materials shall be furnished to the Department with each shipment.

<u>Nonreflective Sheeting Properties</u>. Nonreflective sheeting shall consist of a flexible, pigmented cast vinyl film having a smooth, flat outer surface and shall meet the following requirements.

The Department reserves the right to sample and test delivered materials according to Federal Specification LS-300.

- (a) Adhesive. The sheeting shall have a Class 1, pre-coated, pressure sensitive adhesive according to ASTM D 4956. The adhesive shall have a protective liner that is easily removed when tested according to ASTM D 4956. The adhesive shall be capable of being applied to new or refurbished aluminum and reflectorized backgrounds without additional adhesive.
- (b) Color. The sheeting shall be uniform in color and devoid of streaks throughout the length of each roll.
- (c) Gloss. The sheeting shall exhibit a minimum 85 degree gloss-meter rating of 40 when tested according to ASTM D 523.
- (d) Durability. Applied sheeting that has been vertically exposed to the elements for seven years shall show no appreciable discoloration, cracking, crazing, blistering, delamination, or loss of adhesion. A slight amount of chalking is permitted but the sheeting shall not support fungus growth.

- (e) Testing. Test panels shall be prepared by applying the sheeting to 6 1/2 x 6 1/2 in. (165 x 165 mm) pieces of aluminum according to the manufacturer's specifications. The edges of the panel shall be trimmed evenly and aged 48 hours at 70 to 90 °F (21 to 32 °C). Shrinkage and immersion testing shall be as follows.
 - (1) Shrinkage. The sheeting shall not shrink more then 1/64 in. (0.4 mm) from any panel edge when subjected to a temperature of 150 °F (66 °C) for 48 hours and shall be sufficiently heat resistant to retain adhesion after one week at 150 °F (66 °C).
 - (2) Immersion Testing. The sheeting shall show no appreciable decrease in adhesion, color, or general appearance when examined one hour after being immersed to a depth of 2 or 3 in. (50 or 75 mm) in the following solutions at 70 to 90 °F (21 to 32 °C) for specified times.

- (f) Adhesive Bond: The sheeting shall form a durable bond to smooth, corrosion and weather-resistant surfaces and adhere securely when tested according to ASTM D 4956.
- (g) Thickness. The thickness of the sheeting without the protective liner shall be a maximum of 0.005 in. (0.13 mm).
- (h) Cutting. Material used on bed cutting machines shall have a smooth plastic liner.
- (i) Identification. The sheeting shall have a distinctive overall pattern in the sheeting unique to the manufacturer. If material orientation is required for optimum retroreflectivity, permanent orientation marks shall be incorporated into the face of the sheeting. Neither the overall pattern nor the orientation marks shall interfere with the reflectivity of the sheeting.
- (j) Packaging. Both ends of each box shall be clearly labeled with the sheeting type, color, adhesive type, manufacturer's lot number, date of manufacture, and supplier's name. Material Safety Data Sheets and technical bulletins for all materials shall be furnished to the Department with each shipment.

SELF-CONSOLIDATING CONCRETE FOR CAST-IN-PLACE CONSTRUCTION (BDE)

Effective: November 1, 2005 Revised: January 1, 2007

<u>Definition</u>. Self-consolidating concrete is a flowable mixture that does not require mechanical vibration for consolidation.

<u>Usage</u>. Self-consolidating concrete may be used for cast-in-place concrete construction items involving Class MS, DS, and SI concrete.

Materials. Materials shall be according to Section 1021 of the Standard Specifications.

Mix Design Criteria. Article 1020.04 of the Standard Specifications shall apply, except as follows:

- (a) The cement factor shall be according to Article 1020.04 of the Standard Specifications. If the maximum cement factor is not specified, it shall not exceed 7.05 cwt/cu yd (418 kg/cu m). The cement factor shall not be reduced if a water-reducing, retarding, or high range water-reducing admixture is used.
- (b) The maximum allowable water/cement ratio shall be according to Article 1020.04 of the Standard Specifications or 0.44, whichever is lower.
- (c) The slump requirements shall not apply.
- (d) The coarse aggregate gradations shall be CA 13, CA 14, CA 16, or a blend of these gradations. CA 11 may be used when the Contractor provides satisfactory evidence to the Engineer that the mix will not segregate. The fine aggregate proportion shall be a maximum 50 percent by weight (mass) of the total aggregate used.
- (e) The slump flow range shall be ± 2 in. (± 50 mm) of the Contractor target value, and within the overall Department range of 20 in. (510 mm) minimum to 28 in. (710 mm) maximum.
- (f) The visual stability index shall be a maximum of 1.
- (g) The J-ring value shall be a maximum of 4 in. (100 mm). The Contractor may specify a lower maximum in the mix design.
- (h) The L-box blocking ratio shall be a minimum of 60 percent. The Contractor may specify a higher minimum in the mix design.
- (i) The column segregation index shall be a maximum 15 percent.
- (j) The hardened visual stability index shall be a maximum of 1.

<u>Test Methods</u>. Illinois Test Procedures SCC-1, SCC-2, SCC-3, SCC-4, SCC-5, SCC-6, and Illinois Modified AASHTO T 22, 23, 121, 126, 141, 152, 177, 196, and 309 shall be used for testing of self-consolidating concrete mixtures.

<u>Mix Design Submittal</u>. The Contractor's Level III PCC Technician shall submit a mix design according to the "Portland Cement Concrete Level III Technician" course manual, except target slump information is not applicable and will not be required. However, a slump flow target range shall be submitted. In addition, the design mortar factor may exceed 1.10 and durability test data will be waived.

A J-ring value shall be submitted if a lower mix design maximum will apply. An L-box blocking ratio shall be submitted if a higher mix design minimum will apply. The Contractor shall also indicate applicable construction items for the mix design.

Trial mixture information will be required by the Engineer. A trial mixture is a batch of concrete tested by the Contractor to verify the Contractor's mix design will meet specification requirements. Trial mixture information shall include test results as specified in the "Portland Cement Concrete Level III Technician" course manual. Test results shall also include slump flow, visual stability index, J-ring value, L-box blocking ratio, column segregation index, and hardened visual stability index. For the trial mixture, the slump flow shall be near the midpoint of the proposed slump flow target range.

<u>Trial Batch</u>. A minimum 2 cu yd (1.5 cu m) trial batch shall be produced, and the selfconsolidating concrete admixture dosage proposed by the Contractor shall be used. The slump flow shall be within 1.0 in. (25 mm) of the maximum slump flow range specified by the Contractor, and the air content shall be within the top half of the allowable specification range.

The trial batch shall be scheduled a minimum of 21 calendar days prior to anticipated use and shall be performed in the presence of the Engineer.

The Contractor shall provide the labor, equipment, and materials to test the concrete. The mixture will be evaluated by the Engineer for strength, air content, slump flow, visual stability index, J-ring value, L-box blocking ratio, column segregation index, and hardened visual stability index.

Upon review of the test data from the trial batch, the Engineer will verify or deny the use of the mix design and notify the Contractor. Verification by the Engineer will include the Contractor's target slump flow range. If applicable, the Engineer will verify the Contractor's maximum J-ring value and minimum L-box blocking ratio.

A new trial batch will be required whenever there is a change in the source of any component material, proportions beyond normal field adjustments, dosage of the self-consolidating concrete admixture, batch sequence, mixing speed, mixing time, or as determined by the Engineer. The testing criteria for the new trial batch will be determined by the Engineer.

When necessary, the trial batches shall be disposed of according to Article 202.03 of the Standard Specifications.

<u>Mixing Portland Cement Concrete</u>. In addition to Article 1020.11 of the Standard Specifications, the mixing time for central-mixed concrete shall not be reduced as a result of a mixer performance test. Truck-mixed or shrink-mixed concrete shall be mixed in a truck mixer for a minimum of 100 revolutions.

Wash water, if used, shall be completely discharged from the drum or container before the succeeding batch is introduced.

The batch sequence, mixing speed, and mixing time shall be appropriate to prevent cement balls and mix foaming for central-mixed, truck-mixed, and shrink-mixed concrete.

<u>Falsework and Forms</u>. In addition to Articles 503.05 and 503.06 of the Standard Specifications, the Contractor shall consider the fluid nature of the concrete for designing the falsework and forms. Forms shall be tight to prevent leakage of fluid concrete.

<u>Placing and Consolidating</u>. Concrete placement and consolidation shall be according to Article 503.07 of the Standard Specifications, except as follows:

Revise the third paragraph of Article 503.07 of the Standard Specifications to read:

"Open troughs and chutes shall extend as nearly as practicable to the point of deposit. The drop distance of concrete shall not exceed 5 ft (1.5 m). If necessary, a tremie shall be used to meet this requirement. The maximum distance of horizontal flow from the point of deposit shall be 25 ft (7.6 m), unless approved otherwise by the Engineer. For drilled shafts, free fall placement will not be permitted."

Delete the seventh, eighth, ninth, and tenth paragraphs of Article 503.07 of the Standard Specifications.

Add to the end of the eleventh paragraph of Article 503.07 of the Standard Specifications the following:

"Concrete shall be rodded with a piece of lumber, conduit, or vibrator if the material has lost its fluidity prior to placement of additional concrete. The vibrator shall be the pencil head type with a maximum diameter or width of 1 in. (25 mm). Any other method for restoring the fluidity of the concrete shall be approved by the Engineer."

<u>Quality Control by Contractor at Plant</u>. The specified test frequencies for aggregate gradation, aggregate moisture, air content, unit weight/yield, and temperature shall be performed as indicated in the contract plans.

Slump flow, visual stability index, and J-ring or L-box tests shall be performed as needed to control production. The column segregation index test and hardened visual stability index test will not be required to be performed at the plant.

<u>Quality Control by Contractor at Jobsite</u>. The specified test frequencies for air content, strength, and temperature shall be performed as indicated in the contract plans.

Slump flow, visual stability index, and J-ring or L-box tests shall be performed on the first two truck deliveries of the day, and every 50 cu yd (40 cu m) thereafter. The Contractor shall select either the J-ring or L-box test for jobsite testing.

The column segregation index test will not be required to be performed at the jobsite. The hardened visual stability index test shall be performed on the first truck delivery of the day, and every 300 cu yd (230 cu m) thereafter. Slump flow, visual stability index, J-ring value or L-box blocking ratio, air content, and concrete temperature shall be recorded for each hardened visual stability index test.

The Contractor shall retain all hardened visual stability index cut cylinder specimens until the Engineer notifies the Contractor that the specimens may be discarded.

If mix foaming or other potential detrimental material is observed during placement or at the completion of the pour, the material shall be removed while the concrete is still plastic.

<u>Quality Assurance by Engineer at Plant</u>. For air content and aggregate gradation, quality assurance independent sample testing and split sample testing will be performed as indicated in the contract plans.

For slump flow, visual stability index, and J-ring or L-box tests, quality assurance independent sample testing and split sample testing will be performed as determined by the Engineer.

<u>Quality Assurance by Engineer at Jobsite</u>. For air content and strength, quality assurance independent sample testing and split sample testing will be performed as indicated in the contract plans.

For slump flow, visual stability index, J-ring or L-box, and hardened visual stability index tests, quality assurance independent sample testing will be performed as determined by the Engineer.

For slump flow and visual stability index quality assurance split sample testing, the Engineer will perform tests at the beginning of the project on the first three tests performed by the Contractor. Thereafter, a minimum of ten percent of total tests required of the Contractor will be performed per plant, which will include a minimum of one test per mix design. The acceptable limit of precision will be 1.5 in. (40 mm) for slump flow and a limit of precision will not apply to the visual stability index.

For the J-ring or the L-box quality assurance split sample testing, a minimum of 80 percent of the total tests required of the Contractor will be witnessed by the Engineer per plant, which will

include a minimum of one witnessed test per mix design. The Engineer reserves the right to conduct quality assurance split sample testing. The acceptable limit of precision will be 1.5 in. (40 mm) for the J-ring value and ten percent for the L-box blocking ratio.

For each hardened visual stability index test performed by the Contractor, the cut cylinders shall be presented to the Engineer for determination of the rating. The Engineer reserves the right to conduct quality assurance split sample testing. A limit of precision will not apply to the hardened visual stability index.

SELF-CONSOLIDATING CONCRETE FOR PRECAST PRODUCTS (BDE)

Effective: July 1, 2004 Revised: January 1, 2007

<u>Definition</u>. Self-consolidating concrete is a flowable mixture that does not require mechanical vibration for consolidation.

<u>Usage</u>. Self-consolidating concrete may be used for precast concrete products.

Materials. Materials shall be according to Section 1021 of the Standard Specifications.

Mix Design Criteria. The mix design criteria shall be as follows:

- (a) The minimum cement factor shall be according to Article 1020.04 of the Standard Specifications. If the maximum cement factor is not specified, it shall not exceed 7.05 cwt/cu yd (418 kg/cu m).
- (b) The maximum allowable water/cement ratio shall be according to Article 1020.04 of the Standard Specifications or 0.44, whichever is lower.
- (c) The slump requirements of Article 1020.04 of the Standard Specifications shall not apply.
- (d) The coarse aggregate gradations shall be CA 13, CA 14, CA 16, or a blend of these gradations. CA 11 may be used when the Contractor provides satisfactory evidence to the Engineer that the mix will not segregate. The fine aggregate proportion shall be a maximum 50 percent by weight (mass) of the total aggregate used.
- (e) The slump flow range shall be ± 2 in. (± 50 mm) of the Contractor target value, and within the overall Department range of 20 in. (510 mm) minimum to 28 in. (710 mm) maximum.
- (f) The visual stability index shall be a maximum of 1.
- (g) The J-ring value shall be a maximum of 4 in. (100 mm). The Contractor may specify a lower maximum in the mix design.
- (h) The L-box blocking ratio shall be a minimum of 60 percent. The Contractor may specify a higher minimum in the mix design.

- (i) The column segregation index shall be a maximum 15 percent.
- (j) The hardened visual stability index shall be a maximum of 1.

<u>Placing and Consolidating</u>. The maximum distance of horizontal flow from the point of deposit shall be 25 ft (7.6 m), unless approved otherwise by the Engineer.

Concrete shall be rodded with a piece of lumber, conduit, or vibrator if the material has lost its fluidity prior to placement of additional concrete. The vibrator shall be the pencil head type with a maximum diameter or width of 1 in. (25 mm). Any other method for restoring the fluidity of the concrete shall be approved by the Engineer.

<u>Mix Design Approval</u>. The Contractor shall obtain mix design approval according to the Department's Policy Memorandum "Quality Control/Quality Assurance Program for Precast Concrete Products".

SILT FILTER FENCE (BDE)

Effective: January 1, 2008

For silt filter fence fabric only, revise Article 1080.02 of the Standard Specifications to read:

"1080.02 Geotextile Fabric. The fabric for silt filter fence shall be a woven fabric meeting the requirements of AASHTO M 288 for unsupported silt fence with less than 50 percent geotextile elongation."

Replace the last sentence of Article 1081.15(b) of the Standard Specifications with the following:

"Silt filter fence stakes shall be a minimum of 4 ft (1.2 m) long and made of either wood or metal. Wood stakes shall be 2 in. x 2 in. (50 mm x 50 mm). Metal stakes shall be a standard T or U shape having a minimum weight (mass) of 1.32 lb/ft (600 g/300 mm)."

SUBCONTRACTOR MOBILIZATION PAYMENTS (BDE)

Effective: April 2, 2005

To account for the preparatory work and operations necessary for the movement of subcontractor personnel, equipment, supplies, and incidentals to the project site and for all other work or operations that must be performed or costs incurred when beginning work approved for subcontracting in accordance with Article 108.01 of the Standard Specifications, the Contractor shall make a mobilization payment to each subcontractor.

This mobilization payment shall be made at least 14 days prior to the subcontractor starting work. The amount paid shall be equal to 3 percent of the amount of the subcontract reported on form BC 260A submitted for the approval of the subcontractor's work.

This provision shall be incorporated directly or by reference into each subcontract approved by the Department.

TEMPORARY EROSION CONTROL (BDE)

Effective: November 1, 2002 Revised: January 1, 2008

Revise the third paragraph of Article 280.03 of the Standard Specifications to read:

"Erosion control systems shall be installed prior to beginning any activities which will potentially create erodible conditions. Erosion control systems for areas outside the limits of construction such as storage sites, plant sites, waste sites, haul roads, and Contractor furnished borrow sites shall be installed prior to beginning soil disturbing activities at each area. These offsite systems shall be designed by the Contractor and be subject to the approval of the Engineer."

Add the following paragraph after the third paragraph of Article 280.03 of the Standard Specifications:

"The temporary erosion and sediment control systems shown on the plans represent the minimum systems anticipated for the project. Conditions created by the Contractor's operations, or for the Contractor's convenience, which are not covered by the plans, shall be protected as directed by the Engineer at no additional cost to the Department. Revisions or modifications of the erosion and sediment control systems shall have the Engineer's written approval."

Add the following paragraph after the ninth paragraph of Article 280.07 of the Standard Specifications:

"Temporary or permanent erosion control systems required for areas outside the limits of construction will not be measured for payment."

Delete the tenth (last) paragraph of Article 280.08 of the Standard Specifications.

THERMOPLASTIC PAVEMENT MARKINGS (BDE)

Effective: January 1, 2007

Revise Article 1095.01(a)(2) of the Standard Specifications to read:

"(2) Pigment. The pigment used for the white thermoplastic compound shall be a highgrade pure (minimum 93 percent) titanium dioxide (Ti0₂). The white pigment content shall be a minimum of ten percent by weight and shall be uniformly distributed throughout the thermoplastic compound.

The pigments used for the yellow thermoplastic compound shall not contain any hazardous materials listed in the Environmental Protection Agency Code of Federal Regulations (CFR) 40, Section 261.24, Table 1. The combined total of RCRA listed heavy metals shall not exceed 100 ppm when tested by X-ray fluorescence spectroscopy. The pigments shall also be heat resistant, UV stable and color-fast yellows, golds, and oranges, which shall produce a compound which shall match Federal Standard 595 Color No. 33538. The pigment shall be uniformly distributed throughout the thermoplastic compound."

Revise Article 1095.01(b)(1)e. of the Standard Specifications to read:

"e. Daylight Reflectance and Color. The thermoplastic compound after heating for four hours ± five minutes at 425 ± 3 °F (218.3 ± 2 °C) and cooled at 77 °F (25 °C) shall meet the following requirements for daylight reflectance and color, when tested, using a color spectrophotometer with 45 degree circumferential/zero degree geometry, illuminant C, and two degree observer angle. The color instrument shall measure the visible spectrum from 380 to 720 nm with a wavelength measurement interval and spectral bandpass of 10 nm.

White: Daylight Reflectance75 percent min. *Yellow: Daylight Reflectance45 percent min.

*Shall meet the coordinates of the following color tolerance chart.

Revise Article 1095.01(b)(1)k. of the Standard Specifications to read:

"k. Accelerated Weathering. After heating the thermoplastic for four hours ± five minutes at 425 ± 3 °F (218.3 ± 2 °C) the thermoplastic shall be applied to a steel wool abraded aluminum alloy panel (Federal Test Std. No. 141, Method 2013) at a film thickness of 30 mils (0.70 mm) and allowed to cool for 24 hours at room temperature. The coated panel shall be subjected to accelerated weathering using the light and water exposure apparatus (fluorescent UV - condensation type) for 75 hours according to ASTM G 53 (equipped with UVB-313 lamps).

The cycle shall consist of four hours UV exposure at 122 °F (50 °C) followed by four hours of condensation at 104 °F (40 °C). UVB 313 bulbs shall be used. At the end of the exposure period, the panel shall not exceed 10 Hunter Lab Delta E units from the original material."

TRAFFIC SIGNAL GROUNDING (BDE)

Effective: April 1, 2006 Revised: January 1, 2007

Revise Article 873.02 of the Standard Specifications to read:

"873.02 Materials. Materials shall be according to the following.

Item	Article/Section
(a) Electric Cable – Signal, Lead-in, Communication, Service,	
and Equipment Grounding Conductor	
(b) Electrical Raceway Materials	1088.01"

Revise Article 873.04 of the Standard Specifications to read:

"873.04 Grounding System. All traffic signal circuits shall include an equipment grounding conductor according to Article 801.04. The equipment grounding conductor shall consist of a continuous, green, insulated conductor Type XLP, No. 6 AWG, stranded copper installed in raceways and bonded to each metal enclosure (handhole, post, mast arm pole, signal cabinet, etc.). All clamps shall be bronze or copper, UL approved.

A grounding cable with connectors shall be installed between each handhole cover and frame. The grounding cable shall be looped over cable hooks installed in the handholes and 5 ft (1.5 m) of extra cable shall be provided between the frame and cover.

All equipment grounding conductors shall terminate at the ground bus in the controller cabinet. The neutral conductor and the equipment grounding conductor shall be connected in the service installation. At no other point in the traffic signal system shall the neutral and equipment grounding conductors be connected."

Revise Article 873.05 of the Standard Specifications to read:

***873.05 Method of Measurement.** Electric cable will be measured for payment in feet (meters) in place. The length of measurement shall be the distance horizontally and vertically measured between the changes in direction, including cables in mast arms, mast arm poles, signal posts, and extra cable length as specified in Article 873.03. The vertical cable length shall be measured according to the following schedule.

Add the following Article to Section 873 of the Standard Specifications:

"873.06 Basis of Payment. This work will be paid for at the contract unit price per foot (meter) for ELECTRIC CABLE, of the method of installation (IN TRENCH, IN CONDUIT, or AERIAL SUSPENDED), of the type, size, and number of conductors specified.

The type specified will indicate the method of installation and whether the electric cable is Service, Signal, Lead-in, Communication, or Equipment Grounding Conductor."

Revise the heading of Article 1076.04 of the Standard Specifications to read:

"1076.04 Electric Cable – Signal, Lead-in, Communication, Service, and Equipment Grounding Conductor."

Add the following paragraph to the end of Article 1076.04 of the Standard Specifications:

"(e) Equipment Grounding Conductor. The cross linked polyethylene (XLP) insulated conductor shall be according to Articles 1066.02 and 1066.03. The stranded copper conductor shall be No. 6 AWG and the insulation color shall be green."

TRAINING SPECIAL PROVISIONS (BDE) This Training Special Provision supersedes Section 7b of the Special Provision entitled "Specific Equal Employment Opportunity Responsibilities," and is in implementation of 23 U.S.C. 140(a).

As part of the contractor's equal employment opportunity affirmative action program, training shall be provided as follows:

The contractor shall provide on-the-job training aimed at developing full journeyman in the type of trade or job classification involved. The number of trainees to be trained under this contract will be \mathscr{S} . In the event the contractor subcontracts a portion of the contract work, he shall determine how many, if any, of the trainees are to be trained by the subcontractor, provided however, that the contractor shall retain the primary responsibility for meeting the training requirements imposed by this special provision. The contractor shall also insure that this Training Special Provision is made applicable to such subcontract. Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training.

The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within the reasonable area of recruitment. Prior to commencing construction, the contractor shall submit to the Illinois Department of Transportation for approval the number of trainees to be trained in each selected classification and training program to be used. Furthermore, the contractor shall specify the starting time for training in each of the classifications. The contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and will be reimbursed for such trainees as provided hereinafter.

Training and upgrading of minorities and women toward journeyman status is a primary objective of this Training Special Provision. Accordingly, the contractor shall make every effort to enroll minority trainees and women (e.g. by conducting systematic and direct recruitment through public and private sources likely to yield minority and women trainees) to the extent such persons are available within a reasonable area of recruitment. The contractor will be responsible for demonstrating the steps that he has taken in pursuance thereof, prior to a determination as to whether the contractor is in compliance with this Training Special Provision. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

No employee shall be employed as a trainee in any classification in which he has successfully completed a training course leading to journeyman status or in which he has been employed as a journeyman. The contractor should satisfy this requirement by including appropriate questions in the employee application or by other suitable means. Regardless of the method used the contractor's records should document the findings in each case.

The minimum length and type of training for each classification will be as established in the training program selected by the contractor and approved by the Illinois Department of Transportation and the Federal Highway Administration. The Illinois Department of Transportation and the Federal Highway Administration shall approve a program, if it is reasonably calculated to meet the equal employment opportunity obligations of the contractor and to qualify the average trainee for journeyman status in the classification concerned by the end of the training period. Furthermore, apprenticeship programs registered with the U.S. Department of Labor, Bureau of Apprenticeship and Training, or with a State apprenticeship agency recognized by the Bureau and training programs approved by not necessarily sponsored by the U.S. Department of Labor, Manpower Administration, Bureau of Apprenticeship and Training shall also be considered acceptable provided it is being administered in a manner consistent with the equal employment obligations of Federal-aid highway construction contracts. Approval or acceptance of a training program shall be obtained from the State prior to commencing work on the classification covered by the program. It is the intention of these provisions that training is to be provided in the construction crafts rather then clerk-typists or secretarial-type positions. Training is permissible in lower level management positions such as office engineers, estimators, timekeepers, etc., where the training is oriented toward construction applications. Training in the laborer classification may be permitted provided that significant and meaningful training is provided and approved by the Illinois Department of Transportation and the Federal Highway Administration. Some offsite training is permissible as long as the training is an integral part of an approved training program and does not comprise a significant part of the overall training.

Except as otherwise noted below, the contractor will be reimbursed 80 cents per hour of training given an employee on this contract in accordance with an approved training program. As approved by the Engineer, reimbursement will be made for training of persons in excess of the number specified herein. This reimbursement will be made even though the contractor receives additional training program funds from other sources, provided such other source does not specifically prohibit the contractor from receiving other reimbursement. Reimbursement for offsite training indicated above may only be made to the contractor where he does one or more of the following and the trainees are concurrently employed on a Federal-aid project; contributes to the cost of the training, provides the instruction to the trainee or pays the trainee's wages during the offsite training period.

No payment shall be made to the contractor if either the failure to provide the required training, or the failure to hire the trainee as a journeyman, is caused by the contractor and evidences a lack of good faith on the part of the contractor in meeting the requirement of this Training Special Provision. It is normally expected that a trainee will begin his training on the project as soon as feasible after start of work utilizing the skill involved and remain on the project as long as training opportunities exist in his work classification or until he has completed his training program.

It is not required that all trainees be on board for the entire length of the contract. A contractor will have fulfilled his responsibilities under this Training Special Provision if he has provided acceptable training to the number of trainees specified. The number trained shall be determined on the basis of the total number enrolled on the contract for a significant period.

Trainees will be paid at least 60 percent of the appropriate minimum journeyman's rate specified in the contract for the first half of the training period, 75 percent for the third quarter of the training period, and 90 percent for the last quarter of the training period, unless apprentices or trainees in an approved existing program are enrolled as trainees on this project. In that case, the appropriate rates approved by the Departments of Labor or Transportation in connection with the existing program shall apply to all trainees being trained for the same classification who are covered by this Training Special Provision.

The contractor shall furnish the trainee a copy of the program he will follow in providing the training. The contractor shall provide each trainee with a certification showing the type and length of training satisfactorily complete.

The contractor will provide for the maintenance of records and furnish periodic reports documenting his performance under this Training Special Provision.

METHOD OF MEASUREMENT The unit of measurement is in hours.

<u>BASIS OF PAYMENT</u> This work will be paid for at the contract unit price of 80 cents per hour for TRAINEES. The estimated total number of hours, unit price and total price have been included in the schedule of prices.

UNINTERRUPTABLE POWER SUPPLY (UPS) (BDE)

Effective: April 1, 2006 Revised: January 1, 2007

Add the following paragraph to the end of Article 801.14 of the Standard Specifications:

"The warranty for an uninterruptable power supply (UPS) shall cover a minimum of two years from date the equipment is placed in operation; however, the batteries of the UPS shall be warranted for full replacement for a minimum of five years."

Add the following Section to the Standard Specifications:

"SECTION 862. UNINTERRUPTABLE POWER SUPPLY (UPS)

862.01 Description. This work shall consist of furnishing and installing an uninterruptable power supply (UPS).

862.02 Materials. Materials shall be according to the following.

Item	Article/Section
(a) Uninterruptable Power Supply	

CONSTRUCTION REQUIREMENTS

862.03 General. The UPS shall provide power for full run-time operation for an "LED-only" intersection (all colors red, yellow, and green) or flashing mode operation for an intersection using red LED's. A UPS that provides a minimum of two hours of full run-time operation will be designated as "standard". A UPS that provides a minimum of six hours of full run-time operation will be designated as "extended".

The UPS shall include, but not be limited to the following: inverter/charger, power transfer relay, batteries, a separate manually operated non-electronic bypass switch, and all necessary hardware and interconnect wiring according to the plans. The UPS shall provide reliable emergency power to the traffic signals in the event of a power failure or interruption. The transfer from utility power to battery power and visa versa shall not interfere with the normal operation of traffic controller, conflict monitor/malfunction management unit, or any other peripheral devices within the traffic controller assembly.

The UPS shall be designed for outdoor applications, and shall meet the environmental requirements of, "NEMA Standards Publication No. TS 2 – Traffic Controller Assemblies", except as modified herein.

862.04 Installation. When a UPS is installed at an existing traffic signal cabinet, the UPS cabinet shall partially rest on the lip of the existing controller cabinet foundation and be secured

to the existing controller cabinet by means of at least four bolts. The UPS cabinet shall include a bottom constructed of the same material as the cabinet.

When a UPS is installed at a new signal cabinet and foundation, it shall be mounted as shown on the plans.

862.05 Basis of Payment. This work will be paid for at the contract unit price per each for UNINTERRUPTABLE POWER SUPPLY, STANDARD or UNINTERRUPTABLE POWER SUPPLY, EXTENDED."

Add the following article to Section 1074 of the Standard Specifications:

"1074.04 Uninterruptable Power Supply (UPS).

- (a) Operation.
 - (1) The UPS shall be line interactive and provide voltage regulation and power conditioning when utilizing utility power.

The UPS shall be sized appropriately for the intersection load. The total system load shall not exceed the manufacturer's specifications.

A standard UPS shall provide a minimum of two hours full run-time operation for LED signal modules load at 77 °F (25 °C) (minimum 700 W/1000 VA active output capacity, with 80 percent minimum inverter efficiency). An extended UPS shall provide a minimum of six hours full run-time operation for the same conditions.

- (2) The maximum transfer time from loss of utility power to switchover to battery backed inverter power shall be 65 milliseconds.
- (3) The UPS shall have four sets of normally open (NO) and normally closed (NC) single-pole double-throw (SPDT) relay contact closures, available on a panel-mounted terminal block, rated at a minimum 120 V/1 A, and labeled so as to identify each contact according to the plans.
 - a. The first set of NO and NC contact closures shall be energized whenever the unit switches to battery power. Contact shall be labeled or marked "On Batt".
 - b. The second set of NO and NC contact closures shall be energized whenever the battery approaches approximately 40 percent of remaining useful capacity. Contact shall be labeled or marked "Low Batt".
 - c. The third set of NO and NC contact closures shall be energized two hours after the unit switches to battery power. Contact shall be labeled or marked "Timer".

- d. The fourth set of NO and NC contact closures shall be energized in the event of inverter/charger failure. Contact shall be labeled or marked "UPS Fail".
- (4) Operating temperature for the inverter/charger, power transfer relay, and manual bypass switch shall be -35 to 165 °F (-37 to +74 °C).
- (5) Both the power transfer relay and manual bypass switch shall be rated at 240 VAC/30 amps, minimum.
- (6) The UPS shall use a temperature-compensated battery charging system. The charging system shall compensate over a range of 1.4 2.2 mV/°F (2.5 4.0 mV/°C) per cell. The temperature sensor shall be external to the inverter/charger unit. The temperature sensor shall come with 6.5 ft (2 m) of wire.
- (7) Batteries shall not be recharged when battery temperature exceeds 122 °F \pm 5 °F (50 °C \pm 3 °C).
- (8) The UPS shall bypass the utility line power whenever the utility line voltage is outside of the following voltage range: 100 VAC to 130 VAC (± 2 VAC).
- (9) When utilizing battery power, the UPS output voltage shall be between 110 and 125 VAC, pure sine wave output, ≤ 3 percent THD, 60 Hz ± 3 Hz.
- (10) The UPS shall be compatible with the Department's traffic controller assemblies utilizing NEMA TS 1 or NEMA TS 2 controllers and cabinet components for full time operation.
- (11) When the utility line power has been restored at above 105 VAC ± 2 VAC for more than 30 seconds, the UPS shall dropout of battery backup mode and return to utility line mode.
- (12) When the utility line power has been restored at below 125 VAC \pm 2 VAC for more than 30 seconds, the UPS shall dropout of battery backup mode and return to utility line mode.
- (13) The UPS shall be equipped to prevent a malfunction feedback to the cabinet or from feeding back to the utility service.
- (14) In the event of inverter/charger failure, the power transfer relay shall revert to the NC state, where utility line power is reconnected to the cabinet. In the event of an UPS fault condition, the UPS shall always revert back to utility line power.
- (15) Recharge time for the battery, from "protective low-cutoff" to 80 percent or more of full battery charge capacity, shall not exceed twenty hours.

- (16) The manual bypass switch shall be wired to provide power to the UPS when the switch is set to manual bypass.
- (17) When the intersection is in battery backup mode, the UPS shall bypass all internal cabinet lights, ventilation fans, and service receptacles.
- (18) As the battery reserve capacity reaches 50 percent, the intersection shall automatically be placed in all-red flash. The UPS shall allow the controller to automatically resume normal operation after the power has been restored. The UPS shall log an alarm in the controller for each time it is activated.
- (19) A blue LED indicator light shall be mounted on the front of the traffic signal cabinet or on the side of the UPS cabinet facing traffic and shall turn on to indicate when the cabinet power has been disrupted and the UPS is in operation. The light shall be a minimum 1 in. (25 mm) diameter, be viewable from the driving lanes, and able to be seen from 200 ft (60 m) away.
- (20) All 24 volt and 48 volt systems shall include an external component that monitors battery charging to ensure that every battery in the string is fully charged. The device shall compensate for the effects of adding a new battery to an existing battery system by ensuring that the charge voltage is spread equally across all batteries.
- (b) Mounting/Configuration.
 - (1) General.
 - a. The inverter/charger unit shall be rack or shelf-mounted.
 - b. All interconnect wiring provided between the power transfer relay, manual bypass switch, and cabinet terminal service block shall be at least 6.5 ft (2 m) of #10 AWG wire.
 - c. Relay contact wiring provided for each set of NO/NC relay contact closure terminals shall be 6.5 ft (2 m) of #18 AWG wire.
 - d. To ensure interchangeability between all UPS manufacturers, the UPS power transfer relay and manual bypass switch shall be interconnected with Type IV or Type V NEMA cabinets as shown on the plans.
 - (2) Battery Cabinet.
 - a. The inverter/charger and power transfer relay shall be installed inside the external battery cabinet and the manually bypass switch shall be installed inside the traffic signal cabinet.

- b. Batteries shall be housed in a separate NEMA Standard TS 2 rated Type II cabinet. This external battery cabinet shall be according to Article 1074.03 for the construction and finish of the cabinet.
- c. No more than two batteries shall be mounted on individual shelves for a cabinet housing four batteries and no more than four batteries per shelf for a cabinet housing eight batteries.
- d. A minimum of three shelves shall be provided. Each shelf shall support a load of 132 lb (60 kg) minimum for dual batteries.
- e. The battery cabinets housing four batteries shall have nominal outside dimensions according to a NEMA Type II cabinet; or alternatively, a width of 14 in. (355 mm), a depth of 9 in. (230 mm), and a height of 45 to 55 in. (1.14 to 1.4 m). The battery cabinets housing eight batteries shall have nominal outside dimensions according to a NEMA Type III cabinet; or alternatively, a width of 28 in. (710 mm), a depth of 9 in. (230 mm), and a height of 45 to 55 in. (1.14 to 1.4 m). Clearance between shelves shall be a minimum of 10 in. (250 mm).
- f. The battery cabinet shall be ventilated through the use of louvered vents, filters, and one thermostatically controlled fan as per NEMA TS 2 specifications. The cabinet fan shall not be energized when the traffic signals are on UPS power.
- g. The battery cabinet shall have a door opening to the entire cabinet. The door shall be attached to the cabinet through the use of a continuous stainless steel or aluminum piano hinge. The cabinet shall be provided with a main door lock which shall operate with a traffic industry conventional No. 2 key. Provisions for padlocking the door shall be provided.
- h. The UPS with battery cabinet shall come with all bolts, conduits and bushings, gaskets, shelves, and hardware needed for mounting.
- i. A warning sticker shall be placed on the outside of the cabinet indicating that there is an uninterruptable power supply inside the cabinet.
- (c) Maintenance, Displays, Controls, and Diagnostics.
 - (1) The UPS shall include a display and/or meter to indicate current battery charge status and conditions.
 - (2) The UPS shall have lightning surge protection compliant with IEEE/ANSI C.62.41.
 - (3) The UPS shall be equipped with an integral system to prevent battery from destructive discharge and overcharge.

- (4) The UPS hardware and batteries shall be easily replaced without requiring any special tools or devices.
- (5) The UPS shall include a resettable front-panel event counter display to indicate the number of times the UPS was activated and a front-panel hour meter to display the total number of hours the unit has operated on battery power.
- (6) The UPS shall be equipped with an RS-232 port.
- (7) The manufacturer shall include two sets of equipment lists, operation and maintenance manuals, board-level schematic and wiring diagrams of the UPS, and battery data sheets. The manufacturer shall include any software needed to monitor, diagnose, and operate the UPS. The manufacturer shall include any required cables to connect the UPS to a laptop computer.
- (d) Battery System.
 - (1) Individual batteries shall be 12 V type, 65 amp-hour minimum capacity at 20 hours, and shall be easily replaced and commercially available off the shelf.
 - (2) Batteries used for the UPS shall consist of four to eight batteries with a cumulative minimum rated capacity of 240 amp-hours.
 - (3) Batteries shall be premium gel cell, deep cycle, completely sealed, prismatic leadcalcium based, silver alloy, valve regulated lead acid (VRLA) requiring no maintenance.
 - (4) Batteries shall be certified by the manufacturer to operate over a temperature range of -13 to 160 °F (-25 to + 71 °C).
 - (5) The batteries shall be provided with appropriate interconnect wiring and corrosionresistant mounting trays and/or brackets appropriate for the cabinet into which they will be installed.
 - (6) Batteries shall indicate maximum recharge data and recharging cycles.
 - (7) Battery interconnect wiring shall be via a modular harness. Batteries shall be shipped with positive and negative terminals pre-wired with red and black cabling that terminates into a typical power-pole style connector. The harness shall be equipped with mating power-pole style connectors for the batteries and a single, insulated plug-in style connection to the inverter/charger unit. The harness shall allow batteries to be quickly and easily connected in any order and shall be keyed and wired to ensure proper polarity and circuit configuration.
 - (8) Battery terminals shall be covered and insulated so as to prevent accidental shorting."

ATTACHMENTS

A. Employment Preference for Appalachian Contracts (included in Appalachian contracts only)

I. GENERAL

1. These contract provisions shall apply to all word performed on the contract by the contractor's own organization and with the assistance of workers under the contractor's immediate superintendence and to all work performed on the contract by piecework, station work, or by subcontract.

2. Except as otherwise provided for in each section, the contractor shall insert in each subcontract all of the stipulations contained in these Required Contract Provisions, and further require their inclusion in any lower tier subcontract or purchase order that may in turn be made. The Required Contract Provisions shall not be incorporated by reference in any case. The prime contractor shall be responsible for compliance by any subcontractor or lower tier subcontractor with these Required Contract Provisions.

3. A breach of any of the stipulations contained in these Required Contract Provisions shall be sufficient grounds for termination of the contract.

4. A breach of the following clauses of the Required Contract Provisions may also be grounds for debarment as provided in 29 CFR 5.12:

Section I, paragraph 2; Section IV, paragraphs 1, 2, 3, 4 and 7; Section V, paragraphs 1 and 2a through 2g.

5. Disputes arising out of the labor standards provisions of Section IV (except paragraph 5) and Section V of these Required Contract Provisions shall not be subject to the general disputes clause of this contract. Such disputes shall be resolved in accordance with the procedures of the U.S. Department of Labor (DOL) as set forth in 29 CFR 5, 6 and 7. Disputes within the meaning of this clause include disputes between the contractor (or any of its subcontractors) and the contracting agency, the DOL, or the contractor's employees or their representatives.

6. Selection of Labor: During the performance of this contract, the contractor shall not:

a. Discriminate against labor from any other State, possession, or territory of the United States (except for employment preference for Appalachian contracts, when applicable, as specified in Attachment A), or

b. Employ convict labor for any purpose within the limits of the project unless it is labor performed by convicts who are on parole, supervised release, or probation.

II. NONDISCRIMINATION

(Applicable to all Federal-aid construction contracts and to all related subcontracts of \$10,000 or more.)

1. Equal Employment Opportunity: Equal employment opportunity (EEO) requirements not to discriminate and to take affirmative action to assure equal opportunity as set forth under laws, executive orders, rules, regulations (28 CFR 35, 29 CFR 1630 and 41 CFR 60 (and orders of the Secretary of Labor as modified by the provisions prescribed herein, and imposed pursuant to 23 U.S.C. 140 shall constitute the EEO and specific affirmative action standards for the contractor's project activities under this contract. The Equal Opportunity Construction Contract Specifications set forth under 41 CFR 60-4.3 and the provisions of the American Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) set forth under 28 CFR 35 and 29 CFR 1630 are incorporated by reference in this contract. In the execution of this contract, the contractor agrees to comply with the following minimum specific requirement activities of EEO:

a. The contractor will work with the State highway agency (SHA) and the Federal Government in carrying out EEO obligations and in their review of his/her activities under the contract.

b. The contractor will accept as his operating policy the following statement:

"It is the policy of this Company to assure that applicants are employed, and that employees are treated during employment, without regard to their race, religion, sex, color, national origin, age or disability. Such action shall include: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship, preapprenticeship, and/or on-the-job-training."

2. EEO Officer: The contractor will designate and make known to the SHA contracting officers an EEO Officer who will have the responsibility for an must be capable of effectively administering and promoting an active contractor program of EEO and who must be assigned adequate authority and responsibility to do so.

3. Dissemination of Policy: All members of the contractor's staff who are authorized to hire, supervise, promote, and discharge employees, or who recommend such action, or who are substantially involved in such action, will be made fully cognizant of, and will implement, the contractor's EEO policy and contractual responsibilities to provide EEO in each grade and classification of employment. To ensure that the above

agreement will be met, the following actions will be taken as a minimum:

a. Periodic meetings of supervisory and personnel office employees will be conducted before the start of work and then not less often than once every six months, at which time the contractor's EEO policy and its implementation will be reviewed and explained. The meetings will be conducted by the EEO Officer.

b. All new supervisory or personnel office employees will be given a thorough indoctrination by the EEO Officer, covering all major aspects of the contractor's EEO obligations within thirty days following their reporting for duty with the contractor.

c. All personnel who are engaged in direct recruitment for the project will be instructed by the EEO Officer in the contractor's procedures for locating and hiring minority group employees.

d. Notices and posters setting forth the contractor's EEO policy will be placed in areas readily accessible to employees, applicants for employment and potential employees.

e. The contractor's EEO policy and the procedures to implement such policy will be brought to the attention of employees by means of meetings, employee handbooks, or other appropriate means.

4. Recruitment: When advertising for employees, the contractor will include in all advertisements for employees the notation: "An Equal Opportunity Employer." All such advertisements will be placed in publications having a large circulation among minority groups in the area from which the project work force would normally be derived.

a. The contractor will, unless precluded by a valid bargaining agreement, conduct systematic and direct recruitment through public and private employees referral sources likely to yield qualified minority group applicants. To meet this requirement, the contractor will identify sources of potential minority group employees, and establish which such identified sources procedures whereby minority group applicants may be referred to the contractor for employment consideration.

b. In the event the contractor has a valid bargaining agreement providing for exclusive hiring hall referrals, he is expected to observe the provisions of that agreement to the extent that the system permits the contractor's compliance with EEO contract provisions. (The DOL has held that where implementation of such agreements have the effect of discriminating against minorities or women, or obligates the contractor to do the same, such implementation violates Executive Order 11246, as amended.)

c. The contractor will encourage his present employees to refer minority group applicants for employment. Information and procedures with regard to referring minority group applicants will be discussed with employees.

5. Personnel Actions: Wages, working conditions, and employee benefits shall be established and administered, and personnel actions of every type, including hiring, upgrading, promotion, transfer, demotion, layoff, and termination, shall be taken without regard to race, color, religion, sex, national origin, age or disability. The following procedures shall be followed:

a. The contractor will conduct periodic inspections of project sites to insure that working conditions and employee facilities do not indicate discriminatory treatment of project site personnel.

b. The contractor will periodically evaluate the spread of wages paid within each classification to determine any

evidence of discriminatory wage practices.

c. The contractor will periodically review selected personnel actions in depth to determine whether there is evidence of discrimination. Where evidence is found, the contractor will promptly take corrective action. If the review indicates that the discrimination may extend beyond the actions reviewed, such corrective action shall include all affected persons.

d. The contractor will promptly investigate all complaints of alleged discrimination made to the contractor in connection with his obligations under this contract, will attempt to resolve such complaints, and will take appropriate corrective action within a reasonable time. If the investigation indicates that the discrimination may affect persons other than the complainant, such corrective action shall include such other persons. Upon completion of each investigation, the contractor will inform every complainant of all of his avenues of appeal.

6. Training and Promotion:

a. The contractor will assist in locating, qualifying, and increasing the skills of minority group and women employees, and applicants for employment.

b. Consistent with the contractor's work force requirements and as permissible under Federal and State regulations, the contractor shall make full use of training programs, i.e., apprenticeship, and on-the-job training programs for the geographical area of contract performance. Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. In the event a special provision for training is provided under this contract, this subparagraph will be superseded as indicated in the special provision.

c. The contractor will advise employees and applicants for employment of available training programs and entrance requirements for each.

d. The contractor will periodically review the training and promotion potential of minority group and women employees and will encourage eligible employees to apply for such training and promotion.

7. Unions: If the contractor relies in whole or in part upon unions as a source of employees, the contractor will use his/her best efforts to obtain the cooperation of such unions to increase opportunities for minority groups and women within the unions, and to effect referrals by such unions of minority and female employees. Actions by the contractor either directly or through a contractor's association acting as agent will include the procedures set forth below:

a. The contractor will use best efforts to develop, in cooperation with the unions, joint training programs aimed toward qualifying more minority group members and women for membership in the unions and increasing the skills of minority group employees and women so that they may qualify for higher paying employment.

b. The contractor will use best efforts to incorporate an EEO clause into each union agreement to the end that such union will be contractually bound to refer applicants without regard to their race, color, religion, sex, national origin, age or disability.

c. The contractor is to obtain information as to the referral practices and policies of the labor union except that to the extent such information is within the exclusive possession of the labor union and such labor union refuses to furnish such information to the contractor, the contractor shall so certify to

the SHA and shall set forth what efforts have been made to obtain such information.

d. In the event the union is unable to provide the contractor with a reasonable flow of minority and women referrals within the time limit set forth in the collective bargaining agreement, the contractor will, through independent recruitment efforts, fill the employment vacancies without regard to race, color, religion, sex, national origin, age or disability; making full efforts to obtain qualified and/or qualifiable minority group persons and women. (The DOL has held that it shall be no excuse that the union with which the contractor has a collective bargaining agreement providing for exclusive referral failed to refer minority employees.) In the event the union referral practice prevents the contractor from meeting the obligations pursuant to Executive Order 11246, as amended, and these special provisions, such contractor shall immediately notify the SHA.

8. Selection of Subcontractors, Procurement of Materials and Leasing of Equipment: The contractor shall not discriminate on the grounds of race, color, religion, sex, national origin, age or disability in the selection and retention of subcontractors, including procurement of materials and leases of equipment.

a. The contractor shall notify all potential subcontractors and suppliers of his/her EEO obligations under this contract.

b. Disadvantaged business enterprises (DBE), as defined in 49 CFR 23, shall have equal opportunity to compete for and perform subcontracts which the contractor enters into pursuant to this contract. The contractor will use his best efforts to solicit bids from and to utilize DBE subcontractors or subcontractors with meaningful minority group and female representation among their employees. Contractors shall obtain lists of DBE construction firms from SHA personnel.

c. The contractor will use his best efforts to ensure subcontractor compliance with their EEO obligations.

9. Records and Reports: The contractor shall keep such records as necessary to document compliance with the EEO requirements. Such records shall be retained for a period of three years following completion of the contract work and shall be available at reasonable times and places for inspection by authorized representatives of the SHA and the FHWA.

a. The records kept by the contractor shall document the following:

 The number of minority and non-minority group members and women employed in each work classification on the project;

(2) The progress and efforts being made in cooperation with unions, when applicable, to increase employment opportunities for minorities and women;

(3) The progress and efforts being made in locating, hiring, training, qualifying, and upgrading minority and female employees; and

(4) The progress and efforts being made in securing the services of DBE subcontractors or subcontractors with meaningful minority and female representation among their employees.

b. The contractors will submit an annual report to the SHA each July for the duration of the project, indicating the number of minority, women, and non-minority group employees currently engaged in each work classification required by the contract work. This information is to be reported on Form FHWA-1391. If on-the-job training is being required by special provision, the contractor will be required to collect and report training data.

III. NONSEGREGATED FACILITIES

(Applicable to all Federal-aid construction contracts and to all related subcontracts of \$10,000 or more.)

a. By submission of this bid, the execution of this contract or subcontract, or the consummation of this material supply agreement or purchase order, as appropriate, the bidder, Federal-aid construction contractor, subcontractor, material supplier, or vendor, as appropriate, certifies that the firm does not maintain or provide for its employees any segregated facilities at any of its establishments, and that the firm does not permit its employees to perform their services at any location, under its control, where segregated facilities are maintained. The firm agrees that a breach of this certification is a violation of the EEO provisions of this contract. The firm further certifies that no employee will be denied access to adequate facilities on the basis of sex or disability.

b. As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms and washrooms, restaurants and other eating areas, timeclocks, locker rooms, and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated by explicit directive, or are, in fact, segregated on the basis of race, color, religion, national origin, age or disability, because of habit, local custom, or otherwise. The only exception will be for the disabled when the demands for accessibility override (e.g. disabled parking).

c. The contractor agrees that it has obtained or will obtain identical certification from proposed subcontractors or material suppliers prior to award of subcontracts or consummation of material supply agreements of \$10,000 or more and that it will retain such certifications in its files.

IV. PAYMENT OF PREDETERMINED MINIMUM WAGE

(Applicable to all Federal-aid construction contracts exceeding \$2,000 and to all related subcontracts, except for projects located on roadways classified as local roads or rural minor collectors, which are exempt.)

1. General:

a. All mechanics and laborers employed or working upon the site of the work will be paid unconditionally and not less often than once a week and without subsequent deduction or rebate on any account [except such payroll deductions as are permitted by regulations (29 CFR 3) issued by the Secretary of Labor under the Copeland Act (40 U.S.C. 276c)] the full amounts of wages and bona fide fringe benefits (or cash equivalents thereof) due at time of payment. The payment shall be computed at wage rates not less than those contained in the wage determination of the Secretary of Labor (hereinafter "the wage determination") which is attached hereto and made a part hereof, regardless of any contractual relationship which may be alleged to exist between the

contractor or its subcontractors and such laborers and mechanics. The wage determination (including any additional classifications and wage rates conformed under paragraph 2 of this Section IV and the DOL poster (WH-1321) or Form FHWA-1495) shall be posted at all times by the contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers. For the purpose of this Section, contributions made or costs reasonably anticipated for bona fide fringe benefits under Section 1(b)(2) of the Davis-Bacon Act (40 U.S.C. 276a) on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of Section IV, paragraph 3b, hereof. Also, for the purpose of this Section, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs, which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in paragraphs 4 and 5 of this Section IV.

b. Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein, provided, that the employer's payroll records accurately set forth the time spent in each classification in which work is performed.

c. All rulings and interpretations of the Davis-Bacon Act and related acts contained in 29 CFR 1, 3, and 5 are herein incorporated by reference in this contract.

2. Classification:

a. The SHA contracting officer shall require that any class of laborers or mechanics employed under the contract, which is not listed in the wage determination, shall be classified in conformance with the wage determination.

b. The contracting officer shall approve an additional classification, wage rate and fringe benefits only when the following criteria have been met:

 the work to be performed by the additional classification requested is not performed by a classification in the wage determination;

(2) the additional classification is utilized in the area by the construction industry;

(3) the proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination; and

(4) with respect to helpers, when such a classification prevails in the area in which the work is performed.

c. If the contractor or subcontractors, as appropriate, the laborers and mechanics (if known) to be employed in the additional classification or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken shall be sent by the contracting officer to the DOL, Administrator of the Wage and Hour Division, Employment Standards Administration, Washington, D.C. 20210. The Wage and Hour Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

d. In the event the contractor or subcontractors, as appropriate, the laborers or mechanics to be employed in the additional classification or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits, where appropriate), the contracting officer shall refer the question, including the views of all interested parties and the recommendation of the contracting officer, to the Wage and Hour Administrator for determination. Said Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advised the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

e. The wage rate (including fringe benefits where appropriate) determined pursuant to paragraph 2c or 2d of this Section IV shall be paid to all workers performing work in the additional classification from the first day on which work is performed in the classification.

3. Payment of Fringe Benefits:

a. Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the contractor or subcontractors, as appropriate, shall either pay the benefit as stated in the wage determination or shall pay another bona fide fringe benefit or an hourly case equivalent thereof.

b. If the contractor or subcontractor, as appropriate, does not make payments to a trustee or other third person, he/she may consider as a part of the wages of any laborer or mechanic the amount of any cost reasonably anticipated in providing bona fide fringe benefits under a plan or program, provided that the Secretary of Labor has found, upon the written request of the contractor, that the applicable standards of the Davis-Bacon Act have been met. The Secretary of Labor may require the contractor to set aside in a separate account assets for the meeting of obligations under the plan or program.

- 4. Apprentices and Trainees (Programs of the U.S. DOL) and Helpers:
 - a. Apprentices:

(1) Apprentices will be permitted to work at less than the predetermined rate for the work they performed when they are employed pursuant to and individually registered in a bona fide apprenticeship program registered with the DOL, Employment and Training Administration, Bureau of Apprenticeship and Training, or with a State apprenticeship agency recognized by the Bureau, or if a person is employed in his/her first 90 days of probationary employment as an apprentice in such an apprenticeship program, who is not individually registered in the program, but who has been certified by the Bureau of Apprenticeship and Training or a State apprenticeship agency (where appropriate) to be eligible for probationary employment as an apprentice.

(2) The allowable ratio of apprentices to journeyman-level employees on the job site in any craft classification shall not

be greater than the ratio permitted to the contractor as to the entire work force under the registered program. Any employee listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated above, shall be paid not less than the applicable wage rate listed in the wage determination for the classification of work actually performed. In addition, any apprentice performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. Where a contractor or subcontractor is performing construction on a project in a locality other than that in which its program is registered, the ratios and wage rates (expressed in percentages of the journeyman-level hourly rate) specified in the contractor's or subcontractor's registered program shall be observed.

(3) Every apprentice must be paid at not less than the rate specified in the registered program for the apprentice's level of progress, expressed as a percentage of the journeymanlevel hourly rate specified in the applicable wage determination. Apprentices shall be paid fringe benefits in accordance with the provisions of the apprenticeship program. If the apprenticeship program does not specify fringe benefits, apprentices must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification. If the Administrator for the Wage and Hour Division determines that a different practice prevails for the applicable apprentice classification, fringes shall be paid in accordance with that determination.

(4) In the event the Bureau of Apprenticeship and Training, or a State apprenticeship agency recognized by the Bureau, withdraws approval of an apprenticeship program, the contractor or subcontractor will no longer be permitted to utilize apprentices at less than the applicable predetermined rate for the comparable work performed by regular employees until an acceptable program is approved.

b. Trainees:

(1) Except as provided in 29 CFR 5.16, trainees will not be permitted to work at less than the predetermined rate for the work performed unless they are employed pursuant to and individually registered in a program which has received prior approval, evidenced by formal certification by the DOL, Employment and Training Administration.

(2) The ratio of trainees to journeyman-level employees on the job site shall not be greater than permitted under the plan approved by the Employment and Training Administration. Any employee listed on the payroll at a trainee rate who is not registered and participating in a training plan approved by the Employment and Training Administration shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any trainee performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed.

(3) Every trainee must be paid at not less than the rate specified in the approved program for his/her level of progress, expressed as a percentage of the journeyman-level hourly rate specified in the applicable wage determination. Trainees shall be paid fringe benefits in accordance with the provisions of the trainee program. If the trainee program does not mention fringe benefits, trainees shall be paid the full amount of fringe benefits Wage and Hour Division determines that there is an apprenticeship program associated with the corresponding journeyman-level wage rate on the wage determination which provides for less than full fringe benefits for apprentices, in which cases such trainees shall receive the same fringe benefits as apprentices.

(4) In the event the Employment and Training Administration withdraws approval of a training program, the contractor or subcontractor will no longer be permitted to utilize trainees at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

c. Helpers:

Helpers will be permitted to work on a project if the helper classification is specified and defined on the applicable wage determination or is approved pursuant to the conformance procedure set forth in Section IV. 2. Any worker listed on a payroll at a helper wage rate, who is not a helper under a approved definition, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed.

5. Apprentices and Trainees (Programs of the U.S. DOT):

Apprentices and trainees working under apprenticeship and skill training programs which have been certified by the Secretary of Transportation as promoting EEO in connection with Federal-aid highway construction programs are not subject to the requirements of paragraph 4 of this Section IV. The straight time hourly wage rates for apprentices and trainees under such programs will be established by the particular programs. The ratio of apprentices and trainees to journeymen shall not be greater than permitted by the terms of the particular program.

6. Withholding:

The SHA shall upon its own action or upon written request of an authorized representative of the DOL withhold, or cause to be withheld, from the contractor or subcontractor under this contract or any other Federal contract with the same prime contractor or any other Federallyassisted contract subject to Davis-Bacon prevailing wage requirements which is held by the same prime contractor, as much of the accrued payments or advances as may be considered necessary to pay laborers and mechanics, including apprentices, trainee's and helpers, employed by the contractor or any subcontractor the full amount of wages required by the contract. In the event of failure to pay any laborer or mechanic, including any apprentice, trainee, or helper, employed or working on the site of the work, all or part of the wages required by the contract, the SHA contracting officer may, after written notice to the contractor, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds until such violations have ceased.

7. Overtime Requirements:

No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers, mechanics, watchmen, or guards (including apprentices, trainees, and helpers described in paragraphs 4 and 5 above) shall require or permit any laborer, mechanic, watchman, or guard in any workweek in which he/she is employed on such work, to work in excess of 40 hours in such workweek unless such laborer, mechanic, watchman, or guard receives compensation at a rate not less than one-and-one-half times his/her basic rate of pay for all hours worked in excess of 40 hours in such workweek.

8. Violation:

Liability for Unpaid Wages; Liquidated Damages: In the event of any violation of the clause set forth in paragraph 7 above, the contractor and any subcontractor responsible thereof shall be liable to the affected employee for his/her unpaid wages. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory) for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer, mechanic, watchman, or guard employed in violation of the clause set forth in paragraph 7, in the sum of \$10 for each calendar day on which such employee was required or permitted to work in excess of the standard work week of 40 hours without payment of the overtime wages required by the clause set forth in paragraph 7.

9. Withholding for Unpaid Wages and Liquidated Damages:

The SHA shall; upon its own action or upon written request of any authorized representative of the DOL withhold, or cause to be withheld, from any monies payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other Federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph 8 above.

V. STATEMENTS AND PAYROLLS

(Applicable to all Federal-aid construction contracts exceeding \$2,000 and to all related subcontracts, except for projects located on roadways classified as local roads or rural collectors, which are exempt.)

1. Compliance with Copeland Regulations (29 CFR 3):

The contractor shall comply with the Copeland Regulations of the Secretary of Labor which are herein incorporated by reference.

2. Payrolls and Payroll Records:

a. Payrolls and basic records relating thereto shall be maintained by the contractor and each subcontractor during the course of the work and preserved for a period of 3 years from the date of completion of the contract for all laborers, mechanics, apprentices, trainees, watchmen, helpers, and guards working at the site of the work.

b. The payroll records shall contain the name, social security number, and address of each such employee; his or her correct classification; hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalent thereof the types described in Section 1(b)(2)(B) of the Davis Bacon Act); daily and weekly number of hours worked; deductions made; and actual wages paid. In addition, for Appalachian contracts, the payroll records shall contain a notation indicating whether the employee does, or does not, normally reside in the labor area as defined in Attachment A, paragraph 1. Whenever the Secretary of Labor, pursuant to Section IV, paragraph 3b, has found that the wages of any laborer or mechanic include the amount of any costs reasonably anticipated in providing benefits under a plan or program described in Section 1(b)(2)(B) of the Davis Bacon Act, the contractor and each subcontractor shall maintain records which show that the commitment to provide such benefits is enforceable, that the plan or program is financially responsible, that the plan or program has been communicated in writing to the laborers or mechanics affected, and show the cost anticipated or the actual cost incurred in providing benefits. Contractors or subcontractors employing apprentices or trainees under approved programs shall maintain written evidence of the registration of apprentices and trainees, and ratios and wage rates prescribed in the applicable programs.

c. Each contractor and subcontractor shall furnish, each week in which any contract work is performed, to the SHA resident engineer a payroll of wages paid each of its employees (including apprentices trainees, and helpers, described in Section IV, paragraphs 4 and 5, and watchmen and guards engaged on work during the preceding weekly payroll period).

The payroll submitted shall set out accurately and completely all of the information required to be maintained under paragraph 2b of this Section V.

This information may be submitted in any form desired. Optional Form WH-347 is available for this purpose and may be purchased from the Superintendent of Documents (Federal stock number 029-005-0014-1), U.S. Government Printing Office, Washington, D.C. 20402. The prime contractor is responsible for the submission of copies of payrolls by all suncontractors.

d. Each payroll submitted shall be accompanied by a "Statement of Compliance," signed by the Contractor or subcontractor or his/her agent who pays or supervises the payment of the persons employed under the contract and shall certify the following:

 that the payroll for the payroll period contains the information required to be maintained under paragraph 2b of this Section V and that such information is correct and complete;

(2) that such laborer or mechanic (including each helper, apprentice, and trainee) employed on the contract during the payroll period has been paid the full weekly wages earned, without rebate, either directly or indirectly, and that no deductions have been made either directly or indirectly from the full wages earned, other than permissible deductions as set forth in the Regulations, 29 CFR 3;

(3) that each laborer or mechanic has been paid not less that the applicable wage rate and fringe benefits or cash equivalent for the classification of worked performed, as specified in the applicable wage determination incorporated into the contract.

e. The weekly submission of a properly executed certification set forth on the reverse side of Optional Form WH-347 shall satisfy the requirement for submission of the "Statement of Compliance" required by paragraph 2d of this Section V.

f. The falsification of any of the above certifications may subject the contractor to civil or criminal prosecution under 18 U/S. C. 1001 and 31 U.S.C. 231.

g. The contractor or subcontractor shall make the records required under paragraph 2b of this Section V available for

inspection, copying, or transcription by authorized representatives of the SHA, the FHWA, or the DOL, and shall permit such representatives to interview employees during working hours on the job. If the contractor or subcontractor fails to submit the required records or to make them available, the SHA, the FHWA, the DOL, or all may, after written notice to the contractor, sponsor, applicant, or owner, take such actions as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds. Furthermore, failure to submit the required records upon request or to make such records available may be grounds for debarment action pursuant to 29 CFR 5.12.

VI. RECORD OF MATERIALS, SUPPLIES, AND LABOR

1. On all federal-aid contracts on the national highway system, except those which provide solely for the installation of protective devices at railroad grade crossings, those which are constructed on a force account or direct labor basis, highway beautification contracts, and contracts for which the total final construction cost for roadway and bridge is less than \$1,000,000 (23 CFR 635) the contractor shall:

a. Become familiar with the list of specific materials and supplies contained in Form FHWA-47, "Statement of Materials and Labor Used by Contractor of Highway Construction Involving Federal Funds," prior to the commencement of work under this contract.

b. Maintain a record of the total cost of all materials and supplies purchased for and incorporated in the work, and also of the quantities of those specific materials and supplies listed on Form FHWA-47, and in the units shown on Form FHWA-47.

c. Furnish, upon the completion of the contract, to the SHA resident engineer on /Form FHWA-47 together with the data required in paragraph 1b relative to materials and supplies, a final labor summary of all contract work indicating the total hours worked and the total amount earned.

2. At the prime contractor's option, either a single report covering all contract work or separate reports for the contractor and for each subcontract shall be submitted.

VII. SUBLETTING OR ASSIGNING THE CONTRACT

1. The contractor shall perform with its own organization contract work amounting to not less than 30 percent (or a greater percentage if specified elsewhere in the contract) of the total original contract price, excluding any specialty items designated by the State. Specialty items may be performed by subcontract and the amount of any such specialty items performed may be deducted from the total original contract price before computing the amount of work required to be performed by the contractors' own organization (23 CFR 635).

a. "Its own organization" shall be construed to include only workers employed and paid directly by the prime contractor and equipment owned or rented by the prime contractor, with or without operators. Such term does not include employees or equipment of a subcontractor, assignee, or agent of the prime contractor.

b. "Specialty Items" shall be construed to be limited to work that requires highly specialized knowledge, abilities, or equipment not ordinarily available in the type of contracting organizations qualified and expected to bid on the contract as a whole and in general are to be limited to minor components of the overall contract.

2. The contract amount upon which the requirements set forth in paragraph 1 of Section VII is computed includes the cost of material and manufactured products which are to be purchased or produced by the contractor under the contract provisions.

3. The contractor shall furnish (a) a competent superintendent or supervisor who is employed by the firm, has full authority to direct performance of the work in accordance with the contract requirements, and is in charge of all construction operations (regardless of who performs the work) and (b) such other of its own organizational resources (supervision, management, and engineering services) as the SHA contracting officer determines is necessary to assure the performance of the contract.

4. No portion of the contract shall be sublet, assigned or otherwise disposed of except with the written consent of the SHA contracting officer, or authorized representative, and such consent when given shall not be construed to relieve the contractor of any responsibility for the fulfillment of the contract.

Written consent will be given only after the SHA has assured that each subcontract is evidenced in writing and that it contains all pertinent provisions and requirements of the prime contract.

VIII. SAFETY: ACCIDENT PREVENTION

1. In the performance of this contract the contractor shall comply with all applicable Federal, State, and local laws governing safety, health, and sanitation (23 CFR 635). The contractor shall provide all safeguards, safety devices and protective equipment and take any other needed actions as it determines, or as the SHA contracting officer may determine, to be reasonably necessary to protect the life and health of employees on the job and the safety of the public and to protect property in connection with the performance of the work covered by the contract.

2. It is a condition of this contract, and shall be made a condition of each subcontract, which the contractor enters into pursuant to this contract, that the contractor and any subcontractor shall not permit any employee, in performance of the contract, to work in surroundings or under conditions which are unsanitary, hazardous or dangerous to his/her health or safety, as determined under construction safety and health standards (29 CFR 1926) promulgated by the Secretary of Labor, in accordance with Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S. C. 333).

3. Pursuant to 29 CFR 1926.3, it is a condition of this contract that the Secretary of Labor or authorized representative thereof, shall have right of entry to any site of contract performance to inspect or investigate the matter of compliance with the construction safety and health standards and to carry out the duties of the Secretary under Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 333).

IX. FALSE STATEMENTS CONCERNING HIGHWAY PROJECTS

In order to assure high quality and durable construction in conformity with approved plans and specifications and a high degree of reliability on statements and representations made by engineers, contractors, suppliers, and workers on Federal-aid highway projects, it is essential that all persons concerned with the project perform their functions as carefully, thoroughly, and honestly as possible. Willful falsification, distortion, or misrepresentation with respect to any facts related to the project is a violation of Federal law. To prevent any misunderstanding regarding the seriousness of these and similar acts, the following notice shall be posted on each Federal-aid highway project (23 CFR 635) in one or more places where it is readily available to all persons concerned with the project:

NOTICE TO ALL PERSONNEL ENGAGED ON FEDERAL-AID HIGHWAY PROJECTS

18 U.S.C. 1020 reads as follows:

"Whoever, being an officer, agent or employee of the United States, or of any State or Territory, or whoever, whether a person, association, firm, or corporation, knowingly makes any false statement, false representation, or false report as to the character, quality, quantity, or cost of the material used or to be used, or the quantity or quality of the work performed or to be performed, or the cost thereof in connection with the submission of plans, maps, specifications, contracts, or costs of construction on any highway or related project submitted for approval to the Secretary of Transportation; or

Whoever knowingly makes any false statement, false representation, false report or false claim with respect to the character, quality, quantity, or cost of any work performed or to be performed, or materials furnished or to be furnished, in connection with the construction of any highway or related project approved by the Secretary of Transportation; or

Whoever knowingly makes any false statement or false representation as to material fact in any statement, certificate, or report submitted pursuant to provisions of the Federal-aid Roads Act approved July 1, 1916, (39 Stat. 355), as amended and supplemented;

Shall be fined not more than \$10,000 or imprisoned not more than 5 years or both."

X. IMPLEMENTATION OF CLEAN AIR ACT AND FEDERAL WATER POLLUTION CONTROL ACT

(Applicable to all Federal-aid construction contracts and to all related subcontracts of \$100,000 or more).

By submission of this bid or the execution of this contract, or subcontract, as appropriate, the bidder, Federal-aid construction contractor, or subcontractor, as appropriate, will be deemed to have stipulated as follows:

1. That any facility that is or will be utilized in the performance of this contract, unless such contract is exempt under the Clean Air Act, as amended (42 U.S.C. 1857 <u>et seq.</u>, as amended by Pub.L. 91-604), and under the Federal Water Pollution Control Act, as amended (33 U.S.C. 1251 <u>et seq.</u>, as amended by Pub.L. 92-500), Executive Order 11738, and regulations in implementation thereof (40 CFR 15) is not listed, on the date of contract award, on the U.S. Environmental Protection Agency (EPA) List of Violating Facilities pursuant to 40 CFR 15.20.

2. That the firm agrees to comply and remain in compliance with all the requirements of Section 114 of the Clean Air Act and Section 308 of the Federal Water Pollution Control Act and all regulations and guidelines listed thereunder.

3. That the firm shall promptly notify the SHA of the receipt of

any communication from the Director, Office of Federal Activities, EPA indicating that a facility that is or will be utilized for the contract is under consideration to be listed on the EPA List of Violating Facilities.

4. That the firm agrees to include or cause to be included the requirements of paragraph 1 through 4 of this Section X in every nonexempt subcontract, and further agrees to take such action as the government may direct as a means of enforcing such requirements.

XI. CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY AND VOLUNTARY EXCLUSION

1. Instructions for Certification - Primary Covered Transactions:

(Applicable to all Federal-aid contracts - 49 CFR 29)

a. By signing and submitting this proposal, the prospective primary participant is providing the certification set out below.

b. The inability of a person to provide the certification set out below will not necessarily result in denial of participation in this covered transaction. The prospective participant shall submit an an explanation of why it cannot provide the certification set out below. The certification or explanation will be considered in connection with the department or agency's determination whether to enter into this transaction. However, failure of the prospective primary participant to furnish a certification or an explanation shall disqualify such a person from participation in this transaction.

c. The certification in this clause is a material representation of fact upon which reliance was placed when the department or agency determined to enter into this transaction. If it is later determined that the prospective primary participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause of default.

d. The prospective primary participant shall provide immediate written notice to the department or agency to whom this proposal is submitted if any time the prospective primary participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.

e. The terms "covered transaction," "debarred," "suspended," "ineligible,""lower tier covered transaction," "participant," "person," "primary covered transaction," "principal," "proposal," and "voluntarily excluded," as used in this clause, have the meanings set out in the Definitions and Coverage sections of rules implementing Executive Order 12549. You may contact the department or agency to which this proposal is submitted for assistance in obtaining a copy of those regulations.

f. The prospective primary participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency entering into this transaction.

g. The prospective primary participant further agrees by submitting this proposal that it will include the clause titled

"Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transaction," provided by the department or agency entering into this covered transaction, without modification in all lower tier covered transactions and in all solicitations for lower tier covered transactions.

h. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant may decide the method and frequency by which it determines the eligibility of its principals. Each participant may, but is not required to, check the nonprocurement portion of the "Lists of Parties Excluded from Federal Procurement or Nonprocurement Programs" (Nonprocurement List) which is compiled by the General Services Administration.

i. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.

j. Except for transactions authorized under paragraph f of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause or default.

Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Primary Covered Transactions

1. The prospective primary participant certifies to the best of its knowledge and belief, that it and its principals:

a. Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal department or agency;

b. Have not within a 3-year period preceding this proposal been convicted of or had a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State or local) transaction or contract under a public transaction; violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

c. Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State or local) with commission of any of the offenses enumerated in paragraph 1b of this certification; and

d. Have not within a 3-year period preceding this application/proposal had one or more public transactions (Federal, State or local) terminated for cause or default.

2. Where the prospective primary participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

2. Instructions for Certification - Lower Tier Covered Transactions:

(Applicable to all subcontracts, purchase orders and other lower tier transactions of \$25,000 or more - 49 CFR 29)

a. By signing and submitting this proposal, the prospective lower tier is providing the certification set out below.

b. The certification in this clause is a material representation of fact upon which reliance was placed when this transaction was entered into. If it is later determined that the prospective lower tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the department, or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.

c. The prospective lower tier participant shall provide immediate written notice to the person to which this proposal is submitted if at any time the prospective lower tier participant learns that its certification was erroneous by reason of changed circumstances.

d. The terms "covered transaction," "debarred," "suspended," "ineligible," "primary covered transaction," "participant," "person," "principal," "proposal," and "voluntarily excluded," as used in this clause, have the meanings set out in the Definitions and Coverage sections of rules implementing Executive Order 12549. You may contact the person to which this proposal is submitted for assistance in obtaining a copy of those regulations.

e. The prospective lower tie participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with which this transaction originated.

f. The prospective lower tier participant further agrees by submitting this proposal that it will include this clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions.

g. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant may decide the method and frequency by which it determines the eligibility of its principals. Each participant may, but is not required to, check the Nonprocurement List.

h. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealing.

i. Except for transactions authorized under paragraph e of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.

Certification Regarding Debarment, Suspension, Ineligibility And Voluntary Exclusion-Lower Tier Covered Transactions:

1. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any Federal department or agency.

2. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

XII. CERTIFICATION REGARDING USE OF CONTRACT FUNDS FOR LOBBYING

(Applicable to all Federal-aid construction contracts and to all related subcontracts which exceed \$100,000 - 49 CFR 20)

1. The prospective participant certifies, by signing and submitting this bid or proposal, to the best of his or her knowledge and belief, that:

a. No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

b. If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

2. This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by 31 U.S.C. 1352. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

3. The prospective participant also agrees by submitting his or her bid or proposal that he or she shall require that the language of this certification be included in all lower tier subcontracts, which exceed \$100,000 and that all such recipients shall certify and disclose accordingly.

MINIMUM WAGES FOR FEDERAL AND FEDERALLY ASSISTED CONSTRUCTION CONTRACTS

This project is funded, in part, with Federal-aid funds and, as such, is subject to the provisions of the Davis-Bacon Act of March 3, 1931, as amended (46 Sta. 1494, as amended, 40 U.S.C. 276a) and of other Federal statutes referred to in a 29 CFR Part 1, Appendix A, as well as such additional statutes as may from time to time be enacted containing provisions for the payment of wages determined to be prevailing by the Secretary of Labor in accordance with the Davis-Bacon Act and pursuant to the provisions of 29 CFR Part 1. The prevailing rates and fringe benefits shown in the General Wage Determination Decisions issued by the U.S. Department of Labor shall, in accordance with the provisions of the foregoing statutes, constitute the minimum wages payable on Federal and federally assisted construction projects to laborers and mechanics of the specified classes engaged on contract work of the character and in the localities described therein.

General Wage Determination Decisions, modifications and supersedes decisions thereto are to be used in accordance with the provisions of 29 CFR Parts 1 and 5. Accordingly, the applicable decision, together with any modifications issued, must be made a part of every contract for performance of the described work within the geographic area indicated as required by an applicable DBRA Federal prevailing wage law and 29 CFR Part 5. The wage rates and fringe benefits contained in the General Wage Determination Decision shall be the minimum paid by contractors and subcontractors to laborers and mechanics.
